Murder By Injection

Murder By Injection: The Story of the Medical Conspiracy Against America was written by **Eustace Clarence Mullins** in 1988 and now is back in print. The Minister highlighted the book in 2004 and recommended it to the world. In the excerpt below Mullins forecasts the danger posed by today’s medical madmen and their death-dealing vaccine cult:

Yet, in the state of Virginia, and in many other states, parents are compelled to submit their children to this procedure while the medical profession not only receives its pay for this service, but also makes splendid and prospective patients for the future.’

“The present writer [Mullins] well remembers the 1920s, as a child in Virginia, going to school for some weeks without having submitted to the compulsory vaccination ordered by the state authorities. Each morning, the teacher would begin the day’s classes by asking, ‘Clarence, did you bring your vaccination certificate today?’ Obviously, this was the most urgent business of the educational system, taking priority over such mat-

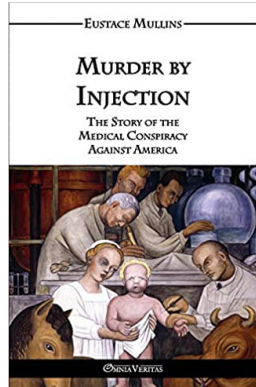
ters as lessons and studying. Each morning, I would have to reply, ‘No, I didn’t bring it today.’ The other children would turn and stare at this dangerous classmate, who might infect them all with some terrible disease. My mother had been a registered nurse, and she never urged me to go ahead with my vaccination. I suspect she knew more than the doctors about its possible effects. After postponing the dreaded ordeal for some weeks, I was finally led to the doctor like an animal being led up the plank to be stunned, and I received my injection. Of course it made me extremely ill, as my body fought the infection, but the class was delivered from peril, and I was accepted as a duly branded member of society. In ‘The Curse of Canaan,’ I wrote of the deliverance of our children up for ritual sacrifice, a practice which seemingly ended with the destruction of the Baal cult some five thousand years ago. Unfortunately, the Cult of Baal seems to be firmly entrenched in the present Establishment, which is often known by the sobriquet, the Brotherhood of Death. It is disturbing to see how the educationists eagerly embrace each new offense against children in our schools, railing against any mention of morality or religion, while solemnly indoctrinating six year olds in the advantages of ‘an alternative life style’ in their sexual preferences. The present goal of the National Education Association seems to be that teachers should hand out condoms to the class before beginning each day’s activities...”

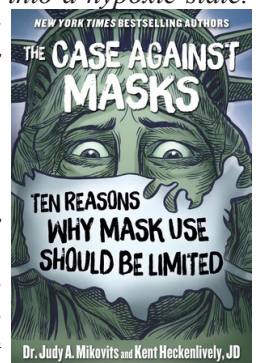
Dr. Judy Mikovits on mask wearing:

Dr. Judy Mikovits, a Ph.D in Biochemistry and Molecular Biology, was asked about masks by *The Final Call*:

At a recent TedTalk before the purchase Musk, a self-described “free speech absolutist,” decried Twitter’s current censoring policies: **“[H]aving tweets mysteriously be promoted and demoted with no insight into what’s going on, having a black box algorithm promote some things and not other things, I think this can be quite dangerous.”**

Within 24 hours of the April 25th sale the previously banned discussion of the COVID therapeutic drug **Ivermectin** was trending with thousands of Tweets. Any mention of the success of any drug other than the “vaccine” has been ruthlessly scrubbed from the platform for the last two years. The significance of this development was discussed by **Tucker Carlson** in a segment of his *Fox News* show:

“Elon Musk...knows how important Twitter is to the people who run our system, who run the global

system. For them, censorship and propaganda are not a feature of their rule—their rule depends on censorship and propaganda. If you are offering policies that really benefit nobody but yourself, you have to lie about them, and you must prevent anyone from complaining about it.

“...Again, you can’t overstate what a threat this is—not simply to the people occupying seats of political power, but to the whole non-profit universe that exists and thrives and becomes rich, supporting them through censorship and propaganda. So, groups like the Anti-Defamation League (ADL) or Media Matters take money in order to censor people. They issue some report calling you a racist and then social media shuts you down. Elon Musk is saying ‘No, people should be able to speak freely.’ That would mean the end of their control over speech—groups like the ADL and Media Matters. So, the media and these nonprofit groups have to stop this before it happens.... If free speech is restored to even one big social media platform, it all comes tumbling down.”

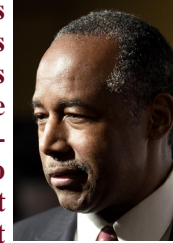
Dr. Ben Carson Says Trust in Public Health System Has Been Destroyed

The *Epoch Times* interviewed brain surgeon **Dr. Ben Carson** after the federal court ruling striking down Joe Biden’s mask mandate in transportation. The former chief of pediatric neurosurgery at Johns Hopkins Hospital explained how the public’s trust in the American health system has been destroyed:

“We’ve gotten into a system where we have the media in cahoots with the executive branch, sort of overlooking all the other safeguards that we have in our system. And as a result of that, what we’ve done has completely destroyed the trust of the people in the CDC, the NIH, the government health system. It’s going to take a very long time to get that trust back....It’s too bad that a federal court system had to come in and bring some common sense into the discussion. But the fact of the matter is, we all know, from multitudinous data, that the masks aren’t doing very much, particularly in things like airplanes that already have HEPA filters.”

Carson targeted the government’s single-minded focus on “vaccinations” and their curious policy of banning successful treatments.

“[Hydroxychloroquine] was roundly criticized by our government officials. So was Ivermectin and some other therapeutics that work perfectly fine in other parts of the world. Why would they work in other parts of the world and not work here? Why is it, in Western Africa, there’s almost no COVID? Because they take hydroxychloroquine as an anti-malarial. Why in southern India is there almost no COVID? Because they take Ivermectin. Maybe they’re not taking it specifically for COVID, but look at the results.”



7,500% Increase in Recorded Cases of Cancer Following COVID-19 Vaccines

Pathologist **Dr. Ryan Cole** (in photo) said that he is hearing from doctors all across the world that cancer rates are “taking off like wild fire” following COVID-19 “vaccinations.” Their patients with stabilized stage 1 cancers advance to stage 4 within a couple of weeks of the shot. He concludes that the cancer-fighting T-cells are being neutralized by the “vaccinations.”



Cancer is not considered a common side effect of vaccines. This may be due to the time it takes for cancer cells to proliferate and be exposed through cancer screening. And by then most people would probably not even associate a diagnosis of cancer with a previous vaccine.

Brian Shilhavy, editor of *Health Impact News*, searched for various forms of cancer in the CDC’s Vaccine Adverse Event Reporting System (VAERS) and found 739 cases resulting in 84 deaths following COVID-19 “vaccinations” for the past 16 months.

Using the exact same search for all FDA-approved vaccines for the previous 30 years before the COVID-19 shots were issued emergency use authorizations, Shilhavy found just 220 cases resulting in 16 deaths over 360 months. That’s an average of .6 cases per month for the previous 30 years compared to an average of 46 cases of cancer per month following COVID-19 vaccines—an increase of 7,567%.

Philadelphia Reverses on Mask Mandate; Ends It Days After Reinstatement

Philadelphia ended its indoor mask mandate, abruptly reversing course just days after people in the city were ordered to resume the ineffective and unscientific measure. The Board of Health cited “decreasing hospitalizations and a leveling of case counts” but did not release data to back up its reversal.

Philadelphia had been the first major U.S. city to reinstate its indoor mask mandate, but faced fierce blowback as well as a legal effort to get the mandate thrown out. Philadelphians, tired and angry at the continual pushing of failed “pandemic policies,” appeared to be largely ignoring the order, and few masks were worn at the Philadelphia 76ers’ home playoff game even though they were required under city rules.

The restaurant industry had pushed back against the city’s reimposed mask mandate, saying workers would bear the brunt of customer anger over the new rules. Several businesses and residents sued the city, seeking to overturn the renewed mandate.
