

Fake Death Counts Drove the Plandemic For Two Years British Study Shows

The media’s unrelenting 24-7 broadcasting of “COVID” death and case counts is intended to drive the frightened masses into taking the depopulation shots. But British scientists have released a new report showing fundamental flaws in the way COVID deaths were counted in the U.K.

Researchers found cases where COVID negative individuals, and those whose death was clearly not caused by COVID, were still classified as “COVID-19 deaths.” In care homes, they say, deaths were certified as COVID deaths by doctors doing their inspection via a video call. Researchers found that 14 different terms were used to describe a person who had died with COVID: these included “involving COVID,” “underlying COVID,” “died within either 28 or 60 days of a positive test,” and “due to COVID.” Under all those categories, deaths were added to the “COVID death” count.

Dr. Carl Heneghan, epidemiologist and director at the University of Oxford’s Centre for Evidence-Based Medicine, said that “It is incredibly important to understand the logical chain of events that led to death. But if every health body is using a different definition, how do we know whether COVID has directly caused the death or if it was something else that was underlying? Two years into this pandemic, it is clear nobody can really understand or answer that question.”

According to Heneghan, “By the very nature of people who are in care homes, they have lots of comorbidities (the presence of two or more diseases at the same time) that contribute to their death. This usually includes either underlying heart failure, or diabetes, or something else—and then they got COVID.”

In the United States, according to official CDC data, approximately 95 percent of people who “died with COVID” had an average of four other causes of death listed on their death certificate. Even with this staggering number it is still unknown out of this 95 percent of people, how many of these deaths were actually caused by a COVID infection.

Study: Lockdown States Fared Worst, No Mandate States Among the Best

A new study by the **Committee To Unleash Prosperity** compared state performance on metrics including the economy, education, and mortality from the “virus.” It found that the most aggressive followers of Fauci—New York, California, New Jersey and Illinois—were among the worst states in dealing with the coronavirus, performing “poorly on every measure,” the report said.

Those states “had high age-adjusted death rates; they had high unemployment and significant GDP losses, and they kept their schools shut down much longer than almost all other states,” the report added.

The Fauci-resistant states like Utah, Nebraska, Vermont, Montana, South Dakota and Florida received the best scores. *“The study...found that locking down businesses, stores, churches, schools, and restaurants had almost no impact on health outcomes across states....States with strict lockdowns had virtually no better performance in COVID death rates than states that remained mostly open for business.”*

Over 30% of businesses were affected by the depopulation policies of the U.S. government, with many having to close permanently or having to drastically cut the number of employees.

Federal Judge Declares CDC’S Mask Mandate for Planes, Trains UNLAWFUL

U.S. District Judge Kathryn Kimball Mizelle has ruled that the CDC’s unscientific and ineffective travel mask mandate exceeded their statutory authority. The court order states that “our system does not permit agencies to act unlawfully even in pursuit of desirable ends.” The judge found that the mandate was not even needed: “At the time when the CDC issued the mandate, the COVID-19 pandemic had been ongoing for almost a year and COVID-19 cases were decreasing.”

All the major airlines and rail services were quick to announce they were no longer requiring masks. Uber and Lyft also ditched their mask requirements for riders and drivers.

CDC Admits that Teen suicide attempts spiked during COVID-19 lockdowns

The disastrous effect of the Depopulation policies on the world continues to be made manifest. A new CDC study shows that the rate at which girls ages 12 through 17, in particular, were visiting the emergency rooms for suicide attempts between February and March of 2021 increased nearly 51% compared to the same period in 2019 before schools and businesses were forced to close their doors.

The percentage of teenagers who were hospitalized for suspected suicide attempts spiked in 2020 and 2021 amid COVID-19 lockdowns.

Researchers also noted a nearly 4% increase in ER visits for suspected suicide attempts among boys ages 12 through 17 over the same time period.

Risk factors include a “lack of connectedness to schools, teachers and peers” due to physical distancing measures, “barriers to health treatment,” “increases in substance abuse” and anxiety related to “family health and economic problems.”

ER visits for “mental health concerns and suspected child abuse,” which are also risk factors for suicide, “also increased in 2020 compared with 2019, potentially contributing to increases in suspected suicide attempts,” researchers wrote. General mental-health-related ER visits among teens ages 12 through 17 increased 31% in 2020 compared to 2019.

Rise in Child Vaccinations Linked to Shocking Rise in Autism

- (12) HPV (teenagers)

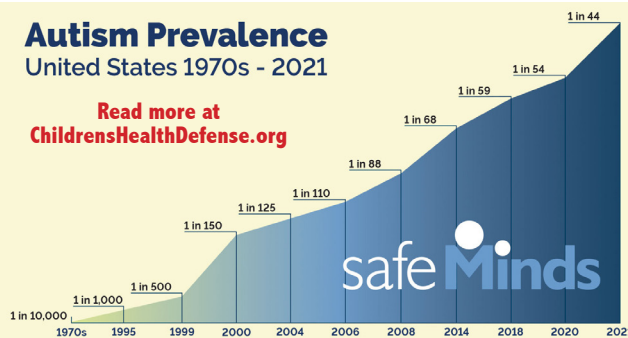
