## Watchdog Group Uncovers \$350 Million in Secret Payments to Fauci, Collins, Others at NIH

Between 2010 and 2020, pharmaceutical companies and others paid an estimated \$350 million in “royalties” to the National Institutes of Health (NIH) and hundreds of its scientists, including the agency's recently departed director, **Dr. Francis Collins**, and **Dr. Anthony Fauci**, according to the nonprofit government watchdog group **Open the Books**. Its CEO Adam Andrzejewski told reporters that “We now know that there are 1,675 scientists that received payments during the period.” They found that Collins received 14 payments and Fauci received 23 payments.

Andrzejewski explained why: the royalty payments are given “When an NIH employee makes a discovery in their official capacity, the NIH owns the rights to any resulting patent...Employees are listed as inventors on the patents and receive a share of the royalties obtained through any licensing, or ‘technology transfer,’ of their inventions.”

But the question remains, why the secrecy? Who are the companies paying these massive sums? And are these payments in effect bribes for favorable treatment by these agencies that are allegedly guarding the public health? And most important did these payments and the scientists that received them play any role in the corrupted process that forced this deadly COVID-19 depopulation “vaccine” into millions of arms?

Andrzejewski said the files Open the Books is receiving through the Freedom of Information Act are heavily censored. “We don't know the payment amount to the scientist, and we don't know the name of the third-party payer, all of that is being redacted.”

“We believe there is an unholy conflict of interest inherent at NIH,” he said.

## Missouri Bill Protects Doctors If They Prescribe Medicines That Treat COVID-19

Missouri lawmakers passed legislation that prevents state licensing boards from disciplining doctors who prescribe ivermectin and hydroxychloroquine.

HB 2149 also bars pharmacists from questioning doctors or disputing patients regarding the usage of such drugs and their efficacy. The bill passed the House by a vote of 130–4 and now heads to Gov. Mike Parson to be potentially signed into law. The bill reads:

## Trust the “Doctors”? History of Medical Racism & Savagery

The alleged “father of gynecology” **James Marion Sims** practiced his surgical technique on enslaved Black women without anesthesia. Between 1845 and 1849, three Black women—**Anarcha**, **Lucy**, and **Betsey**—each underwent up to thirty operations that were so horrifically painful that Sims's assistants “could not stomach their bone-chilling shrieks.” The women themselves were forced to take turns restraining each other as Sims cut into their bodies.

## Killing the Elderly: Nursing Home Chain Has Highest COVID Death Rate

An investigation by *USA Today* found that **Trilogy Health Services**, one of the nation’s largest nursing home chains, was the most dangerous place for a senior citizen to be during the “COVID-19” plandemic.

When the death toll was made known by *USA Today*, Trilogy, which operates homes in four states—Indiana, Kentucky, Michigan and Ohio—simply altered their data and cut their death count by nearly half. Trilogy originally reported 772 deaths at 113 facilities from October 2020 through February 2021, far higher than any other nursing home chain. *USA Today* reported in March that



*“Deaths across a scattering of Midwestern nursing homes began surging around Thanksgiving. By Valentine’s Day last winter, the death toll had climbed into the hundreds. [Our] investigation has traced the casualties back to one nursing home chain, Trilogy Health Services, owned by a real estate venture with a new business plan for the cutthroat world of eldercare.... This nursing home chain stood out for nationally high death rates as pandemic peaked.”*

The investigation also revealed that eldercare facilities were allowed to charge a higher rate for people with “COVID-19” who were treated at the nursing home instead of being transferred to a hospital. Government agencies charged with oversight of nursing homes appeared to be AWOL as the death count mounted.

As many as one third of all deaths attributed to “COVID-19” have occurred in nursing homes, a fact that has led some to speculate that the elderly were actually targeted for depopulation by a corrupt healthcare system that could no longer afford the high cost of their care.

According to reports, from 700 to 800 covid-related wrongful death lawsuits have been filed across the health care industry.

## Most Americans Don’t Want Those Shots

An analysis by **Dr. Meryl Nass** explains Americans’ refusal to continue to line up for the depopulation shots that are now shown to have NO health value at all.

**“257.6 million (of a total 334 million Americans) got at least one dose of vaccine.... It seems like the vast majority of Americans went along with the vaccine program. But Not for Long. A surprising 15% of the initially vaccinated (and 11% of all Americans) never went back for their second shot. That is huge. There is no other vaccine where such a high percentage fails to complete a two dose series. So if you add together the 18% who refused any shot and the 11% (of all Americans) who refused to complete the initial series, you are up to 29% vaccine refusers and ex-vaxxers who did not get ‘fully vaccinated,’ using CDC’s terminology.**

## Bill Gates Admits Damage to Black Children

The world’s foremost Depopulator admits his school closing “policies” caused extraordinary damage to Black children.

## The Point of Masks: To Cause Alarm

Science journalist **Laurie Garrett** has been a leading voice promoting draconian COVID mandates for the last two years—especially masks. In a video that has resurfaced from the **National Academy of Medicine in 2018**, Garrett gives us the real rationale for mask mandates:

**“There’s only a couple of countries that have ever really done large-scale studies to try and figure out what might work. Japan, it may not surprise you, is one of them. In one of their large studies they basically showed that ... it seemed like the major efficacy of a mask is that it causes alarm in the other person and so you stay away from each other. And that’s what I think happened with SARS. When I was in the SARS epidemic I saw everywhere all over Asia people started wearing these masks, and it is alarming, when you walk down the street and everyone coming toward you has a mask on, you definitely do social distancing, you definitely—it’s just a gut thing. But did the mask really help them? Did the mask keep the virus out? Almost certainly not. If the virus was around their face, the mask would not have made a difference.”**

## History of Black Sterilization: History is Best Qualified

Decades before Adolf Hitler came to power in Germany, American whites embraced eugenics, the pseudo-scientific belief in the need to genetically engineer human beings to form a superior society, and to weed out “undesirables” or “depopulate” humanity by targeting the “unfit” for elimination. In 1907—when Hitler was just 18 years old—Indiana passed the world’s first law authorizing the state to force involuntary sterilizations.

Ultimately, thirty-three states enacted eugenics-based laws in the 20th century, under which 60,000 Americans were forcibly sterilized, thousands were barred from marriage, and thousands were forced into segregated “colonies.” The victims of these government-sanctioned sterilization policies were disproportionately poor, mentally disabled, American Indian, Black, or other non-white people.
