Evidence is finally surfacing in so-called mainstream media that confirms the position the Nation of Islam has held throughout the “pandemic”; the corporate-controlled United States Government has overplayed the COVID-19 epidemic. Now their efforts are backfiring.

Contradictions and lies of federal health officials are being exposed, along with inflated case rates that are used to drive the vaccine campaign.

On Jan. 7, the State of New York reported that nearly half the patients currently in New York hospitals were admitted for reasons other than COVID-19. Forty-three percent of the 11,548 patients were brought in for a multitude of reasons such as overdose; car accident; heart attack. Governor Kathy Hochul told a press conference she wanted to “drill down” on the numbers to see how many patients were actually being treated for coronavirus versus merely having it, a disease which often causes no or mild symptoms.

“In August of this year (2021), the infamous U.S. Food and Drug Administration (FDA) openly states that the PCR test, previously touted as the gold standard for identifying the presence of Covid-19, was not developed with actual samples of the virus. Instead, *genetic material from a common cold virus was used. Neither Covid-19 nor any of its ‘variant’ forms has been isolated,*” (Minister Ava Muhammad, “*The Covid-19 PCR Test: Companion Weapon to the Vaccine in the Era of Biological Warfare Against the Original People.*” *The Final Call*)

The waning “public health emergency” is unraveling the enemy’s plans to cull the population by 2 billion to 3 billion people with the deadly vaccines. Yet, Dr. Anthony Fauci continues to lead an aggressive vaccine campaign.

As of December 31, 2021, the vaccines had directly caused 21,382 deaths and 1,016,999 injuries. (See VAERS data weekly in *The Final Call*.)

Alternative or naturopathic doctors and scientists argue that vaccines are not healthcare. Even the manufacturers admit they do not prevent or treat disease. Vaccines are a hoax, contends California-based naturopath practitioner and alternative healing author Dr. Robert O. Young.

“The biggest fraud against humanity is the fact that viruses have never been isolated,” he testified before the International Tribunal for Natural Justice Judicial Commission of Inquiry into Weaponisation of the Biosphere, held in Bali, Indonesia, in June 2019. “Why is there a new virus every year with a new name with similar types of symptomologies?”

He cited the damaging amounts of vaccines children received in their first years of life. The poison includes

17,500 micrograms of antifreeze, first six years; 5,700 micrograms of aluminum, a known neurotoxin; unknown quantities of bovine serum; 801.6 micrograms of formaldehyde, a carcinogen and embalming agent; 23,250 micrograms of gelatin, animal carcass or soil; 500 micrograms of human albumin.

Attorney Robert F. Kennedy, Jr., notes in “The Real Anthony Fauci,” Chapter 10, “More Harm Than Good,” that after suing the Department of Health and Human Services (HHS) in 2017 *for safety studies of 69 doses of 16 vaccines mandated for American children, HHS admitted that none of the vaccines had been tested for safety*, although most medical products cannot get licensed without first undergoing randomized placebo-controlled trials that compare health outcomes.

“*It’s for the purpose of sterilization and population control,*” said Dr. Young. It is Bill Gates, eugenicist and Microsoft founder, who has said at least 3 billion people on the planet need to die, vaccines are the way to do it, and the target is Africa.

Sacha Stone, founder of the International Tribunal for Natural Justice, stated that multi-lateral agencies and the so-called health and regulatory authorities appear in the main to have become weaponized and working in collusion against humanity. Dr. Young agreed, saying *it’s not a bacterial war, but a war of systemic poisoning. “They’re using chemical warfare against all of us ... I haven’t met these Luciferian people, wherever they may be. They hide because they fear the light of which I represent.”*

According to one panelist, a friend admitted after attending a recent Davos Forum (World Economic Forum) with the architects and controllers of money and the politics of the world, that there is a *“definite, systematic plan, because they have worked ... to get rid of at least a third of the people on the earth.”* When asked if he was included as marked for death, he was told, “No, because you’re of European stock,” said the panelist, who presided as chief justice for the tribunal.

Dr. Young advised that in addition to Bill Gates’ words about depopulation and sterilization, listen to former Secretary of State Henry Kissinger. *“He talks about his this is a win-win situation and mandating vaccines is part of the plan for depopulation.”*

“They just give you vaccinations. Now you can’t even take your children to school without their telling you you have to be vaccinated. Do you know what they’re putting in that damn vaccine? They tell you it’s this, but it may be that.” *Minister Louis Farrakhan, Part 2, Saviours’ Day 2004: “Reparations: What Does America and Europe Owe?”*

The Minister has taught on several occasions, *“In*

1961 the Honorable Elijah Muhammad told us don’t take the polio vaccine and we obeyed him. And later we found out that the vaccine was contaminated with something called SV40, which was a cancer that they were injecting the children with.”

Dr. Ridgely Muhammad in a recent edition of *The Final Call* republished a Twitter reply from Minister Farrakhan to Dr. Safiyya Shabazz regarding the role of doctors in the Hereafter: “... the Honorable Elijah said: *‘In The Hereafter, we will not need hospitals, insane asylum’ Or anything of the kind! Because all our disease starts with rebellion against God, eating the wrong foods, and thinking the wrong thoughts.*” #AskFarrakhan”

Dr. Young’s testimony also bore witness to the Teachings of the Honorable Elijah Muhammad, in particular, his Guidance and Instructions in *“How To Eat To Live: From God In Person.”*

“*Ninety-five percent of all sickness and diseases are caused by what you eat, what you drink, what you breathe, and what you think. And I added additional thought in there, what you believe,*” said Dr. Young. *“So you have to manage your thoughts. You have to manage your beliefs, because they do change the biochemistry of the body.”*

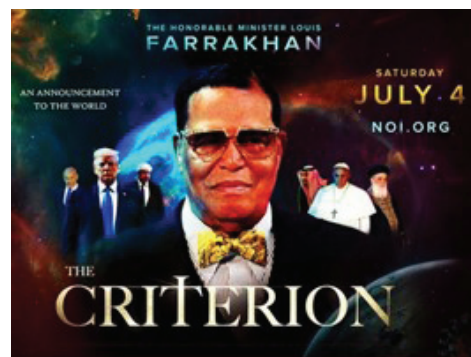
It is his position that germs do not cause disease, but are symptoms of a cause-and-effect relationship.

The Government's Response to COVID-19 is Forcing a Separation

COVID-19 was dangerous but the government's response has been deadly and destructive. America's health system allowed many of her citizens to die. Mass media scared us to death. The lockdowns locked us out of your jobs, locked us out of your social world, locked us out of your restaurants, locked us out of your sport and play. Very briefly let's get down to the actual facts backing up the above accusations:

1. American citizens who went to hospitals complaining of flu like symptoms in early 2020 were not treated but sent home to get sicker and turn blue from a lack of oxygen. Then when they came back to the hospital on the verge of death, they were misdiagnosed as having pneumonia, put on expensive and dangerous drugs like remdesivir and then stuck on ventilators to die. They were denied safe, effective, affordable and easily obtainable alternative therapies for this virus like Hydroxychloroquine (HCQ) and Ivermectin. Meanwhile, the mass media was

hiding the great victory over COVID in the Uttar Pradesh in India which destroyed COVID in weeks after supplying Ivermectin to the majority of their 240 million citizens of that province. While America's government was hiding HCQ from its citizens, hundreds of millions of Africans were taking HCQ to protect them from malaria. Research has shown that 6 countries (Mozambique, the Democratic Republic of the Congo, Nigeria, Uganda, Côte d'Ivoire, and Niger) that used HCQ on a weekly

basis to protect their citizens against malaria, as of December 2021, had an average death rate due to COVID of 4.3 per 100,000 compared to America's 242.7 per 100,000 population, a ratio of 1 to 56.4. But would the government allow Ivermectin and HCQ to be prescribed by doctors? No, when doctors, such as America's Frontline Doctors, the Front Line COVID-19 Critical Care Alliance (FLCCC) and others, would dare challenge the hospital administrators and CDC and prescribe other medicines, they were threatened with losing hospital privileges and having their state licenses to practice medicine revoked. If they dared to speak up on YouTube and social media, their posts and videos were taken down.

2. Every newscast, all day long was report-

ing on COVID infections even though 99.99 percent of people under 65 recovered from such infections. And the vast majority of even those over 65 recovered, if they were allowed to get a proper diagnosis and treatment.

3. According to a June 3, 2020, Wall Street Journal article "How Many U.S. Workers Have Lost Jobs During Coronavirus Pandemic?..." the Labor Department estimated that between March and May of 2020 at the heart of the lockdowns, 29 million jobs were lost due to the government's response to the "pandemic."

4. We could not visit our loved ones in the hospital, if they had COVID. We had to social distance 6 feet apart. We had to cover our faces like criminals hiding from the law.

5. During the lockdowns from April to June of 2020, we were not allowed to sit down in restaurants and had to drive to the back window like they did Black people in the South during segregation.

6. We couldn't go to sporting events, night clubs or musical concerts.

7. Now you say we must take your experimental COVID-19 vaccines, which were made up in months at "warp speed" using our tax money, but not tested for long-term safety. Then you, Mister Government, gave the vaccine manufacturers "indemnity," which meant that we could not sue them for damages due to their experimental products. You promised us that these shots would prevent us from getting and spreading COVID-19, but one year later you are telling those who took these shots that they need to take booster shots, because they are not protected from new variants of SARS-CoV-2. And now you even say that we might have to take boosters every year into the foreseeable future.

Okay, okay you lied to the American people, but what is the FDA trying to hide now? When the FDA approved a new Pfizer booster shot called Comirnaty on August 23, 2021, Pfizer had to produce safety data 30 days after FDA approved the new shots. However, after that time period elapsed, a group of over 80 medical researchers, public health officers, scientists and journalists filed a Freedom of Information request: "Despite the FDA's claim that it is committed to transparency, especially for COVID-19 emergency use authorizations (EUAs), the agency first requested 55 years to release the data supporting the approval of Comirnaty after a Freedom of Information Act (FOIA) request was filed, and then asked for an extra 20 years to fully comply."

75 years? Man, we will all be dead by that time or is this the crime that the government is trying to hide in this day of planned genocide? What is in these shots that the government is trying to force on our children? Why are they so hellbent on everybody taking these experimental gene therapies that they misrepresent as "vaccines?" The CDC even admits on their website

that one year after the release of these experimental jabs, there are at least 21,000 deaths due to these shots. Any other drug would have been pulled out of circulation when the deaths reached over 150 or at most 200, according to Dr. Peter McCollough.

Even though Big Pharma and the government is telling us, like Eddie Murphy said, "Trust me," White Americans are fed up and are separating from their own system. According to a "60 Minutes" report, "Why are Americans choosing to quit their jobs in record numbers?" it was stated that over 20 million Americans have quit their jobs in the second half of 2021. It is a parallel society, so, the first thing is, everything you need, you can get from your group ... People have also found new jobs ... It is a very much cloistered society where we do business with one another. We home-school our kids together, we pool our resources to fund these lawsuits, our social life is together. We did this program called Small Business Rescue where we would support businesses in our community. The government doesn't have any plan for these people, so we buy local, we support them. So, it is a parallel society."

'Enriching the Wealthy'

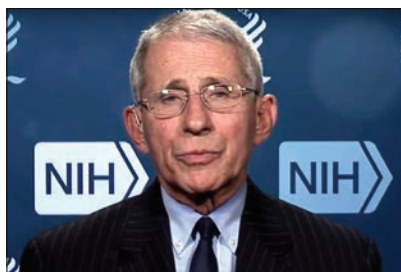

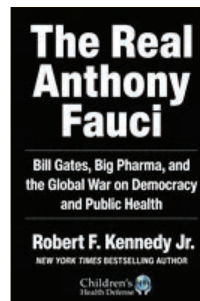
Dr. Fauci's business closures pulverized America's middle class and engineered the largest upward transfer of wealth in human history. In 2020, workers lost \$3.7 trillion while billionaires gained \$3.9 trillion. Some 493 individuals became new billionaires, and an additional 8 million Americans dropped below the poverty line. The biggest winners were the robber barons—the very companies that were cheerleading Dr. Fauci's lockdown and censoring his critics: Big Technology, Big Data, Big Telecom, Big Finance, Big Media behemoths (Michael Bloomberg, Rupert Murdoch, Viacom, and Disney), and Silicon Valley Internet titans like Jeff Bezos, Bill Gates, Mark Zuckerberg, Eric Schmidt, Sergey Brin, Larry Page, Larry Ellison, and Jack Dorsey.

The very Internet companies that snookered us all with the promise of democratizing communications made it impermissible for Americans to criticize their government or question the safety of pharmaceutical products; these companies propped up all official pronouncements while scrubbing all dissent. The same Tech/Data and Telecom robber barons, gorging themselves on the corpses of our obliterated middle class, rapidly transformed America's once-proud democracy into a censorship and surveillance police state from which they profit at every turn.

CEO Satya Nadella boasted that Microsoft, by working with the CDC and the Gates-funded Johns Hopkins Center for Biosecurity, had used the COVID pandemic to achieve “two years of digital transformation in two months.” Microsoft Teams users ballooned to 200 million meeting participants in a single day, averaged more than 75 million active users, compared to 20 million users in November 2019, and the company's stock value skyrocketed. Larry Ellison's company, Oracle, which partnered with the CIA to build new cloud services, won the contract to process all CDC vaccination data. Ellison's wealth increased by \$34 billion in 2020; Mark Zuckerberg's wealth grew by \$35 billion; Google's Sergey Brin by \$41 billion; Jeff Bezos by \$86 billion; Bill Gates by \$22 billion and Michael Bloomberg by nearly \$7 billion. Ellison, Gates, and the other members of this government/industry collaboration used the lockdown to accelerate construction of their 5G network of satellites, antennae, biometric facial recognition, and “track and trace” infrastructure that they, and their government and intelligence agency partners, can use to mine and monetize our data, further suppress dissent, to compel obedience to arbitrary dictates, and to manage the rage that comes as Americans finally wake up to the fact that this outlaw gang has stolen our democracy, our civil rights, our country, and our way of life—while we

huddled in orchestrated fear from a flu-like virus.

With fears of COVID generously stoked, the dramatic and steady erosion of constitutional rights and fomenting of a global coup d'état against democracy, the demolition of our economy, the obliteration of a million small businesses, the collapsing of the middle class, the evisceration of our Bill of Rights, the tidal wave of surveillance capitalism and the rising bio-security state, and the stunning shifts in wealth and power going to a burgeoning oligarchy of high-tech Silicon Valley robber barons seemed, to a dazed and uncritical America, like it might be a reasonable price to pay for safety. And anyway, we were told, it's just for 15 days, or maybe 15 months, or however long it takes for Dr. Fauci to “follow the data” to his answer.

Failing Upward

Dr. Fauci's catastrophic failure to achieve beneficial health outcomes during the COVID-19 crisis is consistent with the disastrous declines in public health during his half-century running NIAID. For anyone who might have assumed that federal and public health bureaucrats survive and flourish by achieving improvements in public health, Dr. Fauci's durability at NIAID is a disheartening wake-up call. By any measure, he has consistently failed upward.

The “J. Edgar Hoover of public health” has presided over cataclysmic declines in public health, including an exploding chronic disease epidemic that has made the “Fauci generation”—children born after his elevation to NIAID kingpin in 1984—the sickest generation in American history, and has made Americans among the least healthy citizens on the planet. His obsequious subservience to the Big Ag, Big Food, and pharmaceutical companies has left our children drowning in a toxic soup of pesticide residues, corn syrup, and processed foods, while also serving as pincushions for 69 mandated vaccine doses by age 18—none of them properly safety tested.

When Dr. Fauci took office, America was still ranked among the world's healthiest populations. An August 2021 study by the Commonwealth Fund ranked America's health care system dead last among industrialized nations, with the highest infant mortality and the lowest life expectancy. “If health care were an Olympic sport, the US might not qualify in a competition with other high-income nations,” laments the study's lead author, Eric Schneider, who serves as Senior Vice President for Policy and Research at the Commonwealth Fund.

Following WWII, life expectancy in the US climbed for five decades, making Americans among the longest-lived people in the developed world. IQ also grew steadily by three points each decade since 1900. But as Tony Fauci spent the 1990s expanding the pharmaceutical and chemical

paradigm—instead of public health—the pace of both longevity and intelligence slowed. The life expectancy decrease widened the gap between the US and its peers to nearly five years, and American children have lost seven IQ points since 2000.

Under Dr. Fauci's leadership, the allergic, autoimmune, and chronic illnesses which Congress specifically charged NIAID to investigate and prevent, have mushroomed to afflict 54 percent of children, up from 12.8 percent when he took over NIAID in 1984. Dr. Fauci has offered no explanation as to why allergic diseases like asthma, eczema, food allergies, allergic rhinitis, and anaphylaxis suddenly exploded beginning in 1989, five years after he came to power. On its website, NIAID boasts that autoimmune disease is one of the agency's top priorities. Some 80 autoimmune diseases, including juvenile diabetes and rheumatoid arthritis, Graves' disease, and Crohn's disease, which were practically unknown prior to 1984, suddenly became epidemic under his watch. Autism, which many scientists now consider an autoimmune disease, exploded from between 2/10,000 and 4/10,000 Americans when Tony Fauci joined NIAID, to one in thirty-four today. Neurological diseases like ADD/ADHD, speech and sleep disorders, narcolepsy, facial tics, and Tourette's syndrome have become commonplace in American children. The human, health, and economic costs of chronic disease dwarf the costs of all infectious diseases in the United States. By this decade's end, obesity, diabetes, and pre-diabetes are on track to debilitate 85 percent of America's citizens. America is among the ten most overweight countries on Earth. The health impacts of these epidemics—which fall mainly on the young—eclipse even the most exaggerated health impacts of COVID-19.

What is causing this cataclysm? Since genes don't cause epidemics, it must be environmental toxins. Many of these illnesses became epidemic in the late 1980s, after vaccine manufacturers were granted government protection from liability, and consequently accelerated their introduction of new vaccines. The manufacturer's inserts of the 69 vaccine doses list each of the now-common illnesses—some 170 in total—as vaccine side effects. So vaccines are a potential culprit, but not the only one. Other possible perpetrators—or accomplices—that fit the applicable criterion—a sudden epidemic across all demographics beginning in 1989—are corn syrup, PFOA flame retardants, processed foods, cell phones and EMF radiation, chlorpyrifos, ultrasound, and neonicotinoid pesticides.

The list is finite, and it would be a simple thing to design studies that give us these answers. Tracing the etiology of these diseases through epidemiological research, observational and bench studies, and animal research is exactly what Congress charged Dr. Fauci to perform. But Tony Fauci controls the public health bankbook and has shown little interest in funding basic science to answer those questions.

Is this because any serious investigation into the sources of the chronic disease epidemic would certainly implicate the powerful pharmaceutical companies and the chemical, agricultural, and processed food multinationals that Dr. Fauci and his twenty-year business partner, Bill Gates, have devoted their careers to promoting? As we shall see, his capacity to curry favor with these merchants of pills, powders, potions, poisons, pesticides, pollutants, and pricks has been the key to Dr. Fauci's longevity at HHS . . .

But that level of collusion on an international scale costs big bucks. Satan’s helpers must be compensated. Pfizer, Johnson & Johnson, and Moderna and other pharmaceutical giants are paying as much as 80% of the bills at these media outlets through their advertising budgets.

And now it has been revealed that Bill Gates has given \$319 million to key media organizations all over the globe. Alan MacLeod of *MintPress* analyzed the grants given by the **Gates Foundation** and found that it has bankrolled hundreds of media outlets and ventures.

Recipients of this cash include many of America’s most important news outlets, including *CNN* (\$3.6mil), *NBC* (\$4.3mil), *NPR* (\$24.6mil), *PBS* (\$.5mil), *Public Radio International* (\$7.7mil), and *The Atlantic* (\$1.4mil). Among the Gates-funded foreign organizations are *Al-Jazeera* (\$1mil), the *BBC* (\$3.6mil), *The Guardian* (\$13mil), *Financial Times* (\$2.3mil), *Daily Telegraph* (\$3.4mil), *Nation Media Group* (Kenya—\$4mil), and European newspapers such as *Le Monde* (France—\$4.4mil), *Der Spiegel* (Germany—\$5.4mil) and *El País* (Spain—\$4mil).

According to *MintPress*, “The Gates Foundation has also given nearly \$63 million to charities closely aligned with big media outlets....Gates continues to underwrite a wide network of investigative journalism centers as well, totaling just over \$38 million, more than half of which has gone to the D.C.-based International Center for Journalists *to expand and develop African media*.” Gates gave \$382,997 to the **Poynter Institute for Media Studies**, the group that own “PolitiFact,” the “fact-checkers” in charge of attacking any non-vaccine treatment.
