



I wrote this book to help Americans—and citizens across the globe—understand the historical underpinnings of the bewildering cataclysm that began in 2020. In that single *annus horribilis*, liberal democracy effectively collapsed worldwide. The very governmental health regulators, social media eminences, and media companies that idealistic populations relied upon as champions of freedom, health, democracy, civil rights, and evidence-based public policy seemed to collectively pivot in a lockstep assault against free speech and personal freedoms.

Suddenly, those trusted institutions seemed to be acting in concert to generate fear, promote obedience, discourage critical thinking, and herd seven billion people to march to a single tune, culminating in mass public health experiments with a novel, shoddily tested and improperly licensed technology so risky that manufacturers refused to produce it unless every

government on Earth shielded them from liability.

Across Western nations, shell-shocked citizens experienced all the well-worn tactics of rising totalitarianism—mass propaganda and censorship, the orchestrated promotion of terror, the manipulation of science, the suppression of debate, the vilification of dissent, and use of force to prevent protest. Conscientious objectors who resisted these unwanted, experimental, zero-liability medical interventions faced orchestrated gaslighting, marginalization, and scapegoating.

American lives and livelihoods were shattered by a bewildering array of draconian *diktats* imposed without legislative approval or judicial review, risk assessment, or scientific citation. So-called Emergency Orders closed our businesses, schools and churches, made unprecedented intrusions into privacy, and disrupted our most treasured social and family relationships. Citizens the world over were ordered to stay in their homes.

Standing in the center of all the mayhem, with his confident hand on the helm, was one dominating figure. As the trusted public face of the United States government response to COVID, Dr. Anthony Fauci set this perilous course and sold the American public on a new destination for our democracy.

This book is a product of my own struggle to understand how the idealistic institutions our country built to safeguard both public health and democracy suddenly turned against our citizens and our values with such violence. I am a lifelong Democrat, whose family has had eighty years of deep engagement with America's public health bureaucracy and long friendships with key federal regulators, including Anthony Fauci, Francis Collins, and Robert Gallo. Members of my family wrote many of the statutes under which these men govern, nurtured the growth of equitable and effective public health policies, and defended that regulatory bulwark against ferocious attacks funded by industry—and often executed by Republican-controlled congressional committees intent on defunding and defanging these agencies to make them more "industry friendly."

I built alliances with these individuals and their agencies during my years of environmental and public health advocacy. I watched them, often with admiration. But I also watched how the industry, supposedly being regulated, used its indentured servants on Capitol Hill to systematically hollow out those agencies beginning in 1980, disabling their regulatory functions and transforming them, finally, into sock-puppets for the very industry Congress charged them with regulating.

My 40-year career as an environmental and public health advocate gave me a unique understanding of the corrupting mechanisms of "regulatory capture," the process by which the regulator becomes beholden to the industry it's meant to regu-

late. I spent four decades suing the US Environmental Protection Agency (EPA), and other environmental agencies to expose and remedy the corrupt sweetheart relationship that so often put regulators in bed with the polluting industries they regulated. Among the hundreds of lawsuits I filed, perhaps a quarter were against regulatory officials making illegal concessions to Big Oil, King Coal, and the chemical and agricultural polluters that had captured their loyalties. I thought I knew everything about regulatory capture and that I had armored myself with an appropriate shield of cynicism.

But I was wrong about that. From the moment of my reluctant entrance into the vaccine debate in 2005, I was astonished to realize that the pervasive web of deep financial entanglements between Pharma and the government health agencies had put regulatory capture on steroids. The CDC, for example, owns 57 vaccine patents and spends \$4.9 of its \$12.0 billion-dollar annual budget (as of 2019) buying and distributing vaccines. NIH owns hundreds of vaccine patents and often profits from the sale of products it supposedly regulates. High level officials, including Dr. Fauci, receive yearly emoluments of up to \$150,000 in royalty payments on products that they help develop and then usher through the approval process. The FDA receives 45 percent of its budget from the pharmaceutical industry, through what are euphemistically called "user fees." When I learned that extraordinary fact, the disastrous health of the American people was no longer a mystery; I wondered what the environment would look like if the EPA received 45 percent of its budget from the coal industry!

Today many of my liberal chums are still crouched in a knee jerk posture defending "our" agencies against Republican slanders and budget cuts, never quite realizing how thoroughly the decades of attacks succeeded in transforming those agencies into subsidiaries of Big Pharma.

In this book, I track the rise of Anthony Fauci from his start as a young public health researcher and physician through his metamorphosis into the powerful technocrat who helped orchestrate and execute 2020's historic

coup d'état against Western democracy. I explore the carefully planned militarization and monetization of medicine that has left American health ailing and its democracy shattered. I chronicle the troubling role of the dangerous concentrated mainstream media, Big Tech robber barons, the military and intelligence communities and their deep historical alliances with Big Pharma and public health agencies. The disturbing story that unfolds here has never been told, and many in power have worked hard to prevent the public from learning it. The main character is Anthony Fauci....

The Genocidal Plot Against the Rise of Black People Being Exposed

On December 21, 2021 a federal jury found Dr. Charles Lieber guilty of two counts of making false statements to the U.S. government about whether he participated in **Thousand Talents Plan**, a program designed by the Chinese government to attract foreign-educated scientists. They also found him guilty of failing to declare income earned in China and failing to report a Chinese bank account.

Dr. Lieber was Chair of the Department of Chemistry and Chemical Biology at Harvard. He was considered one of the world's leading experts on nanotechnology and a potential Nobel Prize winner. **He invented electronic chips so small and flexible that they could be injected into parts of the human body, like the brain or the retina.**

Dr. Lieber worked with Chinese scientists at the Wuhan Institute where work was done to produce the SARS-CoV-2 gain of function research that Fauci keeps denying. However, even Dr. Lieber, while receiving hundreds of thousands of dollars from the Chinese and millions of dollars in grants from the NIH, did not trust some of his Chinese col-

leagues. Dr. Lieber wrote in an email to a Chinese colleague at another institution: "These people want to use me, so we will not let that happen, versus me using them. But we'll be ever so polite in the mean time."

Previous presidents of the United States, including Donald Trump, have complained about Chinese theft of intellectual property from U.S. companies manufacturing high tech products in China. So, why would America, through the NIH, fund research on top level secret gain of function (biological weaponization of viruses) in China? It is not that the CIA or other government intelligence organizations did not know China and other countries were developing biological weapons, and it is not that they didn't predict the possibility of these biological weapons getting loose into the general population. In fact, Robert F. Kennedy Jr.'s new book, **"The Real Anthony Fauci: Bill Gates, Big Pharma, and the Global War on Democracy and Public Health,"** described a simulation exercise in 2017 in which:

2017' chronicled an imaginary coronavirus pandemic that would, supposedly, run from 2025 to 2028. The exercise turned out to be an eerily precise predictor of the COVID-19 pandemic exactly three years later." (p. 413)

Right before the outbreak of COVID-19 in Wuhan province in October of 2019, Gates personally organized another simulated disaster study called "Event 201" in that same month. According to Kennedy: "This war game consisted of four 'tabletop' simulations of a worldwide coronavirus pandemic. Participants included a group of high-ranking kahunas from the World Bank, the World Economic Forum, Bloomberg/Johns Hopkins University Populations Center, the CDC, various media powerhouses, the Chinese government, a former CIA/NSA director, vaccine maker Johnson & Johnson, the globe's largest pharmaceutical company; finance, and leveraging the pandemic to promote mandatory mass vaccinations." (p.425) and biosecurity industry chieftains, and the president of Edelman, the world's leading corporate PR firm...They drilled a retinue of psychological warfare techniques for controlling official narratives, silencing dissent, forcibly masking large populations."

These revelations have forced one of America's foremost medical doctors, Dr. Peter McCullough to announce, on the 12/19/21 Joe Rogan Experience podcast, that you should read the three new books by authors Robert F. Kennedy Jr., Pam Popper and Dr. Peter R. Breggin which all

document : **"If you want to find the evidence that Moderna was working on the vaccine even before the virus ever emanated out of the lab. If you want to find collusions in the operations with the Gates Foundation and GAVI and CEPI and Pfizer and Moderna and the vaccine manufacturers and the Wuhan lab and National Institutes of Health and Ralph Baric and the University of North Carolina at Chapel Hill and how this was organized..." These authors present that "it was going to be a coronavirus. It's gonna be related to MERS and SARS. It's gonna come over here to the United States. It's gonna shut down cities and frighten people. There's gonna be confusion regarding a drug -hydroxychloroquine, Ivermectin—and we are going to utilize all that to railroad the population into mass vaccinations. It was all laid out in the SPARS [2017] pandemic training seminar."**

Dr. Peter R. Breggin in his 2021 book, **"COVID-19 and the Global Predators: We are the Prey,"** keeps asking the question why are Fauci, the NIH, the CIA and the Chinese military all working in cahoots to produce bioweapons? We must ask who is their common enemy? Are they working together to reduce the world population or are they concerned about a certain race or ethnic group?

A look back in history may help us answer that question, because this is not the first time America has worked with a foreign government to poison a Black population. Dr. Lee Merritt in an interview with Richard Sachs points out "If you, if you look at what happened in South Africa, what we were

involved with and there's some really, really interesting information about that, they came out through Desmond Tutu's **Truth and Reconciliation Commission**. What they were working on were tactile pathogens, and there was a guy named Larry Ford. We would, theoretically, weren't doing this, but he was an **OB-GYN** doctor in Los Angeles, and he was going back and forth and there was one of the few people still be alive, at the time of this Truth and Reconciliation said, 'we called it Project Larry.' And he would come over and spend a whole day showing us how to turn everyday items into bioweapons."

The official name for this genocidal plot was called **"Project Coast."** Project Coast was a 1980s top-secret chemical and biological weapons (CBW) program instituted by the apartheid-era government of South Africa, headed by Dr. Wouter Basson, known as "Dr. Death." According to a "60 Minutes" investigation on the suicide of Larry Ford in 2002 called "Dr. Death" and his accomplice: "In Dr. Ford's home and office, there was indication this gynecologist had some connections to both the army's biowarfare program and to the CIA. The CIA would not confirm this connection.

Reporter Silenced After He Asked Why ‘Travel Ban’ Only On Black African Nations

Reporter **Simon Ateba** of *Today News Africa* has been snubbed by the White House after he asked why Biden’s COVID travel ban only involved Black African countries:

“The U.S. is among the countries that have imposed sanctions on ... 8 African nations, when...the variant is in 57 countries. Why don’t you just lift it or impose sanctions on all the countries that have it? What would you say to those who believe that this is a racist ban that targets only African and Black African nations?”

Biden’s spokesperson **Jennifer Psaki** tried to silence the insistent African reporter but she could not ignore the substance of Ateba’s question. The African continent is largely unaffected by the coronavirus and to date 94% of Africans have refused to be “jabbed” with the deadly liquid, including 75% of African health workers, who cite “concerns over vaccine safety and adverse side effects.”

The “Omicron variant” has now been allegedly detected in 77 countries, so Biden’s Blacks-only travel ban appears to be punishment for the Africans’ mass refusal of the “vaccine.” Nigeria—where only 2% of their 206 million people are fully “vaccinated”—just destroyed one million expired donated COVID-19 doses. Faisal Shuaib, head of Nigeria’s health care agency, complained that developed countries “hoarded” the “vaccines,” and “At the point they were about to expire, they offered them for donation.”

The “Vaccine Hesitancy” of Joe Biden, Kamala Harris and Andrew Cuomo

In an Aug. 6, 2020, interview **Joe Biden** said:
“If and when the vaccine comes, it’s not likely to go through all the tests that need to be done, and the trials that are needed to be done.”

In a July 28, 2020, speech, **Biden** asked:

“How are you going to distribute the vaccine when it arrives...? And the question of whether it’s real, when it’s there, that requires enormous transparency. You’ve got to make all of it available to other experts across the nation, so they can look and see, so there’s consensus this is a safe vaccine. Because already you have, what percent is American people saying if the vaccine were there tomorrow, they wouldn’t take it? And it’s not the usual anti-vaccine crowd. It’s beyond that because people are losing faith in what the president says. Think about it.”



And on Oct 7, 2020, **Kamala Harris** said *“...if Donald Trump tells us to take it, I’m not taking it.”*

New York Gov. **Andrew Cuomo** said during a Sept 24, 2020, press conference:

“The first question is, is the vaccine safe? Frankly, I’m not going to trust the federal government’s opinion, and I wouldn’t recommend [a COVID-19 vaccine] to New Yorkers based on the federal government’s opinion.”

He was asked on Oct. 19, 2020, “How confident are you in the approval process at the FDA right now?”

“I’m not that confident, but my opinion doesn’t matter. I don’t believe the American people are that confident. You’re going to say to the American people now, ‘Here’s a vaccine, it was new, it was done quickly, but trust this federal administration, and their health

administration that it’s safe, and we’re not 100 percent sure of the consequences.’ I think it’s going to be a very skeptical American public about taking the vaccine, and they should be... You’re going to need someone other than this FDA and this CDC saying it’s safe.”

All of these comments came AFTER **The Honorable Minister Louis Farrakhan** warned the world on **July 4th, 2020**, that the “vaccine” and its pushers are not trustworthy.

NY Legislation Provides for Indefinite Detention of Unvaccinated at Governor’s Whim

In January 2022, New York lawmakers could vote on a bill that would grant permission to detain anyone suspected of presenting a “significant threat to public health” and remove them from public life on an indefinite basis.

Bill A416 gives the governor of New York and his or her surrogates the right to remove and detain any individual or groups of people through issuing a single order. The orders only have to include the individual’s name or “reasonably specific descriptions of the individuals or groups.”

Though the bill attempts to state that no one shall be held for more than 60 days, the language allows for court orders to waive this maximum detention time. After 60 days, the court is allowed an additional 90 days to consider the detention of an individual, a cycle that can last indefinitely per the opinion of state officials.

The bill will “require an individual who has been exposed to or infected by a contagious disease to complete an appropriate, prescribed course of treatment, preventive medication or **vaccination**,” essentially giving the government the right to detain anyone it wants and forcibly vaccinate that person.

As the language of the bill refers to individuals or groups who “potentially” pose a threat, the bill is a preemptive strike against anyone the governor believes has the capacity to “pose a threat in the future, such as those refusing to receive the COVID-19 vaccination.”

NY Times Report: 1 of Every 100 Older Americans Has Perished

Under the “guidance” of United States “health” authorities at the CDC and FDA, and their refusal to allow the sick to receive successful treatments, one out of every 100 elderly Americans have died during the “pandemic.”

The *New York Times* reports that seventy-five percent of people who have died of Mr. Fauci’s “virus” have been 65 or older. For people younger than 65, that ratio is closer to 1 in 1,400.

Remarkably, it is reported that “Since vaccines first became available a year ago, older Americans have been vaccinated at a much higher rate than younger age groups (87% of people 65 and older have been fully vaccinated) and yet the brutal toll on them has persisted. [And] in the past two months, the portion of older people has risen once again, according to data from the Centers for Disease Control and Prevention.”

Not only do they die of medical mistreatment but older Americans suffer the stress of loneliness and isolation from family and community and the fear generated by the vaccine-crazed depopulators. Concocted threats of “deadly variants,” “surges,” lock downs, and forced mandates wreak havoc on their physical and mental condition and actually weakens their immune systems.

Simone Mitchell-Peterson, CEO of the Chicago chapter of **Little Brothers — Friends of the Elderly**, said that she could detect a difference in the physical appearance of elderly people. *“You can see the frailty of our elders. Many of them have lost weight. Many of them just look older. Their stoop is a little more pronounced.”*

The Consequences of the “Vaccines”

An analysis titled **“Worse Than the Disease: Reviewing Some Possible Unintended Consequences of mRNA Vaccines Against COVID-19,”** by **Drs. ...and a variety of permanent disabilities, many of which involve neurological dysfunction. In a May 2021 interview with **Dr. Joseph Mercola**, Dr. Seneff said:

“To have developed this incredibly new technology so quickly, and to skip so many steps in the process of evaluating [its safety], it’s an insanely reckless thing that they’ve done....So, I really dug into the research literature by the people who’ve developed these vaccines, and then more extensive research literature around those topics. And I don’t see how these vaccines can possibly be doing anything good...”



PayPal Attacks Vaccine Truth Organization

Last week PayPal abruptly informed the **National Vaccine Information Center (NVIC)** that it would no longer process donations made by its supporters, effective immediately. 
