


The Rome Declaration: Thousands of doctors gather in Puerto Rico, commit to deliver care and demand that Big Pharma, Big Tech and Government get out of doctor-patient relationship



A physicians' summit was recently held in Puerto Rico (September 12 - 14) where medical professionals were given an opportunity to compare studies and assess the efficacy of the various treatments that have been developed in hospitals, doctors' offices, and research labs throughout the world. And, 3,000 of those doctors signed onto what was called the "Rome Declaration" presented to them by Dr. Robert Malone, architect of the mRNA vaccine platform.

The Rome Declaration states, in part:

"Thousands have died from Covid as a result of being denied life-saving early treatment. The Declaration is a battle cry from physicians who are daily fighting for the right to treat their patients, and the right of patients to receive those treatments— without fear of interference, retribution or censorship by government, pharmacies, pharmaceutical corporations, and big tech. We demand that these groups step aside and honor the sanctity and integrity of the patient-physician relationship, the fundamental maxim "First Do No Harm", and the freedom of patients and physicians to make informed medical decisions. Lives depend on it.

We the physicians of the world, united and loyal to the Hippocratic Oath, recognizing the profession of medicine as we know it is at a crossroad, are compelled to declare the following:

WHEREAS, it is our utmost responsibility and duty to uphold and restore the dignity, integrity, art and science of medicine;

WHEREAS, there is an unprecedented assault on our ability to care for our patients;

WHEREAS, public policy makers have chosen to force a "one size fits all" treatment strategy, resulting in needless illness and death, rather than upholding fundamental concepts of the individualized, personalized approach to patient care which is proven to be safe and more effective;

WHEREAS, physicians and other health care providers working on the front lines, utilizing their knowledge of epidemiology, pathophysiology and pharmacology, are often first to identify new, potentially lifesaving treatments;

WHEREAS, physicians are increasingly being discouraged from engaging in open professional discourse and the exchange of ideas about new and emerging diseases, not only endangering the essence of the medical profession, but more importantly, more tragically, the lives of our patients;

WHEREAS, thousands of physicians are being prevented from providing treatment to their patients, as a result of barriers put up by pharmacies, hospitals, and public health agencies, rendering the vast majority of healthcare providers helpless to protect their patients in the face of disease. Physicians are now advising their patients to simply go home (allowing the virus to replicate) and return when their disease worsens, resulting in hundreds of thousands of unnecessary patient deaths, due to failure-to-treat;

WHEREAS, this is not medicine. This is not care. These policies may actually constitute crimes

against humanity."

From the onset of this so-called "pandemic" the public was led to believe that this "novel coronavirus" had the medical profession baffled. Fortunately, many doctors, including the Front Line COVID-19 Critical Care Alliance (FLCCC) developed treatment protocols that they used to save millions of lives, while their credibility and medical reputation were being smeared by the

American Medical Association and their hospital privileges threatened by hospital administrators. Movies and television "soap operas" like "General Hospital," created the impression that hospitals are run by doctors but that has changed drastically since the 1970s.


Dr. Kevin R. Campbell describes this drastic change in the healthcare landscape in his 2015 article, "The Rise of the Machine: How Hospital/ Practice Administrators Have Assumed Control Over Healthcare". He states: "In the past, physicians were responsible for both the business and practice of medicine. While administrative personnel played an important and complementary role in practice and hospital management, physicians were the cornerstone. In comparison, today the leadership structure in medicine is now an entirely foreign landscape. Administrators DOMINATE medical practices today and, according to the New York Times, their salaries are responsible for a high percentage of medical costs. While the numbers of physicians that are entering the workforce has trended toward a constant number (with little or no growth) the numbers of administrators have risen nearly 3,000 percent over the last 30 years. (See graph) However, now administrators have evolved into the overlords of medical practice and are now dictating how and when and where physicians and other healthcare providers work."

So, the stage was set for a so-called "pandemic" with the hands of doctors tied by hospital administrators who forbade them to practice medicine and watch their patients be neglected, mistreated and finally die.

Dr. Elizabeth Lee Vliet, former director of the Association of American Physicians and Surgeons and current President of Truth for Health Foundation, was interviewed in a September 22, 2021, edition of The Epoch Times:

EPOCH TIMES: Lately, I hear that people who stand up for medical freedom, whether its doctors or patients, get labeled as anti-science or political dissidents. Why?

DR. VLIET: "...Ignaz Semmelweis made the observation that if you used a disinfectant before you performed surgery it would reduce infection. He was



labeled a heretic. Elizabeth Blackwell, first American woman to go to medical school, espoused handwashing between deliveries of babies. It's something so basic but she was labeled a dissident. ...That's exactly what we've seen in 2020. All of us front line doctors who were practicing good medical principles of evaluating the patient, using the tools at hand and picking things based on a track record of safety that works for viruses, inflammation, blood clots, using medicines we have used every day of our career, were attacked. Suddenly...we were now labeled political dissidents and heretics because we used basic medicine to treat viral illness. This has been the most effective way to keep people out of the hospital. We have over 200 studies on hydroxychloroquine's effectiveness. We have over 60 studies on ivermectin's effectiveness and controlled studies on corticosteroids' and blood thinners' effectiveness. While we were saving lives, all of the government spokespeople who were espousing the party line and criticizing us were the ones disobeying basic medical principles of early treatment and forcing everyone who got sick to wait until they were critically ill. They were sending patients to a hospital to be put on a ventilator and that gave them a 30% risk of dying. They are guilty of causing an excessive number of deaths with policies that betray all the principles of medicine."

Doctors are finally standing up against corrupt hospital administrators, the CDC, the FDA

and this Big Pharma Beast, but we should have been warned. Minister Farrakhan has warned us "Separation or Death." We must feed, clothe, house and take care of ourselves. We need our own land and our own hospitals. Being close to white people has never been safe. Now it is more dangerous than ever because they have been thrown under the bus with us. ‘We’re Done With Fear’ Florida’s Black Surgeon General Pushes Back on Vaccine Mandates

“I say to those of us in America, we need to call a meeting of our skilled virologists, epidemiologists, students of biology and chemistry, and we need to look at not only what they give us. We need to give ourselves something better.”

America’s Vaccine-Only Covid-19 policy and its conversion into a full-fledged police state to enforce that policy has made it the worst place on Earth to suffer the effects of the virus. With the so-called “vaccines” now proven to be an utter failure and killing at least 16,000, the state of Florida has made a bold move with the appointment of Dr. Joseph Ladapo as the state’s new Surgeon General and Secretary of the Florida Department of Health. Born in Nigeria, he came to this country at the age of 5 with his family. His father, a microbiologist, came here to continue his studies. The 45-year-old Black man holds a Harvard Medical School degree in Internal Medicine and a PhD in Health Policy from Harvard Graduate School of Arts and Sciences. His primary research interests include reducing the burden of cardiovascular disease and ending tobacco use. He and his wife are the parents of three young children.

Dr. Ladapo came to public attention as part of a group of physicians called America’s Frontline Doctors, which stepped forward early last year and exposed the fact that successful Covid-19 treatments were being suppressed by the corporate-controlled American government, media and health care system. Dr. Ladapo opposes the mandatory vaccines, mask mandates, lockdowns that have been imposed by elected officials on the federal, state and local level. No laws have been enacted requiring these methods. The National Institutes of Health (NIH), Centers for Disease Control (CDC), the Food and Drug Administration (FDA) are all administrative agencies with no power to make law. All of these corporate-controlled government agencies are accused of implementing a depopulation program rather than a health care system and are named defendants in multiple lawsuits.

A medical doctor and scientist, Dr. Ladapo insisted that science, not fear, must drive public policy:

“We’re done with fear. That’s been something that’s been unfortunately a centerpiece of health policy in the United States ever since the beginning of the pandemic, and it’s over here (Florida). Expiration date. It’s done.”

Dr. Ladapo vigorously defends the individual human right to reject being vaccinated. “Vaccines are up to the person. There’s nothing special about them compared to any other preventive measure,” he noted during Governor Ron DeSantis’ September 21 press conference announcing his appointment: “It’s been treated almost like a religion, and it’s just senseless. There are lots of

good pathways to health and vaccinations are not the only one,” he stated. They include losing weight, exercising more, and eating more fruits and vegetables.”

He emphasized that Florida will completely reject fear as a way of making policy in public health.

Dr. Ladapo also opposes mask mandates and lockdowns. “Viruses inevitably spread, and authorities have oversold face coverings as a preventive measure,” he penned, in an opinion piece for the Wall Street Journal entitled “Masks Are a Distraction From the Pandemic Reality” (10/28/20).

“A hallmark of Covid-19 pandemic policy has been the failure of political leaders and health officials to anticipate the unintended consequences of their actions. This tendency has haunted many decisions, from lockdowns that triggered enormous unemployment and increased alcohol and drug abuse, to school closures that are widening educational disparities between rich and poor families. Mask mandates may also have unintended consequences that outweigh the benefits.”

“Most of the randomized trials of community or household masking have shown that wearing a mask has little or no effect on respiratory virus transmission,” he cited from a May 2020 review published in the CDC’s journal, Emerging Infectious Diseases, the Centers for Disease Control.

“In March (2020), when Anthony Fauci said, ‘wearing a mask might make people feel a little bit better but it’s not providing the perfect protection that people think it is,’ his statement reflected scientific consensus, and was consistent with the World Health Organization’s guidance. Almost overnight, the recommendations flipped. The reason? The risk of asymptomatic transmission,” wrote Dr. Ladapo. “Health officials said mask mandates were now not only reasonable but critical. This is a weak rationale, given that presymptomatic spread of respiratory viruses isn’t a novel phenomenon in public health. Asymptomatic or mild cases appear to contribute more to Covid-19 transmission, but this happens in flu cases, too, though no one has called for mask mandates during flu season.”

He concluded that “Shifting focus away from mask mandates and toward the reality of respiratory viral spread will free up time and resources to protect the most vulnerable Americans.”

Since the end of last month, daily deaths in the state of Florida have dropped 48% (from 376 to 195) and daily new cases have dropped 60% (from 9,112 to 3,596) according to The New York Times COVID-19 tracking system.

The growing resistance army against America’s Covid-19 aggressive, hostile vaccination campaign argues that the numbers of cases across the country are skewed to promote fear, but even then, the skewed numbers in Florida should be exploding, not decreasing at twice the rate compared to America as a whole. They contend that statistics indicate the decline, which began before Dr. Ladapo’s appointment, stems from Florida’s abandonment of masks, social distancing, and shutdowns long ago.

Nationwide, the CDC claims that the number of people now in the hospital with COVID-19 has fallen to somewhere around 75,000 from over 93,000 in early September. New cases are on the downswing at about

112,000 per day on average, a drop of about one-third over the past 2 1/2 weeks. Deaths attributed to the virus are also declining, averaging 1,900 a day versus more than 2,000 less than a week ago, the Associated Press reported on October 1.

Dr. Ladapo harshly criticized his colleagues in the healthcare system, saying that their failed approach to treating COVID-19 “was a direct result of scientists—my colleagues, some of them—taking the science and basically misrepresenting it to fit their agendas, their interests, what they wanted to see people do. . . . And this idea that people don’t get to make their own decisions on issues of health related to their own their own personal health is wrong, and it’s not something that we’re going to be about.”

“We all have opinions. We all have a perspective, and we’re absolutely entitled to those perspectives. What’s been happening over the past year is that people have been taking the science and they’ve been misrepresenting them,” continued Dr. Ladapo. “They have been using the science, and it’s been unclear when your discussion about the science ends and what you want people to do with the science begins. . . . You’ll know when we’re talking about data, and you’ll know when we’re talking about our opinions, our impression, our preferences about the data that will always be clear here. So, you can count on that.”


It is a far, refreshing cry from America’s scare tactics, bribery, coercion, and bullying by her minions to make people to take these injurious, often fatal injections.

The CDC’s own VAERS database has recorded the damage, injuries, and deaths as a result of the failed and dangerous “vaccines.” Out of 752,801 reports, which studies show represent a small fraction of actual events, there have been 15,937 deaths, over 71,000 hospitalizations, over 85,000 people have gone to urgent care, and over 20,000 have been permanently injured. There have been 117,838 doctor visits, 6,737 anaphylaxis (severe allergic reactions) and 9,035 cases of Bell’s Palsy (which causes facial paralysis); 2,262 miscarriages; 7,582 heart attacks, 6,812 cases of myocarditis/pericarditis (heart inflammation and inflammation of the outer lining of the heart).

All of this, yet the “vaccine” does not stop transmission, hospitalization, or deaths from the virus. Prior to Covid-19, when a person was infected after injection it was referred to as “vaccine failure”. Now its called a “breakthrough”. The CDC reports that it began collecting data on “breakthrough” Covid infections on May 1. But so many people reported infection from the virus after being vaccinated, the agency changed the focus of how it uses the data, according to an online update on September 7. It stopped reporting the total number of “breakthrough” cases and now reports only severe cases. The U.S. holds out its “vaccine” as the singular solution for Covid-19 but has the worst record for cases and deaths in the world.

Pfizer Scientists Say Natural Immunity Is Better than Their Vaccine, Pfizer is "Evil"

Three Pfizer scientists were secretly recorded saying that natural immunity to the "COVID-19 virus" is superior to the "vaccine," and they had been told not to discuss it publicly. Natural immunity occurs when a person with COVID19 recovers and has built-up anti-bodies to fight further corona virus infections.



Nick Karl, one of the scientists, said that those who recovered "probably have... more antibodies against the virus....So your antibodies are

probably better at that point than the vaccination," he added.

Chris Croce, another scientist at Pfizer, told an undercover reporter that people are "probably more" protected by natural immunity when compared with vaccination.

Croce then commented on his own employer: ***"I work for an evil corporation...Our organization is run on COVID money....There's ears and eyes everywhere [at Pfizer]. You don't talk about anything that can implicate you, or ... Big Pharma."***

A third scientist who allegedly works for Pfizer, Rahul Khandke, said that employees have had to sit through many seminars where they're told that getting the company's vaccine is safer than getting COVID-19 and that they cannot discuss the differences in public.

The scientists were speaking to undercover reporters from **Project Veritas**, a nonprofit reporting group.

Sen. Rand Paul (R-Ky.), a medical doctor,

said the undercover videos amounted to a "Truth bomb!"

"Pfizer scientists candidly admit naturally acquired immunity to COVID equal to or better than vaccine," Paul wrote on Twitter.

Colorado Hospital Refuses Kidney Transplant to Woman Over COVID-19 Vaccine Refusal

A hospital in Colorado rejected a woman for a kidney transplant after she refused to get a COVID-19 vaccine, officials have confirmed.

Leilani Lutali received a letter on Sept. 28 informing her that the transplant team at the University of Colorado Hospital decided to designate her inactive on the waiting list for transplants.

"You will be inactivated on the list for non-compliance by not receiving the COVID vaccine," the letter states.

According to the United Network for Organ Sharing, a nonprofit that manages the U.S. organ transplantation system, such policies are not unique, but aren't mandated for transplant facilities.

At least one other hospital reportedly rejected prospective transplant recipients over a refusal to get a COVID-19 vaccine.

Sam Allen was told earlier this year by University of Washington Medicine that his heart transplant surgery couldn't be completed unless he got vaccinated.
