

# Project Salus: U.S. Department of Defense Data Indicates Covid Vaccine is Bioweapon Designed for Depopulation of Indigenous People

The Honorable Minister Louis Farrakhan has been warning Black people for decades about the U.S. Government’s plan to kill billions of people through a depopulation agenda, most recently in his July 4, 2020 Global Message, *“The Criterion.”* More evidence bearing witness to his divine guidance has surfaced through an interview with California-based Attorney Thomas Renz conducted by global researcher Mike Adams.

Of the 16,310 people who have died in America since receiving the Covid-19 “vaccine,” Black and Indigenous people have been hardest hit and evidence is demonstrating it is deliberate. In addition, the “vaccine’s” effectiveness wanes over time, according to data documented by the Artificial Intelligence branch of the Department of Defense under *“Project Salus.”* Attorney Renz broke the news during the interview, which aired October 1, 2021. (Brighteon TV at [brighteon.com](#).)

After being fully vaccinated, 161,000 people were infected with Covid-19. Previously called “vaccine failure,” these post-vaccine infections are now referred to as “breakthrough cases.” Approximately 33,000 people were hospitalized, and 10,400 required ICU admission. These disturbing numbers are found in the federal government’s 17-slide presentation entitled *“Effectiveness of mRNA COVID-19 Vaccines Against the Delta Variant Among 5.6M Medicare Beneficiaries 65 Years and Older.”*

“...This is bombshell information that obliterates the official narrative of (President Joe) Biden and (Dr. Anthony) Fauci, which falsely claims that we’re experiencing a pandemic of the unvaccinated,” Mr. Adams summarized.

He explained that *“Project Salus”* is run in cooperation with the Joint Artificial Intelligence Center, utilizing Humetrix, a platform which provides real-time analysis of health care information. Between January and August 2021, it ran an analysis of 5.6 million fully vaccinated Medicare beneficiaries aged 65 or older who received the deadly mRNA product: 2.7 million with Pfizer and 2.9 million with Moderna.

“As Delta variant surged to over 50% in June, COVID-19 hospitalizations more than doubled ... In this 80% vaccinated, 65+ population, an estimated **60% of COVID-19 hospitalizations occurred in fully vaccinated individuals in the week ending August 7th,**” illustrates Slide 12 of the PowerPoint presentation (September 28).

“Biden, Fauci, all these guys, you can see where they reference the CDC and different things—graphs from CDC presentations—things like that throughout this. There is zero question these guys know this. They’re lying to the American people outright. This is a crooked marketing project for Big Pharma, big tech, big government, at the expense of American lives, and it’s got to stop,” charged Attorney Renz.

He emphasized data showing that the risk of infection and hospitalization for those who are unvaccinated is falling over time.

A final slide showed Native Americans have the highest increased risk of hospitalization after vaccination of any ethnic group (50%), followed by Hispanics (40%) then Black People (25%).

“This is hitting Native Americans more than any other group and yet nobody is warning the Native American community about what is effectively [Antibody Dependent Enhancement] from vaccines,” stated Mr. Adams.

He cited Dr. Sherry Tenpenny, an osteopathic medical doctor, board-certified in neuromusculoskeletal and emergency medicine. Dr. Tenpenny has described Antibody Dependent Enhancement as a process wherein the vaccines gradually damage the immune system in the months subsequent to the shot, making vaccinated individuals far more vulnerable to subsequent infections.

“Why is this the case? The gain-of-function properties which were engineered into the SARS-CoV-2 biological weapon—via Fauci, Daszak (President of research company EcoHealth Alliance) and the NIH (National Institutes of Health) — target ACE2 receptors which exist in higher densities in targeted organ systems of many minority groups such as Native Americans, Hispanics and Blacks,” wrote Mr. Adams in an October 11 summary of the data.

“Gain-of-function” research aims to make viruses more transmissible or more virulent, according to bioethics scientists.

Attorney Renz said he doesn’t have enough evidence to achieve certainty, but he has heard numerous reports about the dangerous effects the “vaccine” seems to pose especially to so-called minority communities. **“It has to do with certain genetic differences.... But, luckily for us, I also just got the report that in New York City, one of the most vaccinated places in the universe, only 26% of African Americans are vaccinated. If that’s true, good...Now I**

said yesterday on an interview there’s not a whole lot of times in my life where Louis Farrakhan and I have been on the same page. But when it comes to this vaccine, we’re dead on there.” Attorney Renz went on, suggesting that the low vaccination rate among Black people in New York City is attributable to The Minister’s July 4, 2020 warning *“Don’t take their vaccines.”*

The Minister is **“absolutely correct,”** concurred Mr. Adams. **“He is Nation of Islam, but there are many other different groups of course, they are recognizing that this appears to be, in their view, a biological weapon targeting Blacks and Hispanics and basically people of dark skin,”**

Minister Farrakhan has been at the forefront and often alone in warning Black people of Satan’s (U.S. Government) diabolical plans long before Covid-19.

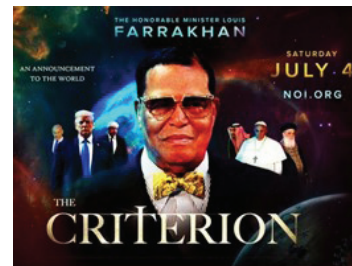
The “depopulation memorandum” introduced by Henry Kissinger, the former secretary of state under President Richard Nixon, became the policy of the U.S. Government, stated Minister Farrakhan, during Part 37 of his 58-week Lecture Series *“The Time and What Must Be Done,”* which originally aired Saturday, September 21, 2013.

The policy to depopulate the Third World by putting sterilants in water and staple foods, as well as other methodologies, is primarily through the United States Department of Agriculture, Department of Defense, Agency for International Development (USAID) and the “CIA” (Central Intelligence Agency), Minister Farrakhan revealed.

*“‘... It’s easier to kill a million people than it is to control a million people’... Zbigniew was not playing. It is easier to kill a million because they are killing millions as we speak,” Minister Farrakhan said in The Criterion. “They are making money now, plotting to give seven billion five hundred million people a vaccination. # Covid-19 Exposes Rotten Core of America's 'Health Care System'

**“My aim is to destroy the medical profession, because it is a culture of drugs not a culture of healing.”** —The Honorable Elijah Muhammad

There is a reason why America's healthcare system did such a dismal job of confronting the COVID-19 so-called “pandemic.” Her system was already rotten to the core and must be replaced. In fact, according to an August 4, 2021 CNN report called, “US comes in last in health care rankings of high-income countries”:

“The nation has landed in the basement in all seven studies the Commonwealth Fund has conducted since 2004.

The U.S. is the only one of the 11 countries surveyed not to have universal health insurance coverage... Half of lower-income U.S. adults reported that they did not receive care because of the cost, compared to just over a quarter of higher-income Americans, the study found. In the United Kingdom, only 12% of people with lower incomes and 7% with higher incomes said they faced such financial barriers...

In addition to lower access to care, the U.S. also ranked poorly on maternal mortality, infant mortality, life expectancy at age 60, and deaths that were potentially preventable

with timely access to care, the survey found.

And the nation landed at the bottom when it came to administrative efficiency because of the time providers and patients have to spend dealing with paperwork, duplicative medical testing and insurance disputes.”

Hindsight is surely “2020.” We can trace America's present predicament to political decisions made in the past in her attempt to deprive Black people in America health care and the

power of the oil barons to insert the profit motive in medical treatments.

In Part 1 of this series, we pointed out how mathematician Frederick Hoffman, working for Prudential Insurance in 1896, convinced the American government that by simply denying health care to Black people, we would die off in two generations. To accomplish this, Congress repeatedly denied the American people a form of “universal health insurance coverage,” because “Black people would get it.” Implementation of these policies to deny health care to Black people has left all poor Americans without health insurance. Even higher-income

Americans are not receiving quality care because of the cost.

When a serious attempt to at least provide health insurance for the poor and the elderly was passed through Medicare/Medicaid in the 1960's and the Affordable Health Act (Obama Care), the implementors of such programs found a way to deny or interfere with Black people getting proper care. Observe the testimony of Dr. Elizabeth Lee Vliet in a September 20, 2021 interview with Conan Milner describing the “*Erosion of Medical Freedom*”:

“A huge element of medical freedom that physicians historically have always defended is the oath of the physician: to carry out for the benefit of the patient to the best of their ability and judgment.

This is what the core principles of the physician-patient relationship have always stood for, until the 1960s when President Lyndon Johnson pushed through the Medicare/Medicaid Act. To get it passed, he promised that the government would not dictate treatment, would not set prices, and would not interfere with the physician-patient relationship.

All of this has been totally thrown out. The government sets the prices it's going to pay, decides what it's going to cover (in other words: dictates treatment for Medicare and Medicaid beneficiaries), and it dictates what the doctors can do.

In the 1980s, the managed care model was really taking off, and administrators and bean counters with no medical training decided what would be covered, what doctors could do for treatment, and how many treatments a patient could have. They intruded into all aspects of medicine, dictating what could be done.

When physicians signed contracts with these third parties—private insurance companies, government programs, and managed care companies—they all started dictating what doctors could do, and what patients could be allowed to have.

It escalated with the 2010 health care law, which put in even more draconian controls. It gave an exemption to the anti-kickbacks statutes that Congress had enacted when they had pharmacy benefits managers come into the picture who were paid to deny doctor-prescribed medicines to patients. These pharmacy manager middlemen get a kickback to choose something else at a lower cost to benefit the insurance carrier, a pharmaceutical company, or whoever they've contracted with.”

The power of the pharmaceutical companies to dictate what doctors use to treat their patients goes back to the early 1900's when the

Rockefellers and Carnegies hired a non-medical school teacher and educational theorist to study the American and Canadian medical education system. The results of that study in 1910 is called “The Flexner Report.”

Health journalist S.D. Wells notes in the eBook *25 Amazing (and Disturbing) Facts About the Hidden History of Medicine*, “Five score and two years ago, a man named Abraham Flexner was hired by John D. Rockefeller to evaluate the effectiveness of therapies being taught by medical colleges and institutions, with the ultimate goal of dominating control over pharmaceuticals.

“With partnerships including Andrew Carnegie and JP Morgan, a new “doorkeeper” would exist to influence legislative bodies on state and federal levels to create regulations and licensing “red tape” that strictly promoted drug medicine while stifling and shutting down alternative, inexpensive natural remedies. Those medical colleges and institutions that did not submit to this superpower of regulation were crushed and put out of business...

The Flexner report was conveniently titled *Medical Education in the United States and Canada* and the 22-page control ‘mechanism’ was more or less a teamster's union, and medical schools in the U.S. were cut in half by the Flexner Report in less than 15 years, from 160 to 80, and then down below 70 by World War II. This concentrated control is the direct cause of the majority of problems with health care today.”

This Flexner Report strategy affected the Black healthcare system even more dramatically than for America has a whole. There were seven Black medical schools in 1910, less than two generations up from slavery and in the midst of Jim Crow. Now we have only four and they are not exclusively run by us. In 1923, there were 200 Black hospitals. In 2021 we have been left with only one.

Now that we have an historical perspective of how we, by falling for Integration, have put ourselves at the mercy of a ruthless, greedy, genocidal “healthcare” system. This so-called “COVID-19 pandemic” has shown us that we are suffering from institutional racism and biological warfare, so what are we going to do about it? The Most Honorable Elijah Muhammad warned us in 1970's that we need our own hospitals. Minister Farrakhan warned us on July 4, 2020 in “The Criterion” that we must set up a system by which we can test everything that the pharmaceutical industry attempts to bring into the Black community. Our choice remains “Separation or Death.”

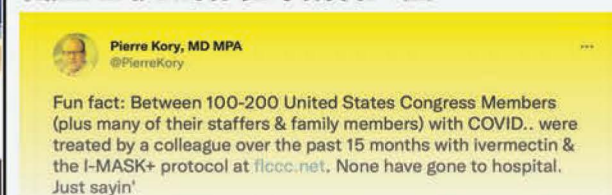
## REPORT: Ivermectin is Used by Hundreds of Congress Members

Titled “As If Expendable,” the report says that “COVID-19 has had a devastating impact on older persons living in care homes in England. 28,186 ‘excess deaths’ were recorded in care homes in England in 2020, with over 18,500 care home residents confirmed to have died with COVID-19 during this period. UK government decisions and failures resulted in violations of the human rights of people living in care homes, notably the right to life, to health and to non-discrimination. From discharging 25,000 patients, including those infected, into care homes; to denying care homes residents admission to hospital and imposing “do not attempt resuscitation” orders on them without due process, to failing to provide PPE and testing to care homes – Older persons living in care homes were abandoned to die.”

A news report by the Canadian Broadcasting Company on how a COVID Intensive Care Unit (ICU) operates featured a man on a ventilator that was later found to be a mannequin, and the same footage was later aired in another Canadian report. This was the latest of several exposés of fraudulent news scenes shown on major news stations designed to project panic and fear and to push watchers to take the death jab.

Despite the government’s condemnation of one of the most effective drugs in stopping COVID-19—a drug that has PROVED to reduce deaths and hospitalizations by more than 90%—a report has surfaced that claims that between 100-200 United States Congress Members (plus many of their staffers & family members) with COVID were successfully treated over the past 15 months with ivermectin, and none have gone to hospital.

**Dr. Pierre Kory**, the foremost expert on the use of ivermectin for COVID-19, made the claim in a Tweet on October 7th.

## Study: Delta ‘Variant’ Does Not Make Children sicker

## Family ‘Mistakenly’ Given COVID Vaccines Instead of Flu Shots @ Walgreens

After the media falsely hyped the dangers of COVID-19 in children, a new study from England finds that the so-called Delta variant does not appear to cause more severe disease in children than earlier forms of the virus. Researchers compared two groups of school-age children with COVID-19: 694 infected with the Alpha variant, and 706 infected with Delta and found that children infected with Delta had slightly more symptoms, but in both groups very few children needed to be hospitalized and long periods of illness were uncommon: “Our data suggest that clinical characteristics of COVID-19 due to the Delta variant in children are broadly similar to COVID-19 due to other variants,” the researchers concluded. That appears to jibe with data reported by the CDC. Director Dr. Rochelle Walensky said “Although we are seeing more cases in children ... these studies demonstrated that there was not increased disease severity in children...”



CNN reported that a family of four was “mistakenly” given COVID-19 vaccines instead of flu shots at a Walgreens pharmacy in Indiana, according to the family’s attorney Daniel Tuley of Evansville. The family of two adults and two children, ages 4 and 5, have not been publicly identified. Tuley says the family went to Walgreens wanting the annual flu shot and left thinking that’s the shot they each received. But about 90 minutes later a pharmacy employee called to explain the vaccine “mistake.” The Pfizer-BioNTech COVID-19 “vaccine,” also known as **Comirnaty**, has not been approved for children under 12, according to the U.S. Food and Drug Administration (FDA). There are currently no COVID-19 “vaccines” approved for that age group.

Attorney Tuley said, “*The family’s children are both experiencing a fever, body aches, coughs, headaches and nausea.... The 4-year-old has had a fever for over a week, and they are being treated by a pediatric cardiologist for tachycardia and high blood pressure. Their prognosis is uncertain at this point in time, and their medical treatment providers continue to monitor their conditions,*” Tuley said.

After a follow-up appointment the mother said that one child had improved but the other had worsened. “Her blood pressure is in the 98th percentile and she continues to have no energy.”
