

# THE GOAL OF TRANSHUMANISM THROUGH COVID-19 VACCINES: Death by Historical 'Mass Murderers'

**"Transhuman":** A being that resembles a human in most respects but has been subjected to technological implants and altered DNA.

Recently, Dr. Joseph Mercola interviewed Dr. Vladimir Zelenko, who has been highlighted previously in *The Final Call* newspaper and was among the first U.S. physicians to develop an early treatment program for the SARS-CoV-2 infection. He popularized the use of hydroxychloroquine and zinc, and when hydroxychloroquine became increasingly difficult to obtain, he was also among the first to identify quercetin as a viable alternative.

As noted by Dr. Zelenko:

*"It's a very treatable infection—or should I say bioweapon?—if done within the first few days, because COVID is two diseases. It's the infectious stage of the virus, and then a week later, you have the pathogenic inflammatory reaction that does all the damage to the lungs and causes blood clots.*

*So, it's all about timing. And the data is very clear. There are dozens of peer-reviewed studies that prove if you treat COVID within the first few days, you have an 85% reduction in hospitalization and death. It's a no-brainer. You could have saved 700,000 people from going to the hospital out of 800,000."*

Interestingly, Dr. Zelenko's description of COVID being two diseases which attack in stages bears witness to Dr. Shankara Chetty's discovery which found that many of his COVID patients got over the flu like symptoms in a few days, but exactly 8 days later they were hit with a severe over reaction of their immune system against the spike protein which seemed to germinate on that 8th day. This over reaction, called a cytokine storm, is also easily combated

given the right diagnosis. But hospital administrators step in with their algorithms to misdiagnose and maltreat the victims to their death.

Instead, the U.S. government was pushing the development of new "vaccines" at "warp speed." However, the U.S. Food and Drug Administration was fully aware that these new so-called vaccines would have serious consequences, yet they pushed them anyway. Zelenko further states:

*"In October, 2020, two months before the vaccine rollout, there was an internal presentation in the FDA to its scientists, and on slide 16 of that presentation, there was a list of side effects: death, heart attack, stroke, blood clots, horrific neurological diseases, myocarditis and many, many more,"* Zelenko says.

*"Now keep in mind, this is two months prior to the rollout. After the vaccines were rolled out, and a few months into it, when the VAERS database started showing the side effects that people were experiencing, there's a 100% correlation with what that slide said would happen, and what actually happened to human beings.*

***That is premeditated mass murder. FDA knew exactly what it was doing. They knew exactly the side effects, and they released it anyway ..."***

He goes on further to say:

*It's never been about health. COVID-19 is easy to treat. It was always about using fear and mass psychosis to get 7 billion people to willfully get injected with the technology that would permit them to participate in the new cryptocurrency-based system, the system that the world will use for finance.*

*Fiat currency and all the traditional ways of transactions will be gone. The only way that you actually will be able to participate in transactions, of buying bread, let's say, is having a transmitting sensor of information with your location. It's the mark of the beast, if you really want to know. With that, you can then buy bread for your family ...*

*Gates and Schwab [are] both talking talk about how these vaccines change who you are. What does that mean? They explain it. [With] the gene editing technology, they are making the human better. That's transhumanism. I call it Human 2.0. Human 1.0 is the version made by God. We are imprinted [with God] in our genetic code. We're made in the image of God because we have his code in us."*

So, if we have God's code in us, who would want to tamper with that code and for what reason? The British Medical Association produced a 1999 book called, **"Biotechnology, Weapons and Humanity"** where it was stated that, **"Genetic engineering of biological agents, to make them more potent, has been carried out covertly for years..."** Former Defense Secretary Cohen **"quoted other reports about what he called 'certain types of pathogens that would be ethnic specific so that they could just eliminate certain ethnic groups and races.'**"


## Dr. Fauci's Pharamanation



Supreme Court Justice **Sonia Sotomayor** claimed, *“We have over 100,000 children, which we've never had before, in serious condition and many on ventilators.”* She made this preposterous claim during oral arguments on whether Pres. ## NPR Reports Vaccines Affect Menstrual Cycle

When enetrainer **Nicki Minaj** tweeted to her 23 million+ followers her concern that the “vaccines” may affect the reproductive system, and then suggested that people do their own research into the matter, the government of America nearly collapsed.



Fearing that her fans may in fact do some research and refuse the poison injection, Depopulation Chief and serial satan Anthony Fauci was rushed into the news cycle to make the following pronouncement: “The answer to that is a resounding no....There’s no evidence that it happens, nor is there any mechanistic reason to imagine that it would happen,” he said, calling it “misinformation.”

NPR now reports that Minaj was dead right and Fauci—again—dead wrong: “A new scientific study shows that vaccination can cause changes to the timing of menstruation.”

Following Minaj’s advice Dr. Alison Edelman, a professor of obstetrics and

gynecology, led the study and claimed that scientists “ignore” menstrual cycles when studying vaccine side effects because “It’s considered unimportant in the grand scheme of things...” The study, which analyzed data from 4,000 women, “found numerous reports of unusually heavy flows and even breakthrough bleeding among some people who hadn’t menstruated in years.”

Dr. Diana Bianchi, director of the Eunice Kennedy Shriver Institute, which funded the work, said that it “does prove that the vaccines are affecting menstruation independently of other possible factors such as pandemic stress.”

Dr. Edelman, in a direct repudiation of Fauci’s quackery says “the immune system and the reproductive system are linked, and some signaling immune cells also can affect the body’s natural clock. Given that relationship, it’s entirely possible that triggering the immune system through vaccination might change a person’s cycles.”

## More Children Dying From Vaccines Than From COVID, Nurse Tells Louisiana Lawmakers

The Children’s Health *Defender* reports that a registered nurse testified at a hearing of the Louisiana lawmakers that her hospital is seeing “terrifying” reactions to COVID vaccines, but hospital officials are failing to report them.

Collette Martin, R.N., a practicing nurse for 17 years, said her Louisiana hospital is witnessing blood clots, heart attacks, strokes, encephalopathy (effects brain function) and heart arrhythmia following COVID vaccination, and staff are failing to report anything to the CDC’s Vaccine Adverse Event Reporting System (VAERS).

She said: “We are not just seeing severe acute [short-term] reactions with this vaccine, but we have zero idea what any long-term reactions are. Cancers, autoimmune [disorders], infertility. We just don’t know.”

Martin said her hospital has seen “more children die from the COVID vaccine than COVID itself.”

“It’s maddening, and I don’t understand why more people don’t see it. I think they do, but they fear speaking out and, even worse, being fired,” Nurse Martin said.

## CBS Analyst Decries ‘Crushing Impact’ of Biden/Fauci COVID Policies on Children

“It’s hurt their dreams, their future learning, loss, risk of abuse, their mental health. And now, with our knowledge, our vaccines—if our policies don’t reflect a more measured and reasonable approach for our children, **they will be paying for our generation’s decisions, the rest of their lives.** And that, to me, is the greatest underreported story of the past year.”
