

'Pandemic' Policies Designed To Destroy Our Health Are Far More Deadly Than Covid-19

Nowhere in the annals of time has the health of the people taken so drastic a nosedive as it has under the COVID-19 "pandemic" policies forced on America by a corrupt gang of pharmaceutical felons and their government imps. In this veritable *coup d'état*, a group of unelected, unregulated but powerful depopulation fanatics brought America to its knees, imposing dictatorial control over the populace, and obliterating the U.S. Constitution, press conference by press conference. They ordered lockdowns that destroyed tens of thousands of businesses, threw millions out of work, disrupted the global economy, closed schools, and forced millions into poverty. Let's take a deeper look at some of the actual reasons for so much devastation.

Cause of Death: Hospitals

The health of Americans suffered the most in this satanic holocaust disguised as public health, and "COVID-19" may not even be the worst of the afflictions. Doctors are now openly admitting that the alleged 890,000 deaths attributed to "COVID-19" have been wildly exaggerated using devious accounting methods designed to boost the fear and panic necessary to drive us all to the needle. And many of those who did die did so needlessly. When Americans sought early treatment at the onset of symptoms, they were routinely denied access to effective remedies proven to moderate the severity of the disease if caught in its early stages. Safe, inexpensive, and available drugs like ivermectin and hydroxychloroquine (about \$2 per pill) had successfully beaten back "COVID-19" in many places on earth. But Anthony Fauci and the drug demons he represents saw no profit for themselves in this early treatment regimen. They incentivized hospitals to send the early symptom-sufferers home *untreated* until they were ambulance-ready. Then, as their lungs become inflamed with disease, they are isolated in hospitals like lepers and put on Remdesivir, a highly toxic drug that failed against Ebola and is also failing against "COVID-19." But its \$3,000 per treatment price tag makes it a resounding success for the drug industry! So deadly is Remdesivir that some hospital nurses dubbed it "Run-death-is-near." When that poison inevitably fails, hospital staff paralyze and attach their victim to a mechanical breathing device that weakens the body but allows them to bill a cool \$39,000. Burial costs vary from state to state.

Dr. Deborah Birx, who used to stand with Fauci at White House press conferences, later said that beyond the 100,000 deaths of the first "COVID-19" surge, *"All of the rest of them, in my mind, could have been mitigated or decreased substantially."* That would mean as many as 790,000 deaths can be attributed to Fauci's disastrous "pandemic" policies—not to COVID-19. Dr. Robert Malone, the actual inventor of the mRNA vaccine technology concurs. He wrote: *"[T]here are over half a million deaths in the United States for this virus, completely unnecessary because the federal government has very actively blocked the ability of physicians to provide lifesaving medications early in the infection."*

Cause of Death: Lockdowns

But Fauci's drug thugs were not satisfied to simply kill off large numbers of Americans. Those left alive would continue to suffer in myriad ways. Their draconian "lockdowns" are now

shown to be utterly unscientific, having absolutely no effect on the "pandemic." A recent Johns Hopkins University study of lockdown policies concluded harshly that *"we find little to no evidence that mandated lockdowns in Europe and the United States had a noticeable effect on COVID-19 mortality rates.... In consequence, lockdown policies are ill-founded and should be rejected as a pandemic policy instrument."*



Alcoholism, Mental Illness, Suicide ...

Too little too late. Not only were they useless for their stated purpose, the "lockdown" policies are responsible for dramatic increases in alcoholism, suicides, mental illness, domestic violence, and surging drug overdoses. Under the new Pharma regime, there have been an estimated 50,000 extra cancer deaths over the past 18 months—deaths that normally would not have occurred. Delayed diagnosis and inability to receive proper treatment because of COVID restrictions are thought to be the primary reasons for this.

Vitamin D Deficiency

Lockdowns and indoor isolation have limited access to the very thing that is known to kill the disease—sunlight! **Deaths, it has been shown, occurred most often in Vitamin D-deficient patients, and Sunlight is the greatest generator of Vitamin D in the body. Fauci, instead, prescribed darkness.** Outdoor activity was strictly prohibited—parks and beaches were closed, basketball hoops and tennis nets were removed, and playgrounds were wrapped in crime scene tape in cities and towns all over America. The physical and psychological damage to children is actually incalculable, as they have spent their early developmental years wearing masks and separated from each other, trapped in their homes, staring at computer screens.

Drug Use, Domestic Violence

From May 2020 to April 2021, the U.S. *recorded 100,306 drug overdose deaths*, a 29% increase from the previous 12-month period, according to CDC data. Domestic violence incidents *increased 8.1% in the U.S.* after lockdown orders were issued.

Increase In Number One Co-Morbidity: Obesity

78 percent of Americans hospitalized for COVID-19 were overweight or obese. Robert F Kennedy, Jr., reports in his book *The Real Anthony Fauci* that Fauci's lockdowns caused Americans to gain an average of two pounds per month and to reduce their daily steps by 27 percent. Kennedy continues:

"He never took time during his daily White House briefings from March to May 2020 to instruct Americans to avoid tobacco (smoking and e-cigarettes/vaping double death rates from COVID); to get plenty of sunlight and to maintain adequate vitamin D levels ('Nearly 60 percent of patients with COVID-19 were vitamin D deficient upon hospitalization, with men in the advanced stages of COVID-19 pneumonia showing the greatest deficit'); or to diet, exercise, and lose weight. Quite the contrary, he didn't recommend avoiding sugar and soft drinks, processed foods, and chemical residues, all of which amplify inflammation, compromise immune response, and disrupt the gut biome which governs the immune system."

73 percent of people reported increased anxiety and 84 percent reported increased depression since stay-at-home orders were initiated. The panicked stockpiling of food, stress eating, and lack of exercise options led to more weight and weight-related illnesses.

Cause Of Death: Media-Induced Anxiety And Depression

The media's unrelenting 24-7 panic preaching led to a 14 percent increase in alcohol consumption. It is found that women had a 41 percent increase in heavy drinking days since onset of the "pandemic," as they try to balance home, work, and caregiving responsibilities. The shuttering of schools and daycare centers meant that the need for childcare reached crisis levels. Children seeing their parents drinking, because of the time "locked down" in the home, one study points out, "can play a major role in the intergenerational transmission of excessive alcohol consumption." If the woman is pregnant or intends to be, lockdown drinking increased the risk of fetal damage, including neurodevelopmental deficiencies, learning disabilities, and behavioral and other mental health problems.

- For two years the Fauci policies paralyzed healthcare systems around the world and delayed cancer diagnosis and treatment. Elective surgeries were canceled and *breast, colorectal and prostate cancer screening dropped sharply.*
- Suicides and suicidal ideation have escalated among Black, Hispanic, and Native American men, though it decreased slightly for the population as a whole.
- A stunning report finds that deaths among people aged 18 to 49 increased more than 40 percent in the 12 months ending October 2021 compared to the same period in 2018–2019, based on death certificate data from the Centers for Disease Control and Prevention (CDC). That's more than 90,000 additional deaths in this age group, of which *less than 43 percent involved COVID.*

Cause Of Death: COVID-19 Vaccines

We are told that all the sickness, death and devastation caused by these policies is justified for a disease that has a far better than 99.986 percent survival rate. Even after unleashing this massive crime wave against the public health, they continue to ruthlessly promote a "vaccine" that is an absolute failure. The long-touted snake oil has no apparent value at all. It DOES NOT prevent infection; it DOES NOT prevent transmission; and, according to the CDC, it *has* prevented almost 23,000 Americans from reaching their next birthday, along with tens of thousands who now have irreversible ailments because of these poisonous vaccine policies.

Nicole Sirotek, a registered nurse and whistleblower who exposed death by ventilators, testified: "I didn't see a single patient die of COVID. I have seen a substantial number of patients die of negligence and medical maleficence...The pharmaceutical companies had gone into these hospitals and decided to practice on the minorities, the disadvantaged, the marginalized population that we know we have no advocates for...the very agencies that should have been protecting them were closed because we were 'sheltering in place'...I was there and I saw that the pharmaceutical companies were rolling out Remdesivir on a substantial number of patients... we all saw it was killing the patients and now it's the FDA approved drug that is continuing to kill patients in the United States."

One after another, doctors and scientists attested to the fact that the majority of the 800,000 Americans who supposedly died of COVID could have been saved. The doctors were prevented from using inexpensive, effective and safe drugs to save their patients. Dr. Paul Marik offered, "Hospitals have become dangerous places for sick people. Patients must do whatever they

can to avoid the hospitals. When they are imprisoned in a hospital, they are denied their rights, they are not allowed a patient advocate, the families are denied access to the patients. They are prisoners to the system. They have no rights and they get treatments which are dictated by the hospitals."

It was a powerful meeting, but at the end of the day, no one answered the question "Why?". Why was this allowed to happen? Dr. Robert Malone said, "regulatory capture"; Dr. Pierre Kory said "corruption"; Dr. Aaron Kheriaty emphasized "greed". All of this is true, but no one point out the "800-pound Gorilla" in the room. The one man who has relentlessly called out the U.S. Government's Depopulation Policy is the Honorable Minister Louis Farrakhan. When we look at the agenda set forward by Memorandum 200, then look at studies and action by succeeding presidents, we will see that they all are following the same Depopulation agenda. National Security Study Memorandum 200: Implications of Worldwide Population Growth for U.S. Security and Overseas Interests (NSSM200) was completed on December 10, 1974 by the United States National Security Council under the direction of Henry Kissinger. It was adopted as Official US Policy by President Gerald Ford in November, 1975.

We must look beyond "regulatory capture", which refers to Big Pharma's takeover of the regulatory agencies. We must look at government policy being implemented by these agencies with taxpayer money. Big Pharma is a hired gun that produces bioweapons while being protected from liability for injury and death of target populations. The Department of Defense, National Institute of Health (NIH) and the "black budget" funding allow development and production of the latest weapons: the so-called "vaccines" poisoning the American public as they drain them of their health and wealth.

In previous articles in The Final Call, we pointed out that America's desire to systematically cull the Black population dates back to the late 1800s after the end of chattel slavery. The Civil War was not fought to free Black people. The North fought to deprive the South of her most valuable asset, her slaves. For a while the Union placed federal troops in the defeated southern states to protect the former slaves from outright slaughter. However, that protection was lifted in 1877 as part of a "Compromise" that settled the intensely disputed 1876 presidential election between Republican Rutherford B. Hayes and Democrat Samuel J. Tilden. With the troops removed there was mass killing and persecution of Black folk, but we didn't die out. Then came along a mathemati-

cal "genius" named Frederick L. Hoffman. In 1896, after looking at the death rates of Blacks verses Whites, he discovered that Blacks were dying at a much faster rate than Whites. He convinced American politicians that they simply needed to deprive Black people of healthcare to solve the "race problem"; by letting us die in the Wilderness of North America. He predicted that although there were 7.5 million Black people in the U.S. in 1890, in two generations they would die off.

That plan did not work out too well. By 1910 there were 9.8 million Black people who had found a way to feed, cloth, house and provide healthcare for themselves. In fact, by 1910 we had bought 16 million acres of land, established over 60 towns and set up 7 medical schools. By 1920 we had 200 hospitals in spite of vehement racism, lack of resources and constant lynching. We were left to die, but would not, so they intensified the undeclared war against us.

For those who argue that if the government is giving these shots to white people, then it should be safe for us, observe how this government has treated their white citizens in its attempt to deprive Blacks of healthcare for over 100 years. Author Thom Hartman in his new book "The Hidden History of American Healthcare", writes that every time the idea of a government funded healthcare system for all of America's citizens was brought to Congress, "People said no, because Black people would get it." This happened in 1912 when Teddy Roosevelt proposed a national healthcare system. Congress said no again when Franklin Roosevelt proposed it. Harry Truman tried in 1947 and the same thing happened; lawmakers complained "Black people would get it."

As some of the vaccine mandates are being rolled back and the latest "Omicron" variant is described by Anthony Fauci and his cohorts as something comparable to the "common cold," we must not forget that Big Pharma, the government and the media tried to get the whole world to take a "kill shot" by using Remdesivir and ventilators to kill us in the hospitals, inflating the COVID-19 deaths to instill fear and panic in the public. The merchants of death and the haters of the Black Nation are far from finished with their plans for genocide. They are just moving into the next phase. You may wish that this would all go away. However, we are at the end of a 6,000-year play and the genetically modified humans don't like us nor themselves anyway. 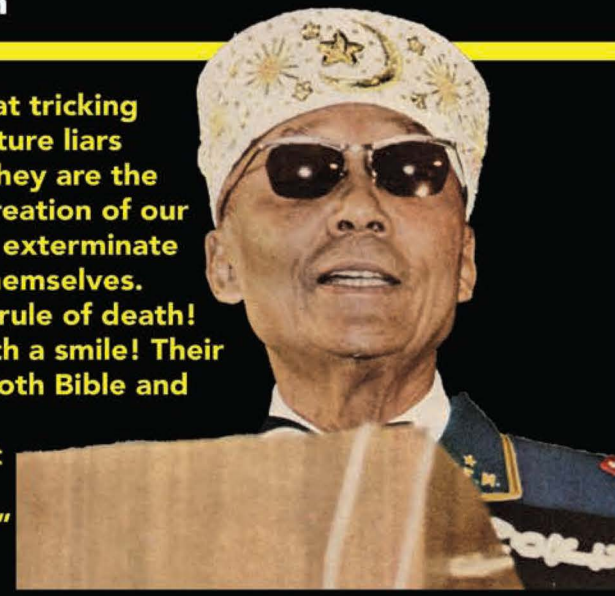

prise” COVID-19 “pandemic,” is apparently why **Dr. Anthony Fauci** could make this now infamous “prediction” in his “Pandemic Preparedness in the Next Administration” speech on Jan. 10, 2017, shortly before Trump’s inauguration: “The thing we’re extraordinarily confident about is that we’re going to see [a pandemic] in the next few years.”
