

Brilliant Black Scientist Speaks Out On Covid-19 Vaccine Mandates And U.S. Policy Of Depopulation

Dr. Christina Parks is an educator, researcher and scientist who gained widespread recognition following her appearance before the Michigan State Legislature on August 10, 2021. Poised and courageous, she advanced the position that Covid-19 vaccine mandates are unscientific, racist and discriminatory. She won our admiration when she used her superior communication skills to indict the abuse of science and clinical medicine. She won our hearts with her charge that the unvaccinated are victims of blatant human and civil rights violations. Dr. Parks has continued to speak on the dangers, as well as the ineffectiveness of the vaccines. She has become a controversial figure because of her stand on truth. Nevertheless, this wife, mother and teacher remains undeterred as she joins the growing ranks of soldiers for justice who are banned from social media platforms.

Dr. Parks recently granted an interview with me. Over a period of several hours, she graciously shared her insight and manifested her deep spirituality. Minister Farrakhan, a Servant of Allah (God), declared the Covid-19 vaccine “death” while it was still in development. He also called for our scientists to analyze the vaccine. Dr. Parks not only possesses impressive credentials specific to the task, her fearlessness in educating the public about the vaccines is invaluable.

Here are excerpts from Dr. Park’s powerful and insightful observations on Covid-19, the government’s “pandemic policies” and other issues of importance to the Black community:

A Declaration of War Against All of Us

I do believe we have the right to reject injecting anything into our body. That’s the first thing. But beyond that, these are so dangerous. It is, I believe, an act of war against people.

I think that the idea that there is massive depopulation going on is too psychologically stressful for many people to cope with. So they would rather choose to what I’ll call ‘stay in the Matrix,’ and not see evidence that’s right in front of their face. ... *The science clearly shows us that this is going to be a mass depopulation event. How big or small it is, I don’t know. I know that God is in control. And so, whatever their intentions are comes up against what His intentions are.*

... I’ve actually been asked to speak by a lot of Patriot groups, which are sort of Trump supporting groups in Western Michigan. And it’s interesting to me that many of their views, in some ways, mirror the Nation of Islam. When I became aware of the Nation of Islam and years ago, there’s this idea that it’s this separatist movement that is separate because it’s racist. And of course, there’s some it that’s uncomfortable, and some people saw it that way. Some people didn’t. But I think the average White middle class American kind of saw it that way. And now, they’re in a position where they are saying, we need to generate our own economies. We need to generate our own alternate economy that can

sustain us, that is **separate** than the global power structure, that is **separate** than the deep state. I actually brought up one of Brother Malcolm’s speeches the other day, and I almost did a double take. And I said I know many people, some of his rhetoric was too strong for them, but if you replace the word “White Devil,” with “Deep State,” it plays exactly clean for this day and age. And you could give it to your average Trump- supporting White middle class person, and they would say, ‘Oh, yes! That’s exactly what I believe!’

Minister Farrakhan’s Call for ‘Something Better’

That’s exactly what my intent is. And it’s a complicated environment because there’s many different political forces. I think we all need to pray that God would lift up those whose hearts are true, and bond them together for this goal, because the endpoint is just too important to allow differences of political opinions, and just all of the drama that usually ensues, egos, whatever it might be, to stop us from reaching this goal. I think that I set it in His hands and hopefully take one step at a time and see what He does. ... This is not just like, throw something at it. ... It’s a very complex process, and I’m just at God’s disposal to use in this and hopefully, He will open the doors, and the scientists themselves are extremely excited about moving forward.

COVID-19 PCR Tests:

I know people were concerned about possible chemical contaminants on the swab. I was concerned that they were sticking it way up by your brain. That just didn’t seem necessary at all. Why are they using these particular procedures without any explanation for why? And if you have a child or even a

teenager, that’s a very sensitive area way up in there near your brain or whatever? Why would you want them to do that? If anything, this is spread oral, fecally and so you could just get a sample from your rear end, and that would actually give you all the information that you would need. And that’s not really very invasive. It might be personally invasive, but it’s not going up near your brain or anything. ... **What PCR does is it amplifies genetic information. It can’t tell you if the virus is live or dead. The virus could be dead.**

U.S. Government Free COVID-19 Home Test Kits

Who trusts the government now anymore? Is the test getting your genetic information? Are you sending that to the government? It’s very skeptical. Now, if I can get it at home, and I don’t want to send it to anybody, maybe that’s okay. But I’m pretty skeptical of anything from the government, unfortunately. I would want it from a private industry, that’s not involved in the government, but I don’t even know where you find that anymore, since they all seem to be so intertwined.

Masks

First of all, there was never any question about whether masks work. They don’t. They’ve always been known not to work, because viruses are so teeny tiny, they get in all of the little areas, and then when you put on a mask, you’re sucking air in more forcefully. So, you’re bringing it from further away. You’re actually more likely to suck virus in, and then if you’re blowing it out, you’re more likely to shoot it further, just like when you put your thumb on a hose ... Then, if you do have the virus, it’s accumulating on the outside of the mask, and then most people are touching the masks all day, and then touching things. Every study that I know of shows no benefit, and some even show that you’re actually more likely to spread it possibly because it’s accumulating on the outside of the mask.

The Vaccine Injury Treatment Alliance:

We want to bring life. We want to bring hope. We want to bring healing. Right now, what I’m trying to do is spearhead an effort to bring doctors and scientists together, who are really just interested in looking at the mechanisms of how the COVID vaccine injures, as well as broadly how vaccines injure. ... We also are looking for administrative people, lawyers, because this is a complex process, and many doctors are having their license threatened for treating the vaccine injured.

Censorship of Dr. Rizza Islam:

Truth is rising. And I think one of the reasons I was a strong advocate for Rizza to speak at the Stop the Mandates rally, was that his voice needs to be heard, and he’s earned it. He’s earned that authentic engagement. And certainly, some mainstream people were very interested. They didn’t know he existed. And they were like, ‘Who is this person?’ I think that it is critical that not just the Black community hear his voice, because he elucidates his case, he speaks his case for the Black community, for his vision, so clearly, with such grace, with such love, but with such forceful power and no compromise, that many people will understand after hearing him and that will bring many strong alliances.

Public Health Agency's reassessment of COVID-19 as "not being socially critical" due to a better understanding of the Omicron variant which is milder and associated with fewer hospitalizations. At its peak the virus only had an overall 1% mortality rate. "It's time to open up Sweden," said Prime Minister Magdalena Andersson. "The pandemic isn't over, but it is moving into a new phase."

Denmark has reclassified COVID-19 as an "endemic" disease instead of a "pandemic" disease. This means we can expect new variants of the disease each year like with the common cold and the flu. 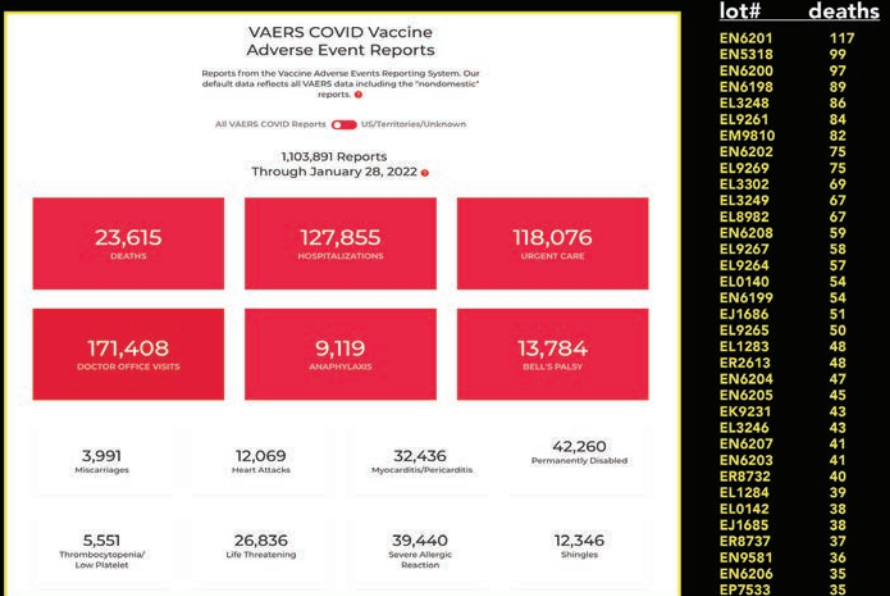

'Run the World' actress fired from the series over COVID-19 vaccine mandate

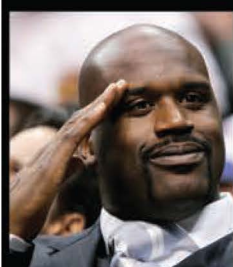

Truckers by the Thousands Join Convoy in Protest of Canada's Brutal COVID Mandates



Truckers in Canada have shut down the busiest border crossing in North America, the Detroit-Windsor border, stopping traffic on both sides of the border. The truckers told Fox News that they are fighting for 'all Canadians' as thousands from all over Canada joined a massive convoy that rolled into their capital of Ottawa to the parliament building to end the vaccine and mask mandates imposed by the government of Canadian president Justin Trudeau. The peaceful protest grew in scope as millions of Canadians lined the roads and highways in freezing temperatures to show support for the drivers.

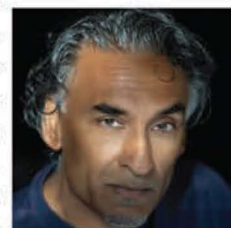

The truckers GoFundMe page collected donations totaling more than \$9 million. But GoFundMe froze the funds, claiming that the truckers had violated the website's terms of service, though CFO Jeneen Minter would not provide any proof of the charge.



Turning a "Pandemic" into a "Casedemic" Why Biden's Testing Plot is a Scamdemic

The government's not-so-subtle shift in focus from COVID "deaths" to "cases" has been accompanied by a massive push for widespread testing of the American people. Biden says they have purchased one billion "home test kits" to distribute "free" to the American people. Dr. Setty: "To be entirely clear, if only a test can tell a cold and Omicron apart, then Omicron is just a cold."

"Given our focus on 'cases,' we have in recent days reached even higher heights of Orwellian absurdity with respect to tracking and responding to the virus.... Today's narrative around Omicron continues the pattern of extreme exaggeration of all public COVID-19 stats, followed by the inevitable over-reaction from policymakers, politicians and the public. Two years into this global nightmare it is becoming clear that the pandemic is overwhelmingly a man-made and policy-made event, where it is the policy choices themselves that are causing the vast majority of harm, not the virus."

Hospitals Paid Big \$\$ To Kill Us

What Are They REALLY Testing For?

Army Whistleblower Reports Huge Increase in Deaths & Injuries Since Vaccine Rollout

The “COVID-19” money trail leads from government medical programs to hospitals—all the way to the undertaker. In a viral video Dr. Peterson Pierre outlined the perverse cash incentives amounting to over \$100,000 per “COVID” patient. He concludes that “The Biden Administration is literally paying hospitals to kill you.” The CARES Act, signed into law in 2020 by Pres. Trump, floods the medical industry with a COVID cash tsunami. Dr. Pierre describes it:

The current situation is this: If you have COVID and you end up in the hospital, you’re put on a rigid protocol. There’s a high mortality rate in the hospitals and your family is kept in the dark as to what is happening. What’s going on here?

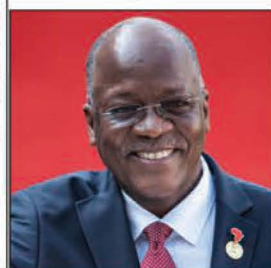
- 1) The CARES Act provides bonuses to hospitals whenever people have a diagnosis of COVID.
- 2) The Center of Medicare and Medicaid Services is waiving patient Bill of Rights. This is a deadly combination. Hospitals get a payment because they give a free COVID test in the emergency room. They get a boosted payment if they get a diagnosis of COVID.
- 3) Hospitals get another bonus payment if the patient is admitted with COVID.
- 4) Hospitals get another bonus payment if the patient is put on Remdesivir.
- 5) Another bonus payment for hospitals if the patients are put on mechanical ventilators.
- 6) Another 20% bonus payment if the [dead] patient diagnosis is marked as “COVID,” even though the patient might not have died from COVID.
- 7) There are also bonus payments to coroners.

Do you understand the gravity of what is happening right now? The Biden Administration is literally paying hospitals to kill you! That’s what’s happening. This is terrible. We need to stop it. These are real human lives we’re talking about. They’re priceless.

It’s estimated that hospitals receive \$100 000 per covid patient. **Ladies and Gentlemen, think about it.**



Early on, Tanzania’s President **John Magufuli**, who had a Ph.D. in chemistry, declared that COVID-19 had been defeated in his country, attributing it to God’s help in the form of natural remedies. Magufuli enraged the Western powers when he suspected that the coronavirus PCR test kits were being fraudulently used to hype the infection rates.

In May 2020, he sent in swabs from a goat, a papaya, a sheep, and motor oil, giving each sample a human name, gender, and age, and they all tested positive for COVID-19! With the scam exposed—and by a certified chemist, no less—Africa became more vaccine-resistant than it ever had been. Magufuli warned Africa, *“You should stand firm. Vaccinations are dangerous. If the white man was able to come up with vaccinations, he should have found a vaccination for AIDS by now; he would have found a vaccination [for] tuberculosis by now; he would have found a vaccination for malaria by now; he would have found a vaccination for cancer by now.”*

It is suspicious that Pres. Magufuli died in 2021 at age 61 allegedly of “heart failure,” but thanks to him, Africa has the lowest rate of COVID “vaccination” in the world and the lowest rate of infections and deaths.

Department of Defense data show big spikes in miscarriages, neurological disorders, cancer and other illnesses among members of the U.S. military since its rollout of COVID-19 “vaccines.”

Attorney **Thomas Renz** testifying at a Senate hearing said data provided to him by three whistleblowers showed COVID “vaccines” are causing “catastrophic harm” to members of the U.S. military while not preventing them from getting the virus.

Renz said diagnoses for neurological issues increased ten times from a five-year average of 82,000 to 863,000 in 2021. Other medical conditions were also dramatically increased among military personnel:

Hypertension: 2,181% increase.
Diseases of the nervous system: 1,048% increase.
Multiple sclerosis: 680% increase.
Guillain-Barré syndrome: 551% increase.
Breast cancer: 487% increase.
Female infertility: 472% increase.
Pulmonary embolism: 468% increase.
Migraines: 452% increase.
Ovarian dysfunction: 437% increase.
Testicular cancer: 369% increase.
Tachycardia: 302% increase.

Attorney Renz also told the Senate panel that some data appeared to have been purposely removed from the database and even “doctored” in order to hide the extent of the “vaccine” damage.

A DOD spokesman claimed “there was a glitch” in the DOD database that “gave the false impression that there was a huge spike in miscarriages, cancer and other medical issues among military members in 2021,” and said the database had “been taken down [only] to identify and correct the problem.”

The U.S. Army began discharging service members who refuse the vaccine, which is mandated across all arms of the military. A lawsuit filed by 18 service members challenging the mandate is pending, as is the plaintiffs’ most recent request for an injunction.

In a letter to **Secretary of Defense Lloyd J. Austin**, Sen. Ron Johnson, who convened the hearing, asked military officials to “explain what actions DOD has taken to investigate the root cause for the increases in these diagnoses,” and to “explain why and when this information was removed and identify who removed it.”

“It’s not a bacterial war, but a war of systemic poisoning.
