

The Unraveling of a Great Nation: Satan Casts Out Satan

Big insurance blames big Pharma for rise in death rates

The head of Indianapolis-based insurance company, *OneAmerica*, said the death rate among Americans 18-64 has risen a stunning 40% from levels before the deployment of the so-called “COVID-19 vaccine.”

“We are seeing, right now, the highest death rates we have seen in the history of this business—not just at *OneAmerica*,” the company’s CEO Scott Davison said during a December 30, 2021, online news conference. *OneAmerica* is a **\$100 billion insurance company** that has been headquartered in Indianapolis since 1877. The company has approximately 2,400 employees selling life insurance, including group life insurance to employers nationwide.

“Just to give you an idea of how bad that is, a three-sigma or a one-in-200-year catastrophe would be 10% increase over pre-pandemic,” he said. “So, 40% is just unheard of.”

He further added, “For *OneAmerica*, we expect the costs of this are going to be well over \$100 million...” paid out to policyholders in group life insurance and disability claims.

Other insurance companies have also been alarmed at the sudden increase in claims that will negatively affect their bottom line. According to Edward Dowd, former Portfolio Manager at *Blackrock*, insurance companies do not plan to be left “holding the bag.” *Blackrock*, with a **\$69 billion net worth**, manages more money than any other investment firm in the world, with more than \$10 trillion in assets under management as of Dec. 31, 2021. While at *Blackrock*, Dowd grew the fund that he managed from \$2 billion to \$14 billion, and he predicted both the dot-com bubble burst in 2000 and the housing bubble burst in 2008.

Dowd believes the increased death rates can be directly attributed to the mRNA vaccines. He has sounded the alarm on Moderna and Pfizer as sinking ships that investors need to abandon. Signs of the exodus have already popped up since this extra death data was released by the insurance companies.

Moderna’s stock is down some 70 percent from its high of \$484 on August 9, 2021, wiping out almost \$140 billion in investment. Pfizer stock lost \$20 billion in market capitalization on February 8, 2022, when their record earnings fell short of more optimistic expectations.

One of the pillars for the tremendous profitability of vaccine manufacturers during the “pandemic” is their protection from lawsuits arising from any harm their experimental jabs may produce. However, there is an EXCEPTION to that cloak of immunity and that comes into play if it can be shown that those companies were

engaged in FRAUD. Dowd foresees an avalanche of lawsuits coming as the insurance industry continues to uncover the legions of mounting deaths coming from the complications of the mRNA vaccine. He said:

“The FDA is the trusted third-party verification of pharmaceutical products. 50% of their budget comes from Pharma...due to the institutional imperative that was in place at the time and the speed with which they tried to approve these unproven products with this unproven technology, fraud did occur, and what’s my proof of that? The FDA, together with Pfizer, were trying to hide the clinical data.

And it’s come out recently ... that the all-cause mortality for the Pfizer product failed—that means there were more deaths in the vaccine group than the placebo group. Normally in such a case, you have NO drug approval for such drugs. It’s the gold standard. I’ve been told by all my people in the Biotech Industry they were horrified ...”

Since there were more deaths in the vaxxed group than in the unvaxxed, Dowd believes there is a case for fraud, based upon the FDA covering for Pfizer by not releasing their data. He believes this is a knowing attempt to conceal the deaths.



“When one party enters into a contract... and fraud was occurring when they entered into that contract, and the other party did not know that – the contract is void and null. There’s no indemnity if this can be proven, and I think it will be.”

He notes that deaths skyrocketed after the vaccine rollout when they should have dropped: “People are dying and being maimed. This is a fraud that goes beyond the pale... We have the VAERS data... We have the DoD leak... And now we have the insurance company results and the funeral home results... We don’t need to think too hard about this... Deaths should have gone down after the vaccines rolled out. This is the most egregious fraud in history of the nation—and it’s global ... Pfizer’s involved, and they committed fraud.” Again, the insurance companies do not intend to be left “holding the bag.”

And the CDC has admitted it is withholding large portions of COVID-19 data, including vaccine boosters—from the public because it fears the information could be “misinterpreted.” *Kristen Nordlund*, a CDC spokeswoman, said the reason for the slow release of data is “because basically, at the end of the day, it’s not yet ready for prime time.” She added that the CDC’s “priority when gathering



any data is to ensure that it’s accurate and actionable.”

So, the CDC wants the data it releases to be “actionable”, meaning “able to be done or acted upon.” The CDC is releasing data that will make us act the way that they want us to act, and that is take the shots and feed Big Pharma’s coffers at the risk of your life. This is fraudulent behavior by a government agency acting on a hidden agenda of population reduction.



U.S. Continues Bio-Warfare Against Black Population: HIV Genes Found in SARS COV-2 (COVID-19)

On June 3, 1946 (just 10 months after America dropped the first atomic bomb on Japan), *Time Magazine* reported on a debate in Congress that took place a week earlier. The article lifted two statements regarding the quest for bio-warfare and depopulation:

“During a routine House debate on naval appropriations last week, Representative Albert Thomas opened his mouth a millimeter too wide. Out popped a shocker. Said Thomas: “We have something far more deadly than the atomic bomb.”

Representative Harry Sheppard, chairman of the Naval Appropriations subcommittee, revealed more:

“This nation is in possession of scientific factors which place it in

an enviable position. The scientific factors at hand would result in devastation equal to, if not greater than, the atomic bomb. Remember, there are different kinds of devastation.”

... Wrote General H. H. Arnold in *One World or None*: “It is worthwhile pointing out that biological warfare, consisting of the spreading of disease, could occupy a position similar to atomic warfare.... Human beings would have little natural resistance against such synthetic diseases, which might conceivably spread, in a biological chain reaction, through the world’s entire population.”

The inconceivable wickedness of the Enemy of God and His people is being exposed daily, confirming the words of the Honorable Minister Louis Farrakhan.

While COVID 19 dominates public discussions, an older viral terror keeps popping up in the laboratory work of many scientists studying the coronavirus: the HIV gene.

According to the University of Michi-

gan Health/Library, “HIV (human immunodeficiency virus) is a virus that attacks cells that help the body fight infection, making a person more vulnerable to other infections and diseases. It is spread by contact with certain bodily fluids of a person with HIV, most commonly during unprotected sex (sex without a condom or HIV medicine to prevent or treat HIV), or through sharing injection drug equipment.”

“AIDS is the late stage of HIV infection that occurs when the body’s immune system is badly damaged because of the virus.”

The question that has to be answered is why these “viruses” always seem to have a greater, more devastating deathblow to Black people. We must remember that the AIDS virus was initially rumored to have its origins among White homosexuals in San Francisco and New York in the early 1980’s.

However, according to the Center for Disease Control (CDC) Diagnoses of HIV infection, by race/ethnicity and selected characteristics, 2018, *HIV Surveillance Supplemental Report*:

“Black Americans have had the highest age-adjusted death rate due to HIV disease throughout most of the (AIDS) epidemic.

In 2018, Black people made up 13% of the population but accounted for 42% of new HIV diagnoses.

As of 2018, an estimated 40% of people living with HIV in the US were Black American.

In 2019, Black Americans had the highest rate of new HIV diagnoses at 45 diagnoses per 100,000 people, which was more than 8.5 times the rate for White Americans.”

Now, with the onset of COVID-19 allegedly originating in China, we have basically the same results, according to the Kaiser Family Foundation (KFF):

“Over the course of the COVID-19 pandemic, analyses of federal, state, and local data have shown that people of color have experienced a disproportionate burden of cases and deaths. They have shown particularly large disparities in cases and deaths for Black and American Indian and Alaska Native people and in cases among Hispanic people compared to their White counterparts...” Cumulative data over time show persisting disparities in cases for

Hispanic people and deaths for Black people. As of October 5, 2021, the Centers for Disease Control and Prevention (CDC) reported a total of over 34.5 million cases for which race/ethnicity was known for 64% or 22.4 million, and a total of over 570,000 deaths for which race/ethnicity was known for 84% or over 480,000.”

During a November 2004, *Final Call* interview, Boyd Graves, JD, a victim of AIDS, revealed 7 of 15 reports by the US Special Cancer Virus Program which gave proof of the laboratory development of AIDS. He also filed two lawsuits in San Diego Federal District Court naming Presidents Bush and Obama, respectively, in an attempt to force the government to expose the remaining 8 reports. Both lawsuits were dismissed without explanation.

Among the key points of his impeccable research was the following statement about AIDS and the fact that any virus which could be tailored to the Black genome to be more infectious to Blacks: “What the science and medical evidence concludes is that the HIV enzyme seeks out a receptor site in the blood of the Black genome. The receptor site is the CCR5 Delta 32+ (positive) gene that all people of color have. In the same sense, on the other end of the spectrum, is the 15 percent Caucasian population of the world, which is CCR5 Delta 32-(negative) gene. That means that under no circumstances, whether HIV came through the air, intravenous drug usage or any form of the sexual activity, would the virus be transferable in this sector of the world’s population, which is basically of northern European descent.

It is speculated by some experts that, in a worst-case scenario, 85 percent of the world’s population could potentially perish under these designer viruses and designer synthetic biological agents.”

Could the HIV gene, through laboratory engineering be inserted in the COVID 19 virus and tailored for the Black genome, to weaken or negatively affect it? Has history, in any way, implied such an idea could be imagined?

Despite the naysayers, what certainly points to the laboratory invention of these so-called viruses is that they have U.S. government patents.

There are a number of studies in which scientists around the world have

concluded that HIV genes are in the coronavirus.

According to Mr. Graves, there were two abstracts of research presented by Indian and Chinese scientists demonstrating that HIV genes are targeted for the very distinctive Black genome.

One such study was done at the Kusuma School of Biological Sciences, Indian Institute of Technology in New Delhi, late January 2020. Almost a dozen Indian scientists were involved in the project. In plain language, they found that:

HIV had been deliberately inserted into COVID-19.

The Abstract or short summary of their findings were entitled, “Uncanny similarity of unique inserts in the 2019-nCoV...” “Importantly, amino acid residues in all the 4 inserts have identity or similarity to those in the HIV-1 gp120 or HIV-1 Gag.”

After reporting on the various test and processes these scientists used in their conclusions, they wrote: “The finding of 4 unique inserts in the 2019-nCoV, all of which have identity / similarity to amino acid residues in key structural proteins of HIV-1 is unlikely to be fortuitous in nature.”

Another group from China documented three insertions comparing fewer spike glycoprotein sequences of coronaviruses. This is further evidence that HIV genes were inserted to increase the effects of the COVID 19 virus on the Black genome.

These reports, like other controversial reports, were removed from the internet under the guise that all the scientists had withdrawn their conclusions.

In conclusion two new pills for coronavirus were announced, recently, to fight the dreaded COVID 19. One of the pills is Remdesivir. Remdesivir, a drug proven to damage the kidneys, was used to supposedly fight HIV. Instead, it killed people. It was reinvented for COVID-19 and is used by hospitals throughout America. Q: Rep. Kara Hope (D) Michigan, House of Representatives:


“So if I have a business, I can require people to wear their hair short or dress a certain way. Why can’t I require them to wear a mask?”



[Some 26] studies attribute to masking a grim retinue of harms, including respiratory and immune system illnesses, as well as dermatological, dental, gastrointestinal, and psychological injuries. Fourteen of these studies are randomized, peer-reviewed placebo studies. There is no well-constructed study that persuasively suggests masks have convincing efficacy against COVID-19 that would justify accepting the harms associated with masks.

Finally, retrospective studies on Dr. Fauci’s mask mandates confirm that they were bootless. “Regional analysis in the United States does not show that [mask] mandates had any effect on case rates, despite 93 percent compliance. MINNESOTA WOMAN LOSES BOTH LEGS AND HANDS AFTER 2ND PFIZER COVID-19 SHOT






Are the COVID Test Swabs Vaxxing You?

Johns Hopkins researchers revealed the technology now developed to deliver vaccines and other medications through microscopic machines they call “theragrippers.” Inspired by a sharp-toothed parasitic worm, these tiny, star-shaped microdevices can latch onto intestines and release drugs into the body. The *theragrippers* are made of metal and a thin, shape-changing film, then coated in heat-sensitive paraffin wax.

When the paraffin wax coating on the dust-size grippers reaches the temperature inside the body, the devices close autonomously and clamp onto the colonic wall, where they are retained and release their medicine payloads gradually into the body. Eventually, the theragrippers lose their hold on the tissue and are evacuated.

The dangerous deception of this technology is obvious to anybody who has seen the government’s aggressive push for “COVID testing” after their push for the death jabs faltered. The Johns Hopkins website actually demonstrates the size of the *theragripper* technology with a photograph of a cotton swab. The caption reads: “A *theragripper* is about the size of a speck of dust. This swab contains dozens of the tiny devices.”



In fact, this is the same type of swab that is jammed far up the nose for the “COVID tests”—a test that has been found to be useless in determining the presence of viruses. With this technology it is certainly possible—and even probable—that the aggressively marketed and government-funded “Home Test Kits” may have *theragripper* swabs, like the one pictured, that contain one of the deadly “vaccines.” As The Honorable Minister Louis Farrakhan says, “We have no right to trust them.”

Meanwhile, the *Cincinnati Enquirer* reported that there is a possibly toxic substance called sodium azide in at-home COVID-19 test kits, resulting in “a surge in calls about exposures to the chemical since more people started self-testing for COVID-19 at home.”

Fifty million U.S. households have received some version of the test kits.


Vaccine Inventor Condemns COVID “Vaccine”
