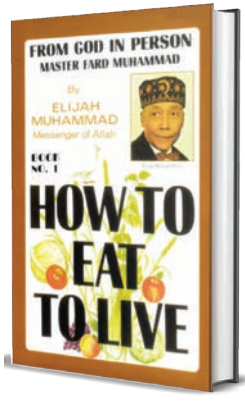


*“The Honorable Elijah Muhammad said to me: ‘This practice today of medicine is not a practice of ‘healing,’ it’s a practice of drugs.’ ... The above statement presents a paradigm shift from this world’s concept that disease caused by the invasion of viruses and bacteria that must be killed by drugs and vaccines, or that disease is the result of “genetic defects” that must be treated with drugs. Interestingly, on October 18, 2019 (the same month that COVID-19 was “discovered” in Wuhan), the Johns Hopkins Center for Health Security, in partnership with the World Economic Forum (an international think tank of bankers) and the Bill and Melinda Gates Foundation hosted *Event 201*, which “modeled a fictional coronavirus pandemic ... where a novel zoonotic coronavirus transmitted from bats to pigs to people ... eventually becomes efficiently transmissible from person to person, leading to a severe pandemic ... The disease starts in pig farms in Brazil...”

The COVID-19 “pandemic” is often compared to the “Spanish Flu” pandemic of 1918-19, which infected 500 million people and killed 20 million people worldwide. However, the so-called “Spanish Flu” did not originate in Spain. It originated here in the United States, concurrent with a “swine” flu outbreak among pigs in Kansas. Juergen A. Richt, Regents Distinguished Professor of Diagnostic Medicine and Pathobiology at Kansas State’s College of Veterinary Medicine and his colleagues studied the 1918 Spanish Flu pandemic. In 2009 they concluded that *“the 1918 pandemic influenza virus and the virus causing the swine flu were the same.”* Richt further stated that their research *“also suggests that*

*pigs could have played a role in maintaining and spreading the 1918 human pandemic influenza virus.*

Dr. Anthony Fauci co-authored an article in 2009, entitled “*Dynasty: Influenza Virus in 1918 and Today*” in which he wrote: “*The 1918-1919 influenza pandemic was a defining event in the history of public health ... The legacy of that pandemic lives on in many ways, including the fact that the descendants of the 1918 virus have continued to circulate for nine decades.*” And according to another National Institutes of Allergy and Infectious Diseases (NIAID) researcher, Dr. Jeffery K. why did he not tell the American people to stay away from eating swine or touching its flesh, instead of forcing humans to “*social distance*” from each other?

Dr. Fauci also should have read on the National Institute of Health’s (his employer) website the descriptions of the most effective treatment of the 1918-19 “Spanish Flu”: “*The apparent success in reducing the number of infections and deaths reported at this open-air hospital may simply have been caused by patients and staff experiencing levels of natural ventilation far higher than in a conventional hospital ward. Instead of recommending fresh air

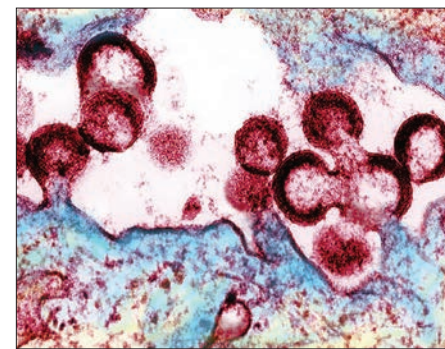

Acquired immunodeficiency syndrome (AIDS) viewed under a microscope Photo: MGN Online

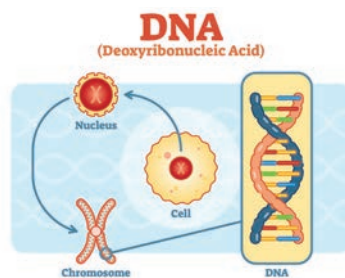

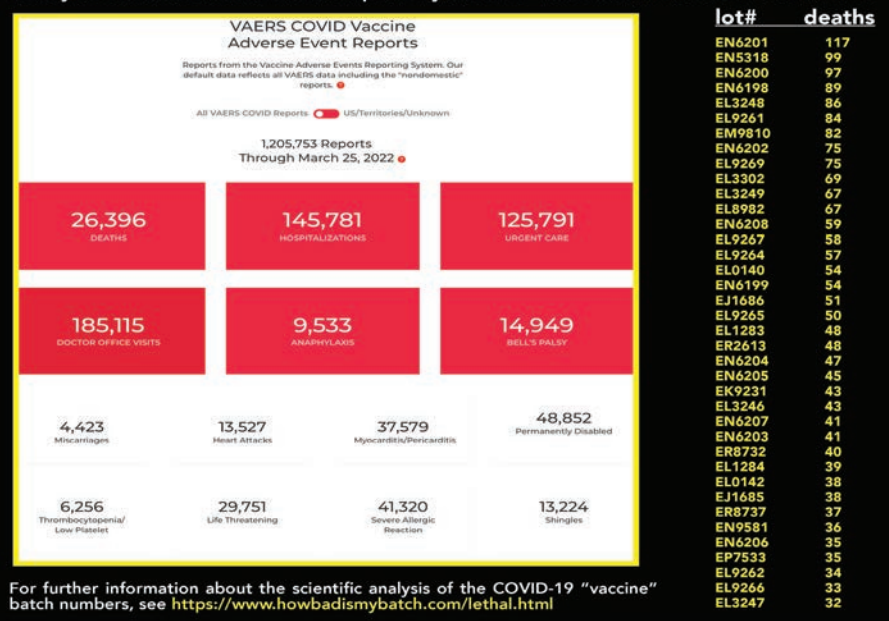

## "Social Distancing" Has NO BASIS in Science

In July 2020 a public-private partnership program between the Bill Gates, Mastercard, and the Artificial Intelligence company Trust Stamp introduced a "biometric identity platform" in remote communities in West Africa. The "Wellness Pass" is a digital vaccination record and identity system that ties an individual's health record into a financial system. Critics



say that the program is more aimed at promoting the health of markets for vaccines and Mastercard's "World Beyond Cash" program rather than the health of individuals. They note that "Trust Stamp" is offering the same technology to COVID-19 response that it offers to law enforcement and prison systems for the purposes of surveillance and predictive policing.

## The COVID Cult & the Stockholm Syndrome

Why would anyone continue to follow the failed and damaging "pandemic" policies of an enemy who is openly trying to kill the human race, long after the enemy has retreated? The Stockholm Syndrome is a condition in which hostages develop a psychological and emotional bond with their captors during captivity.

Stockholm syndrome victims dutifully embrace the stay-at-home orders; they wear 3 masks when their captor calls for just one; they happily shut down their small family business; they slather on loads of disinfectant chemicals on their bodies; and they otherwise over-comply with the depopulators' every wish and desire. The term Stockholm Syndrome was first used by the media in 1973 when four hostages were taken during a bank robbery in Stockholm, Sweden. The hostages defended their captors after being released and would not agree to testify in court against them.

Actions and attitudes similar to those suffering from Stockholm Syndrome have also been found in victims of sexual abuse, domestic violence, human trafficking, extremism, terrorism, economic oppression, political repression, and religious persecution.

A literature review and meta-analysis of the effects of lockdowns on COVID-19 mortality released in January 2022 by **Johns Hopkins Institute for Applied Economics and Global Health** has now concluded:

*"...lockdowns during the initial phase of the COVID-19 pandemic have had devastating effects. They have contributed to reducing economic activity, raising unemployment, reducing schooling, causing political unrest, contributing to domestic violence, and undermining liberal democracy. These costs to society must be compared to the benefits of lockdowns, which our meta-analysis has shown are marginal at best. Such a standard benefit-cost calculation leads to a strong conclusion: lockdowns should be rejected out of hand as a pandemic policy instrument."*

## Bill Gates Complains: 'I'm cited as some mastermind in some evil plot'

Billionaire land owner, eugenicist, and pandemic profiteer Bill Gates has been treated as the vaccine oracle of the world even though he has no medical degree. He was interviewed at the Bloomberg New Economy Forum, where he admitted that COVID has been *"an interesting test in people's trust in their politicians or their health system."*

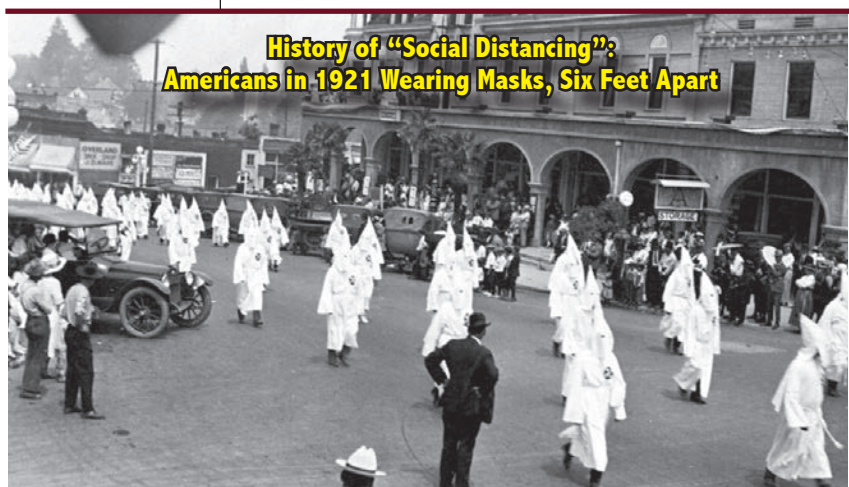
In fact, it is based on a computer model created by a 15-year-old Albuquerque, New Mexico high school student named Laura Glass. Along with her father Robert (a government scientist then working at Sandia National Laboratories) the child worked up a computer model for a science and engineering fair in 2006. Her "model" suggested high school students could infect huge swaths of a population, so putting a stop to those contacts would hypothetically "save lives."

Her efforts earned her third place in the science fair but through her father's government connections the youth's contagion computer model ended up on the desks of the US Department of Homeland Security of the George Bush administration. Glass received a call from Homeland Security Secretary Michael Chertoff requesting a briefing. Ultimately the Centers for Disease Control (CDC) made "social distancing" official policy in February 2007.

## Israel's 'Vaccine' Tragedy: '80% of serious COVID cases are fully vaccinated'

In his landmark address titled "The Swan Song" **The Honorable Minister Louis Farrakhan** agreed with Dr. Anthony Fauci that Israel should be viewed as a model to assess the safety and effectiveness of the worldwide "vaccine rollout." Israel's former prime minister **Benjamin Netanyahu** gave his country over to Pfizer to be the guinea pig for their "vaccine." Pfizer's CEO **Albert Bourla** said Netanyahu called him 17 times and offered to pay top dollar for the vaccines (about \$31 per dose). Netanyahu declared that Israel "will become the first country to get out of the coronavirus....Victory is within our grasp."

Netanyahu then mandated vaccines, masks, social distancing, shut-downs, and shut-ins more harshly than almost any other country; and he banned safe and effective treatments like Ivermectin and hydroxychloroquine. Despite strong opposition from the Orthodox Jewish community, Israel, as of March 2021, had the highest vaccinated population per capita in the world (73% have at least 1 dose, 56% had booster).

**Dr. Anthony Fauci** publicly held up Israeli vaccine data as authoritative enough to set US policy. But the data was not what Fauci expected. On Nov. 12, 2021, Fauci said this:

*"They [Israel] are seeing a waning of immunity not only against infection but against hospitalization and to some extent death, which is starting to now involve all age groups. It isn't just the elderly."*

In other words, Israel's data was proving that the vaccines' purported protective efficacy wanes drasti-

cally not only in the threat of infection but also in regard to severe COVID and death. Speaking about the "effectiveness" of the vaccines in countries with high vaccination rates, Fauci admitted:

*"It's waning to the point that you're seeing more and more people getting breakthrough infections, and more and more of those people who are getting breakthrough infections are winding up in the hospital."*

### It Just Got Worse from There

Despite the appalling failure of and rising deaths from the 1st, 2nd, and 3rd shots, Israel continued on, requiring shots for children and elderly, leading to the largest death spike to date (see chart below). Hospitals were filled with VACCINATED people — NOT the "vaccine" refusers. On August 5, 2021, Dr. Kobi Haviv, director of the Herzog Hospital in Jerusalem, reported on Channel 13 News that *"Most of the elderly are vaccinated, most of the population is vaccinated, and that's why around 90 percent, 85-90 percent of the patients hospitalized here are patients that were fully vaccinated."*

Nearly four in five of the most severe COVID cases at Tel Aviv Sourasky Medical Center were people who have had "at least three injections," said Jacob Giris, the facility's director. "The vaccine has no significance regarding severe illness, which is why just twenty percent of our patients are unvaccinated," he said on Feb. 6, 2022.

Meanwhile, a recent survey identified more than 40 different categories of vaccine side effects that included increased hospitalizations, exacerbation of pre-existing diseases, neurological and allergic side effects, and menstrual cycle irregularities, the latter raising fears among women that the "vaccine" may affect their future ability to have children.

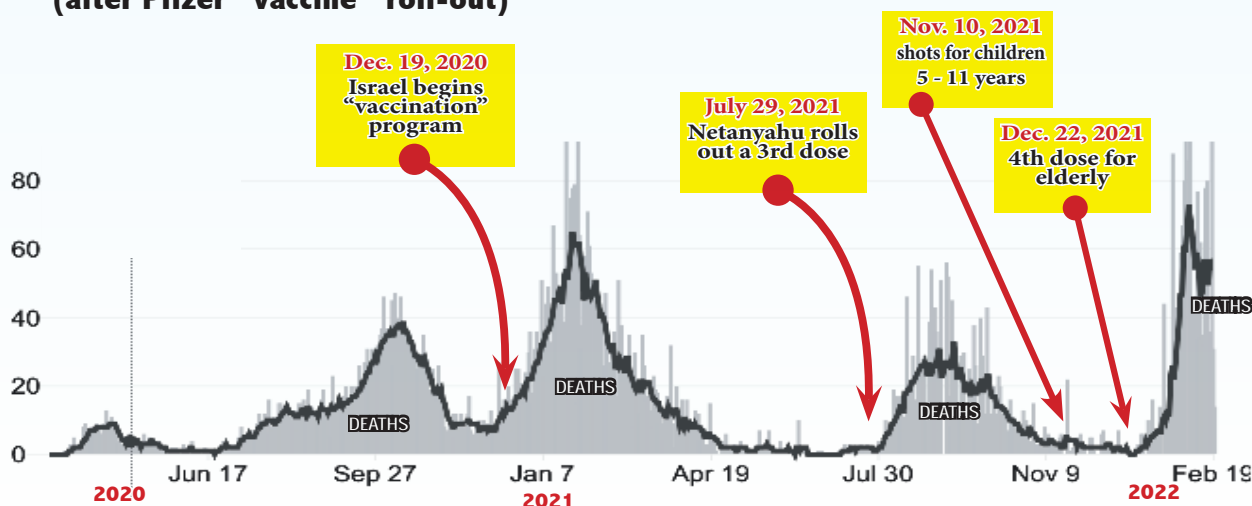
