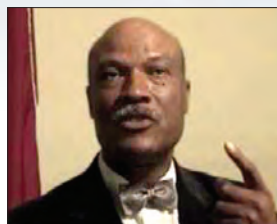

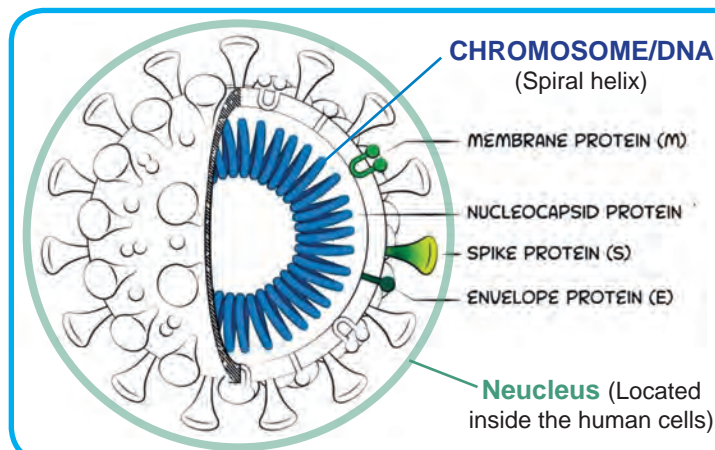

What exactly is DNA and what is its function? According to www.genome.gov:

“Deoxyribonucleic acid (DNA) is a molecule that contains the biological instructions that make each species unique. DNA, along with the instructions it contains, is passed from adult organisms to their offspring during reproduction ... DNA contains the instructions needed for an organism to develop, survive and reproduce. To carry out these functions, DNA sequences must be converted into messages that can be used to produce proteins, which are the complex molecules that do most of the work in our bodies. Each DNA sequence that contains instructions to make a protein is known as a gene.”

Let’s read how Moderna describes their new technology imitating mRNA, which they call “The ‘Software of Life’”:

“Recognizing the broad potential of mRNA science, we set out to create an mRNA technology platform that functions very much like an operating system on a computer... We need to get the mRNA into the targeted tissue and cells while evading the immune system. If the immune system is triggered, the resultant response may limit protein production and, thus, limit the therapeutic benefit of mRNA medicines. We also need ribosomes to think the mRNA was produced naturally, so they can accurately read the instructions to produce the right protein... Utilizing these instruction sets gives our

investigational [experimental] mRNA medicines a software-like quality. We also have the ability to combine different mRNA sequences encoding for different proteins in a single mRNA investigational medicine.”

This “mRNA technology” in these so-called COVID-19 “vaccines” instructs our infected cells to produce the “spike proteins” which they proposed would alert your immune system to produce protection against future infestations of the spike protein. Theoretically, mRNA injected into the cells would only survive a few hours. However, Dr. Robert Malone published a May 28, 2022 article, “When is mRNA not really mRNA?”, where he emphatically declares that this synthetic mRNA “... can persist in lymph nodes for at least 60 days after injection. This is not natural, and this is not really mRNA. These

molecules have genetic elements similar to those of natural mRNA, but they are clearly far more resistant to the enzymes which normally degrade natural mRNA, seem to be capable of producing high levels of protein for extended periods, and seem to evade normal immunologic mechanisms for eliminating cells which produce foreign proteins which are not normally observed in the body.”

Moderna’s website explains that not only can their injections program our cells to produce the “spike protein” but they “also have the ability to combine different mRNA sequences encoding for different proteins in a single mRNA” shot. The transhumanists have used the COVID-19 pandemic to scare the world

into taking these gene altering shots that are just the beginning of continuous inoculations with different “messages” to manipulate and permanently change the DNA of humans. The World Economic Forum’s image of the future is that humanity will be divided into two classes: one is a group of genetically modified (GMO) super-humans served primarily by robots and computer technology; the other is a group of genetically modified (GMO) sub-humans permitted to live in permanent servitude.

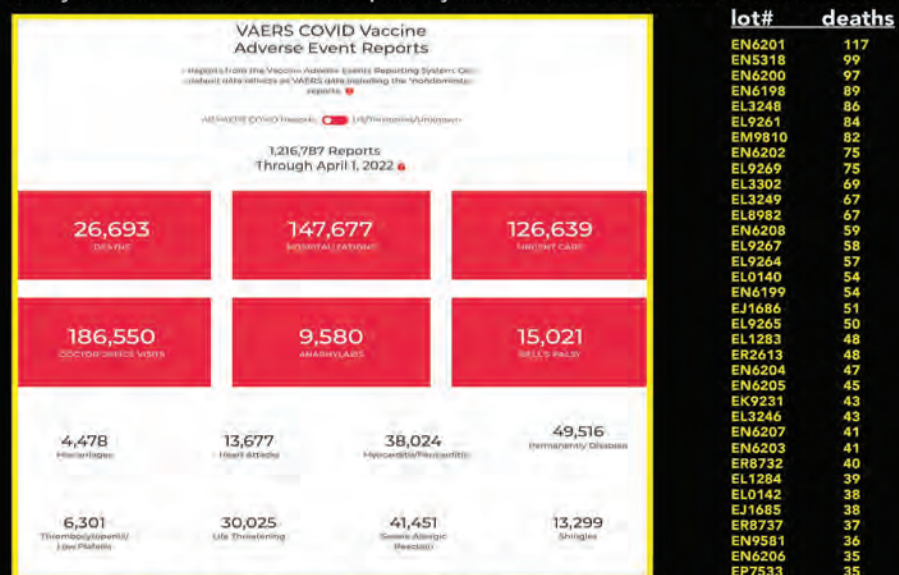

Robert Kennedy's Blistering Rebuke of Dr. Anthony Fauci

Anthony Fauci's "50-year regime has been calamitous for public health and for democracy. His administration of the COVID pandemic was, likewise, a disaster. As the world watched, Tony Fauci dictated a series of policies that resulted in by far the most deaths, and one of the highest percentage COVID-19 body counts of any nation on the planet. The US, with 4 percent of the world's population, suffered 14.5 percent of total COVID deaths. By September 30, 2021, mortality rates in the US had climbed to 2,107/1,000,000, compared to 139/1,000,000 in Japan...

Meanwhile, for the past two years Fauci has denied that natural immunity—the immunity that a person derives from having been infected with a sickness—gives that person better protection than any vaccine. This has always been a medically sound concept until depopulation became the open objective of the medical establishment. To push everyone to the death needle Fauci feigned ignorance of that science-based concept.

But now an interview has resurfaced that Fauci gave to C-SPAN in 2004 that yet again proves Fauci is America's chief COVID deceiver. Fauci responded to a caller who wanted to know if she should get a flu vaccine even if she had had a flu infection 35 years earlier. Fauci responded:

"Well no. If she got the flu for fourteen days, she's as protected as anybody can be, because the best vaccination is to get infected yourself. If she really has the flu, if she really has the flu, she definitely doesn't need a flu vaccine....[S]he doesn't need it...[T]he most potent vaccination is getting infected yourself."

Candace Owens: Claims She Would Not Take COVID Vaccine Even on Her Deathbed

Talk show host and political commentator **Candace Owens** was questioned whether she was truly unvaccinated: *"I am not getting this vaccine, ever. Never going to get it. I don't care if I'm on my deathbed and they say 'it can save you,' I'm not going to get it."*

To her Twitter followers she wrote: *"If you do not understand that there is something purely evil involved right now in terms of these vaccines you will never understand. It will NEVER enter my arm."*

In many other social media posts, interviews and broadcasts Owens has been militantly against the "poison" jab.

"I'm principally now opposed to [the 'vaccine'], and I do not understand why anybody who is healthy, able-bodied, and young, would ever get this vaccine if you're not at risk of COVID," she said.

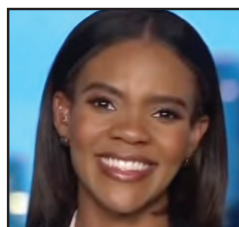
Of the inducements being offered to push vaccine compliance she told Fox News: *"There's something about this that feels like a child predator,"* comparing it to allowing a stranger to come up and offer candy. *"Adults should not be coming to you and trying to bribe you to do anything, especially when we're talking about medical decisions that belong to the parents."*

"Not one person in my family will ever touch the COVID-19 vaccine. That is the decision that we have made, unabashedly, as a family," she tweeted. "Medical freedom is an individual right that should never be infringed upon and any person who thinks otherwise has no place in our government."

"I am proud that I committed myself to standing firm against the bribery, media propaganda, coercion, celebrity-peer pressure campaign, plus censorship. I made a personal decision for me and my family," Owens wrote in a Facebook post.

"We can always look to history to see where these things come from," saying it reminded her of when she "studied Stalin youth programs, Hitler youth programs. When you are talking about schools and the government issuing these brain-washing doctrines... It is because they are trying to raise up children to do whatever the state wants unquestioningly," she added.

"It's time for parents to take control of their children and realize the government is trying to step in as the parent and it's quite frankly inappropriate....It is isn't easy to swim against such a polluted current but here I am. I trust my gut much more than trust Dr. Fauci. May we all do what we feel in our hearts is right, unabashedly."



Miscarriages Expose Depopulation Agenda

Depopulation is most effective when it targets the womb and renders its victims sterile—unable to produce another generation. As of today, the CDC admits that the COVID-19 "vaccines" have likely caused the deaths of 26,396 people. The injections have caused 1.2 million injuries, and among them are 4,423 miscarriages. 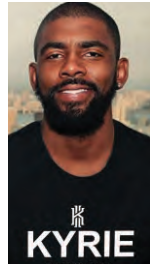

NBA's Un-Jabbed Irving Vows to Keep Up Fight Against Mandates

Brooklyn Nets NBA player **Kyrie Irving** is keeping up the fight against vaccine mandates and the damage they have wreaked on those who refused to be guinea pigs.



He told the *New York Daily News*, “I think there are a lot of people dealing with real consequences from being unvaccinated. And I don’t think it’s talked about enough in terms of our essential workers and people on the front lines... But I know everybody still feels it, and there’s a whole community of people that have lost their jobs due to this mandate as well.”

There were 1,400 New York City municipal workers fired because of the vaccine mandates, according to reports.

Japanese Find That Ivermectin Shows Remarkable Results Against “COVID-19”

Japanese researchers knew of Ivermectin as a Nobel Prize-winning miracle drug that treats onchocerciasis, the debilitating parasitic disease known as River Blindness. They were curious about the apparent effectiveness of Ivermectin in stemming COVID-19.

They investigated thirty-one “onchocerciasis endemic” countries that used “community-directed treatment with ivermectin.” The researchers compared their COVID-19 statistics with 22 “non-endemic” countries.

They found that the mortality rate was “significantly less” in the thirty-one countries that used ivermectin for onchocerciasis. In the countries where ivermectin was used frequently, there were 134.4 cases per 100,000 people and the number of deaths was 2.2 per 100,000. In countries that do not use ivermectin, there are 950.6 cases per 100,000 and 29.3 deaths per 100,000. This realization prompted Tokyo’s Medical Association Chairman to hold a live press conference recommending ivermectin to all doctors and for all COVID-19 patients.

American History of Medical Racism & Savagery

In 1962, **Dr. Emanuel Mandel** and **Dr. Chester Southam** of the **Jewish Chronic Disease Hospital** in Brooklyn injected live cancer cells into 22 elderly patients without their consent. When whistleblowers exposed the experiments, hospital administrator **Solomon Seigel** maintained that the cancer cells “are harmless.” The New York State Board of Regents found the doctors guilty of fraud, deceit, and unprofessional conduct, and revoked their licenses for one year. However, two years later, the **American Association for Cancer Research** elected **Dr. Southam** its president.

Slave Plantation Passes Are Back: And Now Whites Are Slaves Too! Part 3

Accounts of how the plantation passport system operated in America are described in **Theodore Weld’s** 1839 book *American Slavery As It Is*:

A negro can hardly walk unmolested at the south.—Every colored stranger that walks the streets is suspected of being a runaway slave, hence he must be interrogated by every negro hater whom he meets, and should he not have a pass, he must be arrested and hurried off to jail. Some masters boast that their slaves would not be free if they could. How little they know of their slaves! They are all sighing and groaning for freedom. May God hasten the time!

...When the slaves have done their day’s work, they must be herded together like sheep in their yards, or on their plantations....The slaves must all be at their homes precisely at eight o’clock, P.M. At this hour the drums beat in the cities, as a signal for every slave to be in his den. In the country, the signal is given by firing guns, or some other way by which they may know the hour when to be at home. After this hour, the guard in the cities, and patrols in the country, being well armed, are on duty until daylight in the morning. If they catch any negroes during the night without a pass, they are immediately seized and hurried away to the guard-house, or if in the country to some place of confinement, where they are kept until nine o’clock, A. M., the next day, if not called for by that time, they are hurried off to jail, and there remain until called for by their master and his jail and guard house fees paid. The guards and patrols receive one dollar extra for every one they can catch, who has not a pass from his master, or overseer, but few masters will give their slaves passes to be out at night unless on some special business: notwithstanding, many venture out, watching every step they take for the guard or patrol, the consequence is, some are caught almost every night, and some nights many are taken; some, fleeing after being hailed by the watch, are shot down in attempting their escape, others are crippled for life.

Mad Israeli Scientist: Humans are now HACKABLE ANIMALS thanks to vaccines

Israeli intellectual **Yuval Noah Harari**, a professor at the Hebrew University of Jerusalem, declared that “*Humans are now hackable animals. The idea that humans have this soul or spirit, they have free will and nobody knows what’s happening inside me—so whatever I choose whether in the election or in the supermarket, that’s my free will? That’s over.*”

“*Today, we have the technology to hack human beings on a massive scale. Everything is being digitalized [and] monitored.*”

A proud homosexual, Dr. Harari explained that “If you know enough biology and you have enough computing power and data—you can hack my body, my brain and my life. You can understand me better than I understand myself. You can know my personality type, my political views and my deepest fears and hopes. And you can do that not just to me, but to everyone.”

Dr. Harari is no minor figure. **Pres. Barack Obama** considers him to be one of his favorite authors and touted his book *Sapiens* in a nationally televised interview. Harari is a top advisor to Great Reset depopulator **Klaus Schwab** and his **World Economic Forum**, where he spoke and made these nightmarish claims in 2020.

“We humans should get used to the idea that we are no longer mysterious souls. We are now hackable animals. A system that understands us better than we understand ourselves can predict [and] manipulate our feelings and decisions, and can ultimately [decide] for us. By hacking organisms, elites may gain the power to re-engineer the future of life itself. Because once you can hack something, you can usually also engineer it.”

Harari continued: “**In the past, many tyrants and governments wanted to do it. But nobody understood biology well enough, and nobody had enough computing power and data to hack millions of people. Neither the Gestapo nor the KGB could do it. But soon, at least some corporations and governments will be able to systematically hack all the people.**”

Harari said of the COVID-19 “pandemic”: “It’s often said that you should never allow a good crisis to go to waste, because a crisis is an opportunity to also do ‘good’ reforms that in normal times, people will never agree to. But in a crisis, you see, we have no chance—so let’s do it.”

“**The vaccine will help us, of course. It will make things more manageable, [such as] surveillance. People could look back in a hundred years and identify the [COVID-19] pandemic as the moment when a regime of surveillance took over—especially surveillance under the skin,**” said Harari.
