

skinned people losing their pigmentation. In his 2013 landmark lecture series, **The Time and What Must Be Done (Part 39)**, the Honorable Minister Louis Farrakhan walked us through recent developments in western science:

1. In 2013 Australian geneticist Dr. Alan Cooper of the University of Adelaide analyzed the DNA of ancient skeletons and found that the genetic makeup of the modern European “was established around 4,500 B.C. in the mid-Neolithic—or 6,500 years ago ...” Furthermore, “The genetics show that something around that point caused the genetic signature of previous populations to disappear. However, we don’t know *what* happened or *why*.”

2. Evolutionary biologist Dr. Jonathan Pritchard of the University of Chicago led a team that isolated the five genes responsible for skin color and concluded that these genes “started to be more common” in the Asian and European population 6,600 years ago. A 2006 New York Times article, “Still Evolving, Human Genes Tell New Story,” reported that Dr. Pritchard’s work “impl[ie]d that Europeans acquired their pale skin much more





recently” than 45,000 years ago.

3. Molecular biologist Dr. Keith Cheng, of Pennsylvania State University College of Medicine, led a study that, in his words, shows that Europeans “lightened up quite recently, perhaps only 6,000 to 12,000 years ago.” Dr. Cheng further stated:

**“There was a single moment in this research ... [when] I began to sweat. Not only did white-skinned people evolve from black-skinned people, but lighter-skinned people, whether they are Europeans or Asians, like me, were actually mutants of dark-skinned people.”**

4. Other researchers at Tel Aviv University in 2018 pinpoint the **“abrupt” appearance of white-skinned people to exactly 6,500 years ago to an area close to the Island of Patmos in the Aegean Sea, near modern Turkey.**

5. Finally, a 2014 study published by the National Academy of Sciences not only pinpoints the time of these mutations to a period of “6,500–4,000 years ago,” but also claims that “... the actual nature of the *selection pressure* remains unknown.”

The researchers concur on the date of the beginning of the mutations, but they could not figure out **“why”** a group of people choose to lighten their skin, since white skin did not increase the survivability of these originally darker people. In particular, independent research teams led by Dr. Bruce Etinger, Dr. Marc C. Hochberg, and Dr. Khizar Abbas found that white-skinned people have weaker bones and are more susceptible to skin-cancer:


years ago that resulted in a new, made race of people on our planet.

the made race to overcome and control the original, darker people.



## Fauci Emails Show Uselessness of Masks

Private emails of America's Depopulator in Chief, Anthony Fauci, prove that he knew masks have no benefit in the plandemic even as he was telling the world that masks and "vaccines" are their only hope. Fauci wrote to a colleague:



*"The typical mask you buy in the drug store is not really effective in keeping out virus, which is small enough to pass through material. It might, however, provide some slight benefit in keep out gross droplets if someone coughs or sneezes on you. I do not recommend that you wear a mask, particularly since you are going to a very low risk location. Your instincts are correct, money is best spent on medical countermeasures such as diagnostics and vaccines."*

A complaint filed at the International Criminal Court in The Hague addressed the strange stance of the world's governments and their lockstep application of mask mandates:

*The World Health Organisation (WHO) has admitted that there is no evidence available on the usefulness of masks to protect non-sick individuals. In addition to hypoxia and hypercapnia, breathing*

*through facemask residues bacterial and germ components on the inner and outside layer of the facemask. These toxic components are repeatedly breathed back into the body, causing self-contamination. Breathing through facemasks also increases temperature and humidity in the space between the mouth and the mask, resulting in a release of toxic particles from the mask's materials. - for riding or going abroad in the night, or riding horses in the day time, without leave, a slave may be whipped, cropped, or branded in the cheek with the letter R, or otherwise punished, not extending to life, or so as to render him unfit for labor.

### Drug experiments increase in prisons

WASHINGTON, D.C.—A prison advertisement reads: "Would you like to be transferred to a minimum security prison where you would have a private room ... television, access to our own stereo, better food ... as well as have an opportunity to make \$30 dollars a month just for getting high on heroin, amphetamine and morphine?"

ACCORDING TO the Federal Prisoners' Coalition such advertisement has allegedly been distributed at the maximum security facilities in Atlanta and Leavenworth. The "minimum" security facilities for prisoner transfer, the FPC states, are the National Institute of Mental Health Addiction Research Centers around the country. The specific advertisement suggested the NIMH unit at Lexington, Kentucky.

This, according to the Clearinghouse to End Medical Experimentation on Prisoners, reflects the current state of government-backed experimentation at prison

illegal experiments, while at the same time serves the aims of the government. DESPITE ACTIVITIES ranging from psycho-surgery

to chemical brain alterations, Dr. Bertram Brown, director of the NIMH recently announced his support of continued "behavior modification" programs. Dr. Brown boasted that the programs have proved a "marked success" in helping many people lead more normal lives.

He acknowledged that as many as 3,000 psychotherapists are conducting ongoing experimentations on as many as 60,000 subjects in hospitals, schools and prisons.

Dr. Brown added that the NIMH intended to finance \$2 million worth of research this year, and another \$1 million will be financed by the federal Alcohol and Drug Abuse Agency. His statement was issued following an NIMH "white paper" on behavior modification which by-and-large absolved the agency of any unethical motivation.

#### PERHAPS THE STRONG-

EST statement of concern in the paper was an acknowledgment that "behavior modification programs have, in some places

been designed to preserve authoritarian control and discipline, rather than to teach skills that would benefit the prisoners, once they are released.

"It is not clear whether prisoners are ever able to be true volunteers in any experimental program held in prison," the report said. It noted that the Bureau of Prisons (BP) and the Law Enforcement Assistance Administration (LEAA) last year halted such programs because of legal uncertainties.

Nevertheless, brainwashing, chemical experimentation and other forms of mental seduction is prevalent, and prisoners are still a favorite target. At the Jessup Prison in Maryland, the University of Maryland still maintains a research facility for testing vaccines for infectious diseases such as Cholera, typhoid, influenzas, and malaria — the financial incentive being \$2.00 per day.

"Actually the doctors pay \$10.00 a day per inmate but \$8.00 goes to the prison administration..." clearing-house sources state.

### Vax Inventor Says Don’t Take It

**Dr. Robert Malone**, the scientist that invented the mRNA platform used to create the toxic “jab,” had sobering words for an audience of thousands at a Los Angeles “Defeat the Mandates” rally:

“...Evil has many roots. A willingness to deny human dignity is one of the largest. In our hearts, and in our souls, we all know this is true.



### Depopulators Attack Children with Dangerous “Vaccines”

There is no COVID emergency for children under five years old. Children under 18 years old have a 99.995% recovery rate, and a body of medical literature indicates that almost zero healthy children under five years old have died from COVID.

A large study conducted in Germany showed zero deaths for children under 5 and a case fatality rate of three out of a million in children without comorbidities.

A Johns Hopkins study monitoring 48,000 children diagnosed with COVID showed a zero mortality rate in children under 18 without comorbidities.

A study in *Nature* demonstrated that children under the age of 18 with no comorbidities have virtually no risk of death.

Data from England and Wales, published by the UK Office of National Statistics on January 17, 2022, revealed that throughout 2020 and 2021, only one (1) child under the age of 5, without comorbidities, had died from COVID in the two countries, whose total population is 60 million.

Another study suggests children’s bodies clear the virus more easily than adults. This study, published in December in *Nature*, demonstrated how children efficiently mount an effective, robust, and sustained immune response.

### Tennis world stunned after 15 “fully vaccinated” players quit Miami Open

The tennis world is shocked after favorites **Paula Badosa** and **Jannik Sinner** both retired from their Miami Open quarter-finals on the same day.
