CDC ADMITS ERRORS IN COVID-19 DEATHS

For the past two years, I and many others have detailed the ways in which COVID-19 deaths have been overcounted to create the illusion of the pandemic being far worse than it actually is.

Now, the U.S. Centers for Disease Control and Prevention and individual states are backtracking on their death statistics, showing we were right all along. Deaths were initially exaggerated for political purposes, and now they’re being downplayed for the same reason.

CDC Removes More Than 72,000 COVID Deaths

As reported by The Defender, March 14, 2022, the CDC had removed 72,277 “COVID deaths” from the tally, including 24% of those attributed to children under 18. They claim a “coding logic error,” a faulty algorithm, had “accidentally” counted deaths that weren’t related to COVID. As reported by Udumbara: “Some of the pediatric deaths attributed to COVID-19, according to a search of the CDC’s Wonder system, include deaths where drowning or drug use was listed as the primary cause of death.”

Meanwhile, the CDC used the false death statistics among children to push for COVID shots for 5- to 7-year-olds. In November 2021, CDC director Rochelle

Walensky cited that data to justify the recommendation to issue emergency use authorization for the Pfizer shot for this age group.

Somehow, we’re supposed to believe that it took the CDC two years to realize this error. It’s simply not believable, and The Epoch Times has filed a Freedom of Information Act request for internal communications relating to the data change.

Ironically, the adjustment comes on the heels of fact-checking articles “debunking” claims that COVID deaths have been overcounted. For example, in early March, Health Feedback claimed there’s “no evidence COVID deaths have been overcounted,” and that “the evidence suggests the opposite.”

Yet here we are. Deaths were clearly overcounted, not undercounted. That fact check didn’t age well.

CDC Has Been Turned Into a Propaganda Agency

According to Dr. Meryl Nass, a member of the Children’s Health Defense scientific advisory committee, the CDC is cherry-picking data to justify its public health policies, and when it gets caught, it simply blames its “outdated IT systems.” In a March 19, 2022, article, she wrote:

“CDC is not a public health agency. It is a public propaganda agency that collects a massive amount of data. CDC marshals its huge data library to create presentations that support the current administration’s public health policies ...

A 2007 Senate oversight report on the CDC noted the agency spent \$106 million on the Thomas R. Harkin Global Communications (and Visitor) Center, and summarized its 115-page report with the following:

‘A review of how an agency tasked with fighting and preventing disease has spent hundreds of millions of tax dollars for failed prevention efforts, international junkets, and lavish facilities, but cannot demonstrate it is controlling disease.’”

Health Officials End Reporting COVID-19 Deaths

Curiously, three months before the CDC started changing its mortality statistics, the U.S. Health and Human Services stopped collecting data on hospitalizations and deaths from COVID-19 altogether. The HHS announced changes to the reporting requirements for hospitals and acute care facilities January 6, 2022. The new guidelines, which took effect February 2, note “The retirement of fields which are no longer required to be reported,” which include the “previous day’s COVID-19 deaths.”

What are they trying to hide? Are they stopping the flow of data to prevent examination and analysis? According to some, the HHS hospital data are among the best we have in the U.S., so ending that data collection doesn’t make sense. January 2021, Alex C. Madrigal, co-founder of the COVID Tracking Project, wrote:

“In a series of analyses that we ran over the past several months, we came to nearly the opposite conclusion of other media outlets. The hospitalization data coming out of HHS are now the best and most granular publicly available data on the pandemic.”

An unnamed federal health official spoke with a reporter from WSWS, calling the move to stop reporting COVID-29 hospital deaths “incomprehensible.” The official added:

“It is the only consistent, reliable and actionable dataset at the federal level. Ninety-nine percent of hospitals report 100% of the data every day. I don’t know any scientists who want to have less data.”

Changing Definitions Justify the COVID Narrative

From the start of the pandemic, changing definitions have allowed authorities to manipulate data in what-

ever way they needed. Now, states are starting to change the way they define a “COVID death,” resulting in lowered mortality rates. In Massachusetts, for example, COVID deaths dropped by 3,700 after the state changed its definition to be in alignment with that of the Council of State and Territorial Epidemiologists.

As reported by CBS Boston:

“The state said currently the COVID death definition includes anyone who has the disease listed as a cause of death on their death certificate. It also includes anyone who had a diagnosis within 60 days but did not have it listed as a cause on their death certificate. Under the new definition, the timeframe is changed to 30 days for people without a COVID diagnosis on their death certificate.”

For the record, counting someone who died of any cause as a COVID death simply because they tested positive within 30 days of their death is still a grossly inaccurate way of determining the true death toll from this virus, because we know PCR tests have a false positive rate of about 97% when run at 35 cycles or greater, as was the norm from the start.

Results From At-Home Tests Aren't Reported

Case counts are also being adjusted downward. In mid-January 2022, the Biden administration started distributing half a billion at-home COVID tests to the American public, and the results from those are not being reported anywhere.

As a result, case counts will be skewed downward. According to 13NewsNow:

“... the fallibility of case counts is the reason health officials track several COVID-19 metrics, like hospitalizations, deaths, and now, even viral samples in the wastewater—metrics that do not necessarily rely on people to go get tested or report the results they get at home.”

And yet the HHS is no longer requiring hospitals to report COVID deaths, which is one of the metrics health officials are supposedly focusing on in lieu of tracking cases. Don't get me wrong, PCR testing was a scam from the start and I'm not suggesting we should pay much attention to those data. The point here is that the tracking of COVID data has been fatally flawed from the start.

What they're really trying to do is shift toward passive monitoring, starting with wastewater sampling.

Eventually, the goal is to monitor every person's biological processes in real-time, and this is part and parcel of the transhumanist Fourth Industrial Revolution and The Great Reset.

CDC Hides Data

To make matters even murkier, the CDC is also hiding data on COVID hospitalizations and the COVID jab. The stated justification for not making certain data public is that people are “misinterpreting” the data. In other words, the data show that the COVID jabs don't work, and the CDC doesn't want that to be widely known.

It has also collected data on the effectiveness of COVID-19 boosters, but for some reason has not included the data for 18- to 49-year-olds in any of its publications. “Coincidentally,” this is “the group least likely to benefit from extra shots,” the Times pointed out, adding:

“Much of the withheld information could help state and local health officials better target their efforts to bring the virus under control. Detailed, timely data on hospitalizations by age and race would help health officials identify and help the populations at highest risk. Information on hospitalizations and death by age and vaccination status would have helped inform whether healthy adults needed booster shots.”



COVID Has Served a Purely Political Agenda

Over the past two years, the pandemic has been used to usher in a range of radical changes that would never have been accepted were it not for widespread panic. It was used to implement illegitimate voting rules, which appear to have had an impact on the 2020 elections.

It was used to announce the urgent need for a “Great Reset” and a Fourth Industrial Revolution. It's been used to strip people of basic human rights, and to justify radical environmental policies that will result in lower standards of living.

It was also used to abruptly transition the vaccine industry from conventional vaccine manufacturing using eggs to the use of risky gene transfer technology. The only thing the pandemic has not been used for is to make recommendations that actually improve public health. And throughout, data have been massaged and manipulated to justify the unjustifiable.

Now, it appears data are being manipu-

lated yet again—this time to artificially end the COVID crisis so that the Biden administration can take credit for it during the upcoming elections. As stated in a February 24, 2022, letter from Impact Research, titled “Taking the Win Over COVID-19”:

“It's time for Democrats to take credit for ending the COVID crisis phase of the COVID war; point to important victories like vaccine distribution and providing economic stability for Americans, and fully enter the rebuilding phase that comes after any war. Below we lay out some strategic thoughts for Democrats positioning themselves on COVID-19 ...”

Strategic positioning includes declaring the crisis phase over; pushing for “feeling and acting more normal,” and taking the side of people who are burned out on COVID and don't want to hear about it anymore. Not setting a standard of zero COVID as the “victory condition,” and to “stop talking about restrictions and the unknown future ahead.”

“If Democrats continue to hold a posture that prioritizes COVID precautions over learning how to live in a world where COVID exists, but does not dominate, they risk paying dearly for it in November,” the letter states.

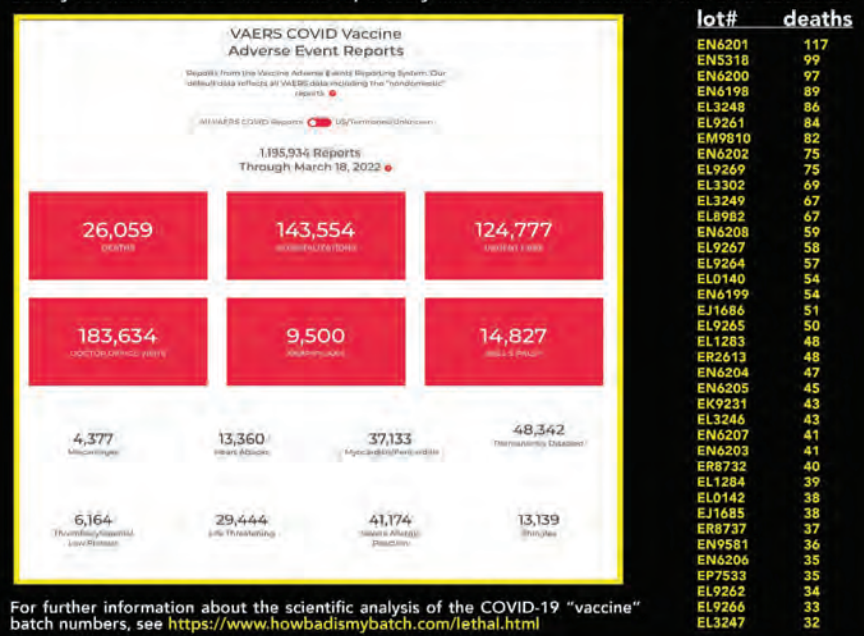
Dr. Anthony Fauci perhaps did not receive this memo, as he is out there signaling that we can expect a return to COVID restrictions at any given point. The COVID-19 VACCINE: "We Have No RIGHT to Trust Them."

Gov't COVID funding helped Black colleges survive the pandemic.

Historically Black colleges and universities (HBCUs) have been vaccine cheerleaders, and to this day many of their campuses have dutifully followed the disastrous lockdown policies and anti-science vaccine and mask mandates. HBCUs were given nearly \$3 billion under the American Rescue Plan, Pres. Joseph Biden's sweeping COVID-19 relief package.

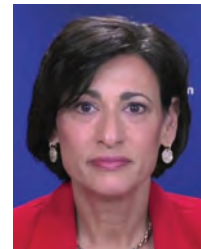
"We have a number of students that have food and housing insecurity," he said. "So you can be at home with unreliable internet access, with food housing insecurity, or you could be on campus where we could provide everybody for the most part with a single room and you got food access, and you got access to both WiFi and Ethernet. That was a better deal for everybody."

More than 4 out of 5 college and university presidents (81%) polled agreed on some level that government funds allowed their institutions to keep tuition at pre-pandemic levels.

The HBCU administrators seem oblivious to the well-established dangers of the vaccine and exhibit a naive faith and dependence on a government with a record of medical racial mayhem.

CDC Chief Walensky admits she learned about COVID vaccine through CNN

Who is actually running the depop plot at the CDC? Turns out it is the Pharma-bought pandemic panic pushers at **Jeff Zucker's CNN**. Center for Disease Control & Prevention director **Dr. Rochelle Walensky** was asked how the agency could have improved over the past two years. Her answer is stunning: "Um...well, you know I think...*I can tell you where I was when the CNN feed came that it was 95 percent effective*...um the vaccine. So many of us wanted to be hopeful. So many of us wanted to say, 'Okay, this is our ticket out, right, now we're done.'"



"Um, so I think we have perhaps too little caution and too much optimism, um, for some good things that came our way...I really do," Walensky continued. "I think all of us wanted this to be done. Nobody said 'waning' when when you know this vaccine's gonna work, oh well, maybe it'll work, it'll wear off. Nobody said, 'Well what if the next variant doesn't, it doesn't, it's not as potent against the next variant.'"

Incredibly, this unscientific gibberish comes from the leader of the agency that the White House and Congress rely on to imposed lockdowns and vaccine and mask mandates, among a long list of harmful and unlawful edicts.

Have COVID Deaths Been Overcounted?

In late August 2020, the CDC published data showing only 6% of the total death count had "COVID-19" listed as the sole cause of death. The remaining 94% had an average of 2.6 comorbidities or preexisting health conditions that contributed to their deaths.

Through a series of COVID funding schemes hospitals were financially incentivized to overcount COVID cases and deaths. And yet there are many examples of people who died from other causes—like motorcycle accidents and gunshot wounds—who were counted as COVID deaths simply because they had a positive COVID test within a month of their death, or tested positive post-mortem.

In one egregious example, Lucais Reilly shot his wife in the head, and then turned the gun on himself, committing suicide on Thanksgiving 2020. The very next day—and before the coroner had even signed the death certificates—these fatalities showed up on the Colorado state website as "COVID" deaths. Nowhere on the death certificates does it say "COVID."

A disturbing study at **Brown University** shows scores in three key cognitive tests slumped between 2018 and 2021, with face mask rules among the likely culprits. Scientists collected data from 1,600 children and analyzed the cognitive development of the youngsters through infancy, childhood, and adolescence; they looked at how average development scores in three key areas had been affected during the COVID era—with shocking results. **Researchers found that there was a 23 per cent drop in scores measuring children's intelligence quotients since the start of the “pandemic.”**

The study also found similar regression in the same span in regard to developing children's ability to communicate, both verbally and through subtle facial cues.

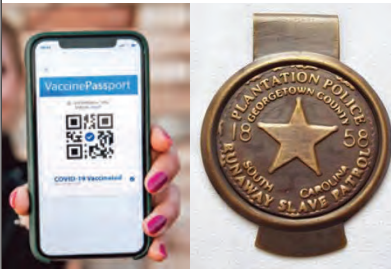
The study's findings come as parents across the globe grapple with the idea that wearing masks may interfere with the natural learning experiences and communication skills of their young children.

The study concluded that “children born during the pandemic have significantly reduced verbal, motor, and overall cognitive performance compared to children born pre-pandemic....In addition, masks worn in public settings and in school or daycare settings may impact a range of early developing skills, such as attachment, facial processing, and socioemotional processing.”

Further, the study's authors said that boys from poor backgrounds were most at risk of a drop in cognitive testing scores, with richer parents better able to mitigate the effects of the pandemic. They explained: “Comparing yearly mean scores since 2011, controlling for age, gender, demographic, and socioeconomic indicators, we find striking evidence of declining overall cognitive functioning in children beginning in 2020 and continuing through 2021....We find that males appear significantly more impacted than females, and that higher socioeconomic status (SES, as measured by maternal education) helps buffer against this negative impact.”

“There are sensitive periods in early childhood development in which language development and emotional development are really rapidly developing for the first few years of life,” said Dr. Ashley Ruba, a postdoctoral researcher in the University of Wisconsin-Madison's Child Emotion Lab. She added that developing children need to see others' subtle verbal or facial cues to accurately discern how someone is feeling—a skill that proves paramount as the youngsters age.”

His master saw the advertisement and sent for him; when he was brought back, his wrists were tied together and drawn over his knees. A stick was then passed over his arms and under his knees, and he secured in this manner, his trowsers were then stripped down, and he turned over on his side, and severely beaten with the paddle, then turned over and severely beaten on the other side, and then turned back again, and tortured by another bruising and beating. He was afterwards kept in the stocks a week, and whipped every morning.

“PLEASE warn every person not to go near [the COVID] vaccines. “Human beings crave coherence. And so if you can put them in a state of incoherence they will literally do anything they can to get back to coherence. It's a typical torture tactic. ‘If you just do what I want, I will allow you to go back to a state of coherence.’ So, if you just accept the [vaccine] passports, you'll be free. Or if you get the vaccination, you'll just be free.”

“Further, by declaring small businesses as ‘non-essential’ during lockdowns, they get shut down, while Amazon, Walmart and other big box stores can take over their market share. A major transfer of wealth occurred away from small family-owned businesses to very large, publicly owned businesses that benefited from the digital economy. The people on Main St. have to keep paying off their credit cards or their mortgage, so they're in a debt trap and they're desperate to get cashflow to cover their debts and expenses.”

“If a few people want to control many, how can you get the sheep into the slaughterhouse without them realizing and resisting? The perfect thing is invisible enemies, like viruses. This ramps up fear so the public believes they need the government to protect them.”

“What COVID-19 is is the institution of controls necessary to convert the planet from the democratic process to technocracy. So what we're watching is a change in control and an engineering of new control systems. So think of this as a coup d'état. It's much more like a coup d'état than a virus.”
