

# 'Licensed To Kill': Vaccine Manufacturers Must Be Made Liable Again For Their Deadly Product

It will be interesting to see if the Big Pharma-owned U.S. Congress accepts this simple solution to stop these deadly vaccine mandates. The question must be asked, *“Why is the government encouraging and protecting vaccine manufacturers to inject our children with poisonous inoculants?”* Supposedly, pharmaceutical companies are required to provide data proving the safety of their vaccines. However, Robert F. Kennedy, Jr. following in the footsteps of his uncle, Senator Edward Kennedy, found out otherwise. On page 201 of Judy Mikovits’

book *“Plague of Corruption”*: she writes, *“Kennedy recently got an admission from the federal government that despite the requirements of the 1986 National Childhood Vaccine Injury Act that a report must be provided to Congress every two years certifying that the vaccines schedule is safe, no such studies have EVER been done.”*

time period the diagnosis of Autism has skyrocketed from 1 in every 10,000 in 1970 to 1 in every 44 in 2021.


If the U.S. government is not trying to protect our children, what is its goal of injecting all of them with these inoculants called “vaccines”? What is the “threat” or “disease” it is worried about? In 2005 the government found an excuse to indemnify the vaccine companies even more. Congress enacted the 2005 PREP Act after the SARS and avian influenza outbreaks to encourage “efficiency and expediency” in responding to public health emergencies by providing “liability immunity” to “covered persons” assisting with “covered countermeasures.” The PREP Act gives the Health and Human Services Department (HHS) wide authority to lead responses to public health emergencies.

Namely, it authorizes the Secretary of HHS to determine diseases, threats, and conditions that constitute a **public health emergency**, when and for how long immunity will remain effective.

Senator Edward Kennedy immediately saw that too much power was being given to the Secretary of the HHS and thereby the Executive branch of government. Kennedy said the bill makes it **“essentially impossible”** for injured parties to sue for damages, and that the measure allows **common diseases** to be used as a reason to activate the **liability shield**.

Kennedy’s warning came true on March 17, 2020, when the HHS secretary issued a declaration to apply the PREP Act to the COVID-19 pandemic. Even now, as the pandemic is being relabeled an “endemic,” the HHS secretary has not removed the protection from the drug companies from lawsuits due to death or injuries to their victims. Right now, the government acknowledges reports at least 27,000 deaths and one million (1,000,000) reports of serious injuries after receiving these so-called “vaccines.”

Dr. Robert Malone is the inventor of the mRNA technology that is used in the development of the COVID-19 “vaccines.” After an initial deep dive into the emerging data on COVID-19, he and his wife Jill published a book,



“How to prepare and protect from the Novel Coronavirus,” on February 11, 2020. The book was sort of a survival manual for those at risk and was self-published via Amazon.

Royalties hit approximately \$1,700.00 after just one month of sales, but on March 10, 2020, they were notified by Amazon that their book would no longer be published. They were later told that their book did not meet “community standards.” And at that moment, he writes, “we knew that something very dark was happening, something we had never seen before. Little did we realize that this was just a very early example of what was to become a large movement over the next two years, a global movement involving collusion between government, legacy media, social media, big technology, big finance and non-governmental organizations to completely control and shape all information and thought concerning the public health response to the novel coronavirus.”

In recent articles in The Final Call newspaper, we have investigated the philosophies and goals of the World Economic Forum which was founded in 1971 by Klaus Schwab. 

## Triple Jabbed up to 5 times more likely to be infected with Covid-19 than the Unvaccinated

Official data published by the UK Health Security Agency confirm Covid-19 “vaccine” effectiveness against infection has fallen to minus-391% among triple jabbed 60- to 69-year-olds, and between minus-298% and minus-324% among those aged 30 to 59.

All other age groups have also suffered a significant drop in vaccine effectiveness, with figures showing all triple-vaccinated adults now between 3 and 5 times more likely to be infected with Covid-19 than unvaccinated adults.

According to the U.K.’s *Daily Expose*, “The figures show that the case-rates are highest among the triple vaccinated in all age groups. But not just by a little bit, instead by a million miles. And the gap between the unvaccinated and triple vaccinated has been getting worse by the month. Therefore, these figures indicate the COVID-19 injections make recipients more likely to be infected with COVID-19 than the unvaccinated population.

“These figures show that 60-69-year-olds are nearly 5 times more likely to be infected with Covid-19 than unvaccinated 60-69-year-olds, and show that 40-59 and 70-79-year-olds are over 4 times more likely to be infected with Covid-19 than their unvaccinated counterparts.



## Teenager Deaths Increased ‘Significantly’ in Summer of 2021

Attorney Robert F. Kennedy, Jr. reports in his book *The Real Anthony Fauci*:

*Troubling statistics from Britain’s Office for National Statistics (ONS) verify the expected: deaths among teenagers during the summer of 2021 increased significantly over the previous year, coinciding with the vaccine rollout. According to an analysis by The Exposé’s Will Jones, between weeks 23 and 37 in 2021—simultaneous with the vaccine rollout—there were 252 deaths among 15- to 19-year-olds in England and Wales, compared to 162 in the same period in 2020, an increase of ninety, or 56 percent—a very high number that deserves some kind of explanation. Importantly, there is no similar rise among younger children aged one to fourteen, a cohort that was not vaccinated. Instead, 2020 was a low-mortality year for this age group. COVID cannot be*

*blamed for the sudden rise in deaths among 15- to 19-year-olds in summer 2021, as the Office of National Statistics (ONS) data shows that over the period, there were only nine deaths with COVID in that age group. This real-world evidence suggests that over the summer, the vaccines killed nine times as many 15- to 19-year-olds as COVID did—eighty-one versus nine.*



## Study Shows People Have Mask Microplastics In Their Lungs

Surgical masks forced onto the public by depopulation officials could have a far unhealthier effect than previously thought. Billions of people strapped polypropylene masks to their faces every day for two years and sucked their air through plastic fibers for eight hours or more. According to a new study published in the *Science of the Total Environment*, microplastics commonly used in surgical masks have been discovered deep in the lungs of most people, suggesting inhalation as the probable cause.

According to the study, this is the first time microplastics have been found in human lung tissue samples significantly above what is considered “normal” in this polluted world. In 2020, the amount of disposable face masks littered into the environment increased by a staggering 9000 percent. The longterm implications for microplastics in the lungs are unknown, but depopulation officials continue to require children to wear masks for school attendance.


## Studies Show Surgical Masks Don’t Even Work for Surgeons

Dr. Manal Mohammed is a Senior Lecturer of Microbiology at University of Westminster focusing on infectious diseases, prevention and treatment.

She studied the effectiveness of surgical masks in stopping flu viruses. Dr. Mohammed writes that “The logic of wearing a surgical mask must surely be: if it works for surgeons, it must work for me. The problem is, the mask isn’t intended to protect the surgeon. It’s intended to stop droplets from



the surgeon’s mouth or nose getting into the patient’s wound and causing sepsis. **But despite their use for more than a century, their prophylactic effectiveness is in doubt.** Indeed, a recent study showed that surgical masks can be a source of bacterial contamination in the operating theatre. Although they are designed to trap bacteria shed by the surgeon’s nose and mouth,



the study found bacteria on the exterior of used masks.”

Dr. Mohammed writes that there is a 2009 study that is often cited as evidence that surgical masks work that compared surgical masks with a specialist mask called an N95 respirator—a mask that fits snugly and filters at least 95% of very small (0.3 micron) particles. The study, published in JAMA,

found that both surgical masks and N95 respirators were about equally effective at preventing the flu, “which is to say, not all that effective,” writes Dr. Mohammed:

“because, of the 446 nurses who took part in this study, nearly one in four (24%) in the surgical mask group still got the flu as did 23% of those who wore the N95. And, because both groups wore masks, it’s impossible to say how they would have fared compared with not wearing a mask at all. Basically, there is no strong evidence to support well people wearing surgical masks in public.”

## American History of Medical Racism & Savagery



Dr. Jonas Salk is considered a “hero” in the medical world; he received multiple honors including the Presidential Medal of Freedom in 1977. But it has now come to light that Dr. Salk conducted Nazi-like experiments on disabled Americans before developing his famous polio vaccine.

Salk vaccinated 8,000 patients at two mental institutions in Michigan. He infected them with wild influenza virus made from dried, infected mouse tissue. 
