To the vast majority of people who are not engaged in a thorough examination and analysis of the “news,” it is just a string of unrelated and confusing incidents. We must analyze what we see and hear through the lens of the Teachings of the Honorable Elijah Muhammad under the Guidance and Direction of the Honorable Minister Louis Farrakhan. This writer brings 27 years of experience as Manager of Muhammad Farms and 24 years in the trenches with the Black Farmers in the struggles with the U.S. Department of Agriculture, to assist in connecting the dots.

Much of the continuing increase in food prices will be fueled by skyrocketing fertilizer costs, forcing farmers to use less, thereby reducing yields. The expected increase in nitrogen fertilizer prices will

be added to an almost four-fold increase: from September of 2020 it jumped from \$420 per ton to \$1,516 per ton in September of 2021, and this was before the Russian/Ukraine war. A long-term research project conducted by Iowa State University demonstrated that corn yields will average only about 60 bu/acre in a continuous corn production system but providing adequate nitrogen increased yields to over 200 bu/acre. So, one can see the tremendous reduction in corn production without the use of nitrogen fertilizers.

Proponents of industrial agriculture say chemical fertilizers are necessary to harvest large yields and feed a growing global population. However, most of the corn crop in America is not used to feed people, but to feed the cattle that are consumed by people.

American farmers each year plant and harvest about 90,000,000 acres of corn. About 50% of the corn is used for feed grain and 30% for ethanol production. Corn is the primary feed grain in the United States, accounting for more than 90 percent of total feed grain production and use. At any given time, there are about 14 million head of cattle in 26,586 feedlots being fed corn to fatten them up for the slaughter. These animals have been taken off the land and put on concrete, so now we have a lot of animal manure in confined spaces instead of being spread out over the land to

fertilize the soil naturally.

Modern industrial agriculture has caused a **great imbalance**. Animals that naturally fertilize the soil have been taken off the land. Now, synthetic fertilizers are used to feed the soil with yield-increasing chemicals which destroy the natural life of soil organisms. Finally, the white man is seeing the light to a degree and is experimenting with “**biodynamic farming**” and “**regenerative agriculture**” ... These terms describe a system where the farm as a whole is basically viewed as one organism, with each part supports the whole. Livestock have their role, as do microorganisms, beneficial insects and worms.

*“Biodynamic farming is really about being a part of nature and working with it rather than trying to conquer nature through unnatural and ultimately destructive means.”*

A number of years ago I attended a “*biodynamic farming*” conference in upstate New York. After attending a few workshops, I asked one of the presenters how to control weeds “*biodynamically*.” This so-called “expert” responded to my question with a question: “*Don’t you know some older Black farmers in the South?*” I paid all that money for them to tell me to go back to my Roots to find

the answer. Black farmers were practicing “*biodynamic*” or “*regenerative agriculture*”—which is simply cooperating with Nature—all along. It was only after they were tricked and pressured by the USDA

into joining the new “industrial farming” revolution after WWII, that they learned to depend on synthetic fertilizers, pesticides and herbicides made from petroleum.

The nitrogen fertilizer industry was built up after WWII to utilize the production capacity of the bomb making ammonium nitrate factories. The bomb manufacturing plants were repurposed to make nitrogen fertilizers, then promoted to the farmers with your tax money by the USDA. The USDA loaned white farmers money to get into “industrial farming” where they used the value of the equipment they bought and the value of their expected crops as **collateral**. Black farmers, however, in order to get the same type of loans, had to put up their **land as collateral**. We know now that it was all a wicked scheme by the U.S. Government to take away the 16 million acres of farmland owned by 893,270 Black farmers in 1910. Today we are down to 18,451 Black farmers owning 4.7 million acres of land.

In 1910, the average black farm consisted of 18 acres, compared to white farms averaging over 138 acres. Black farmers were fighting to keep their families alive, because after the end of chattel slavery, whites kicked them off the plantation, declaring them “untouchables.”

In 1896, Frederick L. Hoffman, a mathematical genius, studied the comparative death rates of Black people and white people. He discovered that

Blacks were dying at a much faster rate than whites. He convinced American politicians that if the government would actively **deprive** Black people of healthcare, it would solve the “**race problem**.” Just let the former slave population die in the Wilderness of North America. He predicted that, although there were 7.5 million Black people in the U.S. in 1890, in **two generations** they would die off.

Obviously that plan did not work. By 1910 despite the vile racism pervasive throughout America, the Black population increased to 9.8 million. The people who built America on their backs found a way to feed, clothe, house and provide healthcare for themselves. In fact, by 1910, they had not only bought 16 million acres of land, they had established over 60 towns and set up 7 medical schools. By 1923 they had 200 hospitals. The U.S. government had to intensify its Depopulation Agenda.

Is the looming famine in 2022 just a series of mistakes or part of a long-term genocidal plan to get people off the land and into the cities to be poisoned and starved? Between 1950 and 2005, the percentage of the world’s inhabitants living in urban areas increased from 29 percent to 49 percent (United Nations 2006 report). **In North America, 81 percent of the people live in cities.** But guess who has the resources and

the plan to make sure the overwhelming urban population is fed? Mr. Bill Gates is the largest individual owner of farmland in America. Mr. Gates and the U.S. Department of Defense are funding research with the intent to develop viruses to put into insects. Infected insects will be placed in fields of crops where they will alter the DNA of the crops, making them into “Edible Vaccines.” **We must remember that Bill Gates, the international spokesperson and one of the world’s largest investors in mRNA technology, is on record declaring that “vaccines” could help reduce the world population by at least 15%.**

## CDC Tracked Millions of Phones to See If Americans Followed COVID Lockdown Orders

Newly released documents show the CDC tracked tens of millions of phones in the USA to monitor compliance with curfews, and track patterns of people visiting schools, the Navajo Nation, and counts visits to pharmacies "for vaccine monitoring."

The documents reveal that the CDC paid \$420,000 to the cellphone data broker **SafeGraph**. The technology news website **Motherboard** obtained the documents through a **Freedom of Information Act** (FOIA) request with the CDC.

The documents contain a long list of how the CDC intends to use the cellphone tracking data. This includes monitoring "visits to parks, gyms, or weight management businesses."

Evidence also emerged recently that the **CIA** was spying not on suspected terrorists but on ordinary Americans, as the **ACLU** noted: "This surveillance is done without any court approval, and with few, if any, safeguards imposed by Congress to protect our civil liberties." They concluded: "These reports raise serious questions about what information of ours the CIA is vacuuming up in bulk and how the agency exploits that information to spy on Americans. This invasion of our privacy must stop." Clearly, the CDC is part of the larger depopulation objective, yet poses as a watchdog of our health.



## How COVID Kicked Our Asch: This Scary Experiment Explains Mass Acceptance of Pure Evil

**Robert S. McNamara was president of the World Bank and US Secretary of Defense under Presidents Kennedy and Johnson. He played a major role in escalating the US involvement in the Vietnam War.**

"Short of thermonuclear war itself, population growth is the gravest issue the world faces over the decades immediately ahead.

## Pilots Injured by "Vaccines" Speak Out

Pilots injured by "COVID-19 vaccines" are now speaking out against vaccine mandates despite a "culture of fear and intimidation." The **Children's Health Defense** reports that a growing number of pilots are coming forward to share stories of injuries they experienced after getting a COVID-19 injection. The **U.S. Freedom Flyers** ([www.usff-shop.com](http://www.usff-shop.com)) is an organization opposing vaccine and mask mandates for pilots and airline staff, and they have launched a series of legal actions against the **U.S. Federal Aviation Administration** (FAA) and several airlines.

Its co-founder, Josh Yoder, a pilot with a major commercial airline and an Army combat veteran, reported that he "has received hundreds of phone calls from airline employees who are experiencing adverse reactions post COVID-19 vaccination." He says that their actions have led to an increasing number of pilots "coming forward to expose the truth regarding these toxic injections."

### Doctor Warns of COVID “Vaccine” Side Effects on Pregnant Women

**Dr. Christiane Northrup** is the board-certified obstetrician-gynecologist with more than 30 years of experience who became widely known through her multiple guest appearances on the **Oprah Winfrey Show** and her **PBS** specials. She told *The Epoch Times* how women were being affected by the COVID “vaccines”:

*“Women are having bleedings. The doctors in our area are doing hysterectomies in young women, like 30-somethings; they said, ‘Oh, it’s not unusual.’ Let me tell you, as a board-certified gynecologist, that’s very unusual. Women’s periods are messed up all over the place....I’ve had a huge Facebook group of thousands of women talking about this situation that was removed.”*

*“My profession is famous for embracing treatments that later on turn into disasters: For example the drug **thalidomide** that results in limb effects in hundreds of babies, the **Dalkon Shield IUD** that was touted as the birth control method of choice for women who had never had children—and then made hundreds of them sterile from infection. And of course, there is **DES** that was given to thousands of women for nausea of pregnancy—and results in reproductive abnormalities in both male and female offspring, including sterility,” Dr. Northrup said.*



Dr. James Thorp

**D**r. James Thorp is a board-certified obstetrician/gynecologist who has practiced for over 42 years. He told *The Epoch Times* that he sees 6,000–7,000 high-risk pregnant patients a year and has seen many complications among them because of the COVID injections.

“I’ve seen many, many, many complications in pregnant women, in moms and in fetuses, in children, offspring,” Thorp said, “fetal death, miscarriage, death of the fetus inside the mom.... What I’ve seen in the last two years is unprecedented,” Dr. Thorp asserted.

Dr. Thorp explained attempts to quantify this effect are hampered by the imposition of gag orders on physicians and nurses that were imposed in September 2021. These unprecedented gag orders are outlined in the newly released publication **“Patient Betrayal: The Corruption of Healthcare, Informed Consent and the Physician-Patient Relationship.”**

Dr. Thorp’s experience with his pregnant patients is consistent with internal **Pfizer** documents that were released by court order. The documents say that there were 274 pregnancy adverse events—many of them considered “serious”—which occurred in the vaccinated mothers. Among the pregnancy-related side effects were miscarriages, rupture of membranes, and fetal deaths.

Consistent with depopulation policy, the **CDC** website recommends the “COVID-19 vaccines” during pregnancy in order to “prevent severe illness and death in pregnant women.” And the **American College of Obstetricians and Gynecologists (ACOG)** also “strongly recommends that pregnant individuals be vaccinated against COVID-19,” adding that pregnant women’s complete vaccination should be a “priority.”

### Walgreens: “Vaccinated” Most Likely to Test Positive

**The HIGHWIRE** investigative journalist **Jefferey Taxen** detailed startling statistics from the Walgreens website: “This is Walgreens COVID-19 index. This is their tracker. They looked at the information that they received at their stores, and they created their own tracker, because I guess they didn’t want to wait for the CDC anymore.”

Walgreens has more than 9,000 stores in all 50 states and territories and has been a COVID-19 testing and injection site. Breaking down their most recent data showing **positive case rates by vaccination status**, shows all **vaccinated** groups show a higher positivity rate for “the virus” than the unvaccinated.

### Lockdown Damage Continues to Mount


**L**ockdown restrictions, including adults wearing face masks, has left a generation of babies and toddlers struggling with speech and social skills, according to an official report from the UK’s Education department.

Using evidence from almost 300 inspections in nurseries, schools and colleges, the education watchdog has highlighted how almost two years of disruption to learning, social distancing, and lockdown restrictions have negatively impacted young people’s communication and language development.

Some inspectors reported that babies are struggling to respond to basic facial expressions, while others noticed a delay in speech and language in toddlers.

Jaxen concludes, “So we’re seeing the booster shot is actually the highest COVID positivity rate of everybody in this Walgreens accounting for people who have come in for these tests.”
