"conspiracy theories." However, as long as white people in America thought that the 3 billion people that Henry Kissinger and his ilk wanted to be culled were the darker people of the world, they ignored Minister Farrakhan's warnings. Deaths, Injuries and Waning Efficacy: The Latest Bad News on COVID Vaccines

Children's Health Defense reports that "Considering the mounting evidence of adverse effects and lack of effectiveness, some physicians and health agencies are calling for the immediate withdrawal of the COVID-19 vaccines."

An astounding study published in *Scientific Reports* further revealed that calls to Israel's National Emergency Medical Services (EMS) for cardiac arrest and acute coronary syndrome increased more than 25% among 16- to 39-year-olds from January 2021 to May 2021, compared to the same time period in 2019 and 2020.

The U.S. Food and Drug Administration (FDA) and Pfizer attempted to hide COVID-19 shot clinical trial data for 75 years. Now that a lawsuit forced the FDA to release thousands of the documents, data about what they were trying to hide is coming out. Among the revelations is evidence that Pfizer deliberately excluded pregnant women from COVID-19 shot trials. So how did they make the recommendation that the shots are safe and effective for pregnant women? It was based on a 42-day study involving 44 rats.

According to investigative author Naomi Wolf: "It looks to me — this is not an overstatement from what I've seen — that this was a clinical trial that by August 2021, Pfizer and the FDA knew was failed; the vaccines were not safe and effective." They knew "[t]hat they weren't working. That the efficacy was waning ... and that they were seriously dangerous. And they rolled it out anyway."

Panel wrestles with judgment of Saenger

Between 1960 and 1972, Jewish doctor Eugene Saenger of the University of Cincinnati conducted Nazi-like radiation experiments on more than 200 cancer patients without their consent, 150 of whom were Black. He exposed each of them to the equivalent of 20,000 X-rays.



According to a journalist, "Saenger deliberately injected hundreds of people with potentially lethal doses of radiation, knowing that most of them would die rather quickly....At least 89 people are acknowledged to have died due to Saenger's treatment, although the number is likely well above 200."

Plandemic creates new billionaire every 30 hours — While Extreme Poverty Explodes

new Oxfam International study, "Profiting from Pain," calculates that for every new billionaire created during the plandemic—one every 30 hours—nearly a million people could be pushed into extreme poverty at the same rate. For the new billionaires, they write, "the pandemic and now the steep increases in food and energy prices have, simply put, been a bonanza for them. Meanwhile, decades of progress on extreme poverty are now in reverse and millions of people are facing impossible rises in the cost of simply staying alive."

573 people became new billionaires during the "pandemic," at the rate of one every 30 hours, while at the same time "We expect this year that 263 million more people will crash into extreme poverty, at a rate of a million people every 33 hours."

"The super-rich have rigged the system with impunity for decades and they are now reaping the benefits. They have seized a shocking amount of the world's wealth as a result of privatization and monopolies, gutting regulation and workers' rights while stashing their cash in tax havens—all with the complicity of governments," said Oxfam.

The world's ten richest men own more wealth than the bottom 40 percent of humanity, 3.1 billion people. The richest 20 billionaires are worth more than the entire GDP of Sub-Saharan Africa.

A worker in the bottom 50 percent would have to work for 112 years to earn what a person in the top 1 percent gets in a single year.

The "pandemic" has created 40 new pharma billionaires. Pharmaceutical corporations like **Moderna** and **Pfizer** are making a \$1,000 profit every second just from their monopoly control of the COVID-19 vaccine, despite its development having been supported by billions of dollars in public investments. They are charging governments up to 24 times more than the potential cost of generic production.

Moderna 'Throwing 30 Million Doses in the Garbage,' CEO Says

The CEO of Moderna, the makers of the toxic waste they call "vaccines," said the company is having to "throw away" millions of doses because "nobody wants them."

Stéphane Bancel made the comments at the World Economic Forum meeting in Davos, and noted his concerns

over the lack of people getting vaccinated and declining to get boosters.

"It's sad to say, I'm in the process of throwing 30 million doses in the garbage because nobody wants them. We have a big demand problem....We right now have governments—we tried to



contact...through the embassies in Washington. Every country and nobody wants to take them....The issue in many countries is that people don't want vaccines."

A string of European countries have found themselves stuck with vaccines that they simply cannot use because of a lack of demand, while their Ukraine war is depleting vaccine budgets. Those nations are now looking to renegotiate their vaccine contracts with suppliers that could grant them the right to "re-phase, suspend, or cancel altogether vaccine deliveries..."

Is Humanity being purposely poisoned as part of a Depopulation Agenda?

A ccording to **Mercola.com**, "In 1992, researchers published data showing the quality of sperm counts in men had been cut nearly in half over the previous 50 years. A 2017 systematic review confirmed this trend, showing a 50% to 60% drop in total sperm count among men in North America, Europe, Australia and New Zealand between 1973 and 2011.

"Testosterone has also declined in tandem with lower sperm counts, while miscarriage rates among women and erectile dysfunction among men have been steadily rising. We can rule out genetics as the cause, because the decline in sperm count is simply too rapid. That leaves us with environmental causes [that] can be broadly divided into two broad categories: lifestyle and chemicals."

Are Humans Going Extinct?

Dr. Shanna H. Swan, a leading environmental and reproductive epidemiologist, published the 2017 report showing a 50% to 60% drop in total sperm count. Dr. Swan refers to this shocking 39-year decline as "the 1% effect," meaning the cumulative effect that an annual change of just 1% has over time.

Dr. Joseph Mercola observes: "If these trends continue, and there's no indication that they won't, in the not-so-distant future, we'll be looking at a male population that is completely infertile. At that point, the human population will become extinct."

Depopulation through forced vaccination

18 Major Airlines Face Lawsuits Over COVID Vaccine Mandates

The lawyer who filed a lawsuit against Atlas Air said he plans to file similar lawsuits against the Federal Aviation Administration (FAA), the U.S. Department of Transportation (DOT) and 18 major airlines over their COVID-19 vaccine mandates.

California attorney **John Pierce** alleges the mandates "imposed by these agencies on the airlines' employees infringed on their constitutional, religious, and medical liberties," *The Epoch Times* reported.

Pierce filed the first lawsuit on behalf of the Atlas Air employees and **U.S. Freedom Flyers** (USFF), an advocacy group opposing airline vaccine and mask mandates. Atlas Air is one of the largest air cargo carriers in the aviation industry.

The lawsuit has the participation of more than 100 plaintiffs, most of whom are unvaccinated pilots and flight attendants. According to the lawsuit:

"Fundamentally, this case is about whether Americans should be required to choose between their livelihoods and being coerced into taking an experimental, dangerous medical treatment."
