



# Black Africa Takes the Lead Against America's Depopulation Agenda

In a previous article published in The Final Call newspaper, we referenced a December 23, 2020 article in the *Malaria Journal*, “*Malaria and COVID-19: Unmasking Their Ties.*” The researchers observed that the number of confirmed cases of COVID-19 is relatively low in countries such as Mozambique, the Democratic Republic of the Congo, Nigeria, Uganda, Niger and Côte d’Ivoire (Ivory Coast). These same six countries represent more

than half of the global number of malaria cases. *To fight malaria these countries have used a number of inexpensive and highly available drugs such as ivermectin, hydroxychloroquine (HCQ) and chloroquine.* So these scientists performed a study to see if the wide use of these drugs might help explain why COVID-19 has not been a serious health threat at all in countries where malaria is widespread. *They found that the wide use of these anti-malarial drugs “may be responsible for the inverse relation between COVID 19 and malaria prevalence,” and may have “curative effects” against COVID-19.*

But instead of giving credit to these


## New Documentary Exposes WHO Program Resulting in Sterilization of African Women


## THE FRAUDULENT HISTORY OF VACCINATION

## Where's the Emergency? FDA Approves Poison Shots for Babies Under 5

The **U.S. Food and Drug Administration (FDA)** unanimously voted to allow the poisonous COVID-19 shots to be given to children age 5 and under. Child sacrifice is described in the Bible (Jeremiah 19:3-6) as a pillar of the worshipers of the false god Baal. In his honor adults would throw their newborn infants into a fire to be burned alive. To date the COVID cult's "Baal vaccines" are responsible for at least 30,000 deaths, 4,700 miscarriages, 160,000 hospitalizations, and 54,000 permanent injuries.

At least some lawmakers are questioning the Baal believers. A letter signed by 18 members of Congress presses the FDA to address unanswered questions concerning "the risks and benefits" of administering "COVID-19 vaccines" to children. They ask the FDA to explain why the FDA and the **Centers for Disease Control and Prevention (CDC)** have not provided the public with more details on children's lack of serious adverse outcomes from COVID-19 infections and how the majority of children have not died from COVID-19 or its variants.

Finally, the letter asks the FDA Commissioner **Robert Califf** to prove there is an actual medical emergency posed by COVID-19 to children 0 to 4 years old.

The medical data show that children under 18 have virtually no risk of death from COVID-19, according to a November 2021 study published in *Nature*. A July 2021 preprint paper found children have a 99.995% recovery rate, and the vast majority of children have minimal symptoms.

Indeed, there is no clinically significant health benefit from the mRNA vaccines.



New Book Shows How COVID Treatments Are Deliberately Suppressed

On a recent episode of “RFK Jr. The Defender Podcast,” Robert F. Kennedy, Jr. interviewed John Leake and Dr. Peter McCullough, authors of the new book *The Courage to Face COVID-19*, which Kennedy called a chronicle of the “deliberate, purposeful and lethal suppression of early treatment during COVID.”

“Our theme [of the book] is: It’s a crime,” said Leake. “It’s a deliberate suppression...deliberately preventing [patients] from accessing drugs that could help keep them out of hospital and dying...It’s precisely because [the drugs hydroxychloroquine and ivermectin] worked that they were suppressed....What is it about this...biopharmaceutical complex that becomes so voracious and so ruthless and unmoored from ethical considerations?” he asked.

Dr. Peter McCullough, an internist, cardiologist, and epidemiologist who has been outspoken in his critique of the Gates/Fauci regime, added: “No matter what we did [or] actually found that worked, we were actively being suppressed at multiple levels: federal agencies, the biopharmaceutical complex, medical systems, hospitals, medical societies, licensing boards [and] pharmacy boards. It was a complete and total suppression of our attempts to save lives.”




Monkey Pox Profiteers
