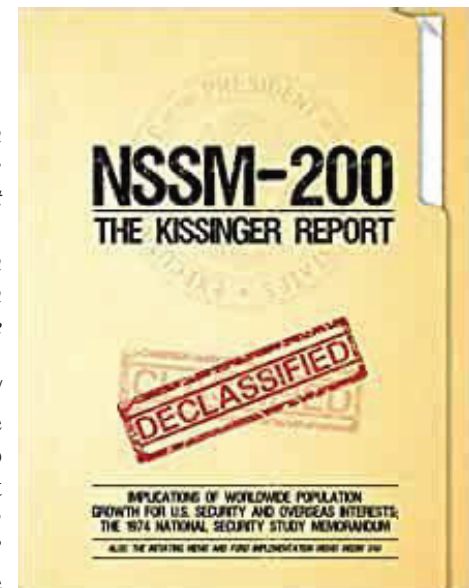

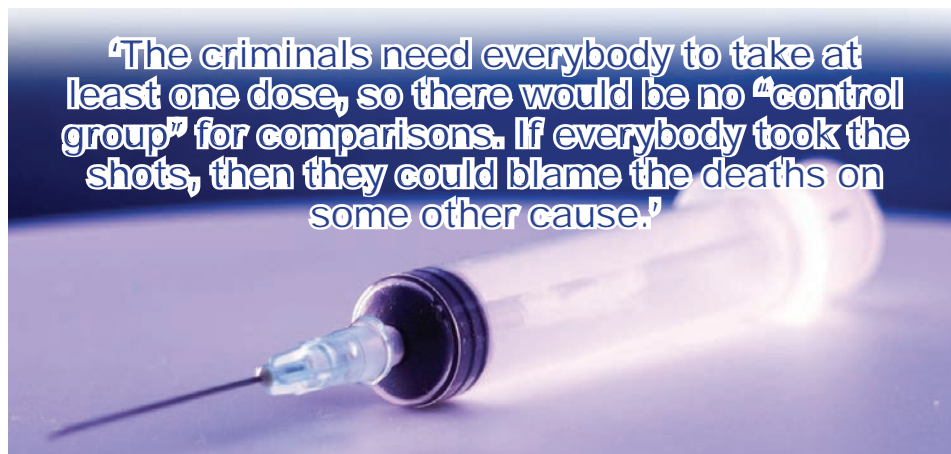

effective mechanism to accomplish both goals is injecting something inside the people to poison and change their thinking. How can you get billions of people to take these death shots? In the same way a shepherd uses the sheepdog to bark and bite at the sheep, forcing them into the corral, these sophisticated murders and hoodlums use a “virus” to scare the people to vaccine stations where they submit to mandatory immune system-killing shots. Rokita highlighted nine instances of what he considered to be *COVID-19 Misinformation and False claims the government spread during the pandemic, such as: “Vaccines stop the spread, natural immunity doesn’t help, school closures were effective and costless, there was no reasonable policy alternative to lockdowns, it is possible to eradicate COVID-19, mask mandates are effective in reducing spread, everyone is equally at risk of hospitalization and death from COVID-19, mass testing of asymptomatic people and contract tracing is effective in reducing spread and the reported number of COVID-19 deaths is accurate.”*

One can be sure that if the government officials who told these lies were Black, we know what whites would do to them. However, since these are whites lying and

Monkey Pox: Truth versus Fearporn

Newly released Pfizer documents reveal Fraud and Corruption

On May 2nd, Pfizer released another 80,000 pages of clinical trial data related to its COVID shot, which the depopulation leaders have tried to force into virtually every global citizen over the age of 5. Pfizer and the FDA went to court to conceal the data for 75 years but the judge rejected their request. And now it is becoming clear why they wanted 75 years to hide. Researchers have found that:

While Pfizer and the U.S. government claimed the "vaccine" was shown to be "95% effective against COVID-19," the documents that Pfizer was court-ordered to release prove otherwise. Researcher **Emerald Robinson** offers an extensive review of the Pfizer docs: *"The data seems to indicate that the efficacy rate was as low as 12 percent within the first week post-jab and then continues to plummet to less than 1 percent."*

The documents further reveal that pregnant women were not included in the safety trials yet were immediately encouraged to take the shots. Pfizer and government officials used data from 44 rats to determine the shots were "safe" for women and their unborn children.

A reported 25,706 patients are missing from Pfizer data. And as of May 2, data from only 9 out of 158 clinical trial sites are accounted for.

Despite claims that the Pfizer poison does not migrate through the body, the documents show that lipid nanoparticles contained within the Pfizer shots were found throughout the body 48 hours post-injection, integrating into other tissues and organs, including ovaries and liver.

NY Mandatory Statewide Adult Vaccination Database is Proposed

Health freedom advocates have warned that New York state depopulators, having successfully stripped the rights of its students when it comes to vaccination choice, are now coming for the adults. Senate Bill S75A, introduced by **State Sen. Brad Hoylman**, would require physicians and healthcare providers to register every shot provided to people 19 and over in the state database. Hoylman has publicly demanded that the NYPD wear masks even though there is absolutely no science supporting any medical benefit to masks, other than to generate fear and distress.

A vaccine database would further enable vaccine passports and systems of segregation based on vaccination status. Such a system would allow easy tracking and targeting of noncompliant adults.



Veteran Doctor Sees Damage to Child Patients from COVID Jab

Dr. Michelle Perro is a pediatrician with four decades of experience in major hospitals and ERs. Once the U.S. Food and Drug Administration authorized the COVID jab for children, aged 12 to 17, it didn't take long before Dr. Perro started seeing injuries in her practice:

"I was amazed at how many kids were injured ... The types of reactions I started seeing were initially neurologic. Some of them in the beginning were simple but concerning, like tinnitus, which is ringing in the ear, and that could be horrific for a kid ...

"I saw cardiac [problems], myocarditis for sure, and abnormal heart rate responses like tachycardia and increased heart rate ...

"I saw POTS — postural orthostatic tachycardia syndrome — something very common in

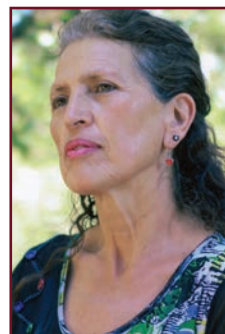
Lyme disease that is very difficult to treat. Another weird thing I saw was this one child with rhabdomyolysis, where he had massive breakdown of his muscle tissue, which is a very rare event in childhood.

"Then, I started seeing people develop symptoms who were unvaccinated, including myself. I got 'spiked.' That's what I call it, 'getting spiked.'

"[I saw] teenage girls with heavy menstrual bleeding, prolonged bleeding, and other menstrual irregularities. There was a smattering of rashes, urticaria, hives — a bizarre host of rashes.

"So, this is the kind of stuff we started seeing, and this began happening last June [2021]... *There is a bigger agenda here, because clearly these vaccines are dangerous for kids. There's no doubt. The data is irrefutable, and yet we've proceeded. So, we're dealing with other agendas here ...* I think parents need to rise up and protect their children, because this is not going away. If anything, it's ramping up."

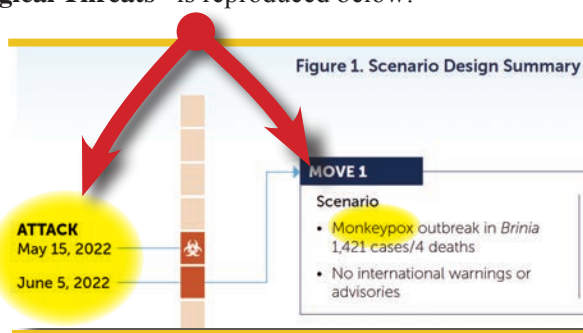

Monkeypox Looks Like Monkey Business

A study analyzing data collected between 2019 and 2021 show that there was an **over 25% increase in emergency calls about cardiac arrest** and heart-related problems for young adults, compared to the same time period in both 2019 and 2020. The researchers explain:

"[T]he weekly emergency call counts were significantly associated with the rates of 1st and 2nd vaccine doses administered to this age group [16 to 39] but were not with COVID-19 infection rates."

RF Kennedy Jr.: Bill Gates Vaccine Killed More African Children Than the Diseases it Targeted

Bill Gates's global vaccine program has never provided proof that the Diphtheria, Tetanus and Pertussis (DTP) vaccine actually yields beneficial health outcomes. The DTP vaccine was discontinued in the US and western nations in the 1990s following thousands of reports of death and brain damage.

A Danish study in 2017 showed that African girls injected with the DTP vaccine died at **10 times the rate of unvaccinated children**. But Bill Gates and the World Health Organization he controls, made DTP a priority for African babies.
