

The Unraveling of CDC Vaccine Campaign: COVID Shots Increase Your Chances of Infection

Contrary to the confusing, misleading data fostered by the Centers for Disease Control (CDC)—one of the many government agencies which belong to Big Pharma—a study published in the June 15 **New England Journal of Medicine** determined that *vaccination actually increases the chances of Covid-19 infection*. Conversely, unvaccinated persons who were infected with the virus actually established better immunity.

The study was done during the Omicron variant wave in Qatar during the period of December 2021 to February 2022, comparing vaccination rates and immunity among more than 100,000 Omicron-infected and non-infected individuals.

Marina Zhang, reporting in **The Epoch Times** on June 21, wrote an article entitled, “**Vaccination Increases Risk of COVID-19 Infection, But Infection Without Vaccination Gives Immunity: Study.**” She cited findings that “*Having two doses of a COVID-19 vaccine has been linked with negative protection against symptomatic infection with the disease, scientists say, while a previous infection without vaccination offers around 50 percent immunity ...*”

Zhang continued, “*The authors of the study found that those who had a prior infection, but no vaccination had a 46.1 and 50 percent immunity against the two subvariants of the Omicron*

variant, even at an interval of more than 300 days since the previous infection. Several analogies were given, nevertheless, whether there were two or three Moderna or Pfizer shots, when longevity of the vaccines were the consideration, naturally developed immunity or immunity after infection with no shots, the vaccinated were, found with negative immunity against both BA.1 and BA.2 Omicron subvariants, indicating an increased risk of contracting COVID-19 than an average person without prior infection and vaccination.”



Despite the many studies and factual data related to the severely adverse effects of the vaccine (including nearly 30,000 fatalities acknowledged by the government), the Biden Administration, primarily through the CDC and Food and Drug Administration (FDA), along with mass media and Big Pharma, continue to push the vaccine, which now leads the depopulation program.

Another **Epoch Times** reporter, Zachary Stieber, openly charged Dr. Ashish Jha, White House COVID-19 Response

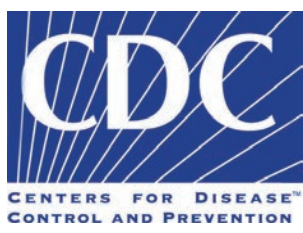
Coordinator, with making a “false claim on behalf of the government regarding the efficacy of the vaccines.” Stieber said he was particularly concerned with a statement Jha made June 20, that “*there have not been any serious side effects of these vaccines.*”

In his June 20 article, “**White House Health Official Makes False Claim About COVID-19 Vaccine,**” Stieber wrote, “*Contrary to Jha’s claim, severe allergic reactions, blood clotting, heart inflammation, and paralysis are among the serious side effects linked to the three COVID-19 vaccines that are available in the United States.*”

Stieber pointed out that Jha, who is on break from his position as Dean of the Brown University School of Public Health while serving in his new post with the Biden Administration—is now on a media tour promoting COVID-19 vaccinations for children and infants under the age of five.

He also quotes, in his article, Dr. Jay Bhattacharya, a professor of medicine at Stanford University, who told **The Epoch Times** in an email, “*There is a well-documented risk of myocarditis from the COVID vaccine, especially in young men and adolescent boys, and an elevated risk of clotting in young women with the Moderna vaccine.*”

Recently, the FDA authorized the Pfizer and Moderna COVID-19 vaccines for babies and young children, while the CDC recommended that virtually every child who is now eligible get one of the vaccines.

In another development, there was the revelation which charged that the **CDC Admits It Never Monitored VAERS for COVID Vaccine Safety Signals**. This startling and disturbing information appeared in **The Defender /Children’s Health Defense** in a June 21, 2022 article by Josh Guetzkow, Ph.D., senior lecturer in the Department of Sociology & Anthropology and the Institute of Criminology at the Hebrew University of Jerusalem. He prefaced the article with the following statement:

“In response to a Freedom of Information Request submitted by Children’s Health Defense, the Centers for Disease Control and Prevention last week admitted it never analyzed the Vaccine



Adverse Event Reporting System for safety signals for COVID-19 vaccines.”

In the body of his report, he repeats his findings with an additional point “... the Centers for Disease Control and Prevention (CDC) last week admitted—despite assurances to the contrary the agency never analyzed the Vaccine Adverse Event Reporting System (VAERS) for safety signals for COVID-19 vaccines.”

He writes, *“In September 2021, I published an article in The Defender in which I used the CDC’s published methodology to analyze VAERS for safety signals from COVID-19 vaccines.”*

Following his article, he said he urged CHD’s legal team to submit a FOIA (Freedom of Informa-

tion Act) request to the CDC about its VAERS monitoring activities.

“Since CDC officials stated publicly that ‘COVID-19 vaccine safety monitoring is the most robust in U.S. history,’ I had assumed that at the very least, CDC officials were monitoring VAERS using the methods they described in a briefing document posted on the CDC website in January 2021 (and updated in February 2022, with minor changes).”

Guetzkow referenced a MEDPAGE article dated March 7, 2022, titled, **“6 Months of U.S. Data Support Safety of mRNA COVID Vaccines**, with a subtopic which said, *“—CDC reports find that most AEs (Adverse Effects) were minor, transient and few patients sought medical care,”* submitted by Molly Walker, deputy managing editor.

He said, however, *“I was wrong. The lynchpin of their safety monitoring was to mine VAERS data for safety signals by calculating what are known as proportional reporting ratios (PRR’s).”*

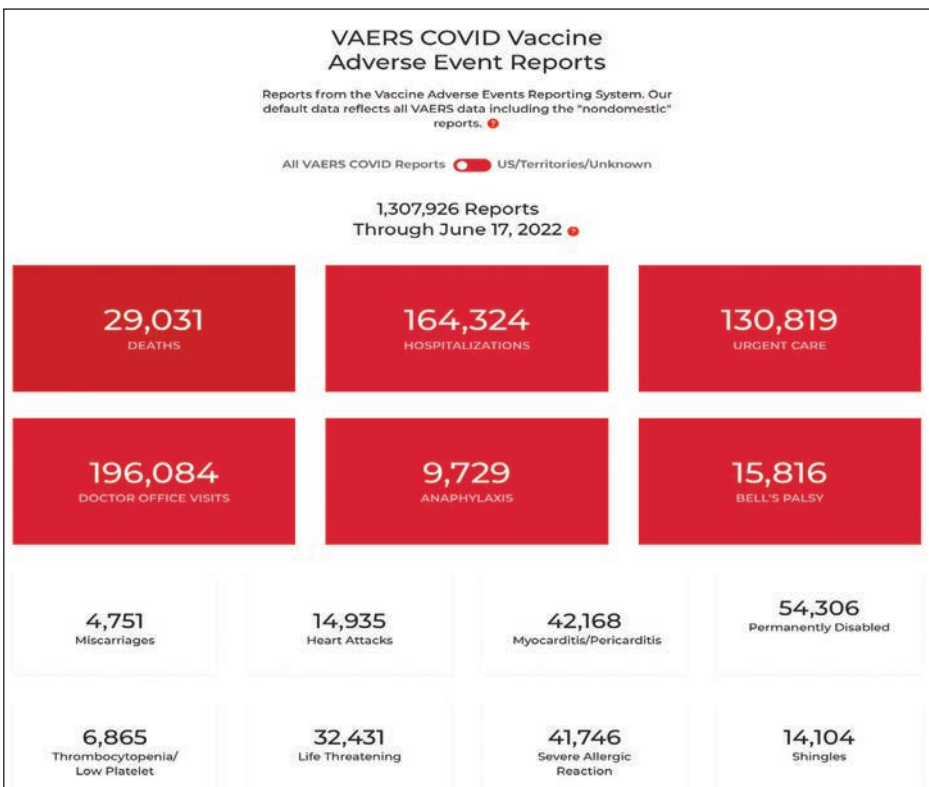
Ultimately, this method does not satisfy the expected monitoring of the COVID-19 vaccines adverse effects.

Guetzkow concluded: *“It remains to be seen if the FDA was properly monitoring VAERS. That will be the subject of a future FOIA request. But even if it was, it doesn’t change the fact that the CDC completely failed in its promise to monitor VAERS for safety signals.”*

The unraveling of this Vax-attack program is unfolding daily. Meanwhile, millions are experiencing multiple serious adverse effects—including death—from these untested, experimental, deadly vaccines. 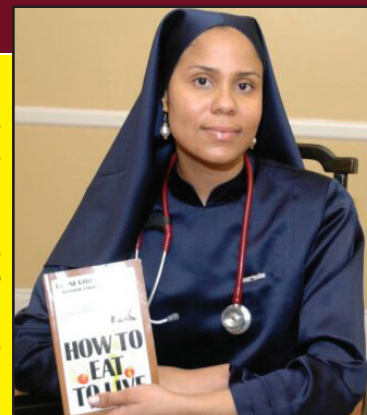
Dr. Safiyya Shabazz: Her Ivermectin Victory Frees All Doctors

769 Athletes Collapsed This Year During Competition. What’s Going On?

Insurance Industry Data Shows Massive "Unexplained" Deaths in Young People

A recent report from the insurance industry reveals a large, unexplained rise in U.S. life insurance claims amongst working age Americans of ages 18-64 beginning in early to mid-2021, timed with the vaccination campaign rollout. In a press conference, the CEO of One America, the \$100 billion Life Insurance giant, publicly stated:

- what we saw just in third quarter, we're seeing it continue into fourth quarter, is that death rates are up 40% over what they were pre-pandemic.
- deaths in this age group are 4 times higher than what would be seen in a 'one-in-200-year catastrophe,' and that '40% is just unheard of.'

- we are seeing, right now, the highest death rates we have seen in the history of this business.

Financial analyst and former Blackrock Managing Director, **Edward Dowd**, reported similar historic increases in death claims over the same time period from discussions with major U.S. life insurance industry executives: 57% for Lincoln National, 41% for Prudential, 32% for Hartford, 24% for MetLife, and 21% for RGA.

In line with these data, the Group Life Insurance industry reported that younger age groups were suddenly dying at historically unprecedented rates beginning in Q3 of 2021.

The timing and magnitude of the historic rise in death and disability are also seen in German health insurance claims data and Medicare billing data.

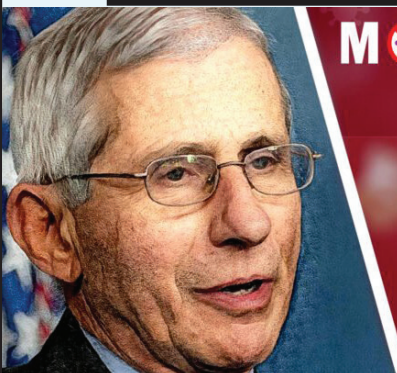

\$9.8 Million Awarded Last Year by Fauci's Agency to Test Monkeypox Treatment
