

Since the current COVID-19 vaccines have been based on the first strain of the virus known as SARS-CoV-2, which causes the illness identified as COVID-19, other variants have developed which are not identical to that first virus.

“A number of strains have emerged and become dominant since the [initial] strain was prevalent, including the currently dominant Omicron variant,” the report continues in part.

Dr. Malone further stated, *“If that antigen has changed slightly, if that virus has changed slightly, [the immune system] still reacts as if it’s the old one.”* He also stated, *“The COVID-19 vaccines are based on the spike protein of the original virus identified in Wuhan. That strain of the virus no longer exists and is not circulating in the population anymore.”*

The article notes a recent study where health-care workers that took multiple vaccines and boosters for the first variant, often face a chronic reinfection as the virus mutates. Later in the article Dr. Malone states *“If a vaccine based on a now-defunct viral strain is repeatedly administered, it trains the immune system to focus more and more on the antigen delivered through the vaccine and to disregard anything else that’s slightly different.”*

Dr. Malone calls this phenomenon *“immune imprinting.”*

Although major media is not reporting it, *“The literature on immune imprinting is bomb-proof,”* Malone said. *“Paper after paper after paper now, in the top peer-reviewed journals from the top laboratories all across the world, are documenting it.”*

On a very controversial note, Malone spoke of a paper published in Nature—a leading scientific journal—which showed that, *“the evolution of the virus is not coming from the general population, but rather from immune-compromised people who have received multiple vaccine doses...and about 30 percent of the highly vaccinated population are having repeated infections.”*

This is contrary to the promoted narrative that the unvaccinated are putting the wider population at risk, Malone noted. There are thousands of doctors and scientists who back or support Dr. Malone and at some point, we should expect to see dire confrontations of various pro-

portions, even in the streets of cities around the world.

“The paradox, according to Dr. Malone, is that most of the countries with emerging economies and low vaccination rates also have the lowest COVID-19 mortality rates in the world. It’s likely that we’re going to continue to see this trend.”

The report helps to make the point with statistics regarding the percentage of population vaccinated vs. the deaths vs. the rate of deaths per

million.

“According to Our World in Data, only 1.4 percent of Haiti’s population has been vaccinated, and the country has recorded 838 COVID-19 deaths, a rate of 73 deaths per 1 million people.”

In South Africa, where 32 percent of the population is vaccinated, there have been nearly 102,000 deaths, a rate of 1,717 deaths per 1 million people.

In the UK, 75 percent of the population is vaccinated, and more than 184,000 people have died, which is a rate of 2,736 deaths per 1 million.

And in the United States, 67 percent of the population is vaccinated, and 1.03 million people have died from the virus, a rate of 3,058 deaths per 1 million people.”

President Biden, Anthony Fauci and other declared multi-vaccine / booster boosters should reassess their scientific advisors, especially since they have reportedly been victims to COVID-19 and can be reinfected, because of the unsacred “jab” of the deluded.

Lawsuit Alleges Gov't Collusion With Social Media to Push "Vaccine"

The nonprofit America First Legal (AFL) released documents revealing "concrete evidence of collusion" between the CDC and social media companies to "censor free speech and promote Biden Administration propaganda," a July 27 press release said.

Documents revealed that the CDC sent a chart of posts to Twitter that it had deemed "misinformation." The CDC conducted regular BOLO, or "Be On the LookOut," meetings where the agency shared with social media firms what it believed was "misinformation."

Apparently, the CDC wanted to undermine the integrity of its own reporting system! The CDC runs the Vaccine Adverse Event Reporting System (VAERS) that collects reports of deaths and injuries from vaccines. And even though it has a stringent process for reporting adverse events and more than 70% of reports are from medical personnel, the CDC wanted the public to know that it "accepts reports from anyone."

The lawsuit documents extensive interactions between Facebook and the CDC that amount to the control and suppression of information they deemed to be unhelpful to its depopulation policies. Facebook, run by **Mark Zuckerberg**, gave at least \$15 million in ad space to the CDC to promote vaccine, social distance, and other messages related to COVID-19, something which might be in violation of the Antideficiency Act's limitation on voluntary services. The lawsuit alleges that Google made sure that search results highlighted the CDC's policies and suppressed any challenges to its COVID narrative.

In the press release, **Stephen Miller**, president of America First Legal, blamed Big Tech for "unlawfully" colluding with the federal government to "silence, censor, and suppress" the free speech rights of Americans as well as violate their First Amendment rights.

"Government is expressly prohibited from censoring competing or dissenting viewpoints or from silencing its political opponents, whether it does so directly or whether it uses an outside corporation to achieve its draconian, totalitarian ends," he said.

Latest Vax Side Effect: Pure Anger

Australia implemented some of the most repressive pro-vaccine measures, just about making it illegal to exist with un-poisoned blood. 


Vaccine Corner


American History of Medical Racism & Savagery

STUDY: Far Fewer Americans Got Jabbed

According to the **Kaiser Family Foundation (KFF)**, nearly 228 million, or roughly 70% of, Americans were unvaccinated, hadn't completed their primary COVID vaccine series, or hadn't gotten their first booster dose as of July 21, 2022. The uptake is particularly low for booster shots. All Americans age 5 and older are eligible for the largest human guinea pig experiment of all time but among adults 50 and over who are eligible for a second booster shot, only 30.9% have gotten it, the data said.

It appears that even those who were originally vaxxed may now have buyer's remorse and want nothing more to do with being jabbed. Numbers keep falling. Some people who oppose the shots only got them because of mandates—a requirement to attend school or keep a job.

The KFF survey finds that only 7% of parents have gotten their children “vaccinated” citing “concerns about the newness of the vaccine and not enough testing or research, concerns over side effects, and worries over the overall safety of the vaccines.” Additionally, “worries about side effects and unknown long-term effects are widespread among parents of young children...” This is a direct reflection of the lack of

trust that the people have in their politicians and official health agencies. The survey found that 44% of Black parents of unvaccinated children fear that they may have to care for them if they experience side effects, and a similar share of Hispanic parents (45%) say they are concerned they won't be able to get their child vaccinated at a place they trust.

A majority of parents of the youngest children “view the vaccine as a bigger risk to their child's health than getting infected with COVID-19. The share saying the vaccine is a bigger risk rises to 73% among Republican and Republican-leaning parents, 71% among parents who are unvaccinated themselves, and 67% among parents whose child has previously tested positive for COVID-19.

Top Medical Official: US Government Is Preventing a Real Investigation Into the COVID Origin

Prof. Jeffrey Sachs is a highly influential member of the medical establishment. He is chairman of the COVID-19 Commission of the LANCET, the foremost medical journal. After initially supporting the claim that the “virus” evolved and spread naturally, Sachs now says that there is clear proof that the National Institutes of Health run by **Anthony Fauci**, and many members of the scientific community, have been impeding a serious investigation of the origins of COVID-19, and that the U.S. may have supported research that has led to millions of deaths:

“I chaired the commission for the Lancet for two years on COVID. I'm pretty convinced it came out of U.S. lab biotechnology, not out of nature...After two years of intensive work on this. So it's a blunder, in my view, of biotech, not an accident of a natural spillover. We don't know for sure, I should be absolutely clear. But there's enough evidence that it should be looked into. And it's not being investigated, not in the United States, not anywhere...”

Dr. Sachs continued: **“...there was a lot of research underway in the United States and China on taking SARS-like viruses, manipulating them in the laboratory, and creating potentially far more dangerous viruses. And the particular virus that causes COVID-19, called SARS-Cov-2, is notable because it has a piece of its genetic makeup that makes the virus more dangerous. And that piece of the genome is called the 'furin cleavage site.' Now, what's interesting, and concerning if I may say so, is that the research that was underway very actively and being promoted, was to insert furin cleavage sites into SARS-like viruses to see what would happen. Oops!”**

Poll: 10 Percent of Americans Regret Vax, 15 Percent Have a New Medical Condition After It

Children's Health Defense (CHD) commissioned a poll to find out about people's position on the COVID “vaccines.” Ten percent of “vaccinated” Americans regret having done so, and 15 percent of the 1,038 adults that took the survey said that they have been diagnosed with a new condition weeks or months after taking the “vaccine.” The most common of the new ailments were blood clots (21%), heart attack (19%), liver damage (18%), and stroke (15%).

Another poll surveyed 829 Americans ages 18–49, and the results show that 22% of them reported a new condition within weeks or months after getting a COVID-19 vaccine. The top conditions were autoimmune problems, blood clots, stroke, lung clots, liver damage, leg clots, heart attack, and disrupted menstrual cycle. Ten percent of these conditions were severe.

Survey participants were then asked if someone they personally know had been medically diagnosed with a new medical condition within the same time frame. Overall, 26% reported yes, while 63% reported no.

Shocking: Europe's Vaccine Carnage

American health officials have done their wicked best to alter or suppress the growing numbers of deaths and permanent injuries as a result of the depopulation shots. But United States law requires that the **CDC** keep a record of the disaster through the **Vaccine Adverse Event Reporting System (VAERS)**. The *Final Call* has been reporting those growing numbers on a weekly basis—the **latest tally showing at least 30,000 deaths** of previously healthy jabbed Americans.




Europe's vaccine monitoring is done via the **European Medicines Agency (EMA)** database. It is now reporting **46,999 deaths and 4,731,833 injuries** following COVID-19 “vaccines.”

This is all the more shocking given that a 2011 Harvard study found that these monitoring databases are underreporting by as much as 99%. This means that only 1 of every 100 adverse events is actually being reported.
