

Drastic Change in CDC Guidelines: But Killer mRNA Vaccines Remain

In last week’s article, it was shown that the COVID-19 vaccines are the problem, not the solution, to the “pandemic.” Without clear explanation or admitting any mistakes in their actions so far, the Centers for Disease Control (CDC) on August 11, 2022, announced several revised guidelines for COVID-19.

The press release from CDC’s Greta Massetti, Ph.D., MPH, MMWR, dated August 11, 2022, and titled, *“CDC streamlines Covid-19 guidance to help the public better protect themselves and understand their risk,”* says: *“We’re in a stronger place today as a nation, with more tools—like vaccination, boosters, and treatments—to protect ourselves, and our communities, from severe illness from COVID-19.”*

However, this formal announcement comes in the wake of the country already moving away from the unilateral and mostly illegal mandates. The end of “proof of vaccination” requirements in many school districts and large institutions, testing requirements, masking, quarantines and protocols removing differences in the handling of vaccinated and unvaccinated, weighs heavily on those citizens who exercised their constitutional rights to choose whether to be injected with an experimental vaccine. While it is a matter of record that tens of thousands were killed as a direct result of the mRNA vaccines and millions more were seriously injured, those who refused the vaccines lost jobs and therefore income, suffered a death knell on small businesses and continuous devastating effects of man-

dates. Some have determined this gross injustice as unforgettable and unforgivable.

The U.S. Government is still refusing to admit that there are safe and effective therapies such as Ivermectin for COVID-19 and most viral infections; patients in the tens of thousands in this country have recovered with no side effects.

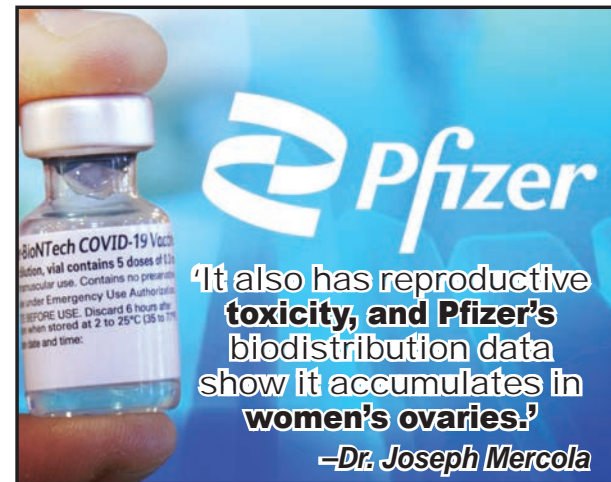
According to Massetti, *“This guidance acknowledges that the pandemic is not over, but also helps us move to a point where COVID-19 no longer severely disrupts our daily lives.”*

In accordance with these major changes, the travel industry is also updating requirements. Carnival Cruise lines in a recent announcement, said it will allow unvaccinated guests to sail, with adjusted protocols for both the vaccinated and unvaccinated.

A Carnival Newsroom Press Release dated August 12, 2022, stated that, “Carnival Cruise Line Removes Pre-Cruise Testing for Vaccinated Guests and Welcomes All Unvaccinated to Sail.”

However, the CDC has not altered or streamlined guidance to end the experimental mRNA vaccination program and that is the major issue with hundreds of doctors, scientists and researchers who agree the vaccine itself is the problem.

As recently as early May, a number of scientists, doctors and researchers have expressed agreement with the findings of Canadian immunologist and vaccine researcher, Dr. Byram Bridle, Ph.D., that *all CO-*

This is obvious in the thousands of cases of adverse effects as indicated in CDC’s Vaccine Adverse Event Reporting System (VAERS) reports regarding the several areas of attack in the bodies of thousands of victims of mRNA vaccine.

The CDC online website states that:

As of October 2021, there are three COVID-19 vaccines approved or authorized for use in the United States to protect against COVID-19 disease. These vaccines are monitored by VAERS and

several other vaccine safety monitoring systems as part of the most intensive vaccine safety monitoring effort in U.S. history. **This continuous, robust safety monitoring helps keep COVID-19 vaccines safe and helps ensure the benefits of vaccination continue to outweigh any risks.**

How can this be true if the mRNA vaccine is responsible for tens of thousands of deaths and millions of adverse effects, while ignoring safe, affordable, and effective natural therapies with no side effects? VAERS then reports that their figures may be only 1% of the total picture since its responses depend on voluntary reports, when most Americans, including health professionals, know nothing of VAERS or how to access it.

Among the most demonic of multiple crimes against humanity is the path by which these vaccines ultimately reached the injection site of millions of people throughout the earth.

In a May 16, 2022 report entitled **‘We Made a Big Mistake on COVID-19,’** by long-time researcher and health-activist, Dr. Joseph Mercola, he revealed that Dr. Bridle *“had gained access to Pfizer’s biodistribution study from the Japanese regulatory agency. The research demonstrates a huge problem with all COVID-19 vaccines.”* (Note: The original report from Bridle does not mention Pfizer. It says: Dr. Byram Bridle is an Associate Professor of Viral Immunology at the University of Guelph in Ontario, Canada. He is part of the Canadian COVID Care Alliance (CCCA) group of doctors. On May 21, 2021 Dr. Byram Bridle revealed to Alex Pierson that the Pfizer COVID-19 vaccine Lipid Nanoparticle (LNP) biodistribution data he obtained from the Japanese government through a FOIA (Freedom of Information Act) request reveals that the vaccine LNPs do not stay in the deltoid muscle where the vaccine is injected (as experts claimed), but in fact moves about the entire body. Bridle *“cautioned that serious side effects could occur in those who receive an mRNA-based COVID-19 ‘vaccine.’”*

While vaccine developers were supposedly under the “assumption” that the mRNA in the vaccine would remain in the local area of the muscle where it was injected, it is now known that mRNA, according to Pfizer’s own data, can travel to any area of the body in a few hours.

Not only does it affect the cardiovascular and neurological system, but according to Dr. Mercola in the same article, *“It also has reproductive toxicity, and Pfizer’s biodistribution data show it accumulates in women’s ovaries.”*

Dr. Mercola’s assessment of the report continues: *“Once in your blood circulation, the spike protein binds to platelet receptors and the cells that line*

your blood vessels. When that happens, it can cause platelets to clump together, resulting in blood clots, and/or cause abnormal bleeding.”

He explained that when this happens one of several things can occur:

- It can cause abnormal bleeding; heart problems; neurological damage.

Dr. Bridle even warns that people who have been vaccinated against COVID-19 absolutely should not donate blood.

“Pfizer documents submitted to the European Medicines Agency also show the company failed to follow industry-standard quality management practices during preclinical toxicology studies and that key studies did not meet good laboratory practice standards.”

Bridle’s conclusions were the result of a \$230,000 government grant for research on the COVID vaccine development in 2020. Bridle then, with a team of international scientists, requested Freedom of Information Act (FOIA) access to Pfizer’s biodistribution study from the Japanese regulatory agency. The (FOIA) is becoming a turnstile as several entities are requesting documents with respect to various aspects of this clouded debacle of the vaccine protocol.

“The research,” Dr. Bridle maintained, *“... previously unseen, demonstrates a huge problem with all COVID-19 vaccines.”*

He said that people who have been vaccinated against COVID-19 absolutely should not donate blood, seeing how the vaccine and the spike protein are both transferred. In fragile patients receiving the blood, the damage could be lethal.

Breastfeeding women, Bridle maintains, *“also need to know that both the vaccine and the spike protein are being expelled in breast milk, and this could*

be lethal for their babies. You are not transferring antibodies. You are transferring the vaccine itself, as well as the spike protein, which could result in bleeding and/or blood clots in your child ...”

This is obvious in the thousands of cases of adverse effects as indicated in VAERS reports regarding the several areas of attack in the bodies of thousands of victims of the mRNA vaccine.

Standard studies designed to assess these risks were not performed in compliance with accepted empirical research standards. Furthermore, in key studies designed to test whether the vaccine remains near the injection site or travels throughout the body, Pfizer did not even use the commercial vaccine (BNT162b2) but instead relied on a ‘surrogate’ mRNA producing the luciferase protein.”*

The more we learn about the COVID-19 vaccines, the worse they look.

29 Percent of Young Pfizer Vaccine Recipients Suffered Heart Effect

According to a new study "nearly three in 10 children who received Pfizer's 'vaccine' experienced heart effects afterwards."

The study, reported by the *Epoch Times*, examined 301 students aged 13 to 18 across two schools in Thailand. They had received the 2-dose Pfizer "vaccine" and researchers found that 29 percent of the youth experienced cardiovascular effects, including heart palpitations, chest pain, and shortness of breath. Fifty-four had abnormal electrocardiogram results. Six experienced a heart valve disease; six had high blood pressure, and seven were diagnosed with heart inflammation. Two of the children were hospitalized, with one being admitted to intensive care.

Cardiologist **Dr. Peter McCullough** reviewed the study results and commented: *"Any form of heart damage in young persons is concerning since the long-term risks of heart failure and sudden death with exercise are unknown....This is one of about 200 published papers demonstrating the risks of COVID-19 vaccination far outweigh any theoretical benefit."*

Report: Plandemic Takes Harsh Toll on Teachers

According to the Bureau of Labor Statistics nationwide, **there are at least 280,000 fewer public school teachers than there were before the plandemic.** Florida alone has 8,000 openings, Arizona has 2,200. In Illinois, 88% of school districts surveyed report a shortage.

Three out of four educators surveyed would not recommend the job to others, according to the American Federation of Teachers, the nation's second largest education union.

Depopulation policies that turned teachers into prison guards and mask enforcers made them agents in a devastating reversal of childhood development. **Bill Gates**, the world's foremost depopulator, admits that *"[I]f we knew everything that we know today, we would have shut schools a lot less than we did during this pandemic....K-12, we have a learning deficit that will take us a long time to erase that, and sadly, it's a deficit where the inner city is where it's almost two years. Suburban schools less, private schools—in some cases like my kids—almost no deficit at all,"* Gates confessed.

Of 29 Pregnant Women That Had Bad Reaction to Pfizer Jab, Only One Had a Baby That Lived

As any good depopulator knows, the most effective way to achieve their genocidal ends is to target the womb of the population to be exterminated. That way one doesn't have as many dead bodies to dispose of, and the victims won't even be aware of the crime until long after it has been committed. The society can get a generation of labor from the doomed people, secure in the knowledge that they will be unable to reproduce themselves.

This is exactly what happened to the Ethiopians that immigrated to Israel. In the early 2000s it was revealed that Ethiopian Jewish women were injected with the contraceptive drug Depo-Provera but they were led to believe they were receiving a vaccine to prevent disease. The drug sterilized thousands of Black women and actually halved the Ethiopian birthrate! Israeli officials at first denied the charge but then put the main denier in charge of the "investigation." It was a policy perfectly attuned with Prime Minister **Benjamin Netanyahu's** 2012 warning about Africans: "If we don't stop their entry, the problem that currently stands at 60,000 could grow to 600,000, and that threatens our existence as a Jewish and democratic state."

Now, in 2022, an analysis of documents released through a court order shows that the Pfizer "vaccine" is far more dangerous to pregnant women than the public was told. Of those pregnant women in the Pfizer trial, there are solid data available from 29 pregnancies. Only one out of 29 of these pregnancies resulted in a "normal" outcome. This means that 28 out of the 29 babies died. That is a 97% death rate when an "adverse event" occurs during pregnancy. Even in the case of the "normal outcome," this only means there was an "apparently" healthy baby. However, one cannot be certain that the outcome is "normal" until the baby has had all of his or her physiological systems fully mature—at early adulthood.

In an obvious sign that depopulation—and not health—is their motive, many countries have pushed Pfizer's COVID-19 "vaccine" on pregnant women, often via mandates. According to **Dr. Byram W. Bridle**, professor of Viral Immunology at the University of Guelph in Canada, *"This was being done with the full blessing of their societies for obstetrics and gynecology. Are obstetricians and gynecologists going to continue to make these recommendations when adverse events in pregnant women almost always end in a fatality for the baby?...A 97% death rate among babies from pregnant mothers who reported an adverse event after they were 'vaccinated' is appalling....If I were a regulatory scientist assessing the pregnancy outcome data from Pfizer, there is no way that I would ever have supported the use of their inoculation in pregnant women."*

More Blundering & Misguidance from the Depopulators at the CDC

The Centers for Disease Control and Prevention (CDC) is now acknowledging that it was wrong in the past to downplay natural immunity and promote plainly unscientific policies like asymptomatic testing. The CDC's new COVID-19 "guidance," released on Aug. 11, rescinds and alters a number of key recommendations, including treating unvaccinated and vaccinated people differently for many purposes. Now the agency explicitly states that people with previous infection have protection against severe illness, and it is removing its six-foot "social distancing" advice.

"The CDC is admitting it was wrong here, although they won't put it in those words," **Dr. Jay Bhattacharya**, professor of medicine at Stanford University School of Medicine, told *The Epoch Times*.

The following excerpt is from the book *How to Raise a Healthy Child... In Spite of Your Doctor* (1984), by Robert S. Mendelsohn, M.D.

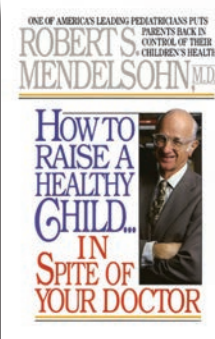
"The greatest threat of childhood diseases lies in the dangerous and ineffectual efforts made to prevent them through mass immunization."

Fasting May Have a Huge Impact on Recovering From Spike Injuries

Predictably, the untested chemical injections called “vaccines” have caused deaths and injuries on a massive scale. In America alone the CDC’s own data show at least 30,000 have perished and nearly 57,000 have suffered permanent injuries after taking the shot. For those who have succumbed to the pressure from their jobs or school to comply, the question of how the body can heal itself is of utmost importance.

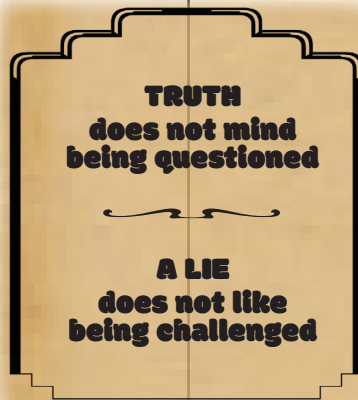

This all may be uglier than we now think. The **Wuhan Institute of Virology** is just one of the many foreign sites where Americans are conducting dangerous bioweapons research. 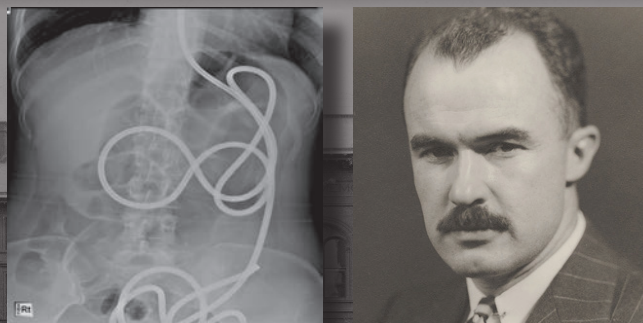


Bloomberg Warned of Human Guinea Pig Abuses in 2005

In a major article titled “BIG PHARMA’S **ISHAMEFUL SECRET**,” in the December 2005 issue of Bloomberg Markets, the authors exposed the fact that “*Every year, drug companies spend \$14 billion to test experimental substances on humans. Across the U.S., the centers that do the testing—and the regulators who watch them—allow scores of people to be injured or killed....In the U.S., 3.7 million people have been human guinea pigs.*”

Study: Vaccines Help COVID Spread

A team of 19 scientists from the United Kingdom have published new research that helps explain why countries with the highest vaccination rates are experiencing the highest numbers of what they call “breakthrough infections,” as well as reinfection with other variants of COVID-19.

This research, published in the journal *Science*, appears to show that the vaccine itself is leading to widespread infection. Instead of stopping the virus, it appears that the mRNA vaccination programs around the world may have inadvertently made the virus more widespread.

The British scientists point out that countries with higher COVID vaccination rates are experiencing high numbers of COVID infections. In contrast, in places where vaccine campaigns have not been widely implemented—including most countries in the continent of Africa—*people are not becoming infected.*

This study demonstrates exactly how the repeat vaccinations are causing people to be more susceptible to COVID-19. Initial doses of the vaccine brought about classic immune responses.

But after multiple jabs and boosters the scientists found that the vaccine begins to desensitize the subjects to the COVID-19 proteins. In other words, the “vaccines” actually turn off the body’s immune response, making the vaccinated MORE vulnerable—not less—to the infection. The unvaccinated, by contrast, are fully protected by their natural immune systems. It is still unclear how long the jabbed suffer from a compromised immune system and if the “vaccine” makes them vulnerable to many other diseases they would have easily resisted before the forced injections.

Plandemic’s Impact on Mental Health

The **Highwire** reported that mental health issues were magnified by the plandemic. Drug overdose deaths in the U.S. topped 100,000 in 2021, and the number of teenage girls who’ve been suicidal has increased 50% nationwide since 2019. One in four parents say their adolescent has seen a mental health specialist; 41% of college students reported having suicidal thoughts in 2021.

Dr. Anthony Fauci was unfazed when asked by a BBC interviewer: “*I’m interested in your reluctance to use the word lockdown. Do you think two years on that they were worth it, or were they too severe?*”

FAUCI’s answer: “*Obviously, when you do have that kind of restriction on society, there are unintended negative consequences.*”
