

# Parents reject Covid-19 shots for babies and young children

Parents across the United States are rejecting the Covid-19 “vaccines” which the U.S. Food and Drug Administration (FDA) has authorized for emergency use in children as young as 6-months-old, according to recent surveys and media reports.

It is universally accepted that the virus and its variants have never qualified as lethal, having an overall survival rate exceeding 98 percent. It is nearly non-existent in children. There are multiple safe and effective treatment protocols for it. This is a pathogen that is a member of the coronavirus family that is never qualified for an experimental vaccine. Now that the “pandemic” has passed and the virus is “endemic,” according to medical and health professionals, scientists and even chief Depopulator Bill Gates, there is no logic in continuing the vaccine campaign.

A recent survey by *Politico* indicates there’s a very low demand for Covid-19 shots in young children in Mississippi and Alabama. Since they became eligible last fall, only 36.6 percent of 5- to 11-year-olds have received one Covid-19 shot while just 30 percent are fully vaccinated, according to its July 14 online health report.

In its survey conducted June 18-23, 2022, *Morning Consult* found that parents in the United States were split on the shots for babies and toddlers. “In the first days of the campaign, 42% of U.S. parents with children under 5 said they will definitely or probably get their kids vaccinated, while 13% said they probably won’t and 32% said they plan to skip the shots altogether,” indicates the survey.

According to the report, ninety-two percent (92 percent) of those who said no to the deadly, experimental gene therapy, said they are worried about the side effects; 89 percent thought that the clinical trials were conducted too fast. And an overwhelming 80 percent said they just don’t trust the vaccine manufacturers.

Some medical and health professionals say the vaccine resistance is “worrisome” and blame the growing distrust in government, public health and science. But parents who took the shots in order to keep their jobs and take care of their families, simply aren’t willing to go so far as to risk their children’s lives, according to Dr. Ridgely Mu’min Muhammad, member of the Nation of Islam Research Group and manager of Muhammad Farms.

Dr. Mobeen Syed, a medical doctor and software engineer, explained in his video podcast a CDC study published on Jan. 25, 2022 in JAMA. According to “Myocarditis Cases Reported After mRNA-Based CO-

*VID-19 Vaccination in the US From December 2020 to August 2021,*” the risk of myocarditis (heart swelling) in young males ages 12-15 after the second dose of the mRNA vaccine, is an appalling 133 times more the rate compared to what was expected.

“If they give this experimental shot to their child, if the child has an adverse reaction, you are stuck with taking care of that child for the rest of its life, without any help from the perpetrators of the adverse effect. You get nothing from the government or the pharmaceutical companies,” Dr. Syed warned.

“Now you’re going to have a sick child for the rest of the child’s life. So, just out of personal pragmatic reasons, you wouldn’t give it to the child,” added Dr. Ridgely.

As reported by Student Minister Ava Muhammad, Official National Spokesperson for the Honorable Minister Louis Farrakhan, also a member of the Nation of Islam Research Group, in her December, 2020 Final Call article, “*The Covid-19 Vaccine and the U.S. Policy of Depopulation,*” it should not surprise us that the government wasted no time giving the pharmaceutical industry, the largest lobby in Washington, D.C., immunity from lawsuits over injuries and death caused by medical countermeasures for Covid-19. That includes: vaccines, therapeutics and respiratory devices (ventilators).

“It goes so far as to prevent anyone harmed by a Coronavirus vaccine from using the 1986 Vaccine Injury Compensation Program to seek some little relief from the government. This blanket protection under the PREP Act went into effect February 4, 2020,

before most of the public was even aware of Covid-19. The World Health Organization did not declare Covid-19 a pandemic until one month later, on March 11 ...," Minister Ava Muhammad wrote.

Now, nearly two years later, evidence is finally surfacing in so-called mainstream media that confirms the position the Nation of Islam has held throughout the "pandemic:" the corporate-controlled United States Government has overplayed the Covid-19 epidemic. Now their efforts are back-firing.

In addition to some southern states, there are parents in Michigan who are not only rejecting the Covid-19 "vaccines," but recent data indicates they are now second-guessing inoculations that they have never questioned before, according to *Bridge Michigan*, a non-partisan, non-profit news source.

It cited a registered nurse who said that before Covid-19, "most parents 'accepted that 'these are the vaccines that my children get (and) they're required for school.' "Now, some of those same parents are not only questioning whether children really need them, they question how the vaccines are made, continued the July 19 article.

[Antifreeze, aluminum, formaldehyde, gelatin, MSG, aborted fetal tissue, human urine] "This is what we are injecting into our newborn babies ... The only thing you prove by vaccinating your children is that if they live through, you just poisoned them, and they survived. There is no such thing as providing immunity or antibodies against these so-called assaults, when it's not about the matter, it's about the environment around the matter. People still get sick," stated California-based naturopath practitioner and alternative healing author Dr. Robert O. Young during an international tribute in 2019.

Meanwhile on July 15, the Department of Health and Human Services renewed Covid as a public health emergency for another three months, de-

spite the continued decline of new "cases" and fatalities worldwide, according to the World Health Organization's (WHO) weekly update published in June.

"Globally, the number of new weekly cases has continued to decline since a peak in January 2022. During the week of 23 until 29 May 2022, over 3.3 million cases were reported, an 11% decrease as compared to the previous week (figure 1). The number of new weekly deaths also continues to decline, with over 9 600 fatalities reported, representing a 3% decrease as compared to the previous week," WHO reported.



"It's no justification for it. There's not a pandemic anymore, but if they don't continue to claim that it's an emergency, then as soon as the emergency's over, the pharmaceutical companies' protection is gone and the government won't buy the shot to give away," said Dr. Ridgely Muhammad.

That was part of the government problem and push against hydroxychloroquine (HCQ) and ivermectin in the first place, he argued. Emergency use authorization could only be granted if there were no known remedies to the virus, otherwise, there's no excuse for it, he said.

"They've got to continue to hide HCQ and Ivermectin and say that there's a pandemic, there's an emergency, to protect the pharmaceutical industry. It's not crazy when you understand that by this time, they thought they would have jabbed everybody. They've got to keep going, but it was supposed to be wham, bam, thank you ma'am; done, and then everybody run into the woods," Dr. Ridgely Muhammad told The Final Call.

## Top Doctor Demands: Where are the autopsies?

**D**r. Jane M. Orient (in photo) is executive director of the **Association of American Physicians and Surgeons**, and she has been practicing general internal medicine since 1981. Dr. Orient is questioning the strange unwillingness of national health officials to perform autopsies on the people who have died to ascertain the true causes of death:



“Thousands of healthy people are dying unexpectedly, but our public health agencies are assuring us that their deaths were not caused

by the COVID jab....If a person dies after a COVID jab, I would like to know whether there are spike proteins in the tissues and blood vessels, and whether there was an immunological reaction that was damaging those tissues. If a mother loses a baby, I would like to see a thorough examination of the placenta. Was the baby’s oxygen and nutrition cut off because of damaged blood vessels?

“I find it shocking that the Centers for Disease Control and Prevention (CDC), the Food and Drug Administration (FDA), the Department of Health and Human Services (HHS) and the Joint Commission that accredits hospitals are not demanding autopsies or testing of vaccine samples. It is not possible to declare a product safe and effective without obtaining direct evidence from potential victims....

## NY: Israeli Opioid Company Lied about Role in Crisis

**B**ig Pharma’s role in Satan’s depopulation agenda is not limited to its COVID death serum they call “vaccines.” Opioid overdoses have claimed nearly a million lives in America. And now New York **Attorney General Letitia James** has charged the **Israel-based Teva Pharmaceutical Industries** with lying to evade accountability for helping fuel the state’s opioid crisis. She said top Teva officials made “demonstrably false” representations that the parent company did not promote or sell opioids in the United States.



“This new evidence shows an even greater disregard for the pain and destruction that this company fueled,” and may constitute a “fraud on the court,” James said.

Teva denied the allegations but admitted it may have to pay \$2.6 billion to settle U.S. opioid lawsuits nationwide.

James’ lawsuit is among more than 3,300 filed by state, local and Native American tribal governments accusing drugmakers of downplaying opioid addiction, and distributors and pharmacies of ignoring red flags about how opioids were being misused.

According to the CDC more than 932,000 people have died since 1999 from a drug overdose. In 2020, 91,799 drug overdose deaths occurred in the United States. They say that 1.27 million Americans are now receiving medication-assisted treatment.

Opioids were involved in 68,630 overdose deaths in 2020 (75% of all drug overdose deaths), a pharmaceutical holocaust largely driven by Connecticut-based **Purdue Pharma** owned by the multi-billionaire **Sackler family**.

New York COVID-19 Quarantine Regulations Unconstitutional and Illegal: Judge Rules

A New York Supreme Court judge ruled that the draconian "Isolation and Quarantine" procedures mandating that people deemed to have "contagious communicable diseases" be quarantined are a violation of state law, and declared them null and void.

Under the order, the State Health Commissioner was given the power to put virtually anyone they feel might be a "health risk" into detention camps! Many believe that the "regulation" is a thinly veiled way to incarcerate massive numbers of Black people. It has been estimated that 70% or more of Blacks are refusing to take the poisonous dart. Disney Employees Suing Company Over Vax Policy



The Epoch Times reports that the Walt Disney Company punished and then fired three longtime employees because they refused the COVID-19 vaccine on religious grounds, according to a new lawsuit.

In July 2021, Disney announced that its employees would have to take the COVID-19 "vaccine" to continue working with the company.

When Florida's government forbade "vaccinate or terminate" policies, Disney began a relentless push to vaccinate all employees, including those who had requested religious exemptions, the lawsuit alleges.

According to one of the plaintiffs, "The mask, face shield, and distancing from cast and guest were clearly punitive measures designed to destroy my health, segregate me, harass, discriminate, and intimidate me into taking an experimental vaccine," which now has a death toll of at least 30,000.

The three plaintiffs say that they refused the jab, citing religious objections. One said he believed he had a religious obligation not to harm his body; another objected to covering her face and contaminating her blood with "vaccine" ingredients, for religious reasons; and the third objected because he believed the "vaccines" were made using cells from aborted babies.

But Disney pushed back and asked them to abandon their religious convictions because the "vaccine" was FDA approved. Employees who refused the needle had to wear masks while outside, wear N95 masks with "Warning" written on the front, eat in segregated areas, and not take off their masks even for a moment, in Florida's intense heat. "I was accused of pulling a mask away from my face just to catch my breath after being forced to wear it for the entirety of my shift, inside and outside, when other cast had the choice not to wear them at all," said one plaintiff.

Disney management showed little mercy, says the lawsuit, and the company singled out unvaccinated employees and made them targets for a bullying campaign. Finally, Disney fired all three employees and became, instead of a magical wonderland, "a corporate machine bent on pursuing financial and political ends at any cost."

Health experts are quitting the NIH and CDC in droves

Anthony Fauci's National Institutes of Health (NIH) and Rochelle Walensky's Centers for Disease Control (CDC) are facing staffing shortages as low morale drives away employees. The "government" divisions of Big Pharma have lost so much credibility that they have become "an embarrassment" to real health professionals.

The last straw may have been the bizarre decision to jab 6 month olds even though there is neither the science nor the cause to justify it. This comes on the heels of the government agencies' unscientific and damaging decisions to close schools and require face masks once they reopened.



In his recent commentary Dr. Marty Makary, a public health expert from Johns Hopkins University, wrote: "At the NIH, doctors and scientists complain to us about low morale and lower staffing: The NIH's Vaccine Research Center has had many of its senior scientists leave over the last year, including the director, deputy director and chief medical officer. 'They have no leadership right now. Suddenly there's an enormous number of jobs opening up at the highest level positions,' one NIH scientist told us.[...] The CDC has experienced a similar exodus."

Makary quoted a senior FDA official: "It's like a horror movie I'm being forced to watch and I can't close my eyes. People are getting bad advice and we can't say anything." Makary said another CDC scientist told us: "I used to be proud to tell people I work at the CDC. Now I'm embarrassed."
