


A Nation Divided: U.S. Government Causing Confusion Over COVID-19

In May of this year the Los Angeles Board of Education voted to postpone the student COVID-19 vaccination mandate for the 2022-23 school year. On the other hand, the Office of the State Superintendent of Education for the District of Columbia (D.C.) announced in July of this year that in the 2022-23 school year, all students are mandated to take or have proof of taking one of the COVID-19 “vaccines.” This country is definitely divided over the COVID vaccinations. The American people are confused because they do not know who to go to for correct information and advice. It is so bad that even top scientists at the CDC, FDA and NIH are leaving their jobs out of frustration caused by the misguidance and bad policies coming from

their agencies. The top brass are **not following the science** that scientists developed for making polices which affect the lives of millions. For instance, a July 14, 2022, article by Marty Makary M.D., M.P.H. and Tracy Beth Høeg M.D., Ph.D., titled “U.S. Public Health Agencies Aren’t ‘Following the Science’...,” states: “It’s like a horror movie

I’m being forced to watch and I can’t close my eyes,” one senior Food and Drug Administration official lamented. “*People are getting bad advice and we can’t say anything.*”

The article continues: “*That particular FDA doctor was referring to two recent developments inside the agency. First, how, with no solid clinical data,*

the agency authorized Covid vaccines for infants and toddlers, including those who already had Covid. And second, the fact that just months before, the FDA bypassed their external experts to authorize booster shots for young children.”

The National Institutes of Health is also suffering from low morale. “*The NIH’s Vac-*

cine Research Center has had many of its senior scientists leave over the last year, including the director, deputy director and chief medical officer. ‘They have no leadership right now. Suddenly there’s an enormous number of jobs opening up at the highest level positions,’” one NIH scientist said.

The Centers for Disease Control has experienced a similar exodus. *“There’s been a large amount of turnover. Morale is low,”* one high level official at the CDC said. *“Things have become so political, so what are we there for?”* Another CDC scientist said: *“I used to be proud to tell people I work at the CDC. Now I’m embarrassed.”*

If the scientists who work for these agencies know that these agencies are not following the science, then those that depend on these agencies are rightfully confused. And look at President Joe Biden: after being fully vaccinated and double boosted, he has been diagnosed with COVID—even though on numerous occasions he told Americans that if they take the COVID shots they would not get COVID.

Fox Network talk show host, Tucker Carlson recently delineated a number of quotes from President Biden singing the praises of the COVID shots, including this July 2021 statement: *“The Delta virus, which is much more transmissible and more deadly in terms of non-unvaccinated people ... The various shots that people are getting now cover that. You’re okay. You’re not going to, you’re not going to get COVID if you have these vaccinations.”* Was the President lying, confused or just unwittingly repeating lies from the CDC, FDA and NIH?

Are we experiencing a chain of debacles and mistakes or is this some type of “war game” playing out? In Attorney Robert F. Kennedy Jr.’s book, *The Real Anthony Fauci*, as far back as 2001 there have been a number of secretive planning sessions and/or biowarfare simulation games that started off with some type of virus release and ended with government-forced vaccines. *“Dark Winter, Atlantic Storm, and Global Mercury were only three of over a dozen Germ Games staged by military, medical and intelligence planners leading up to COVID-19... 
Then came *Event 201* under the direction of Bill Gates in mid-October 2019. Mr. Kennedy explains that this “war game consisted of four ‘tabletop’ simulations of a worldwide coronavirus pandemic. Participants included a group of high-ranking kahunas from the World Bank, the World Economic Forum, Bloomberg/Johns Hopkins University Population Center, the CDC, various media powerhouses, the Chinese government... They drilled a retinue of psychological warfare techniques for controlling official narratives, silencing dissent, forcibly masking large populations and leveraging the pandemic to pro-



mote mandatory mass vaccinations.” Notice that Chinese government officials were included in this “war game,” so who is the enemy here? Are we experiencing governments at war with each other or are these governments collectively planning war against their own citizens?


In May of this year, Judicial Watch said 663 pages of documents obtained from the U.S. Department of Health and Human Services show lipid nanoparticles from Pfizer’s COVID-19 vaccine were found in the liver, ovaries and other organs 48 hours after injection, and Johnson & Johnson vaccine particles were present in test animals months after injection.



Fox News Tucker Carlson Finally Asks the Obvious Question

Study Proves Massive Deception & Corruption at World Health Organization

A major new 43-page report titled **"The WHO Review and Why it Matters to You?"** analyzes the World Health Organization's role in promoting disastrous COVID-19 policies.

It points out for instance that a systematic review of several studies of lockdowns, shelter-in-place orders, and other stringent measures found "lockdowns [a term never used in previous pandemics] have had little to no effect on COVID-19 mortality." On the other hand, "they have imposed enormous economic and social costs where they have been adopted. In consequence, lockdown policies are ill-founded and should be rejected as a pandemic policy instrument." Thus, lockdowns do not save lives. They destroy lives.

'Alarming' Loss of Trust in Drug Biz Fuels Massive Rejection of ALL Vaccines


WHO and UNICEF say that new data shows global vaccination coverage declined in 2021, with **25 million infants missing out on regularly scheduled vaccines**—the largest sustained decline in childhood vaccinations in approximately 30 years. The percentage of children who received three doses of the vaccine against diphtheria, tetanus and pertussis (DTP3) – a marker for immunization coverage within and across countries – fell 5 percentage points between 2019 and 2021 to 81 per cent. They suggest several reasons for the downward spiral relating to military conflicts and supply chain problems, but a widespread distrust of the medical establishment, their mishandling of COVID-19, and a suspicion of being part of a global depopulation plot or being guinea pigs in a massive experiment may account for vaccine rejection on such a large scale.

Meanwhile, the National Vaccine Information Center is reporting that the first reported case of polio in the United States since 2013 "may have been transmitted by someone who received the Sabin live attenuated oral polio vaccine." Executives of Pfizer and Moderna, having grown wealthy with your tax dollars, are moving into luxury homes on streets paved with vaccine gold.


According to the Wall Street Journal, Big Pharma executives “have snapped up multi-million dollar homes in Boston’s most desirable neighborhoods, as well as in tony suburbs, and the stunning Cape Cod holiday resort Provincetown.”

A real estate exec said the boom began in mid-2021, “with Moderna staffers happy to pay over-the-odds for a fast purchase.” He told the Journal: “These aren’t buyers who are going to be browsing for two to three months. These are buyers who are flying in to buy a home.”

The St. Regis building overlooking Boston’s harbor is where two pharmaceutical executives from two different companies bought two \$5 million condos on the same day in 2021.

A Pfizer employee agreed on the spot to purchase a 16th-floor condo with views of Boston Harbor for \$4.85 million. Two hours later, a Moderna executive honed in on the same unit. When she remarked on the coincidence, the real estate agent said, “He just looked at me, completely serious and said, ‘I want the same home, but I need to be one floor higher than Pfizer.’” He reserved the option to buy a 17th-floor unit for \$4.95 million that day, she said.

D.C. Schools Impose COVID Vaccine Mandate Kennedy Org Says It Violates Federal Law

Robert F. Kennedy, Jr., chairman and chief legal counsel for Children’s Health Defense, told the superintendent of schools for the District of Columbia that his organization will sue unless it rescinds its COVID-19 vaccine mandate for students ages 12 and up.

DC school officials announced that the jabs would be required for the upcoming school year despite warnings from legal experts who say the mandate violates federal law.

In a letter sent today to DC school superintendent Christina Grant (in photo), Kennedy said the Pfizer-BioNTech COVID-19 vaccine was never fully approved and still remains under Emergency Use Authorization (EUA). And although courts have upheld many childhood vaccination requirements for licensed and approved vaccines, no court has ever upheld a mandate for schoolchildren for an EUA vaccine, according to Kennedy.



He wrote: “Under the Nuremberg Code, a universal legal norm, no one may be coerced to participate in a medical experiment. Consent of the individual is ‘absolutely essential.’ The liability for forced participation in a medical experiment, not to mention liability for injury from such coerced medical intervention, may be incalculable.”

Birx Admits She Knew COVID-19 Vaccines Were Never Going To Protect Against Infection

The former U.S. official who led the COVID-19 response during the Trump administration said July 22 that COVID-19 vaccines were not expected to protect against infection: “I knew these vaccines were not going to protect against infection. And I think we overplayed the vaccines,” Dr. Deborah Birx said during an appearance on Fox News.



But when the “vaccine” was rolled out over a year ago, Birx told an ABC podcast that “This is one of the most highly-effective vaccines we have in our infectious disease arsenal. And so that’s why I’m very enthusiastic about the vaccine.”

Meanwhile, her co-conspirator Dr. Anthony Fauci has admitted that the “vaccine” he and Birx pushed onto the American population may be causing serious damage to the fertility of women. When asked about studies showing the COVID vaccine’s negative impact on women’s menstrual cycles, Fauci responded thus: “The menstrual thing is something that is quite transient and temporary. We need to study it more.”

Our readers will remember that when rapper Nikki Minaj raised serious questions about the vaccine and fertility, Fauci was arrogantly dismissive: “The answer to that is a resounding no.... There’s no evidence that it happens, nor is there any mechanistic reason to imagine that it would happen,” he said, calling it “misinformation.”

NBA Star Andrew Wiggins Regrets Taking COVID Vaccine: “Wasn’t My Choice!”

Golden State Warriors forward Andrew Wiggins held out until the last possible moment to get the poisonous gene-altering jab government agencies are falsely claiming is a “vaccine.” San Francisco officials had issued an order requiring the injection for all participants age 12 and older at large indoor events. NBA commissioner Adam Silver—who is neither a physician nor an athlete—threatened the loss of wages to the 450 NBA players, 74% of whom are Black.

The former No. 1 pick eventually decided to receive the undisclosed chemicals, and he went on to help Golden State win a championship and make his first All-Star team. But Wiggins says he regrets the decision:
