# The Final Call's Exclusive Interview with Dr. Paul Alexander, Scientist, Epidemiologist and Former White House Advisor

Dr. Paul Alexander is a Trinidadian academic scientist, with extensive experience working with the CDC (Centers for Disease Control and Prevention), HHS (U.S. Department of Health & Human Services), FDA (U.S. Food and Drug Administration), the White House COVID-19 Response Team, and other agencies and organizations.

Dr. Alexander spoke about the many lies propagated by government officials, vaccine companies, and the mainstream media; the CO-VID PCR test fraud; the failures of masks, lockdowns, school and business closures; and more. [Interview edited for clarity and length.]

## Dr. Alexander on the Myth of Asymptomatic Transmission [this refers to an infection that has not manifested in the body in the form of symptoms such as sniffles, coughing, fever, etc.]

We found out very early on that this was about vaccines. We knew the "asymptomatic transmission" was a lie. We said so. I wrote about it. Dr. Anthony Fauci and other government officials were lying. There's no such thing. It's garbage ... We couldn't find one case ...

#### Dr. Alexander on the PCR COVID Test

We showed that the PCR test was oversensitive ... We were even showing that about 95% of all of these "positive cases"—spooking Trump, spooking the world—all of these infections were a lie! Ninety-five percent to 97% of the so-called infectious cases were false-positives. We closed universities and schools and businesses down, knowing—Fauci and Dr. Deborah Birx knew—the PCR test was not a proper diagnostic test. ... You are not picking up COVID virus. You're picking up old coronavirus, common cold coronaviruses, even flu. You're picking up viral dust, fragments, not SARS-CoV-2.

We showed the government agencies and White House officials. They didn't care.

#### Dr. Alexander: 'Masks Are Junk'

Then they started to shut the society down and mandate masks. You tell them that Dr. Paul Alex-

ander said every single blue mask is junk. Every time you wore it from day one, they knew who you were. They knew when you walked around in the mask, you were just being a fool. It doesn't work. They know it. It's just theater, never worked. And it all culminated in the vaccine. They did all of this, and they dangled the vaccine and your freedom in front of you and said,

"Well, you know what, you take this vaccine—Pfizer and Moderna, AstraZeneca and Johnson & Johnson—you get your freedom."

Around June/July 2021, people who were "vaccinated" in January/February 2021 were told, 'Sorry. Put back on your mask,' because the shots didn't work, recounted Dr. Alexander.

You were right to question things. But they made us suffer for two-and-a-half years ... I've published in the American Institute of Economic Research, the Brownstone Institute; I've published prolifically there on failures of the lockdowns, failures of the school closures, failures of the masks, all of the mandates. We showed that everywhere that you implemented a mask mandate in the United States—every state, any city infections spiked ... Mask mandates are just junk, junk science. And the reality is we realized very early on that the push by Fauci and Birx on that podium when Trump would bring them outthey would just speak their scientific junk. Look, I worked in that administration, and I am part of the early treatment and part of all of the vaccine research groups globally... But I'm also a very blunt matter-of-fact person.

#### The Pandemic Response: 'A Complete Failure'

We showed government officials the science—that vaccinated people were becoming infected and spreading back in July of 2021. Why? Because, we told them, first of all, all of the mRNA platforms failed. Every single time they studied this platform, the mRNA gene platform in the animal model, the animals died. The animals died! Liver failure, kidney failure—the animals died! The pharmaceutical industry couldn't even get approval to move forward.

My family didn't take the vaccine. I ensured that. But they brought it to you. Those of you



#### Truth about the Centers for Disease Control (CDC)

The CDC is not a public health agency. It has become a political agency. It works for the government. #### Florida Surgeon General Talks Big Pharma, Gov't Corruption

Florida surgeon general **Dr. Joseph Ladapo** was recently interviewed by **Del Bigtree** for the weekly *The Highwire* program (thehighwire.com).

**Dr. Ladapo**: The pharmaceutical companies—I had no idea how corrupt these companies were before the pandemic....[T]his whole pandemic has prompted me to just look more closely. But basically there's a string of history of these pharmaceutical companies clearly—it's so clear to me now—that they have one god [and] that god is money and profit, and it is not health, absolutely it's not health. them. You need to double-check, triple-check, quadruple-check what they're doing. And you need to have boundaries around them. So I have less confidence in really everything that they're involved in now.


**Del Bigtree**: What would need to be changed at the CDC, the NIH, the HHS...?

Dr. Ladapo: I do think you need a purge of some of the, maybe a lot of, the individuals, particularly in leadership positions who think that it's more important to have a specific message than to be aligned with [the scien-

tific] data. And even at lower levels, I think we could pitch it as "We can leave on friendly terms. This is a new mission. If you're not on board with this new mission, then we'll find a way to—you ought not be part of our organization. We've got nothing against you. This is what we're doing now." And I think that's important and I hope that that happens soon...

Dr. Fauci—people don't even realize that guy, to the best of my knowledge, he's got no training in epidemiology—he's got

in epidemiology—he's got no training at all....He's got no training in health policy. Dr. [Deborah] Birx—I'm not sure how much training she has in any of these topics—public policy, health policy, epidemiology....They weren't even keeping up





#### White House: God Made Two Arms for Two Jabs


influenza vaccine, with annual, updated COVID-19 shots matched to the currently circulating strains for most of the population," he said.

The following excerpt is from *How to Raise a Healthy Child...In*Spite of Your Doctor (1987), by Robert S. Mendelsohn, MD:

#### WHY PEDIATRICIANS ARE DANGEROUS....

7. Pediatricians are the most likely of all specialists to enhance their income by promoting and defending laws that force patients to use their services. It is pediatricians, not politicians, who are responsible for mandatory use of silver nitrate or antibiotic drops in a newborn's eyes, mandatory school physical examinations that provide opportunities for "creative diagnosis" of nonailments, manda-



tory hospital births, and court-ordered use of controversial and unproven methods of treatment to which the parents object. Increasingly, one of the dangers inherent in taking your child to the doctor is the possibility that he may be taken from you and placed in state custody if you reject the treatment that his doctor demands. I have testified in behalf of the parents in many such legal actions in recent years.

8. Pediatricians are the principal foes of breastfeeding, despite incontrovertible evidence that it is one of the most effective ways to assure the future health of your child. Although the LaLeche League is beginning to counter the influence that the formula makers have long had on pediatricians, many doctors either fail to encourage or actively discourage breastfeeding. I won't go into all of the reasons for this, but it is worth noting that the growth of the pediatric specialty in the United States can be attributed in large measure to the financial support of the manufacturers of infant formula, who have long used pediatricians as unpaid salesmen.

#### **Did Lockdowns Increase Mortality Rates?**


Many didn't have access to routine medical care during lockdowns, and are now dying from chronic diseases that went untreated. Just released data from United Kingdom show excess deaths in England and Wales were 14.4% higher than the five-year average—that's 1,350 more deaths per week than normal. A majority of these excess deaths were cardiovascular in nature—a primary adverse effect of the COVID jabs.

#### Fibrous Clots Found in 'VACCINATED' Corpses

Funeral director Richard Hirschman reports that embalmers have been finding numerous long, fibrous clots in the bodies they are preparing for burial. These unidentifiable growths were unknown to them before the forced injections.

"Numerous embalmers from different states confirmed...that they have been seeing these strange clots, starting from either



2020 or 2021....The string-like structures differ in size, but the longest can be as long as a human leg and the thickest can be as thick as a pinky finger."

According to Hirschman, "Prior to 2020, 2021, we probably would see somewhere between 5 to 10 percent of the bodies that we would embalm [having] blood clots. We are familiar with what blood clots are, and we've had to deal with them over time," he told the *Epoch Times*.

He says that now, 50 percent to 70 percent of the bodies he sees have clots. "For me to embalm a body without any clots, kind of like how it was in the day, prior to all of this stuff ... It's rare. The exception is to embalm a body without clots," he noted.

#### **American History of Medical Racism & Savagery**



Wouter Basson was director of Project Coast, the White South African biological and chemical warfare agency that developed various poisons, viruses, biological agents, and drugs to use against Blacks, including a vaccine that caused sterility.

Basson was called the "Mengele of South Africa" and was suspected of at least 229

poisoning murders. When asked about his racist operation, Basson did not mention Hitler, Mengele, or the Nazis: "I must confirm that the structure of the project was based on the U.S. system. That's where we learnt the most."

#### **Ivermectin reduces COVID death risk** by 92%, peer-reviewed study finds

new peer-reviewed study found that regular Ause of ivermectin reduced the risk of dying from COVID-19 by 92%.

The study was conducted on a strictly controlled population of 88,012 people from the city of Itajaí in Brazil.

Individuals who used ivermectin as prophylaxis or took the medication before being infected by COVID experienced significant reductions in death and hospitalization.

According to the study, those who took ivermectin regularly had a 92% reduction in their COVID death risk compared to non-users and 84% less than irregular users.

"The hospitalization rate was reduced by 100% in regular users compared to both irregular users and non-users," the study stated.

The impressive reduction for regular ivermectin users was evident despite the regular



users being at a higher risk for COVID deaths. The regular users were older and had a higher prevalence of type 2 diabetes and hypertension than irregular and non-users.

Irregular users of ivermectin had a 37% lower mortality rate reduction than non-users. The study defined regular users as those who used more than 30 tablets of ivermectin over five months. The dosage of ivermectin was determined by body weight, but "most of the population used between two and three tablets daily for two days, every 15 days."

"Non-use of ivermectin was associated with a 12.5-fold increase in mortality rate and a seven-fold increased risk of dying from COVID-19 compared to the regular use of ivermectin," the study read.
