


What did they know and when did they know it?

“We have talked about the policy of our government to depopulate the Third World by putting sterilants in the water and in staple foods, as well as other methodologies. als and resources were deemed necessary—in her mind—for her national interests; to keep America in the world as the ‘No. 1 superpower.’ ”

Now after two-and-a-half years into this so-called COVID-19 “pandemic,” we must ask ourselves if we are in the middle of the United States government’s planned genocide against the Third World and even America’s own people? We now know that the so-called vaccines developed in a military-like operation called “Warp Speed,” which was headed by a four-star Army general, are not effective against transmission of the SARS-Cov-2 virus and are not safe. In fact, there is mounting evidence that the COVID-19 shots not only increase the transmission of this virus but also have dangerous side effects, including death.

We have learned that the very drugs, hydroxychloroquine and ivermectin, that were attacked like an enemy of the state by government agencies like the FDA and CDC, could have been used to stop the spread of the SARS-Cov-2 virus in its tracks from the very beginning of the so-called “pandemic” in early 2020. However, to protect the government’s scheme of getting Big Pharma to make their kill shots, disguised as vaccines, they had to act like there were no effective remedies available other than vaccines. So, we must question the government’s handling of this so-called “pandemic.” We must ask, “What did they know and when did they know it?”

In a February 2021 interview, Dr. Vladimir Zelenko, who successfully treated thousands of COVID-19 patients using his protocol, which included hydroxychloroquine (HCQ), said: “There are papers with [Dr. Anthony] Fauci’s name on it, calling [HCQ] a miracle drug. Fauci called HCQ a vaccine. There’s a paper in which he called it an absolute dream treatment and vaccine” He continued, “I think this was a genocide against the elderly and a crime against humanity ... There are plenty of people who have blood on their hands, including the media.”

Recently, an August 22, 2005 *Virology Journal* article has been unearthed on the government’s own NIH (National Institute of Health) website titled, “**Chloroquine is a potent inhibitor of SARS coronavirus infection and spread.**” Among other findings, the article states:

“**Background:** Severe acute respiratory syndrome (SARS) is caused by a newly discovered coronavirus (SARS-CoV). No effective prophylactic or post-exposure therapy is currently available.

“**Results:** We report, however, that chloroquine has strong antiviral effects on SARS-CoV infection of primate cells. These inhibitory effects are ob-

served when the cells are treated with the drug either before or after exposure to the virus, suggesting both prophylactic and therapeutic advantage....

“**Conclusion:** Chloroquine is effective in preventing the spread of SARS CoV in cell culture. Favorable inhibition of virus spread was observed when the cells were either treated with chloroquine prior to or after SARS CoV infection.”

So, Dr. Zelenko was right in stating that Fauci, as head of NIAID (National Institute of Allergy and Infectious Diseases) since 1984, knew about the effectiveness of chloroquine and its less toxic metabolite, hydroxychloroquine, at least as early as 2005. Yet when SARS CoV-2 surfaced, he and other officials of the NIH, CDC and FDA acted like they did not know of any effective drugs that could be used to prevent the spread of the virus and save lives.

Interestingly, in that same year, 2005, the Prep Act was signed in preparation for their present genocidal acts. According to Wikipedia, the Public Readiness and Emergency Preparedness Act (PREPA), was passed by the United States Congress and signed into law by President of the United States George W. Bush

in December 2005. Among its many broad powers, the Prep Act gives the Secretary of Health and Human Services (HHS) the ability to make medical declarations that **become law**, like declaring an emergency use authorization (EUA). This EUA allows the pharmaceutical companies to forgo the lengthy 5-to-10-year period previously required to bring a “safe and effective” vaccine to market, but instead they can now stick some experimental drug into the arms of the American people with complete immunity from prosecution for vaccine injuries or death caused by vaccines.

The U.S. Department of Health and Human Services (HHS) oversees the NIAID, the NIH, the FDA, and the CDC.

Former President Donald Trump appointed the former head of Eli Lilly, a major drug company, Alex Azar, to become his Secretary of the HHS, who was confirmed on January 14, 2018. It was Alex Azar who invoked his powers from the Prep Act to declare on January 31, 2020, that a “Public Health Emergency Exists,” which gave permission to the drug companies to produce a “vaccine” without the threat of being sued, because, “No effective prophylactic or post-exposure therapy is currently available.” Yes, the pharmaceutical companies produced their kill shots, but it was the government, including the NIH and Department of Defense, that paid them billions of dollars to do it and protects them from the American people when they wake up to what’s been done to them.

But the government and Big Pharma knew about HCQ since 2005, and they also knew about the safety and effectiveness of Ivermectin in combating the SARS-CoV virus from research published in 2020. In June of 2020 the NIH published on its own website the research article “The FDA-approved drug ivermectin inhibits the replication of SARS-CoV-2 in vitro.”

The article’s abstract states:

“Although several clinical trials are now underway to test possible therapies, the worldwide response to the COVID-19 outbreak has been largely limited to monitoring /containment. We report here that Ivermectin, an FDA-approved anti-parasitic previously shown to have broad-spectrum anti-viral activity in vitro, is an inhibitor of the causative virus (SARS-CoV-2) ... Ivermectin therefore warrants further investigation for possible benefits in humans.”

Case closed. Fauci, HHS, the NIH, FDA and CDC have all lied and thereby allowed and enabled the unnecessary deaths of thousands in the United States and millions across the globe whose governments depended on the United States for guidance.

Fortunately, the African countries listened to Minister Farrakhan instead of the genocidal U.S. government. Like Minister Farrakhan has said, “We Are Victims of Genocide.”

Excess Deaths Skyrocket Since "Vaccine"


Excess deaths are the amount of mortality above normal conditions—all deaths from all causes—and they have dramatically increased since the rollout of the COVID injections. Walensky's CDC "RESET" is
More Medical Tricknology

Centers for Disease Control and Prevention Director **Rochelle Walensky** told *CBS News*, *"We need to have special forces, if you will, to deploy during pandemic times."* Walensky's proposal for the unit comes amid her claim to begin a major reorganization of the agency following "some pretty public mistakes" during the COVID-19 "pandemic."

Walensky, we must remember, says she learned of the science supporting the Pfizer "vaccine" from *"the CNN feed."* Then, America's top infectious disease specialist offered this vaccine gibberish: "Nobody said 'waning' when you know this vaccine's gonna work, oh well, maybe it'll work, it'll wear off. Nobody said, 'Well what if the next variant doesn't, it doesn't, it's not as potent against the next variant.'"

Walensky's latest mea culpa is pure tricknology. She slips in two ominous clues amidst her "apology." First, her use of the term "special forces" doesn't sound very medical- or health-related at all. It is a direct reference to the militarization of the CDC's capabilities.

In May of 2020, the noted US and Israeli government attorney **Alan Dershowitz** was asked if American citizens can be forced to take a vaccination:

"Absolutely. Absolutely. And if you refuse to be vaccinated, the state has the power to literally take you to a doctor's office and plunge a needle into your arm....[Y]ou have no right to refuse to be vaccinated against a contagious disease. Public health, the police power of the Constitution, gives the state the power to compel that; and there are cases in the United States Supreme Court."

Walensky's "special forces" will give the CDC that needle-plunging capability.

Second, Walensky calls it a "RESET." This is a calculated term designed to let the international depopulators know that the US government is still on board with the "Great Reset" plan laid out by the **World Economic Forum** and its megalomaniacal mastermind

Klaus Schwab. He advocates a one-world government with a massively reduced population. Survivors will live in a world of "transhumanism"—the merging of man and machine—which Schwab expected the "pandemic" would usher in. Walensky's "RESETTING" of the CDC was a wink and a nod to that wicked agenda.

Florida Gov. DeSantis Attacks 'Little Elf' Fauci

Florida Gov. **Ron DeSantis** attacked **Dr. Anthony Fauci** with these provocative words during a campaign stop on his "Keep Florida Free Tour":

"I'm just sick of seeing him! I know he says he's going to retire. Someone needs to grab that little elf and chuck him across the Potomac."

DeSantis is a possible 2024 presidential candidate and so the disdain directed at Fauci has larger implications. The 81-year-old Fauci is the powerful director of the National Institute of Allergy and Infectious Diseases, and he is the very face of the medical establishment controlled by Big Pharma. Since the 1980s Fauci has presided over the failing health of America and the expanding wealth of the drug industry. He represents a corrupt institution—one that DeSantis says ought to be "chucked across the Potomac."

In Florida, Gov. And since then, Florida has become among the safest states to be in.

DeSantis was not only repudiating Fauci, who just announced his semi-retirement. DeSantis was signaling Big Pharma that his presidency could mean the end of their profitable reign as drug pushers to the sickest and most chemical-dependent population in American history. They have achieved this status through "agency capture," the wholesale purchasing of the many "public" health agencies and their judicious bribery of see-no-evil politicians.

If he is elected, DeSantis will likely appoint Dr. Ladapo as Surgeon General, but he certainly cannot stop there. 

Their failures are well known, even to themselves. Dr. Deborah Birx, who was “White House Coronavirus Response Coordinator” under Donald Trump, made news recently by admitting that she deceived the president in pursuit of her own misguided desire to lock down the country. But in March of 2021 she told CNN that she believed more than 90 percent of the deaths attributed to COVID-19 were unnecessary:

“I look at it this way. The first time we have an excuse. There were about a hundred thousand deaths that came from that original surge [in 2020]. All of the rest of them, in my mind, could have been mitigated or decreased substantially.”

As of today that means 967,549 died, by Dr. Birx's estimation, unnecessarily! But Fauci, Birx and the government's top depopulators in pursuit of their vaccine-only objective actively and aggressively suppressed safe and effective treatments like Ivermectin and Hydroxychloroquine that had reduced death rates all over the globe.

Mr. Science himself, Anthony Fauci, even wondered “*how a rich and sophisticated country can have the most percentage of deaths and be the hardest-hit country in the world. That I believe should not have happened.*”

This is disingenuous in the extreme. If his aim was to actually protect the health of Americans, he would have

If he could do it all over again, he lamented as only a psychopath could, there “*would have been much more of an alarm and there would have been much, much more stringent restrictions in the sense of very, very heavy, encouraging people to wear masks, physical distancing or what have you.*”

Toxic, Metallic Compounds Found in All COVID Vaccines

The Children's Health Defense reports that a group of German scientists found toxic components—mostly metallic—in all the COVID-19 vaccine samples they analyzed using modern medical and physical measuring techniques.

The Working Group for COVID Vaccine Analysis says that some of the toxic elements found inside the AstraZeneca, Pfizer and Moderna vaccine vials were not listed in the ingredient lists from the manufacturers. Among the metals they found are caesium, potassium, calcium, barium, cobalt, iron, chromium, titanium, aluminum, silicon, and sulphur.

The following excerpt is from *How to Raise a Healthy Child... In Spite of Your Doctor* (1987), by Robert S. Mendelsohn, MD:

“If you think about the relationships you have had with doctors. I suspect you'll be surprised to discover that they're unlike those you have with anyone else who provides you with a service. The typical doctor-patient relationship is revealed in a phrase that has become part of the language—‘*doctor's orders.*’ Doctors *do* give orders to their patients; lawyers, accountants, and other professionals give advice. [...] The confidence inspired by the demeanor of pediatricians is, in my experience, undeserved. It tends to mask the elements of pediatric practice that are threatening to your child.”
