Due to a process known as "immune imprinting," which handcuffs your immune system, we could well be facing the "dark winter" President Biden warned would befall us.

COVID-19 has been going on for nearly three years, and with a whole new set of untested COVID boosters being rolled out, some scientists are taking a step back, cautioning that there still are unanswered questions about how the shots work.

They say more research needs to be done on what is known as "original antigenic sin," aka "immune imprinting," which refers to how your immune system responds to repeated introductions of the COVID variants.

## Understanding Original Antigenic Sin

The following description of original antigenic sin was published in a January 2019 *Journal of Immunology* paper titled "Original Antigenic Sin: How First Exposure Shapes Lifelong Anti-Influenza Virus Immune Responses":

"The term 'original antigenic sin' (OAS) was first used in the 1960s to describe how one's first exposure to influenza virus shapes the outcome of subsequent exposures to antigenically related strains. In the decades that have passed, OAS-like

responses have been shown to play an integral role in both protection from and susceptibility to infections.

"... OAS describes the phenomenon whereby the development of immunity against pathogens/Ags [antigens] is shaped by the first exposure to a related pathogen/Ag ... subsequent infections with similar influenza virus strains preferentially boost the Ab [antibody] response against the original strain ..."

## Simplified Example

Here's a layman's summary to illustrate this phenomenon as simply as possible, within the context of COVID:

- Exposed to the **original Wuhan SARS-CoV-2 strain**, your humoral immune system is programmed to produce antibodies against that specific virus. Similarly, if you got the jab, your body will produce antibodies against the viral spike protein formulated into that shot.

- Exposed to the **Delta strain**, your immune system responds first by boosting production of the orig-

inal antibodies, while antibodies specific against Delta are produced in a far lower amount as it takes time for your body to respond to the new strain.

- Exposed to an **Omicron variant**, your immune system again responds by boosting the original antibodies, while antibodies against Omicron are produced in even lower amounts than those against Delta.

As a result of this process, with each exposure to a new variant, the original antibodies get "backboosted." So, over time, those antibodies come to predominate.

The process is (at least theoretically) the same for all vaccinations. Each booster dose backboosts or strengthens the original antibodies, making them more and more predominant. The problem is that they may not be effective at neutralizing newer strains (depending on the amount of mutation), thus rendering you more and more prone to symptomatic infection.



## Frequent Boosting May Backfire

As reported by ABC News:

*“Some experts say they are concerned that frequent boosting with the original version of the vaccine may have inadvertently exacerbated immune imprinting. At this point in the pandemic, some adults have received four or more doses of the same vaccine ...*

*[Some] scientists worry about a potential backfire, with frequent boosting handcuffing the body’s natural immune system and leaving it exposed to radically different variants that might emerge in the future.*

*‘Where this matters is if you keep giving booster doses with [original] strain, and continue to lock people into that original response. It makes it harder for them to respond then to essentially a completely different virus,’ says Dr. Paul Offit, professor of pediatrics at Children’s Hospital Philadelphia ...*

*The timing of vaccines may also need to be taken into account, as the nation moves from original doses to updated boosters.*

*‘It is true that the best boosts typically are the ones that are given infrequently, that immunologically, if you boost too much and too frequently, then you often have a lower immune*

*response at the end,’ said [director of the center for virology and vaccine research at Beth Israel Deaconess Medical Center, Dr. Dan] Barouch.”*

## Data Confirm Negative Efficacy After Second Dose

In [a recent “Good Morning CHD” episode], Dr. Meryl Nass reviews official data from the U.S. Centers for Disease Control and Prevention, which confirm that people who got two or three COVID jabs are MORE likely to get ill with COVID six to eight months after the last dose than had they gotten none.

## Should You Double Up on COVID Booster and Flu Shot?

Our reckless health authorities are potentially worsening matters further by pushing people to simultaneously get the updated bivalent COVID booster and a seasonal flu vaccine this fall.

Early in September 2022, White House medical adviser Dr. Anthony Fauci urged Americans to

“Get your updated COVID-19 shot as soon as you are eligible,” and White House COVID coordinator Ashish Jha, September 6, stated, “I really believe this is why God gave us two arms, one for the flu shot and the other one for the COVID shot” — a statement that will live on in infamy as one of the most ridiculous comments from a public health official ever uttered.

One problem, although hardly the most important one, is that it’s still far too early for a flu shot. As noted by STAT News:

*“The protection generated by influenza vaccines erodes pretty quickly over the course of a flu season. A vaccine dose given in early September may offer limited protection if the flu season doesn’t peak until February or even March, as it did during the unusually late 2021-2022 season.*

*‘If you start now, I am not a big fan of it,’ Florian Krammer, an influenza expert at Mount Sinai School of Medicine in New York, told STAT. ‘I understand why this is promoted, but from an immunological point of view it doesn’t make much sense.’”*

STAT cites research showing the effective-



ness of the flu shot wanes by about 18% for every 28 days’ post-vaccination. What it doesn’t mention is the fact that the flu shot historically has had an effectiveness

- 29% for all ages
- 49% for children aged 6 months through 8 years
- 6% for children ages 9 through 17
- 25% for adults between the ages of 18 and 49
- 12% for those over 50

## This May Become the ‘Dark Winter’ Biden Warned About

Ever since the rollout of the COVID shots, there have been suspicions that some kind of shedding is happening between the jabbed and the unjabbed. With mass flu vaccination, the possibility of transmission is further exacerbated, and there’s no telling what kind of viral mutations the combination of a bivalent COVID jab and a quadrivalent flu shot might produce.

A study published January 18, 2018, in the journal *PNAS* showed that people who receive the seasonal flu shot and then contract influenza excrete infectious influenza viruses through their breath.

What’s more, those vaccinated two seasons in a row had a greater viral load of shedding influenza A viruses. According to the authors, “We observed 6.3 times more aerosol shedding among cases with vaccination in the current and previous season compared with having no vaccination in those two seasons.”

This study also highlighted the possibility that annual flu vaccination might lead to reduced protection against influenza over time, and that each vaccination can make you progressively more prone to getting sick. That, again, is the original antigenic sin phenomenon discussed above.

Now, combine the possibility of antigenic sin for COVID with the antigenic sin for influenza, and what might we end up with? Who knows? Research has also shown that priming your immune system with influenza vaccine can make you more susceptible to bacterial infections as well, and what are face masks loaded with? Bacteria.

Taken together, we could well be facing the “dark winter,” President Biden warned would befall the unvaccinated last year. But it’ll be those with COVID booster and quadrivalent flu shots who will suffer the most. The rest of us will hopefully avoid problems provided we keep our immune systems strong.

## CDC: Suicide attempts among teen girls increased 50% during plandemic

Suicide is the third leading cause of death among young people in the U.S., according to the Centers for Disease Control and Prevention. Since 2019, the number of teenage girls who have been suicidal has increased 50%.

Depression and suicides were increasing for teenage girls between 2019 and 2021, with experts attributing pressure amid COVID-19 plandemic shutdowns as a major culprit.

The increase was first noted in early May 2020, when E.R. visits for suspected suicide attempts began increasing among adolescents, especially among girls. By that August suicide attempts among girls was 26.2% higher than during the same period a year earlier. Last winter E.R. visits for suspected suicide attempts were 50.6% higher among girls compared with the same period in 2019.

Government Depopulators generated mass fear and anxiety, which seem heightened in young girls, leading to this drastic result. The loss of a girl by suicide, in their diabolical calculation, amounts to an immediate population reduction of 1, and the loss of her future generations.

## U.S. abortions rose in 2020, with about 1 in 5 pregnancies terminated

Black baby abortion has always been one of the main methods of mass racial DEPOPULATION. And now, after a long decline, the number and rate of U.S. abortions increased under the last two years of the COVID population reduction operation.

The pro-abortion Guttmacher Institute counted more than 930,000 abortions in the U.S. in 2020. That is up from about 862,000 abortions in 2017, which was the lowest yearly number since the 1973 U.S. Supreme Court ruling that legalized the procedure nationwide.

About one in five pregnancies ended in abortion in 2020, possibly related to the fear and anxiety purposely generated by the plandemic leaders. Additionally, it is speculated that easier access to financing available through Medicaid may have aided in the increase. In 2020, fewer women were getting pregnant and a larger share of them chose abortion. According to the Guttmacher report, medication abortions, the two-drug combination sometimes called the "abortion pill," accounted for 54 percent of U.S. abortions in 2020, the first time they made up more than half of abortions.

Black women account for 38.4% of abortion recipients, the largest share among other racial and ethnic groups, according to 2019 data from the CDC. That year, white women had the lowest abortion rate (6.6 abortions per 1,000 women and 117 abortions per 1,000 live births), and Black women had the highest (23.8 abortions per 1,000 women and 386 abortions per 1,000 live births).

In 2019, 14.5% of women who obtained an abortion were married, and 85.5% were unmarried. The abortion ratio was 46 abortions per 1,000 live births for married women and 394 abortions per 1,000 live births for unmarried women.

## Nearly Half of Pregnant Women in Pfizer Trial Miscarried

According to Dr. Naomi Wolf, who has analyzed 300,000 Pfizer documents released via a Freedom of Information Act, **44 percent of pregnant women who participated in the drug maker's COVID-19 vaccine trial lost their babies.** Dr. Wolf spoke to Steve Bannon:

"Women will understand how tragic this is. Pfizer took those deaths of babies, those spontaneous abortions and miscarriages, and recategorized them as 'recovered result adverse effects.' In other words, if you lost your baby, it was categorized by Pfizer as a resolved adverse event, like a headache that got better."

Despite proof of Pfizer's baby-killing kool-aid, the CDC recommends COVID-19 "vaccines" for "people who are pregnant, breastfeeding, trying to get pregnant now, or might become pregnant in the future."

## Vaccine Corner


Almost everyone has seen the many horrific videos of young and apparently healthy people dropping dead without warning or obvious cause. The phenomenon is known as **SADS—Sudden Adult Death Syndrome.** In light of the **OBVIOUS** connection to the deadly COVID "vaccines," many are revisiting **Sudden Infant Death Syndrome**, known as **SIDS**, to see whether childhood vaccines may also be the cause.

**Barbara Loe Fisher**, coauthor of *DPT: A Shot in the Dark*, cofounder of **National Vaccine Information Center (NVIC.org)**, and mother of a brain-injured son, addressed the SIDS-vaccine connection, in the online journal *The Vaccine Reaction*:

"From the beginning, death has always been a consequence of vaccination....Since 1986, the Government has awarded over \$2 billion in compensation for deaths and injuries caused by vaccines."

"A nation which spends more per capita on healthcare and requires their children to get more vaccines than any other should have one of the best infant mortality rates, not one of the worst. When healthy babies die shortly after their vaccinations, parents legitimately ask whether vaccines did it, and are met with quick denials by doctors and public health officials."

"Their death certificates typically list SIDS as the cause, which means that no specific symptoms or reason for death could be found. Yet most babies dying after their shots are not found dead in their cribs without any symptoms, but rather have suffered for days with high fever, collapse, screaming, arching of the back, diarrhea, and the like, which their pediatricians often dismiss as unimportant. Others suffer mental and physical deterioration that gets worse after each shot until they are found dead in the crib. The inconvenient truth remains that there are more full-term babies dying before their first birthday than in most developed nations of the world."

## Fauci Admits He Knew his ‘Draconian’ Lockdowns Would Damage School Children

**Dr. Anthony Fauci** was recently caught trying to dodge responsibility for ordering the country into lockdown. When asked, “Do you regret the sweeping shutdown that some said made things worse?” Fauci said, “No, I don’t...And in fact...I didn’t shut down anything.” Yet an almost braggadocious Fauci is on the record in October of 2020 recalling publicly that he advised President Donald Trump: *“When it became clear that we had community spread in the country...I recommended to the president that we shut the country down. That was a very difficult decision, because I knew it would have serious economic consequences, which it did.”*

Most recently Fauci, whose “COVID” response measures are among the worst of all 200 nations on earth, has admitted that he was aware of the damage the lockdown policies would cause on those who were least threatened by “COVID-19”—the children:

*“And sometimes when you do draconian things, it has collateral negative consequences, just like when you shut things down, even temporarily, it does have deleterious consequences on the economy, on the schoolchildren. You know that.”*

Fauci ignored the many nations and states that fared far better without “draconian” damage inflicted on its most vulnerable. Fauci’s comments followed a bombshell education report revealing that COVID-19 lockdowns, which led to school closures and virtual learning polices, resulted in what the Department of Education said was *“the largest average score decline in reading since 1990, and the first ever score decline in mathematics”* among the nation’s schoolchildren.

## Judge Rules Against Vaccine Mandate for NYC Police

**Judge Lyle Frank** said in a Sept. 23 ruling that an estimated 1,750 New York City police officers who lost their jobs for refusing the poison needle must be “reinstated to the status they were as of the date of the wrongful action.”

In a bizarre action 850 more NYC teachers and classroom aides who refused the chemical “COVID” injections were fired, bringing the total to nearly 2,000 school employees. **Mayor Eric Adams**, having not a trace of logic guiding his plandemic policies, simultaneously announced that high school students would no longer have to be “vaccinated” to engage in sports and other extracurricular activities, even while stressing the need for New Yorkers to get their COVID booster shots.

Mayor Adams has not lifted the “vaccine” mandate, while other cities and states are dropping such requirements due to revised CDC guidelines and upcoming elections.

## Study: Chronic Asthma Linked to Childhood Vaccines

A new study has found a possible link between aluminum used in vaccines that are given to young children in the first two years of life, and the risk of developing asthma before age 5. The new study is based on a large group of nearly 327,000 children born between the start of 2008 and the end of 2014.

The study suggests that young children who were vaccinated with most or all of the recommended aluminum-containing vaccines had at least a 36% higher risk of being diagnosed with persistent asthma than children who got fewer vaccines. The study’s authors said that their findings open the door to further research on this issue.

The CDC, which many critics say is simply a “captured” rubber stamp agency for the pharmaceutical companies, actually funded the study, but it was quick to downplay the results. The agency claims an increase in asthma among young children predated the addition of aluminum to vaccines, which occurred in 1991. But other reports assert that aluminum has been used in some vaccines since the 1930s. Aluminum is used in a number of vaccines as an *adjuvant*—a way to boost the immune response the vaccine triggers. By age 2, most children are vaccinated against 15 diseases, and aluminum adjuvants are in vaccines for seven of them, including diphtheria, tetanus, and pertussis; hepatitis B; and some flu vaccines. The CDC noted that many factors that couldn’t be measured in this study might increase a child’s risk of developing asthma. Fox News quoted Dr. Sarah Long, professor of pediatrics at the Drexel University College of Medicine:

“I believe in complete transparency. If you’ve asked a question and here spent our (taxpayer) money to (investigate) that question, I think the results should be aired in all of its warts and glory.”

## American History of Medical Racism & Savagery

### The Tuskegee Experiment: A U.S. Government Nazi-Like Atrocity

The Tuskegee human guinea pig experiments were conducted in Alabama between 1932 and 1972 on 431 Black men who were tricked into believing they were receiving medical treatment for a painful ailment they were told was “bad blood.” The disease was syphilis, and the doctors were well aware that its unchecked spread would ultimately kill those afflicted. Your bodies are turned into a spike protein factory, and spike proteins are definitely acutely toxic in loads of different ways: autoimmunity, blood clots, neurological problems, impact on fertility, and so on.*

*So I’ve told you that they’ve created the impression of a scare; they’ve smashed the economy and civil society using useless measures; they’ve got you to wait for a rushed so-called vaccine that has not shown to be effective or safe, that never could have worked, even if the original setup about a viral threat was correct. And yet they’ve jabbed—I don’t know—4 billion, 6 billion poor souls. Something like one in a thousand people have died. We don’t know how many more will die. But we’re into double figures of millions who’ve definitely been killed as a consequence of this policy. And that tells you that the people who are doing this are ruthless, I’d say diabolical. That we’re beyond wrong and right...*

*We’re in the good versus evil. I’m not, I’ve not been a religious person, but I’m absolutely clear in my mind: the only people—the kind of planning and thinking it takes to have done what has happened—are people who would worship Satan. They’re not normal people. I couldn’t do one part of this and continue to be alive after I’ve done it.*
