

Why is the Government still trying to force these so-called vaccines on our children?

This analysis found there is an 84% increase in the relative incidence of cardiac-related death among males 18-39 years old within 28 days following mRNA vaccination.”

It further states: “The State Surgeon General now recommends **against** the COVID-19 mRNA vaccines for males ages 18-39 years old ... **Non-mRNA** vaccines were **not** found to have these increased risks among **any** population ... The Department continues to stand by its Guidance for Pediatric COVID-19 Vaccines issued March 2022, which recommends **against** use in healthy children and adolescents 5 years old to 17 years old. This now includes recommendations **against** COVID-19 vaccination among infants and children under 5 years old, which has since been issued under **Emergency Use Authorization.**”



mandates. Yet some colleges across the country are still mandating that their students take these shots or be dismissed from school.



The UN-Masking of Black America

Pfizer's Organized Crime in Africa

Democracy Now reported that documents released by WikiLeaks show the pharmaceutical giant Pfizer hired investigators to find evidence of corruption against the Nigerian attorney general to pressure him to drop a \$6 billion lawsuit over fraudulent drug tests on Nigerian children.



Pfizer was under investigation because their researchers did not obtain signed consent forms and did not tell parents their children were getting the experimental drug.

Eleven children died, and others suffered disabling injuries including deafness, muteness, paralysis, brain damage, loss of sight, and slurred speech.

Pharmaceutical companies are increasingly conducting clinical trials for new drugs outside the U.S., usually in countries where regulations are less stringent and trials are much cheaper, often leading to deadly results. Twenty years ago, only 271 trials of drugs intended for use by Americans were conducted overseas. By 2008, the number had risen to nearly 6,500—many taking place in areas with poor and illiterate test subjects.

Germany Sneaks in Vax Passport with planned global public transit pass

In a not-so-stealthy move toward imposing the **VACCINE PASSPORT** and an enforced worldwide slavery, German officials want to introduce a "global public transport ticket" that can be used anywhere around the world.



Travelers would pay a single monthly price of \$47 and they can travel by train, trolley or bus in any city and country in the world. Officials plan to market it as an environmentally friendly measure to reduce gasoline and thus "global warming," and a convenient way to standardize the varied and confusing world transportation systems. Poll: Two thirds of U.S. adults don't plan on getting COVID "boosters"

Trust in the "public health" officials has been obliterated as more and more people wake up to the depopulation agenda of their political leaders.

Despite the pleas of "health" officials like Drs. Fauci, Jha, Walensky, and Murthy, the Kaiser Family Foundation (KFF) poll reveals that two-thirds of adults in the United States **do not** plan to get updated COVID-19 booster shots soon, while 10% said they would only get a booster if it was required.

About 7.6 million people received the updated shots over the first four weeks the boosters have been available, according to CDC data just released. That represents about 3.5% of the 216 million people in the United States aged 12 or older who are eligible to receive the shots.

Vaccine Corner

1/3 of Jabbed Reported Injuries After COVID "Vaccine," CDC's V-safe Data Show

Data collected from the U.S. Centers for Disease Control and Prevention's V-safe app reveal that huge numbers of people (and more women than men) suffered adverse events following their vaccination.

V-safe is a voluntary safety monitoring program put in place by the CDC to monitor adverse reactions after people take a vaccine. It took a court order to release the information, after the CDC was sued by the watchdog group ICAN—the Informed Consent Action Network (which also produces The Highwire weekly news program TheHighwire.com). Vaccine journalist Steve Kirsch commented that the just-released data "clearly shows that these vaccines are the most dangerous vaccines we've ever created..."

The V-safe data show that 33.1% of the people who got the vaccine suffered from a significant adverse event and 7.7% had to seek professional medical care. Kirsch writes that "These are extraordinary numbers....The mainstream media is ignoring this story. So is the mainstream medical community. None of them want the American people to know the truth about how unsafe these vaccines are."

An Estimated 30,000 Americans Were Killed by Ventilators & Iatrogenesis in April 2020

A new analysis of death records during the peak lockdown time in the spring of 2020 shows that medical ventilators widely used to treat “COVID patients” may have killed 30,000 of them.

Attorney **Michael P. Senger** wrote: “To date, we still don’t have especially good studies on the actual causes of excess deaths by state and country when the world first went into lockdown in spring 2020. For political reasons, these deaths were all generally lumped together as ‘Covid deaths,’ but this coding was appallingly sloppy.”

His analysis concluded that “contrary to popular belief, there was no uniquely deadly strain or variant emanating out of New York in spring 2020; this is clear from the fact that several states close to New York such as Vermont, New Hampshire, and Maine experienced little to no excess deaths during that time period. On the contrary, over 30,000 Americans appear to have been killed by mechanical ventilators or other forms of medical iatrogenesis throughout April 2020, primarily in the area around New York [City].”

This result is not altogether surprising, he writes, “as subsequent studies revealed a 97.2% mortality rate among those over age 65 who were put on mechanical ventilators...as opposed to a 26.6% mortality rate among those over age 65 who

were not put on mechanical ventilators—before a grassroots campaign put a stop to the practice by the beginning of May 2020.”

As one doctor later told the *Wall Street Journal*, “We were intubating sick patients very early. Not for the patients’ benefit, but in order to control the epidemic... That felt awful.”

To put this in perspective, patients over age 65 were more than 26 times as likely to survive if they were not placed on mechanical ventilators.

Scientist and epidemiologist **Dr. Paul Alexander** examined Senger’s thesis and added that “Further investigation and study is needed to determine what factors contributed to resident deaths, COVID+ and otherwise.” He wrote that many deaths “were actually due to withholding treatment, neglect, cutting off visitors, isolation protocols, etc.” Dr. Alexander concludes:

“Do not forget, dear readers: There was no discernible excess death in NYC prior to lockdown orders. We are supposed to believe covid was spreading silently, minding its own business, without necessitating more ventilators (or PPE or PCR tests) until elected & public health officials gave it permission to super-spread everywhere at once, triggering profitable — and wasteful — supply/demand opportunities. Even if attendant-mediated transmission played a role, it would mean the actions taken in the name of stopping a virus (one that was already here and circulating for many months) are the things that made it worse.”

CDC database: 648 Nursing Babies Harmed by COVID vax, 3 Dead

An analysis by Israeli scientists of reports in a database run by the CDC and the FDA found 648 cases of side effects in breastfed infants whose mothers received the COVID-19 vaccine, including three deaths.

Health authorities in the United States, Israel and around the world recommended the Pfizer and Moderna vaccines for pregnant and lactating women despite the lack of clinical studies or animal safety studies for that demographic.

In one case, a mother reported losing her 5-month-old infant 13 days after receiving the Pfizer COVID-19 vaccine on Jan. 28, 2021, and breastfeeding him.

“I pumped within an hour of receiving the shot. My 5 month old son nursed the night following the shot and later ate the pumped milk that I acquired the same day of the shot,” she said. “11 days later he was found unresponsive during his nap at daycare.”

After being rushed to the hospital, the mother said, “doctors were able to get his heart beating again with



excessive effort.”

“Organ damage was extensive and he had no brain function; he did not recover.”

In another report, dated March 17, 2021, a 5-month-old died just one day after his mother was vaccinated.

“Patient brought baby to local ER where assessments were performed, blood analysis revealed elevated liver enzymes. Infant was hospitalized but continued to decline and passed away.

Diagnosis of TTP. No known allergies. No new exposures aside from the mother’s vaccination the previous day.”

Naomi Wolf has been analyzing documents a court ordered Pfizer to release. She said that they knew all along that the “mRNA, lipid nano particles and polyethylene glycol” would contaminate the breastmilk of vaccinated mothers. “These are criminal people,” she said of public health and pharmaceutical officials, “concealing the truth from women.”

China ‘began stockpiling PPE months before Covid outbreak’

It is now being reported that China was stockpiling personal protective equipment (PPE) several months BEFORE the first indication that an outbreak of COVID-19 had occurred.

According to *The Telegraph*: “China began severely restricting the export of **personal protective equipment (PPE)**, such as gowns and masks, months before notifying the world of the outbreak of Covid-19, it has emerged. PPE exports to the US fell by around 50 per cent between August and September of 2019, in a significant drop which raised alarm bells at key US government agencies. China also started to buy up global PPE stocks in Europe, Australia and the US around the same time, experts said.” The public has been told that the emergence of “the virus” occurred in a Wuhan seafood market in December 2019.

The revelation is the latest in a growing list of incidents appearing to show clear foreknowledge by governments and prominent individuals of the coming COVID “pandemic.” A series of international planning meetings leading up to “COVID” was outlined in Robert F.
