

Nation of Islam Researchers Talk to World-Renowned Physician about Vaccines, Health, and Depopulation



Dr. Paul Marik

[Note: The following is an interview with Dr. Paul Marik conducted on October 16 at the FLCCC Alliance Educational Conference: Understanding and Treating Spike Protein-Induced Diseases]

Dr. Paul Marik is a world-renowned Pulmonary and Critical Care Specialist. He is the second most published Critical Care Physician in the world, publishing over 500 peer-reviewed journal articles and cited in scientific journals over 43,000 times. He is the chairman and co-founder of the Front Line COVID-19 Critical Care Alliance (FLCCC), which brings together the top experts in the field of pathology, evaluation, and treatment of spike-induced diseases to learn, share and network—and most important—to drive greater attention to and awareness of the increasing number of patients suffering with COVID and “vaccine” injuries. Brother Dr. Ridgely Muhammad and Sister Charlene Muhammad of the Nation of Islam conversed with Dr. Marik at the FLCCC’s educational conference held October 14–17, 2022, in Kissimmee, Florida.

[Note: The “mRNA vaccines” that have been pushed on the world actually instruct the human body to make spike proteins—a process that the body very often cannot control, leading to deaths and serious injuries and other yet unknown health conditions. The conference was designed to address this growing health crisis.]

Dr. Ridgely: Dr. Marik, they [practitioners of orthodox medicine] think that gene therapy can help everybody. So, if you’re trying to stop cancer, they’re just going to figure that one vaccine is going to work on everybody who has cancer. But what you seem to be saying is that the genetic differences between people are so great and unpredictable that you cannot just do a one thing for all.

Dr. Marik: Absolutely. So, this idea that one treatment works for all is a bigger problem in medicine, because it has to be personalized. ... Just looking at us, you can see we’re different, our genes are different. And even in people who are related, their genes are different. So, it has to be individualized. And so, we have to be careful with experimenting with stuff we don’t understand. So, the body has—what I’ve learned, and this is not what I’m taught in medical school—the body has

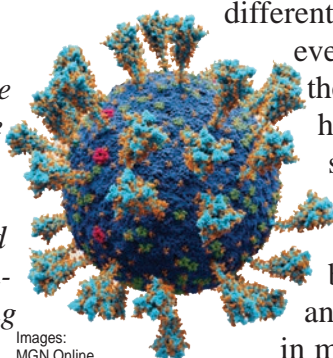
amazing capacity to regenerate and heal itself. That’s what the body does. And what you have to do is you have to embrace and enhance the body’s ability to heal itself. And people are different. Their genes are different. And that’s the skill of medicine.

And so, the remarkable thing is that one patient responds to one therapy and not another. And I think it’s a genetic thing because we’re all genetically different. And so that’s why one treatment will never work.

Dr. Ridgely: So, how much of an understanding of the genome do we have? I’ve heard that it’s just a ten percent understanding. How much do we know?

Dr. Marik: Yeah, so that’s a good question. I mean, the genome has been sequenced. So, we know the sequence, but in terms of understanding what the genes do and how they work, I think we are Neanderthals. We don’t understand it and we should not mess with things we don’t understand. ... The best example is

the statin drugs to treat cholesterol. The body makes cholesterol for a really good reason. You know, there's a very high concentration of cholesterol in our brain. And it's very important for brain function. And so, once you start messing, trying to get a lower cholesterol with drugs and statins, you're messing with nature, and it's going to have really bad consequences. So, we really have to be careful when we mess with nature. So, you'll see many of our [FLCCC Alliance's] therapies are to help the body help itself.

Dr. Ridgely: Yes. You blew my mind when you started running down the benefits of fasting, because that's what the Nation of Islam has been teaching for over 90 years—fasting, and eating just one meal a day.

Dr. Marik: And many religious cultures have fasting. It's not an accident. But they figured out that fasting is really good for the body. Different cultures do it different ways, but they've figured out that it's good for the mind and it's good for the body.

Sister Charlene: What do we do to get people who have been injured by this shot to come out of hiding so that they can get help?

Dr. Marik: A very good website is, *React 19* [<https://react19.org>]. And that's what they're there for, to help vaccine-injured people. They are a really good resource, and they will help people go in different directions. Our website [at <https://covid19criticalcare.com>] also has some links to treatment protocols. We're really into empowering patients and empowering doctors. We don't really go into medications. But there are many organizations that can help people who are vaccine-injured. But if they are vaccine-injured, they must get help, because the longer they wait, it's not going to get better on its own. They really need help. And so, *React 19* is a fantastic organization because they link patients with clinicians.

Sister Charlene: What would you like people to, above all, take away from this conference?

Dr. Marik: I think, first of all, people should take away that it [spike protein-induced disease as a result of vaccine injury and/or COVID complications] is a real disease. You know, many patients go to doctors showing these symptoms, and their doctors dismiss them. They say it's all in their heads. So I think the most important

thing is this is a real disease, and these patients are really suffering. And then the hope is that we can treat it. Patients mustn't lose hope, because we can treat it. We may not be able to cure them 100%, but we can make them better. And I think with time, we're going to learn more and more from this disease, and we'll be better. But I think the first thing is to recognize it, embrace it and treat it.

Sister Charlene: Is this a depopulation agenda?

Dr. Marik: Yes! I think there's a very sinister and dark agenda behind this. That's an area which is more difficult to talk about. But I think there are people who have really bad intentions, that are trying to do bad things, unfortunately. I wish I didn't have to say that, but there is a very bad and nefarious intention to control the population.

Dr. Ridgely: I think they thought they were ready to take over the planet, take over the people with this shot.

Dr. Marik: Yes!

Dr. Ridgely: But people are dying so quickly—it's like the body that God made is saying, "You will not have me." And now, they're dying quickly, and people are recognizing what they're doing, because they've been doing this slowly for a long time. Since people have dropped dead so quickly, we now know that depopulation is what they've been planning all along.

Dr. Marik: It's going to fail, because I think that we've forced them out. We now know what their intention is, and lots of people have been injured. So, I think they're not going to get away with it. I think that there will be more and more people. That's why I think events like this are important, and people need to spread the word that these vaccines are harmful. This is part of a very evil agenda. We need to speak up and stand up! CDC Unanimously Votes to Push Death-Dealing “Vaccines” on School Children

The U.S. Centers for Disease Control and Prevention (CDC) “vaccine advisory committee” voted 15-0 to add the COVID-19 shot to the growing list of recommended childhood vaccines. Most states follow this recommended immunization schedule when establishing vaccine requirements for schools and childcare facilities.

The move is the latest in a long-planned process to kill off a large portion of the human population while turning the survivors into chemically dependent slaves to a constant infusion of immune-system-suppressing “boosters.”

The CDC’s “advice” has been roundly denounced by scientists who point out that the “advisors” have provided not a shred of supporting scientific data to justify the mass injection of a dangerous drug to “protect” against an illness that has almost NO EFFECT on children.

Further, the toxic waste the agency calls a “vaccine” was foisted onto the public under Emergency Use Authorization or EUA, and under that designation the manufacturers escape legal liability for any injuries or deaths their “vaccine” causes.

Commenting on the vote, **Robert F. Kennedy, Jr.**, chairman of the board and chief legal counsel for Children’s Health Defense (CHD), said: **“This reckless action is final proof of the cynicism, corruption and capture of a once exemplary public health agency....This is an act of child abuse.”**



Johns Hopkins School of Medicine professor **Dr. Marty Makary** appeared on **Tucker Carlson Tonight** (photo) and pointed out that **“There has never been a vaccine added to the child immunization schedule without solid clinical evidence that it reduces disease significantly in the community.”**

He added that the CDC only has data from eight mice on the effects of the Omicron “vaccine” in young people. According to Makary, White House Coronavirus Response coordinator **Dr. Ashish Jha** has seen the data on the vaccines’ effects but refuses to make it publicly available.

“What are they hiding? Why can’t we see this information?” he asked. Makary said those who wanted to see the data were **“basically told ‘stop asking questions.’”**

American History of Medical Racism & Savagery

In 1989, the **CDC, Kaiser Permanente, and the Los Angeles County Health Department** tested an experimental measles vaccine on 700 mostly Black and Latino infants, some as young as six months, sometimes giving them dosages hundreds of times normal levels. Standard measles vaccinations are given at 15 months of age. The infants’ parents were not informed that the vaccine was not licensed in the United States or that it had been associated with an increase in death rates—particularly among baby girls—in **Africa.**

Similar experiments were conducted on tens of thousands of children in **Senegal, Guinea-Bissau, Mexico, Gambia, Bangladesh, Togo, Rwanda, Sudan, Zaire and about a dozen other Third World countries,** leading to untold deaths and injuries.

Robert F. Kennedy, Jr. Releases Documentary Exposing Dr. Fauci

Robert F. Kennedy Jr.’s book *The Real Anthony Fauci* is an incredibly well-referenced record of Fauci’s history of decimating human health, and exposes him as a self-serving charlatan. Now Kennedy’s book has been made into a nearly two-hour-long movie. And according to Dr. Joseph Mercola, “You definitely won’t want to miss this one, especially if you didn’t read the book.” *The Real Anthony Fauci* became an immediate best-seller upon its release in 2021, despite Big Tech’s censorship of the book’s advertising. The book and the film reveal how Fauci turned the National Institutes of Health into an incubator for pharmaceutical products and essentially sold the entire country to the drug industry.



The film explores “the carefully planned militarization and monetization of medicine that has left American health ailing and our democracy shattered.” And while the NIH and the National Institutes of Allergy and Infectious Diseases are supposed to serve the public,

the reality is that they’re partnered with private drug companies and act for their benefit. Both agencies own pharmaceutical patents that are then licensed to drug companies, while the agencies themselves collect royalties on the sales. Fauci has personally filed patents on hundreds of new drugs his agency funded. Were it not for this symbiotic relationship with drug companies, the NIH/NIAID would not be working against public health and deceiving the public about drugs and vaccines.

PBS: ‘Nation’s Report Card’ shows test scores at lowest level in decades

A comprehensive study of the plandemic’s impact on America’s students by the National Center For Education Statistics and reported by PBS states: *“The new ‘Nation’s Report Card’ is out and the results are grim. Test scores are at their lowest level in decades, with steep declines in both reading and math proficiency in nearly every state.”* Nearly 450,000 fourth and eighth graders from some 10,000 different schools around the country were tested, and the results are alarming:

Only 36 percent of fourth graders and 26 percent of eighth graders were proficient in math, meaning they could demonstrate solid academic performance on challenging subject matter. In reading, just 33 percent of fourth graders and 31 percent of eighth graders were deemed proficient and above.

From 2019, the average math score for fourth graders fell five points, with eighth graders dropping by eight. In reading, average scores for fourth and eighth graders fell by three points. Not one state in the country saw significant improvement in these average test scores.

PBS News anchor Judy Woodruff commented to the report’s author Peggy Carr, “Sort of difficult circumstances to talk ... about this. I mean, this is almost two decades of educational progress nearly washed away.” Carr: “Well, what I can say is that these findings represent a defining moment in the history of education in this country.”

Meanwhile new studies have shown that the effects of COVID19 were not nearly as severe as believed. Dr. Joseph Mercola reports, “Before the COVID jabs were rolled out, if you were 19 or younger, your risk of dying of COVID was 0.0003%; only 3 per 1 million infected with COVID at this age ended up dying. Between ages 60 and 69, the infection fatality rate was 0.501%, i.e., 1 out of 200 infected died.”

Lie Exposed: Pfizer Never Tested Vaccines for COVID Transmission

A senior Pfizer executive testifying before the European Union Parliament stated that the pharmaceutical company did not know whether its COVID-19 mRNA vaccine would stop virus transmission before it entered the market.

Janine Small, Pfizer’s president of international developed markets, was filling in for CEO **Albert Bourla**, who ducked out of answering for the “vaccine” that is now linked to thousands of deaths and injuries across Europe. He had been called to testify about how secretive vaccine deals were struck with the EU but he unilaterally pulled out of the commitment.

Member of the European Parliament (MEP) **Rob Roos** of the Netherlands asked Small directly, “Was the Pfizer covid vaccine tested on stopping the transmission of the virus before it entered the market?”

Small responded, *“Regarding the question around, um, did we know about stopping the immunization [sic] before it entered the market? No, these, um, you know, we had to really move at the speed of science to really understand what is taking place in the market, and from that point of view, we had to do everything at risk.”* And in that halting and unscientific response the Pfizer executive was admitting that the

company NEVER TESTED THE “VACCINE” FOR TRANSMISSIBILITY. Roos called Small’s comments “scandalous” and “shocking, even criminal.” He pointed out that the claim that the “vaccine” effectively stopped transmission was the basis for the many draconian measures and discriminations that were enacted to divide and remove the unvaxxed from society, including EU’s digital COVID-19 “passport,” lockdowns, and quarantines.

When FDA first issued Emergency Use Authorization for the vaccines to enter the U.S. market, **President Joe Biden** stated wrongly, “You’re not going to get COVID if you have these vaccinations.” **Dr. Anthony Fauci** called vaccinated individuals “dead ends” for the virus, implying that the vaccine prevented transmission of COVID-19.

Pfizer has now admitted that none of those claims—or the lockdowns, business and school closures, “social distancing,” mask mandates, and other policies based on those claims—had any scientific basis.

Vaccine Corner

The following excerpt is from the book *Make an Informed Vaccine Decision For the Health of Your Child: A Parent's Guide to Childhood Shots*, by Dr. Mayer Eisenstein:

“Since 1973, our medical practice has cared for more than 35,000 children who were minimally vaccinated or not vaccinated at all. A few years ago, a well-known doctor visited me to do a study on autism in unvaccinated populations. This was the first time that I really looked at the figures, and I was astounded. I realized that we didn’t have any cases of autism in our unvaccinated population. This wasn’t something that I had preconceptions about. It was a retrospective look at what was really going on. Even when we analyzed the records from 20 years ago when we were giving some vaccines—but not starting until at least six months of age—there was not autism. We also have virtually no asthma, allergies, respiratory illness, or diabetes in our unvaccinated children, a telltale revelation when compared to national rates...”

“I tell our families that medical interventions are often unnecessary....So, my families often ask, ‘Well, why am I coming to you?’ I say, ‘Good question. You’re right.’ Most of the families in our practice are very healthy. I attribute this, for the most part, to home births, nonvaccination, and breastfeeding....”
