


Fasting is the First Defense Against the 'Spike Protein' Genocidal Bioweapon




... **Spermidine** and resveratrol promote autophagy by acting via different metabolic pathways and are therefore likely to have additive or synergistic effects. Furthermore, it is likely that both **spermidine** and resveratrol potentiate autophagy [cell clearing] induced by intermittent fasting... **Wheatgerm**, mushrooms, **grapefruit**, **apples** and **mango** are high natural sources of **spermidine**.”

“In the same “How to Eat to Live,” The Most Honorable Elijah Muhammad writes:

“Virtually all fruits are good. We eat **apples**, oranges, bananas, pears, peaches, tangerines, **man-gos**, plums, grapes... pomegranates, lemons and **grapefruit**.” (pp. 5-6) He further states: “We can live a long, great and healthy life by just drinking good, wholesome milk and eating good **whole wheat bread** if the bread is cooked correctly. ... The whole wheat kernel should be milled and ground very fine.” (p. 37)

Of course, you will eat “wheatgerm” when you eat whole wheat bread baked from flour that has not been stripped of its wheatgerm in the milling and refining process of modern flour milling. Top biological warfare epidemiologist:

"I will never take another vaccine as long as I live"

Dr. Meryl Nass is an internist and biological warfare epidemiologist and one of the harshest critics of the American government's response to the COVID-19 "pandemic." In an interview with **Robert F. Kennedy, Jr.**, on "RFK Jr. The Defender Podcast," Nass said the U.S. Food and Drug Administration (FDA), the Centers for Disease Control and Prevention (CDC) and "who knows how many other federal agencies are just making things up as they go along."



"These are not mistakes," said Nass. "This is malfeasance." Nass told Kennedy:

"I'd like to tell your listeners that I will never take another vaccine as long as I live because God knows what's in them. You can't rely on the fact that anyone is testing them or that the FDA is looking over anybody's shoulder to make sure that what's supposed to be in them is really in them."

"And it seems that the current COVID-19 vaccines are being made with very sloppy processes. We can't be sure what's in them. And why would we think they're gonna do better with the other vaccines in the future?"

Nass said documents obtained through Freedom of Information Act (FOIA) lawsuits revealed that CDC officials acknowledged mRNA COVID-19 vaccines were not included in the old vaccine definition—"so they had to change it."

"It is sinful that despite the harm being done to human beings, the government continues to heavily promote the uptake of these vaccines. They are using celebrities, professional athletes, preachers, politicians, educators and everyday people to pressure us to 'just get the shot.' It is time for all of us to become more proactive in fighting this diabolical scheme."

Study: Vaccinated 5X More Contagious Than Unvaxed 10 Days After Infection

A study published recently in the *New England Journal of Medicine* (NEJM) reports a disturbing discovery: individuals fully vaccinated and boosted against COVID-19 actually recover more slowly from the illness and, surprisingly, even remain contagious for lengthier periods of time as compared to unvaccinated persons. While the study did not investigate implications associated with ill-

ness severity, the findings nonetheless raise significant questions for consideration.

People that are vaccinated remain five times as contagious as those who are unvaccinated ten days after SARS-CoV-2 infection. Put another way, the vaccinated continue to transmit the disease significantly more than the unvaccinated should the data hold up across broader investigation.

American History of Medical Racism & Savagery

The Intercept: Leaked Documents Expose “TRUTH COPS”

The *Intercept* writers Ken Klippenstein and Lee Fang report that “**THE DEPARTMENT OF HOMELAND SECURITY** is quietly broadening its efforts to curb speech it considers dangerous, an investigation by The Intercept has found. Years of internal DHS memos, emails, and documents — obtained via leaks and an ongoing lawsuit, as well as public documents — illustrate an expansive effort by the agency to influence tech platforms.

“The work, much of which remains unknown to the American public, came into clearer view earlier this year when DHS announced a new ‘**Disinformation Governance Board**’: a panel designed to police misinformation (false information spread unintentionally), disinformation (false information spread intentionally), and malinformation (factual information shared, typically out of context, with harmful intent) that allegedly threatens U.S. interests. While the board was widely ridiculed, immediately scaled back, and then shut down within a few months, other initiatives are underway as DHS pivots to monitoring social media now that its original mandate — the war on terror — has been wound down.

“Behind closed doors, and through pressure on private platforms, the U.S. government has used its power to try to shape online discourse. According to meeting minutes and other records appended to a lawsuit filed by Missouri Attorney General Eric Schmitt [just elected senator], discussions have ranged from the scale and scope of government intervention in online discourse to the mechanics of streamlining takedown requests for false or intentionally misleading information.”



Massive Rise in All-Cause Mortality Since Forced “Vaccines”

It is hard to spin death certificates.... CDC data, as well as data provided by life insurance companies stratified by age, showed a 40 percent rise in all-cause mortality among working-age adults (18- to 64-year-olds) in 2021 during the mass vaccination campaign, as compared to the previous five-year baseline. To put this into context, actuaries tell us that a 10 percent rise in all-cause mortality is a once in 200-year disastrous event. The United States didn’t see this kind of spike even during World War II. When age groups were further stratified, life insurance mortality in quarter three of 2021 during the mass vaccination campaign showed even more alarming excess-mortality statistics among middle-aged adults:

81% increase for 25- to 34-year-olds

117% for 35- to 44-year-olds

108% for 45- to 54-year-olds

70% for 55- to 64-year-olds

Most of these excess deaths were not due to COVID. Nor can missed screenings and missed medical appointments during lockdowns account for most of these deaths. If you skip a colonoscopy, you don’t die the following year of colon cancer. You get a slight elevation in your risk of dying from cancer sometime in the next 10 to 20 years. Likewise if you have diabetes and miss your routine primary care appointment for a year, you might consequently have poorly controlled blood sugar for several months. This leads not to death a year later, but to a mildly elevated risk of diabetic complications much further down the road.

Something else—something sudden and acute—happened in 2021 that massively affected mortality for young and middle-aged adults. Our public health establishment has shown no interest in examining this disaster. This total disinterest is a barometer of their priorities.
