Fired Referees Sue NBA Over Vaccine Mandate

Superstar Kyrie Irving is not the only vaccine-intelligent NBA employee. The Children's Health Defense reports that three former National Basketball Association referees are suing the league, alleging they were fired for refusing to receive COVID-19 "vaccines" on religious grounds.

In their complaint, Mark Ayotte, Ken Mauer and Jason Phillips—who have a combined 71 years' worth of NBA officiating experience—accused the NBA of violating federal civil rights law and New York State and New York City human rights laws. The lawsuit alleges the "jab or job ultimatum" instituted by the league for the 2021-2022 season—and which was not applicable to players—led to their suspensions for that season.

Then, despite the NBA's decision to rescind the mandate for the 2022-2023 season, the league fired them.

The plaintiffs are requesting a jury trial, compensatory damages and punitive damages for front and back pay, emotional pain and suffering, reputational damage and attorneys' fees.

The NBA granted a religious exemption to "at least one minor league referee" but not the three plaintiffs because, according to the lawsuit, "The NBA's lawyers, after a pointed interrogation" of the three referees, "adjudged plaintiffs' beliefs to be illogical, unorthodox, and/or not entirely religious and therefore insufficient to satisfy the 'high standard' of a sincerely held religious belief."

The lawsuit alleges, however, that according to "fundamental hornbook law ... an employee's 'sincerely held religious belief' is not held to a 'high standard' at all — it is held to an exceedingly low standard requiring only sincerity" and "a belief need not even be religious to merit Title VII protections, so long as it occupies the same métier as a religious conviction."



Europe sees more deaths in 2022 than in previous 2 years—NOT From COVID!

According to *Expose News*, Europe has now recorded nearly 10,000 MORE excess deaths in 2022 than it recorded in 2020 at the height of the pandemic. Anyone with even a basic level of critical thinking can certainly suggest at least one essential correlation that requires further investigation: the rollout of the mRNA COVID shots. The first of these gene-based drugs was authorized for use in 5 to 11-year-old children in Europe by the European Medicines Agency (EMA) in late November 2021.



Data on death rates in Europe are similarly concerning, according to recent data by other researchers, including the company Eurostat.

In a mid-September article on their website, Eurostat notes that excess mortality in the European Union hit +16% in July 2022, up from +7% in June and May. Reporting this as "an unusually high value," Eurostat notes that the excess mortality rate in July 2020 was +3% in July 2020 and +6% in July 2021. Eurostat suggests unprecedented heat waves this past summer as a possible contributing factor.

But according to UK in a Changing Europe ("the authoritative source for independent research on UK-EU relations"), the UK's Office for National Statistics reported 11,600 more deaths than average in July and August 2022, and "only a small fraction" of those deaths occurred during the infamous heatwave.

So, what else could be at play, if not primarily the heatwave? ...In an extremely roundabout way of acknowledging the possible link between excess deaths and COVID shots, UK in a Changing Europe also says that there needs to be more investigation into international data before being able to discount "implausible suggestions such as harm arising from vaccination."





Florida OB/Gyn Warns of Alarming Rise in Infertility and Miscarriages

Abnormal pap smears, infertility, miscarriages, spontaneous abortion—all troubling signs on

In other words, if you lost your baby, it was categorized by Pfizer as a resolved adverse event, like a headache that got better."

Indeed, the data showed 50 pregnant women took part in the initial vaccine


vaccine manufacturer concedes that diabetes, thrombocytopenia (a serious blood disorder), arthritis, encephalitis (brain inflammation), Guillain-Barré syndrome (paralysis), and death, have all been reported during clinical trials of its vaccine...

"In addition, every year approximately 15,000 people file vaccine adverse reaction reports with the CDC. Many of these cases are serious, requiring hospitalization, resulting in life-threatening disabilities, or death. VAERS is a passive reporting system, so the number of people believed to be hurt by vaccines is vastly underreported. According to Dr. David Kessler, former head of the FDA, 'only about 1 percent of serious events—adverse drug reactions—are reported.'

"...A vaccine industry that errs on the side of denial rather than concern is backward and negligent....Pretending that serious reactions to vaccines are rare does not make it true, incapacitates our children, and degrades our society. Since reputed vaccine risk-to-benefit ratios are spurious, and 'preventive' shots are markedly more unsafe than officially acknowledged, it is morally unconscionable to mandate vaccines for children."
