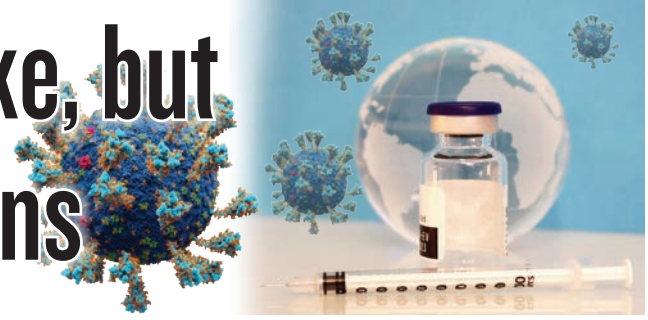


The COVID 'health emergency' is fake, but the fake vaccines are real bioweapons

President Joseph Biden said on November 15, 2022, that he would veto any proposed U.S. Senate resolution to end the COVID national emergency. As long as there is an officially declared “public health emergency,” the drug companies are legally protected from any lawsuits as they continue pushing their “vaccines.” So, since data shows that these injections do not stop transmission or infection, what is the real reason why the federal government continues to push these so-called vaccines? A November 23, 2022, Washington Post article points out that for the first time, a majority of Americans dying from coronavirus disease received at least the primary series of the COVID-19 “vaccine.” In fact, fifty-eight percent of coronavirus deaths in August of this year were people who were vaccinated or boosted, an increase from 23 percent in September of 2021 and 42 percent in February of 2022.

The real agenda for mass vaccination of the world’s population is slowly being exposed—depopulation. Their aim is to cull the population by two to three billion people and engage in genetic manipulation.

Dr. Robert Malone, the inventor of mRNA technology, published an article on October 27, 2022, titled “mRNA Vaccines: The CIA and National Defense.” In this article he states: “The technology is now advanced to the point

I can tell you my friends, or what used to be my buddies at DTRA, Defense Threat Reduction Agency Chem Bio Division, are extremely acutely aware that agents can be engineered to target ethnic groups.”

So, who are the “ethnic groups” to be targeted? This brings us back to the Honorable Minister Louis Farrakhan’s speech at Watergate (Nov. 16, 2017), where he said:

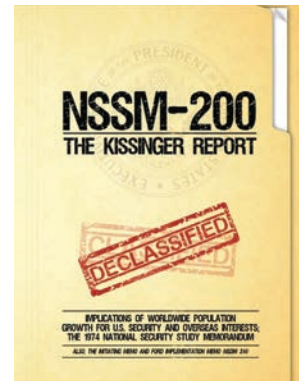

In an August 21, 2021, interview he stated that “Moderna was funded by DARPA.” DARPA stands for The Defense Advanced Research Projects Agency, which

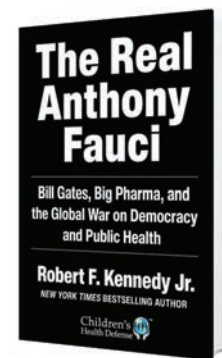
is a secretive research and development agency of the United States Department of Defense responsible for the development of emerging technologies for use by the military. In 2013 DARPA awarded Moderna up to \$25 million to research and develop its messenger RNA therapeutics platform as a rapid and reliable way to make antibody-producing drugs to protect against a wide range of known and unknown emerging infectious diseases and engineered biological threats.

More recently, renowned heart specialist Dr. Peter McCullough revealed a document published on defenseindustrydaily.com titled “DARPA Looking to Harness RNA for Vaccines,” which pointed out that in September 2011, the RN Armor Vax international consortium in Orlando, Florida, received a \$17.3 million technology investment agreement from DARPA. Their research and development program is designed to “identify, investigate, and develop

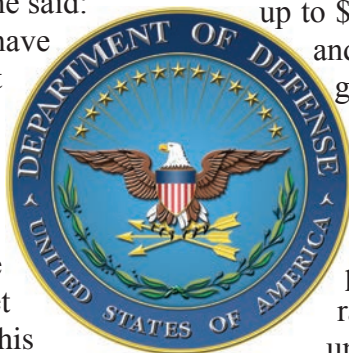
candidate RNA vaccines against infectious disease.”

So, it’s no wonder that after the American public and the world were frightened to death about this new SARS-CoV-2 “virus,” the U.S. military was brought in to head up the “Warp Speed” development, production, and distribution of vaccines, because they already had developed the mRNA platform to quickly synthesize these so-called vaccines. Now as we review what has happened over the last 3 years with the lens of a military operation instead of a “health emergency” lens, we can more clearly understand what has happened to us.

There is extensive planning done before taking on a military campaign. Robert F. Kennedy, Jr., in his monumental book “The Real Anthony Fauci: Bill Gates, Big Pharma, and the Global War on Democracy and Public Health,” described many disaster simulation exercises over the last 20 years. One—called “Event 201”—was personally organized by Bill Gates and conducted in New York City in Octo-

ber of 2019 right before the supposed outbreak of COVID-19 in Wuhan province in that same month. According to Kennedy: "This war game consisted of four 'tabletop' simulations of a worldwide coronavirus pandemic. Participants included a group of high-ranking kahunas from the World Bank, the World Economic Forum, Bloomberg/Johns Hopkins University Population Center, the CDC, various media powerhouses, the Chinese government, a former CIA/NSA director ... They drilled a retinue of psychological warfare techniques for controlling official narratives, silencing dissent, forcibly masking large populations, and leveraging the pandemic to promote mandatory mass vaccinations."

To scare the people into accepting mass vaccinations the depop plotters had to eliminate any and all alternatives to their shots. Anthony Fauci trashed the efficacy of "natural immunity," vilifying repurposed, safe and effective virus-fighting drugs like ivermectin and hydroxychloroquine. Instead, hospitals experiencing patients with flu-like symptoms, after being tested positive with a defective PCR test, were only allowed to give them the kidney-destroying drug remdesivir before putting the patients on the deadly ventilators.

To herd the masses to the so-called vaccines, the corporate media fed them an unending and false diet of inflated statistics of COVID-19 deaths.

We now know that many of the deaths attributed to COVID-19 were misdiagnosed. And many more of those deaths were labeled deaths caused by COVID instead of people with COVID dying from other fatal diseases. Indeed, it is now known that the average age of those who were reported to have died from COVID was over the age of life expectancy.

So, the stage is set for the entrance of this "cure," which turns out to be more deadly than the virus itself. The virus not only had a very low death rate, but for the infected people who survived they acquired natural immunity against that virus and all its variants. On the other hand, the so-called vaccines that were developed using mRNA technology did not even stop infection and spread, which is the

very purpose and function of a real vaccine. Instead, these forced injections caused the body to continuously produce the major component of the SARS-CoV-2 pathogen, which is the toxic spike protein. Instead of protecting the body, the shots created a war within the body—a war that has now killed nearly 33,000 of those who took the "vaccine," and injured hundreds of thousands more, according to the government's own database.

We return now to the inventor of the mRNA technology, Dr. Robert Malone, who explains how the CIA took his invention and tweaked it to perform as a lethal weapon that forces the vaccinated individual to

start a war within his own body—and no one knows how long that war will last. Dr. Malone stated that the RNA that is developed with his original technology will only last a few hours in the body before it is broken down. However, the scientists added a synthetic molecule (pseudouridine) into the structure of the RNA delivered in the vaccine that reduces the ability of the body to break it down and may last at least 60 days while giving instructions to millions of cells to produce the destructive spike proteins. The body will then produce killer cells to destroy these spike protein-infected cells, producing a cellular war within self.

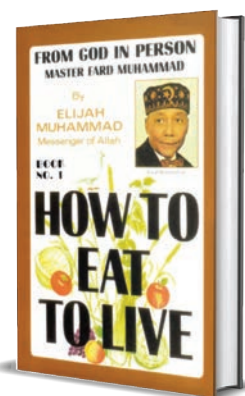

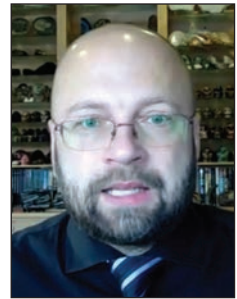

93 Canadian doctors dropped dead suddenly after COVID vaccine

Under-40-year-old Doctors Are Dying at 4x Prior Rate; 8x Prior Rate Under 30

There appears to be a pandemic of doctor deaths in Canada, and the younger they are the more prone they are to dying. Physician and cancer researcher **Dr. William Makis (in photo)** is speaking out about the 93 Canadian doctors who dropped dead suddenly after receiving the COVID vaccine. He says "Most doctors by now have had four COVID shots—some have even had five." Dr. Makis says this is a serious warning sign and that "We need urgent autopsy testing for the spike protein; we need to conduct autopsies on these dead doctors to assess why they died and all just post COVID vaccine."



Dr. Makis told scientist and epidemiologist **Dr. Paul Alexander**:

"I started noticing the doctors dying after the booster shot because some of those deaths occurred right after the booster shots were rolled out. We had some very high-profile sudden deaths. And then that just seemed to accelerate."

"...And so, I kept track of all of these sudden deaths. And it's now at 93 — 93 sudden deaths of actively practicing Canadian doctors who didn't have any obvious prior conditions prior to the vaccine rollout. And this is since the vaccine rollout; 93 sudden deaths and Canadian doctors."

More Vaccinated than Unvaccinated Died from COVID-19 in August

An analysis by the *Washington Post* and the Kaiser Family Foundation found that 58% of coronavirus deaths in August 2022 occurred in people who'd been "vaccinated." Significantly, they write, "It's no longer a pandemic of the unvaccinated." [Note: It never was]

The report also finds that only 11% of Americans have taken the booster despite the massive campaign to push yet another ineffective and dangerous shot onto the public.

And while the U.S. government continues to push its failed "vaccine," its own data show that COVID is still killing 200 Americans every day. *The huge state of Uttar Pradesh in India aggressively distributed the very inexpensive and effective over-the-counter drug IVERMECTIN to its population of 230 million residents, and today they have a daily COVID death rate of just FIVE.*

Vaccine Inventor Calls COVID Policies a DISASTER

Dr. Robert W. Malone is one of the primary inventors of mRNA & DNA vaccines. He has been censored and deplatformed for trumpeting the dangers of the COVID vaccines. He recently wrote the following on his blog, titled "**Worldwide COVID-19 Religious Restrictions: Shocking revelations about Gov control, harassment and of religious groups and peoples.**"

As detrimental as the mass vaccination policies have been, the harms done by the synchronized, global campaigns to essentially lock-up (quarantine) whole populations are enormous.

As has been documented in the scientific literature, lock-ups did little to stop the spread of COVID-19. Based on FOIA'd documents, we now know that Dr. Cliff Lane of NIAID [headed by Anthony Fauci] went to China. He came back advocating a policy to quarantine the entire world.

The United States then convinced the World Health Organization to also advocate for synchronized quarantines, even though there was no scientific evidence to suggest that this would be beneficial. In fact, it went against everything public policy experts had previously believed would work during a pandemic. The lack of scientific evidence that lock-ups would work was laid out nicely in the Great Barrington Declaration that has been discussed here and elsewhere extensively.

This set the stage for other countries to step in line with the policies of the USA and UN. These extended quarantines drove countless peoples into extreme poverty, stopped children from going to school - which impeded childhood learning and development, and made whole economies crash. On the individual level, quarantines caused massive depression, suicide, starvation, social deprivation and increased addictions.

There has never been an experiment carried out on humans across the world such as this. These lock-downs were done without scientific evidence. In the end, the quarantining of the entire world population was an abject failure and may be the most massive human rights violation experienced globally ever.

Leaked emails show Fauci admitting that masks were "ineffective"

Earlier this year the attorneys general of Missouri and Louisiana filed a lawsuit accusing top-level Biden officials of working with social media giants such as Meta (Facebook), Twitter, and YouTube (Google) to censor COVID free speech "under the guise of combating misinformation."

Missouri AG Eric Schmitt just released information from **Dr. Anthony Fauci's seven-hour deposition** proving that the outgoing director of the National Institute of Allergy and Infectious Diseases (NIAID) knew full well that face masks were "ineffective" at the very same time he was pushing for mask mandates across the country.

Emails sent by Fauci to a friend at the start of the pandemic reveal that Fauci never believed masks to be anything more than a symbol of obedience to government depopulators. Two months after the email, Fauci was urging states and local municipalities to mandate masks. Schmitt said in a tweet:

"In Feb. '20 he emailed a friend advising her masks were ineffective," "Confirmed again on Mar. 31. On Apr. 3, he's adamant masks should be worn even though he couldn't cite a single study to prove it. Mandates followed - Lives ruined ... Covid tyranny is born."

Vaccine Corner

The following excerpt is from *Dissolving Illusions: Dis-Tease, Vaccines, and the Forgotten History* (2015), by Suzanne Humphries, M.D., and Roman Bystryanik.

Dr. Suzanne Humphries, nephrologist: "What was most puzzling to me was how I was treated when I tried to protect my own kidney-failure patients from being vaccinated—especially when they were ill.

"After an attempt to get the hospital to defer vaccinating for pneumonia and influenza until the day of hospital discharge instead of admission, I was told not to interfere with the vaccination protocol.

".... Any other time I suggested that a drug was responsible for kidney damage, that drug was immediately discontinued—no questions asked. This happens routinely with certain blood pressure drugs, antibiotics, pain killers, etc. Sometimes kidneys can react to drugs in an allergic fashion—to any drug at any time—and that drug would have been stopped. Some drugs cause direct toxicity to the kidneys, and in the past if I suggested to stop or avoid them, they were always avoided. But now I was unable to protect my own kidney-failure patients from vaccinations given in the hospital.

"Questioning the vaccines seemed to open an entire Pandora's box that apparently had yellow tape over the lock, along with the message, 'Do not cross.' I was met with doublespeak—permitted to write an order to stop a vaccine that was to be given if I got there in time, but I was also told that I was doing it too often and that I should not interfere with the hospital's vaccination policy."

Twitter Says it is No Longer Enforcing Its "Misinformation Policy"

Before Elon Musk bought Twitter, the social media giant suspended 11,000 accounts and removed 100,000 pieces of content for violating its misinformation policy between January 2020 and September 2022, alone.

But now that the "world's richest man" owns it, he has made no secret of his disdain for the censorship regime that has infected social media. CNN Business noted that "Twitter users Monday night spotted a note added to the page on Twitter's website that outlines its Covid policy: 'Effective November 23, 2022, Twitter is no longer enforcing the COVID-19 misleading information policy.'"

Further, Musk revealed an internal investigation of how the policies were put in place. In a Tweet on Nov. 28th Musk wrote: "The Twitter Files on free speech suppression soon to be published on Twitter itself. The public deserves to know what really happened..."



It remains to be seen just how extensive the "Twitter Files" will be, and whether the investigation will blame a few "fact-checkers" or fully expose Twitter's collusion with government depopulators.

The African who Brought Immunization to America

Vaccination as preventive medicine is not new to Black people. Knowledge of the science of immunization came to the European settlers in America by way of an



enslaved African in Boston named **Onesimus**. In 1706 Dr. Onesimus explained the technique of applying the pus from an infected smallpox sore to a small incision in the uninfected person to build resistance to the disease. Using this medical technique **Dr. Zabdiel Boylston** inoculated 248 people (Black slaves among them)—the first introduction of vaccines to the European.

The major thoroughfare in Boston now carries Boylston's—not Onesimus's—name.

For Africans, Dr. Onesimus may have been the single shining light in our medical history with white people. From that point forward the role of white doctors has little to do with health and much more to do with racial experimentation, oppression, and control.

Pfizer R&D Head: "Vaccine" "wasn't ready for prime time"



Head of vaccine R&D at Pfizer, Kathrin Jansen wanted "the anti-vaccine lobby" stopped from "spreading misinformation": "Don't let them get away with it," she said in a 2019 interview. But two years after Pfizer's chemical swill was forced upon the population, there has been a meteoric rise in myocarditis (heart disease), blood clots, lethal heart attacks, strokes, cancer, miscarriages, and sudden death. All are skyrocketing, but they are written off as either normal or coincidental. Heart attacks are now blamed on everything from hot weather and cold showers to soil microbes in your garden, climate change and loud noises.

In a recent interview Jansen explains Pfizer's process, having claimed to get a call from Pfizer CEO Albert Bourla in March 2020: **"Get it done before the end of the year." I said, "This is crazy!" But money was not an issue — and, then, you can do amazing things in an amazing amount of time.... We got creative—we couldn't wait for data, we had to do so much 'at risk'. We flew the aeroplane while we were still building it."**

As **Dr. Joseph Mercola** points out, Pfizer did everything "at your risk." The pharma company risks nothing. It gets paid whether the shots work or not—whether they kill or maim—and it has zero liability for injuries and deaths, financial or otherwise. The person who takes on all the risk is the one who takes the shot. Deaths that the CDC says resulted from the shot are now near 33,000—more than could fit into any indoor sports arena in America. Chicago's United Center is the largest and holds only 24,000. That many healthy people—at least that many—walked in to get the shot and dropped dead soon after.

Jansen takes no responsibility (indeed, she has decided to retire), but now she admits: **"But the mRNA platform wasn't ready for prime time. There were stability issues, formulation issues, that we needed to solve. In 2020, it was only a research process and it needed to be scaled up. Usually, you start with a small reactor, and then you go to bigger and bigger reactors. We didn't have time to do this. Instead, we just cloned this relatively small-scale research process many times and over multiple sites to get to the capacity to produce billions of doses."**

Jansen stresses that this is "not a model for the future," because "it's not sustainable." But those who are continuing this work disagree, because warp speed rollout with minimal or no testing is, in fact, the New Norm. **The Honorable Minister Louis Farrakhan**, February 27, 2021:

"You know, anything that's 'warped' is misshaped. Anything that's 'warped' is crooked. So by rushing so fast to get something out, bypassing normal steps in a true vaccine, now God is gonna turn your 'vaccine' into death in a hurry. Mark my words, by the help of God: Since you loved to take the vaccine, then eat death."

Natural Immunity and the Slave Trade

Natural Immunity refers to how a person infected with a disease develops defenses against that disease and against future infection. In 2004, **Dr. Anthony Fauci** went on C-Span and was asked if someone who got the flu still needs to get a flu vaccine. He replied: **"If she got the flu for 14 days, she's as**

protected as anybody can be because the best vaccination is to get infected yourself."

Fauci forgot all that as more and more profits got in the way of science (Fauci's net worth more than tripled during the plandemic.). He now insists that immunity can only be achieved through chemical jabs, boosters, and boosters, and more boosters.

As long as 240 years ago, natural immunity to disease was well understood even among Jewish slave traders, like Philadelphia "broker" **Isaac Franks**, who in 1782 advertised the sale of a 29-year-old "Negro Man" as "stout and healthy... honest and sober... a good farmer." But most important, he "has had the small-pox"—a selling point even back then.

In 1782 "natural immunity" to disease was well-known and even used as a selling point: "has had the small-pox"
