

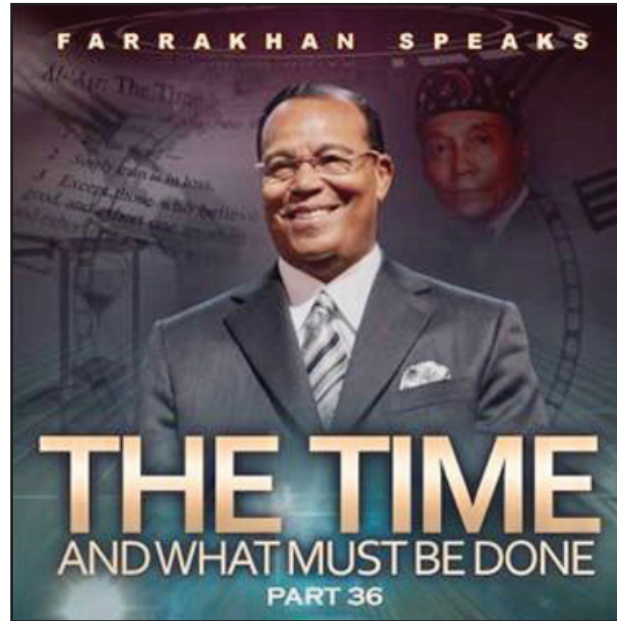
Depopulation Dawns on Vaccine-Truth Activists

They then presented the very evidence that the Honorable Minister Louis Farrakhan presented to the world on September 12, 2013, in his lecture series "THE TIME AND WHAT MUST BE DONE, PART 36." Here is an excerpt from that powerful and timely forecast of a decade ago.]

Well, during my 2012 Saviours' Day message, we spoke on a plan by the government of the United States led by Dr. Henry Kissinger to engage in worldwide depopulation of the darker peoples of the world. Mr. Kissinger as Secretary of State under President Nixon signed National Security Study Memorandum 200, titled "Implications of Worldwide Population Growth for U.S. Security Overseas Interests." It was adopted as official policy in 1975 by President Gerald Ford. Those who analyzed the report said, "Dr. Kissinger proposed that depopulation should be the highest priority of U.S. foreign policy toward the Third World." Think about that.

Although this plan of action was to be activated in developing countries, it was designed as a two-edged sword that could be swung with equal determination in both developed and developing countries alike because in developing countries, like America, a growing number of Third World people live.

This document was signed by Henry Kissinger and directed to the Secretaries of Defense, Agriculture, Central Intelligence and the Deputy Secretary of State, and the Administrator of the Agency for International Development,

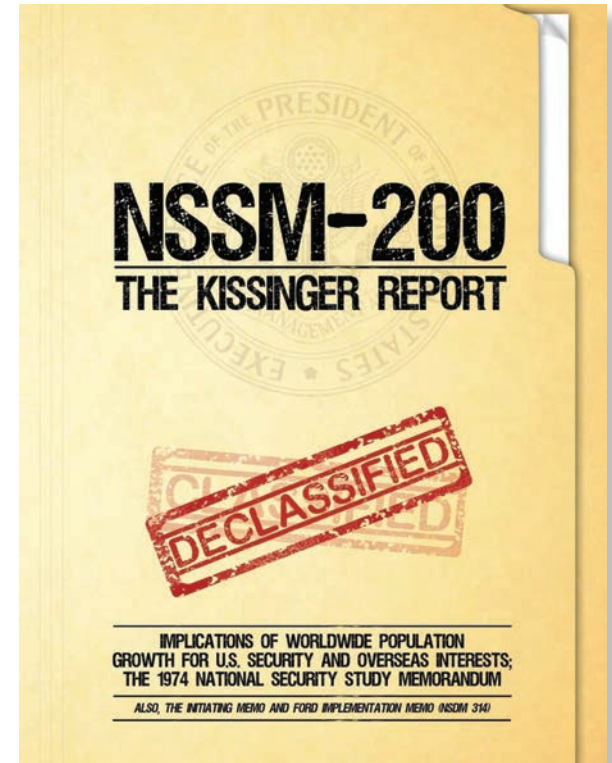

with a copy to the Joint Chiefs of Staff. This was taken like a theatre of war and all factions of government were introduced to this to develop plans and activate plans internationally to cull between two to three billion people from the face of the earth.

Well, Kissinger prepared yet another depopulation manifesto for President Jimmy Carter called, "Global 2000," which detailed using food as a weapon to depopulate the Third World. So then Zbigniew Brzezinski—I think he was Carter's National Security Advisor—said: "It's easier to kill a million people today than to control a million people." So the killing of millions is going on. Let's see what is happening to us.

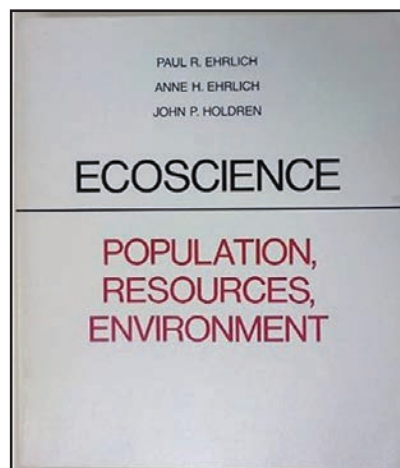

of the President's Council of Advisors on Science and Technology.

This same Dr. Holdren wrote on the subject of overpopulation in an article in 1969, co-authored with [then Professor of Population Studies at Stanford University] [Dr.] Paul Ehrlich, and he argued that "If the population control measures are not initiated immediately and effectively, all the technology man can bring to bear will not fend off the misery to come."

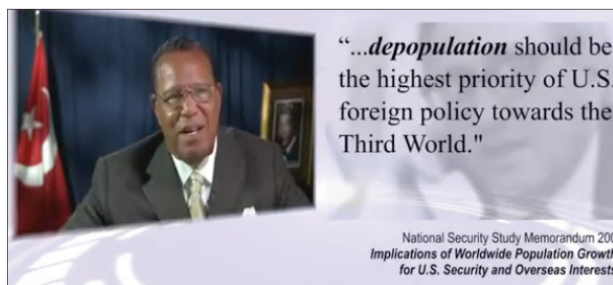
In 1977, Mr. Holdren co-authored a book this time with Paul and Ann Ehrlich, entitled "Eco-science: Population, Resources, Environment," and among the issues discussed in this textbook were (1) The use of milder methods of influencing family-size preferences, such as access to birth control and abortion.

So in all the major cities, particularly among the Black, and the Brown, and the Native Americans, these milder methods were used. And then, number two, the possible role of a wide variety of solutions to overpopulation—from voluntary family planning to enforced population controls, including compulsory abortion, adding sterilants to drinking water or staple foods, forced sterilization for women after they gave birth to a designated number of children.

Well, what does this word "sterilant" mean? To "sterilize" means "to make someone or something unable to produce children or young animals, etcetera." "To deprive of the power of reproducing, to make incapable of germination, to make powerless or useless usually by restraining from a normal function, relation or participation."

You mean to tell me that they're going to add into the water that which will forbid us to reproduce and we're not only going to add it to the water, but we're going to add it to the staple foods that people eat every day? The American people really need to see what the government is doing and how terrible the government is to allow something like this as "policy" not only in Third World countries, but it's policy right here in America.

Do you like Pop Tarts? Do you like Frosted

Flakes? A chemist who works for Kellogg came in the barber shop one day and said: "Don't eat sugared cereals because in the sugar is the poison that sterilizes and brings cancer; and it also is a drug that makes you want it again, and again, and again. It's a habit-forming chemical."

Well, what are "staple foods," because they [sterilants] are not just in the water now. They're in the staple foods. A "staple food" is "a food that can be stored for use throughout the year or produced fresh anytime of the year and forms the basis of a traditional diet." It is a food that is "eaten routinely and in such quantities that it constitutes a dominant portion of a standard diet in a given population."

Typical examples of staples include tuber or root crops, such as beets, carrots, parsnips, potatoes, turnips, radishes, sweet potato. Other staples are grains, legumes and other seeds, maize or corn, wheat, rice, cassava, soybean, sorghum, yams and plantains. These are the "staple foods" of various cultures. From the Asian people it's rice. To the people of Central and South America it's corn and maize and some of the legumes or beans.

So when you get bread that is supposed to contain wheat but if you didn't grow that wheat, where did you get the seeds from that wheat? Where

is the corn coming from? These are the things that are being used to cull populations all over the planet earth. Wheat now is genetically engineered. Corn is genetically engineered. Many vegetables are genetically modified and they [the industrial agricultural corporations] are fighting to keep from advertising what it [a genetically modified crop] really is.

The American Society for Nutrition in its Journal of Nutrition published an abstract in 2006 entitled "Biofortification of Staple Food Crops." Well, "biofortification" is the development of micronutrient-dense staple crops using

Study Seeks Ways to Turn Black Church Leaders into COVID-19 Vaccine Pushers

More than a generation after the Rev. Dr. Martin Luther King gave Black church leaders a new mission of economic and social justice, a study has been launched to turn them into sales and marketing reps for Big Pharma’s depopulation vaccine. The goal of the LSU Pennington Biomedical Research Center study is to “*determine the effectiveness of training church health ministers to educate their congregations about the safety and efficacy of COVID-19 vaccines and booster shots for decreasing vaccine hesitancy and improving testing knowledge in underserved Black communities.*”

More than any other subset of the population, Blacks were steadfast in their refusal to accept the word of corrupt health officials who pushed the “vaccine” even as they knew of its dangers (33,591 deaths) and its inefficacy (does not stop infection or transmission of any virus). More and more doctors are braving the extensive campaign of suppression and professional sanction to warn people to stay far away from the “vaccine.”

The Associated Press has previously reported that across the American Bible Belt a survey from the National Association of Evangelicals revealed that “although 95 percent of evangelical leaders said they would get vaccinated against COVID-19, their congregants overwhelmingly rejected inoculation.”

Another poll showed that 40 percent of white evangelical Protestants said they would likely not get vaccinated, compared with 25 percent of Americans overall.

“[D]on’t get the vaccine, and you can’t go to the supermarket. Don’t have the vaccine. You can’t go to the ball game. Don’t have a vaccine, can’t go to work. Don’t have a vaccine, can’t come in. No shirt, no shoes, no service. That’s where I think we should be right now. Because we continue to waste our breath on people who are just not going to change. Their, you know, circular logic, they just keep going back and saying, it’s my freedom, it’s whatever, I’m free.”

Report: 9 Months from “Vaccine” Rollout, and Substantial Birth Rate Drops in 13 European Countries

As has been previously expressed, any depopulation program worth its salt will aim for the wombs of the target population to destroy the next generation at or before conception. Dr. Robert W. Chandler, MD, completed extensive research on birth rates nine months after the international roll-out of the strange “vaccines” and found that the depopulation agenda is on course:

- Nine months following the rollout of the COVID-19 mRNA “vaccines,” substantial birth rate drops were seen in 13 of 19 European countries, including England and Wales, and Australia; also Taiwan.
- The decline in births in Switzerland was the largest in 150 years—more than during two World Wars, the Great Depression, and the advent of widely available birth control.

- There was an 8.3% drop in the birth rate in Germany through three quarters of 2022.
- England and Wales had a 12% birth rate drop through June 2022, which is when their government stopped publishing data related to this.
- Taiwan reported an alarming birth rate drop, but its data are incomplete.
- Australian birth rates fell 21% from October to November 2021, followed by a 63% decrease from November to December 2021.
- On August 25, 2022, the Swiss Hagemann group found that “every single examined European country shows a monthly decline in birth rates of up to more than 10% compared to the last three years. It can be shown that this very alarming signal cannot be explained by infections with Covid-19.”

Latest Rasmussen poll finds 34% of Americans were injured by COVID jabs

The latest Rasmussen poll finds that 34% of Americans were injured by the covid jabs, and a shocking 7% of the injuries were major and life threatening. The latest poll included 1,000 vaccinated Americans and it shows that approximately 7 in 10 American adults said they received at least one dose of a covid-19 vaccine. Of the vaccinated adults, 34% reported a minor side effect, 4% were unsure, and 7% suffered a major side effect. When the data is extrapolated to the entire U.S. population, it suggests that upwards of 12 million people may have suffered a major side effect from the covid-19 vaccines. Of course, these statistics do not include the most serious side effects — debilitation and death — because the mentally incapacitated and the deceased can’t respond to polls.

“People are really being harmed by this,” said Rasmussen’s head pollster, Mark Mitchell. “It’s true. It’s out there. People are still trying to cover it up. I think that’s a major story.”

The Informed Consent Action Network (ICAN) provided the CDC’s V-safe data in an easy-to-understand format. ICAN said the data “reveals shocking information that should have caused the CDC to immediately shut down its Covid-19 vaccine program.” The real-life data shows that 782,913 individuals had a major health event following covid-19 vaccination. A major side effect is one that requires medical attention, ER intervention and/or hospitalization. Over 25% of vaccine recipients also suffered from an adverse event that required them to miss school, work, and other normal day-to-day activities.

Landmark Lawsuit Slaps Big Media for Censoring COVID-Related Content

A lawsuit filed by **Robert F. Kennedy, Jr.**, and multiple other plaintiffs, alleges the Trusted News Initiative (TNI), a self-described “industry partnership” launched in March 2020 by several of the world’s largest news organizations, partnered with Big Tech firms to collectively censor online news.

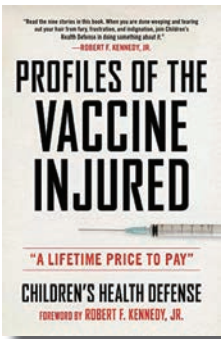

A LIABILITY-FREE INDUSTRY

Israel Officials concealed, manipulated vaccine injury data, say leaked documents

American “health officials” like the CDC’s **Rochelle Walensky** and the NIH’s **Anthony Fauci** extolled the data coming from Israel as top-notch, or even superior to that which comes from American sources. They relied on Israeli medical data to craft COVID-19 “pandemic” response policies for American citizens.

It is now reported that Israel’s Health Ministry last year suppressed and manipulated vital vaccine injury data ahead of its decision to vaccinate 5–11-year-old children, according to a June 2022 letter released last week by **University of Haifa’s Dr. Yaffa Shir-Raz**.

The letter, addressed to the Health Ministry, by Shamir Hospital’s Clinical Pharmacology and Toxicology Head **Professor Mati Berkowitz**, shows that medical researchers found that there were many long-term adverse reactions to the Pfizer vaccine—the only vaccine deployed in Israel through an unusual agreement between **Prime Minister Benjamin Netanyahu** and **Pfizer CEO Albert Bourla**. The letter states that in half the cases they studied, the side effect lasted longer than six months.

According to a report by Yudi Sherman of Frontline news, “Then there were several findings of rechallenges, which is when the side effect resolves itself but returns after another dose. Prof. Berkowitz told Health Ministry officials that a rechallenge makes the causality between the vaccine and the adverse event ‘definitive’. Prof. Berkowitz makes clear in his letter that he is plagued with concern about his findings. One of his concerns was the fact that 150 cases of emergency visits and/or hospitalizations following the COVID injections were not reported to the expert committee tasked with recommending the shots for children. In other words, the committee that met in late June and pushed for 5–11-year-old children to be injected with the Pfizer shots had not seen crucial data about vaccine injuries.

“They now know about people — real people — who were seriously injured from the vaccine, and people who suffered rechallenges and they are not following them up, treating them or compensating them,” Dr. Shir-Raz told Frontline News. “We know that from this letter there are over 150 reports on hospitalizations in adults, but no one has analyzed those cases.”

Prof. Berkowitz’s findings were based on adverse events data from the smallest of Israel’s five HMOs, because “the other four refused” to provide that vital information. Berkowitz terminated his work in June 2022 after he and the team of researchers were not paid. “That means that since June actually — again, no one has been monitoring the side effects,” Dr. Shir-Raz added. “They might have the reports, but no one is analyzing them or doing anything with them, so they are, again, buried with the Ministry of Health.”

The Frontline News report elaborates further on other data manipulations and deceptions uncovered by the researchers that were so egregious that Berkowitz warned health officials that they might expect lawsuits.

Judge Strikes Down New York’s ‘Orwellian’ Covid Vaccine Mandate as ‘Null, Void, and of No Effect’

A New York State Supreme Court judge ruled on Friday that the Commissioner of Health for New York State, **Governor Kathy Hochul** and the **New York State Department of Health** overstepped their authority by mandating the COVID-19 vaccine for the state’s healthcare workers.

Judge Gerard Neri said the vaccine mandate was not authorized by state public health law. The court thus sided with **Medical Professionals for Informed Consent**, who with **Children’s Health Defense**, brought the lawsuit in October.

The judge also had a strong reprimand for the state claiming that taking Covid mRNA shots was a “public health” policy and not a personal health decision.

He pointed out that the Mandate is titled “Prevention of COVID-19 transmission by covered entities.” And yet, the judge writes, “In true Orwellian fashion,” state health officials “acknowledge then-current COVID-19 shots do not prevent transmission.”

According to a statement from New York’s Department of Health, “The requirement is a critical public health tool.” The agency further said, “The State Health Department strongly disagrees with the judge’s decision and is exploring its options.”

One of several British Broadcasting Company (BBC) buildings in England that were recently plastered with photos of individuals who died or were severely injured by the covid “vaccine,” which was relentlessly pushed on the public by the BBC.



Pfizer Pushed Twitter to Censor Posts Showing Vaccine Ineffectiveness

The release of private **Twitter** correspondence by its new owner **Elon Musk** is continuing to show just how deep Twitter’s collusion with the government and Big Pharma to assault freedom of speech actually was.

Documents show that **Dr. Scott Gottlieb** (in photo), the former head of **U.S. Food and Drug Administration (FDA)** turned **Pfizer** board member, lobbied

Twitter to take action against a post accurately pointing out that natural immunity is superior to COVID-19 vaccination—on which Pfizer was poised to make billions of dollars.

On Aug. 27, 2021, Gottlieb pushed Twitter to censor a Tweet by **Dr. Brett Giroir**, another former FDA commissioner, who wrote that based on a new Israeli study it was clear natural immunity, or post-infection immunity, “is superior to vaccine immunity, by ALOT.” He said there was no scientific justification to require proof of COVID-19 vaccination if a person had natural immunity.

Gottlieb apparently knew that the study cited by Giroir demonstrated that the “vaccine” had a very limited value. He wrote to Twitter, **“This is the kind of stuff that’s corrosive. Here he draws a sweeping conclusion off a single retrospective study in Israel that hasn’t been peer reviewed. But this tweet will end up going viral and driving news coverage.”**

Based on Gottlieb’s complaint Twitter reviewed Giroir’s Tweet and determined that it DID NOT break Twitter rules. Yet they still put a tag on it, claiming to all users who viewed it that it was “misleading” and directing them to a link that would show “why health officials recommend a vaccine for most people.” The tag prevented people from replying to, sharing, or liking Giroir’s post.

Gottlieb later complained to Twitter about a post from Justin Hart, a critic of lockdowns and a skeptic of COVID-19 vaccines. Hart wrote that **“sticks and stones may break my bones but a viral pathogen with a child mortality rate of $\lt; 0\%$ has cost our children nearly three years of schooling.”**

Twitter did not take action against Hart but Gottlieb continued to complain against people posting accurate information that might undermine Pfizer profits.
