

Is The COVID Vaccine Safe For Pregnant Women?

Anyone who has done serious and objective research into the COVID vaccine would have to scratch their head wondering why anyone would ask such a question, given all of the injuries and deaths that have been linked to the COVID injections. Based on the statistics from the U.S. government's own database

which tracks vaccine injuries called VAERS (Vaccine Adverse Events Reporting System), the COVID vaccines have already killed more people than all of the other vaccines combined over the past 30 years! This is in addition to the multitude of adverse reactions that include heart attacks, seizures, and many other diseases, conditions, syndromes, and disorders. For these and many other reactions, researchers are baffled as to why these shots were ever allowed to exist in the first place.

In a recent forum, entitled COVID Vaccines—The Threat To Pregnant Women, a panel of four doctors and a nurse warned that these “vaccines” should never have been given to pregnant women. Three of the doctors are OBGYNs and one is a family physician, so they have lots of experience working with pregnant women. The medical professionals did not hold back their sentiments—all expressed their anguish at the medical establishment for pressuring pregnant women into taking these “vac-

cines” despite the known risks and despite the fact that these drugs were and still are experimental!

Michelle Gershman, RN, a nurse who works with pregnant women, pointed out that at her hospital prior to the “COVID vaccine” roll-out, there would be only about 1 fetal death every two months. After the COVID shots were administered, the number of fetal deaths skyrocketed to over 20 per month! Ms. Gershman also noted that the staff at her hospital were shocked by the dramatic increase in fetal deaths and were totally at a loss as to what was causing it. Ms. Gershman also noticed that women who took the COVID shot would go into labor typically within a week. This resulted in many premature deliveries.

Dan McDyer, MD, OBGYN, pointed out that in pregnant women who received the shots, their fetuses were not growing at the normal rate. He also shared that these women tended to have excessive bleeding after giving birth, among many other health problems.

Molly Rutherford, MD, said that the training doctors receive in medical school emphasizes that they should be very careful about giving drugs to pregnant women. Therefore, she was shocked that the medical establishment was actively pushing the COVID shots on pregnant women, especially given the fact that these pharma products had not been—and are still not—fully approved by the U.S. Food and Drug Administration (FDA) and are thus experimental drugs. All of the panel's doctors expressed the

same dismay over an experimental drug being given to pregnant women.

Dr. James Thorp, an OBGYN for nearly 44 years who has testified before the U.S. Congress and has published over 200 medical reports, said that the number of miscarriages has jumped to over 80% since the COVID shots came out! Dr. Thorp and Kimberly Bliss, MD, OBGYN, both presented slides which painted a devastating picture of the harm that the COVID shots are causing pregnant mothers and their babies. Dr. McDyer summarized this dire situation when he said: “Personally, I have never seen such carnage in my entire career.”

One of the most shocking revelations was when Dr. Thorp pointed out that the COVID injection was as effective at killing fetuses as the abortion pill RU486! Yet the medical establishment is still pushing this drug on pregnant women.

Another disturbing aspect of all of this is the emotional trauma that mothers go through when they lose their babies! Some women must get counseling to deal with their loss. Of course, the fathers and other family members are also impacted by the loss of a baby. Dr. Rutherford discussed those issues in her presentation.

Most people hearing this for the first time will be shocked by such revelations. While some would like to believe that this is not true or at least a gross exaggeration, they are unable to have that luxury, because all of the doctors on this panel have many years of experience and outstanding credentials.

The next thought that would most likely cross the minds of people would be how is such a thing possible? Dr. Thorp gave a simple and direct response to that question. He said that:

“... you cannot trust any physician or nurse in the United States of America anymore! ... The medical industrial complex ... is corrupted. I mean that the New England Journal of Medicine is totally corrupted ... The medical-industrial complex needs to be destroyed. I am not a violent person. I am not saying destroyed by violence. By ‘destroy’ I am saying that we the people have the power, and they need to be destroyed by criminal and civil actions, legal actions.”

Dr. Thorp’s comments and that of the other doctors are a wake-up call to the public that they can no longer have blind faith in the medical

establishment, which includes the hospitals, the medical journals, and of course the doctors and nurses. Many people have been brought up to think of hospitals as churches and temples, and doctors as priests and ministers. This is what has fostered the blind faith in these institutions and individuals. What these COVID shots are doing to pregnant women should be the ultimate wake-up call for everyone to start asking questions and doing their own research before allowing experimental drugs into their bodies.

The doctors and nurses on this panel are courageously risking their careers by exposing what they are seeing happening to their patients who are pregnant. They have been doing interviews and whatever else they can to sound the alarm to the devastating impact these COVID shots are having on pregnant women in America and around the world. They also ask why aren't more doctors doing the same as far as warning their patients about the dangers of these COVID shots? They expressed shock and dismay over the fact that they know other doctors are seeing the same

things across the country but instead of speaking out about the shots' dangers, they have been silent instead.

Mary Holland, the President of Children's Health Defense, asked the doctors, why are their fellow doctors going along with this assault on pregnant women? Alix Mayer, who is on the Board of Directors of Children's Health Defense, also expressed her frustration over this situation and noted that a doctor's first responsibility is to their patient!

What is presented in this article is only the tip of the iceberg of what these doctors shared in this powerful forum. Everyone, and especially pregnant women, need to watch this presentation and share it with their networks. Given the history of experimentation on African Americans, we also have good reason to be skeptical. We all must protect our mothers and our babies from those who wish to profit from putting them in harm's way.

NYC Teachers Who Refused COVID Job Had Their Fingerprints & Files Sent To FBI

The legal group **Alliance Defending Freedom** (ADF), which is defending New York teachers in state court, said the New York Department of Education (DOE) flagged the personnel files of NYC teachers who were fired because they declined the COVID vaccine. The teachers were assigned a "problem code" for not taking the shot.

The files and the teachers' fingerprints were then sent over to the FBI and the NY Criminal Justice Services.

The New York City vaccine mandate required Department of Education employees to be fully vaccinated against COVID by Sept. 5, 2022. As of mid-September 2022, approximately 1,950 NYC Department of Education employees had been fired for declining to get the COVID-19 vaccine.

The New York Criminal Justice Services "maintains criminal history records and fingerprint files and performs background checks for employment and licensure."

New "ICD code Z28.310" Tracks UnVaccinated

The U.S. National Center for Health Statistics, a division of the Centers for Disease Control and Prevention (CDC), has been tracking the COVID jab status of US citizens. The operation appears to be a well planned, covert effort by government agencies to increase control of and remove freedoms from innocent people the world over.

The discovery was made by **Dr. Robert Malone**, who noticed how the data-collection program utilizes health reporting codes created by the **World Health Organization** to track those who have not been vaccinated as well as those who have only been partially vaccinated.

The information appears to be structured at least in part to populate the data used for a **digital passport program**, the consequences of which would be devastating to a person's freedom to move about and travel freely.

With complete disregard for medical privacy rights protected by the Privacy Act of 1974, this secret surveillance program has been made possible by the federal health emergency first activated during the "pandemic," only to be extended time and time again since then.



Vaccine Makers Kept \$1.4 Billion in Prepayments for Canceled COVID Shots for the World's Poor

As global demand for COVID-19 vaccines dwindles, the program responsible for vaccinating the world's poor has been urgently negotiating to try to get out of its deals with pharmaceutical companies for shots it no longer needs.

Drug companies have so far declined to refund \$1.4 billion in advance payments for now-canceled doses, according to confidential documents obtained by *The New York Times*.

GAVI, the organization financed by world-culturer Bill Gates, bought the depopulation shots in advance, but now that the Black world has rejected the poison, Gates has been trying to get his money back.

The vaccine-makers have brought in more than \$13 billion from the shots and under the contracts, the companies are not obligated to return the prepayments GAVI gave them to reserve vaccines that were ultimately canceled.

"Vaccine" May Threaten Airline Safety

Since the vaccines were rolled out, numerous high-profile events have occurred which have raised suspicions that the vaccine is threatening air safety. These include:

- Patrick Ford** had a fatal heart attack shortly after lifting off from Chicago O'Hare. His co-pilot managed to take control and land the plane. This is the most dangerous time a pilot can become incapacitated and it is extremely fortunate that the experienced co-pilot was able to save the lives of those on that flight.

- Bob Snow** suffered a sudden cardiac arrest immediately after landing at the Dallas-Fort Worth airport.

- Wilburn Wolfe**, 11 days after receiving the J&J vaccine, developed a migraine-like headache. Two days later, while not on duty, he had a seizure. After the seizure ended, he was paralyzed on the right side of his body. At the hospital, it was discovered that he had had a hemorrhagic stroke (a brain bleed). He was put in a medically induced coma and ultimately died 17 days after his initial vaccination.

- Cody Flint**, an agricultural pilot, had a reaction immediately following vaccination that progressively worsened, and two days later, while flying, became severely disoriented but, miraculously, was able to land safely.

Trust in NEWS Collapses to Historic Low

While other institutions have also experienced precipitous declines, including banks and the medical system, others — like small business and the military — have held steady over the past few decades.



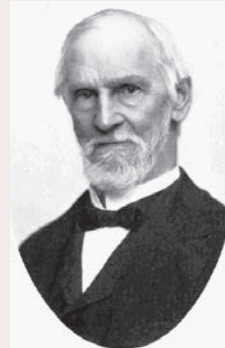
THE TERM "GASLIGHTING"

Study: Vast Majority of “COVID” Deaths Among Older Adults

Alarming Autopsy Results Show Jab Damage

U.S. News & World Report reported that more than 80% of deaths attributed to “COVID-19” during the first two years of the pandemic were among people aged 60 and older, according to a new study from the World Health Organization and the Centers for Disease Control and Prevention.

The trend held true across countries of all economic backgrounds, the report found. But older populations in lower and middle income countries experienced the highest mortality rates and accounted for the majority of global COVID-19 death estimates.

Pfizer Accused of ‘Obscene’ COVID Profits After Posting Record Revenues

Pfizer has been accused of making an “obscene profit” from the coronavirus pandemic after it posted record revenue of more than \$100 billion for 2022, a rise of 23% on the previous year. The company’s fraudulent “COVID” products accounted for over \$56.7 billion of the company’s worldwide revenue. Sales of its two “COVID-19” drugs— Comirnaty (mRNA vaccine) and Paxlovid—in the U.S. alone accounted for

\$19.3 billion, with the company having an estimated market share of 64 percent for the vaccine in America.

“Pfizer has made an obscene profit from the pandemic,” Mohga Kamal-Yanni, policy co-lead at the People’s Vaccine Alliance, told *Newsweek*. “History is littered with egregious examples of pharmaceutical companies exploiting crises for profit, but none have been as lucrative as the COVID-19 pandemic.”

1,696% Increase in Athlete Sudden Death — What’s Going On?

Dr. Joseph Mercola says “Don’t listen to anyone who says this is normal—it’s not. Previously, the number of athletes who ‘died suddenly’ averaged 2.35 per month. **Between 2021 and April 2022, that number shot up to 42 sudden deaths per month.**”

Over the past two years (2021 and 2022), more than 1,650 professional and amateur athletes have collapsed due to cardiac events and 1,148 of them proved fatal.

The **Health Freedom Defense Fund** urged the **NFL Players Association** in a recent letter to implement screening because the vaccines can cause myocarditis, a form of heart inflammation. Young males are the most at risk.

Most NFL players received a COVID-19 vaccine under pressure from teams and the league.

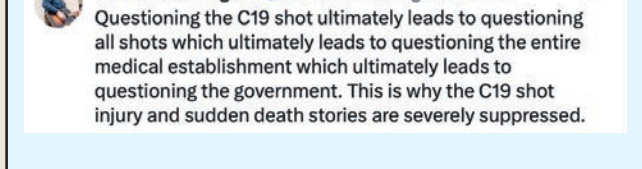
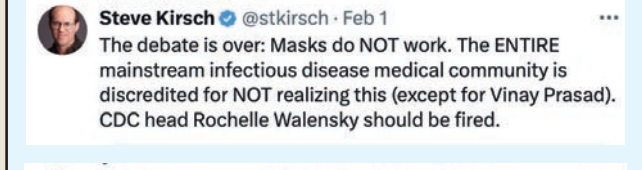
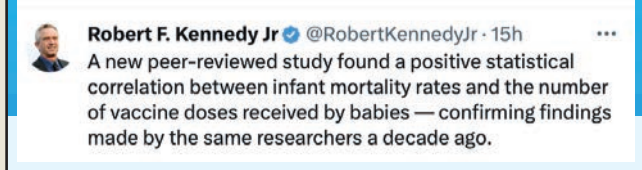
“Safety signals illustrate that the near and long-term health outcomes of the COVID-19 vaccines remain uncertain,” **Leslie Manookian**, president and founder of the fund, told **DeMaurice Smith**, executive director of the players association, in the letter.

“A multitude of adverse reactions to these injections, including myocarditis, are wide-ranging and confirmed, and as such, prudence dictates that the NFLPA investigate the extent to which the COVID-19 shots may have resulted in injury, compromised health or death of players,” Manookian said.

German pathologist Dr. Arne Burkhardt and seven other international pathologists performed autopsies of 30 deceased people at the request of their loved ones. “What they found ... is catastrophic lesions throughout the body in many many organs, blood damage, spleen, liver, brain, skin, testes.”

Burkhardt Group Conclusions:

“[C]lear evidence of vaccine-induced autoimmune-like pathology in multiple organs. That myriad adverse events...very frequently occur in all individuals, particularly following booster injections. Beyond any doubt, injection of gene-based COVID-19 vaccines place lives under threat of illness and death. We note that both mRNA and vector-based vaccines are represented among these cases, as are all four major manufacturers.”
