Future of Food: Control the Food, Control the People

The World Economic Forum (WEF) is an organization made up of the world's wealthiest individuals. 
review the history of the WEF and its attack on humanity with the planned "COVID-19 pandemic," which reveals their real reason for attacking farm animals. There is a basic fallacy in WEF's argument that farm animals cause "climate change" by increasing, through digestive gases, the amount of methane and CO2 in the atmosphere, which they claim, increases global warming. That is nonsense.

Farm animals are part of a beautiful God-created "virtuous eco-cycle" called the Carbon Cycle. Simply put, the Carbon Cycle is the circulation of carbon in various forms through nature. Carbon is essential to life and is found in the air or dissolved in water as carbon dioxide (CO2).

Green plants capture and absorb carbon dioxide from the soil and air and then release some of it into the atmosphere through the process of photosynthesis, converting the CO2 into simple carbohydrates. These carbohydrates are then eaten by humans and animals, whereupon carbon is released by respiration and excretion. In death, humans and animals release carbon as they decay. This cycle of life that God designed represents a perfect carbon cycle, so there can be no net increase in atmospheric carbon dioxide due to living farm animals.

But the real reason for the global elites' attack on farm animals is to destroy the agricultural industry and replace it with chemically synthesized or laboratory-grown imitations of nature. These new products will use toxic materials like petrochemicals from fossil fuels, which they can control. They dig wells one mile deep and spend millions of dollars to get to one deposit of fossil fuels, whereas common people can buy some land and produce food and renewable energy from that land. 
than 15 times its original investment."


Pharma Companies Spent More on Lobbying Than Any Other Industry

new report revealed that in 2022 the pharma-A new report revealed that in 2022 the pharman ceutical industry spent \$374 million on federal lobbying alone, far more than any other industry.

According to analysts, much of the reason for outsized spending by the pharmaceutical industry was related to the massive push for the government to mandate "vaccines" for all Americans.

rom the very start of Europe's colonization of America, the invading settlers were begging their British king to destroy the "savages" at an even faster rate than he already was. Secret Pfizer documents show more horrific drug industry crimes

Dr. Naomi Wolf of *DailyClout* (in photo) has pre-sented new information from the court-ordered release of Pfizer COVID-19 "vaccination" documents showing that nearly 9% of the vaccinated suffered damage to their muscle and skeletal system.

According to Dr. Wolf, "Women were affected at a ratio of almost 4:1 over men, and you'll remember that

I've often said that joint pain is the number-one side effect in the Pfizer documents, but the CDC doesn't mention it."

She said that this would explain why so many people are having to get shoulder, hip, or knee replacements, or why their ankles are giving out in young, otherwise healthy people.

"The bottom line is there were...3,640 adverse events of this kind," Dr. Wolf explained. "Of these, 44 percent were classified by Pfizer as serious ... ""

Reproduction Targeted

Dr. Wolf said: "It's my belief that they were trying to disrupt especially female reproduction....In the Pfizer documents, there's a chart," detailed Dr. Wolf. "And as a woman, this is one of the most painful things to see. And I'm Jewish. And my grandmother lost nine brothers and sisters to the Holocaust. So I don't say this lightly, but this chart is a Mengele-type of chart. It's Mengele science." [Dr. Josef Mengele was a Nazi doctor who conducted horrific medical experiments on Jewish prisoners.]

"Why is it Mengele science?" she asked. "Because they break down 20 different horrible things that can happen to women's menstruation."

According to a report cited on Mercola.com, new sciwomen suffer a 27-fold higher risk of miscarriage following COVID-19 shots.

The shot's contents are biodistributed into the bloodstream within hours and cross "all physiologic barriers including the maternal-placental-fetal barrier and the blood brain barriers in both the mother and the fetus,' wrote Dr. James Thorp, a maternal-fetal medicine expert. Pregnant women were subjected to the shots, and in many cases were mandated to receive them.

As a result, birth rates in multiple European countries fell significantly at the end of 2021, months after COVID-19 shots became widely mandated. Researchers have called for the immediate suspension of COVID-19 vaccination for all persons of childbearing and reproductive age.

Amish Ignored CDC and Avoided COVID Disaster

edical researcher Steve Kirsch asks how the Amish **IV** religious group in Pennsylvania fared so much better during the "COVID crisis" than the American population as a whole. "Making a Killing" Film Exposes COVID Incentives to Kill

A new documentary examines the cash incentives paid to hospitals that appeared to have dictated the treatment given to "COVID-19" patients. The U.S. had one of the worst outcomes than any country, despite having the most expensive and extensive health delivery systems on earth. Many believe that the high number of "pandemic" deaths (now 1,131,439) and hospitalizations (now



6,176,446) in America was driven by profit and greed.

The documentary, titled *Making A Killing*, was produced by Patty Myers (in photo), whose husband died of hospital mistreatment of COVID-19. According to one report, "When the federal government sent \$9,000 to her to pay for her husband's funeral, she got angry. 'I didn't want to take a penny.

It felt like hush money, like they were paying me to keep quiet about how my husband died in the hospital." Myers decided to take the government's money and use it to make the documentary. "When I started making this film, I didn't know about the federal money driving the [hospital] protocol. I do now," Myers said. The federal money was flooding hospitals with cash and generating record-breaking hospital profits. A new report reveals that the 20 largest nonprofit hospitals in America received more than \$23 billion in federal aid during the 2018-2021 time period, and "their cumulative net assets soared from 200 billion in 2018 to \$325 billion in 2021."

As Patty Myers discovered, the federal money incentivized specific medical "treatments" for COVID that happened to be deadly. "If the hospital admitted you with a Covid diagnosis, they got paid more! If they 'treated' you with remdesivir, a drug well-documented as lethal, they got a 20% bonus on the whole bill! Researchers Hid Data Showing

The controversial practice of adding fluoride to drinking water first began in the 1940s, advocates claim, to prevent dental cavities. But cavities have

decreased in countries both with and without water fluoridation, and troubling medical side-effects are now being discovered. **Children's Health Defense** reports that California's dental director intentionally omitted data linking fluoride exposure to brain damage in children.



The documents obtained by the **Fluoride Action Network** show that the study's research team, led by **Dr. Jayanth V. Kumar** (in photo), a dental surgeon, conducted a review of the scientific literature on fluoride's effect on brain development and found a link between fluoride exposure and lowered IQ in children, even at low levels of exposure. However, they omitted the data and wrote a paper concluding there was no evidence of a link.

Four rounds of scientific review rejected Kumar's manuscript as "poorly researched," "internally inconsistent" and committing "unashamed exaggeration" before the journal *Public Health* finally published Kumar's study.

This is highly significant because of a "groundbreaking" U.S. Department of Health and Human Services **National Toxicology Program** (NTP) report that found 52 of 55 human studies showed **lower child IQ with higher fluoride**, and concluded that there was "no obvious threshold" at which fluoridating water is safe.

After COVID "Vaccine" Life Expectancy Takes Tragic Fall, Depopulation Rises

Dr. Joseph Mercola points out: "If the COVID jabs worked, you'd expect excess mortality to drop, yet that's not what we're seeing."

Data now shows that Americans lost nearly three years of life expectancy during the "pandemic."

- In 2019, the average life span of Americans of all ethnicities was 78.8 years;
- By the end of 2020, it had dropped to 77 years;
- By the end of 2021, it was 76.4.

Virginia Commonwealth University professor of population health **Dr. Steven Woolf** told *USA Today*: "That means all the medical advances over the past quarter century have been erased."

While life expectancy dropped across all age groups, the age groups with the highest increases in mortality were working-age adults, 25 through 54, followed by children between the ages of 1 and 4.

Liars & Deceivers to the Very End

Last week CDC director Dr. Rochelle Walensky appeared before a Senate committee and made the

following statement: "We still to this day do not have data on people who are coming into the hospitals who are vaccinated. That is a data point that we have lacked."

Yet, in July 2021 she said: "Unvaccinated Americans count for virtually all recent COVID-19 hospitalizations and deaths."

How is it that the CDC had that data in 2021 when they needed to publicly shame the "unvaccinated," but—under oath, and now that the vaccine-injured are filling hospitals—Walensky now says they currently don't have and NEVER had that information?
