

U.S. Military Runs COVID Vaccines, Former Pharma Exec Tells RFK Jr.

The U.S. government's COVID-19 vaccination effort is a biological weapon project run by the U.S. Department of Defense (DOD), according to Alexandra Latypova, a former pharmaceutical research and development executive with 25 years of industry experience.

Latypova, who oversaw compliance for more than 60 clinical trials, knows the regulatory standards pharmaceutical companies historically were required to meet before bringing a product to market. "People misunderstand that this is just another instance of Big Pharma corruption," she told Robert F. Kennedy, Jr., chairman and chief litigation counsel for Children's Health Defense, during an episode of "RFK Jr. The Defender Podcast."

"It's much, much bigger than that." Latypova said we have government reports describing the COVID-19 vaccines as a biological weapon. "I have a question to our government," she said. "What is it that they're exactly forcing on us?"

The DOD is "fully in charge" of the COVID-19 vaccine clinical trials and the vaccine's manufacturing and distribution, and it owns the

vaccine "until it is injected into a person," she said.

By creating a "pseudo-legal structure" over time that included Emergency Use Authorization (EUA) and other transaction authority agreements—called OTAs—the U.S. government allowed the military to take over the distribution of vaccines without adhering to historical safety testing guidelines or product recall procedures.

According to Latypova, the notion that the COVID-19 vaccines met regulatory standards for safety and effectiveness was the "biggest lie that was sold to the public."

"I am describing a very illegal structure that's made legal on paper," she said. "It's unlawful. They—the government—are driving this." Kennedy agreed with Latypova and pointed out that OTA was designed to allow the Pentagon to quickly buy weapons and weapons systems without paying attention to any existing regulatory authorities.

Kennedy said:

"What they've done is they've taken that authority and they've applied it to the vaccines so they're purchasing the vaccines under OTA as a demonstration product. It's all a huge military operation and the involvement of the drug companies is a kind of window dressing."

The DOD paid the pharmaceutical companies for their brand names so people would think they were getting something from Pfizer or Moder-



na—but all of the distribution and manufacturing is done by the military, Kennedy said. The pharmaceutical companies were brought in to put their name on it and then to pretend to do clinical trials, he said.

Latypova and Kennedy discussed how the military accomplished this without most workers involved in the production and distribution of the vaccine catching on. They also discussed how citizens and lawyers might effectively challenge the Pentagon's COVID-19 vaccination project in the court system.

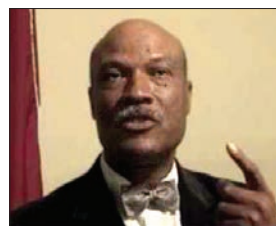
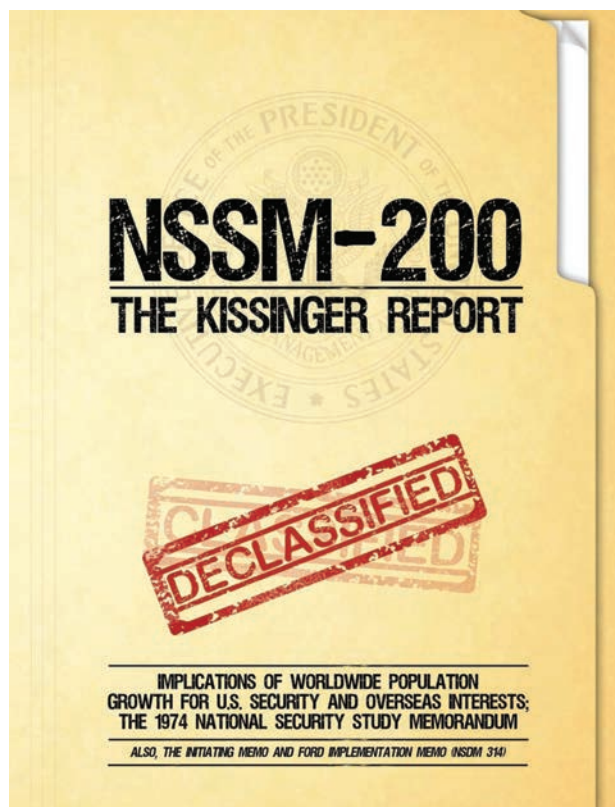
“Hundreds of Covid countermeasures contracts became available via FOIA and SEC disclosures in redacted [censored] form. Review of these contracts indicates a high degree of control by the US Government ... A prototype is defined as “an early sample, model, or release of a product built to test a concept or process.” Latypova posted on her substack that a July 21, 2020, contract was issued by the Department of The Army ordering a demonstration prototype from Pfizer. Now let’s look at how the U.S. Government uses complicated language to hide its dirty deeds. A portion of the government contract reads:

“Request for Prototype Proposals (RPP) 20-11, Objective PRE-20-11 for ‘COVID-19 Pandemic –Large Scale Vaccine Manufacturing Demonstration’ (Pfizer, Inc.) ... The CMF [Consortium Management Firm] Administrative Cost was approved as a ‘Special Allocation’ for Operation Warp Speed (OWS) Prototype Projects executed under the MCDC [Medical CRBN Defense Consortium] OTA. The effort currently has \$1,950,097,500.00 of available funding”

This government document further states:

“The scope of this prototype project is the demonstration by Pfizer of the supply and logistics capability to manufacture and distribute to the Government of 100M doses of a novel mRNA-based vaccine....While pre-clinical, clinical, and chemistry/manufacturing/controls (CMC) activities are described in the Background section of this Statement of Work, the Parties acknowledge and agree that such activities not related to the large-scale manufacturing demonstration are out-of-scope for this prototype project”

What this author appears to be stating is that the Department of Defense is paying pharmaceutical companies to use their brand, to make the public believe that they are producing the vaccines. And these so-called vaccines are not required to go through clinical trials or standard manufacturing controls. This Depopulation policy enlisted the service of many branches of government to carry out its objectives, including the U.S Department of Defense and Agriculture. In subsequent years the Defense and Agriculture departments have been

Africa Beats the Western World in Surviving “Pandemic”

The population of Africa is 1.4 billion. But according to the **World Health Organization**, there have been only 9 million “confirmed” cases and just 174,000 deaths from COVID in Africa; and the continent has the lowest “vaccination” rate in the world.

These numbers are extremely low and in sharp contrast to the rest of the world’s infection and death rates. Europe has half as many people as Africa (750 million), but they reported over 239 million “confirmed” cases and more than 2 million deaths.

America is touted as the very pinnacle of medical technology, having, it is claimed, the finest health-care system on planet earth. But data from **Johns Hopkins University** reveals that **for every 100,000 people in America, 341 died from COVID-19. In England 325 died from COVID; Spain: 256; France: 255.** Compare with these numbers (deaths per 100,000 population) from Africa:

Africa has fared so much better than the West because early on several African leaders were highly suspicious of Western motives, having been the target of “vaccine” depopulation plots in their histories. So they were not cowed by the “pandemic” fear campaign and rejected lockdowns, masking, and vaccines.

Another likely reason is the widespread use of **ivermectin**, a drug used regularly in Africa to prevent river blindness. A 2021 study published in the **American Journal of Therapeutics** found that “using ivermectin early in the clinical course may reduce numbers progressing to severe disease.”

And while ivermectin has shown amazing results in combatting COVID-19 in Africa, vaccine-pushing health officials in America specifically banned ivermectin for use in combatting COVID-19. The numbers above speak for themselves.

Is Destruction of Food Plants Deliberate? Why Here, Why Now?

At least 18,000 cattle were killed in an explosion at a dairy farm in Dimmitt, Texas, on April 10. In January, 100,000 hens were killed in a Connecticut fire at one of the largest egg producers in the country. Are these incidents part of a systematic destruction of the food supply to achieve DEPOPULATION? Here is a partial list of food processing plants “coincidentally” destroyed in 2022:

9. Nutrien Ag Solution, Sunnyside, Washington: fertilizer plant
10. Nestle Frozen Foods, Jonesboro, Arkansas: produces foods for the Nestle, Stouffer’s, Lean Cuisine, DiGiorno, and Tombstone brands.
11. Wayne Hoover Farm, Longswamp Township, Pennsylvania: dairy farm
12. Plainfield Walmart Fulfillment Center, Avon, Indiana: the size of 20 football fields
13. Penobscot McCrum Potato Processing, Belfast, Maine
14. Maricopa Food Pantry, Maricopa, Arizona
15. Rio Fresh, San Juan, Texas: onion-packing
16. East Conway Beef and Pork, Center Conway, New Hampshire
17. Gem State Potato Processing Plant, Heyburn, Idaho: single-engine plane crash
18. Taylor Farms, Salinas, California: wholesale salads and shredded lettuce.
19. Azure Standard, Dufur, Oregon: Organic food distributor
20. Nutrien Ag Solution, Leoti, Kansas: fertilizer
21. General Mills, Covington, Georgia: plane crash
22. Perdue Farms, Chesapeake, Virginia

Alarming Rise in Deaths of Women in Childbirth

One of the world’s top medical experts is raising alarms about the COVID-19 “vaccine” and its effect on pregnant women. **Dr. Peter A. McCullough** writes that “Modern obstetrical care in the US has had a major impact in reducing maternal death rates over several decades. Now there is reversal of these trends.”

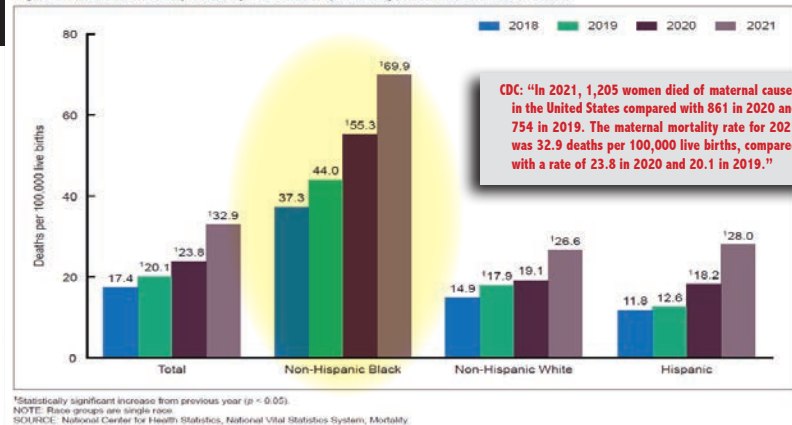
LOOK UP—Mad Scientists At Work!

“COVID-19” School Closings Led to Severe Learning Loss, Study Shows

A new study found that children are over 100 times **less likely to die from COVID** than adults, yet because of school closures they will be dealing with learning loss due to “pandemic” school closures for years to come.

The study, published by the JAMA Network of medical journals, found that children aged 0-19 died from “COVID” at a rate of 1 per 100,000 from August 2021 through July 2022. There was a total of 821 “COVID deaths”—meaning cases when COVID was the stated underlying cause of death—for this age range during the 12-month period. Specifically, the “COVID” death rates for children were:

infants, 0-1 year:	4.3 deaths per 100,000
1 to 4 years:	0.6 per 100,000
5 to 9 years:	0.4 per 100,000
10 to 14 years:	0.5 per 100,000
15 to 19 years:	1.8 per 100,000

By comparison, adults died from “COVID” at a rate of 109 per 100,000, making children more than a hundred times less likely to die from the “virus” than adults. The Centers for Disease Control and Prevention (CDC) released data showing **children account for less than 0.15% of all COVID deaths.**

Meanwhile the school lockdowns have led to the “largest score declines” since the federal government began tracking these metrics in 1990, according to the **National Assessment of Educational Progress**, known as the nation’s report card.

Math and reading scores took major hits nationwide, especially among the country’s most vulnerable students. Black and Hispanic students, for example, experienced steeper declines than white and Asian peers in fourth-grade math after already starting out behind.

Between 2019, the results of the last National Assessment of Educational Progress, and 2022, the number of Black students in public schools performing “below basic” in fourth-grade math on the national assessment spiked from 35% to 46%. The share of Hispanics rose from 27% to 37%. The share of whites scoring at the lowest performance level only increased from 12% to 15%. Test scores in math and English dropped an average of eight points across the country. The drop came after nearly two decades of progress, the study noted, **erasing all the gains** in test scores made between 2000 and 2019.

According to the study’s author, Eric Hanushek, “At the extreme, California is estimated to have lost \$1.3 trillion because of **learning losses during the pandemic.** These losses are permanent unless a state’s schools can get better than their pre-pandemic levels.”

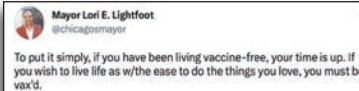

Chicago Ordered to Reinstate Employees Fired over Forced COVID-19 “vaccine”

Chicago must reinstate city employees who were fired for refusing to comply with Mayor Lori Lightfoot’s COVID-19 vaccine mandate and rescind the requirement, a state administrative law judge has ruled. More than 20 unions representing city employees, filed an unfair labor practices charge with the state after Lightfoot imposed the policy in the fall of 2021.

In a 78-page decision Administrative Law Judge **Anna Hamburg-Gal** found that the city was obligated to negotiate with the union over the effects of that policy. It was reported that the employees will receive back pay and 7% interest.
