

THE DANGERS AND RISKS OF GMOs (GENETICALLY MODIFIED ORGANISMS)

The masses of Americans, Blacks in particular, are suffering from other problems produced by "Genetically Modified Organisms."

What is the definition of a "Genetically Modified Organism"? From the *American Heritage Medical Dictionary*, it gives the definition: "An organism whose genetic characteristics have been altered by the insertion of a *modified* gene or a gene *from another organism* using the techniques of **genetic engineering**." And the definition of "gene" is "a molecular unit of heredity of a living organism."

In "Lesson No. 2" of our *Supreme Wisdom Lessons* given to us by *Master Fard Muhammad*, He raises The Question, "What is a Devil?"—and *Muhammad* answers that Question! It is: "A grafted man which is made weak and wicked. Or, any grafted, live germ from original is devil." By inserting, you are grafting into a life germ or seed something that changes *the nature* of that seed. And when you change the nature of the seed from its original state, you are making what is referred to as "devil." Once you graft from the original, then you are producing that which is an opposer to the original, and of the original. So the moment that a genetically modified seed is taken by the wind and blown into a field of natural organic growing corn or wheat or soy, it begins to destroy that field ...

Whenever you start "grafting," you are making an enemy of the thing that you are grafting from. And also, you are making an enemy to the good of the original from which it is grafted.

According to what we are researching, there is a prevalence in the United States of "Genetically Modified Organisms" ["GMOs"]. According to the legal advocacy group *Earthjustice* (Earthjustice.org), in an interview from June 2011 that is titled "GMOs: Engineering an Envi-

ronmental Disaster": "Genetically Modified Foods" are only *loosely regulated* by the U.S. Department of Agriculture; virtually all soybeans, corn, canola, and sugar beets grown in the United States today are patented by *Monsanto*, or other large corporations; and, 70-80 percent of all packaged foods found in supermarkets contain one or more genetically modified ingredients.

Production of **genetically modified organisms** and **genetically engineered crops** has been performed by several major corporations, companies like *Syngenta*, *Bayer*, *DuPont*, *BASF*, and *Dow Chemicals*; these are the leading GMO producers. But *The Monsanto Company* is the largest and most dominant in the world market—and many consumer advocates, organizations, and experts say that *Monsanto* is destroying the food supply as well as the environment.

What are the dangers and risks of Genetically Modified Organisms? A study published in the *International Journal of Science* in 2009 titled "A Comparison of the Effects of Three GM Corn Varieties on Mammalian Health" demonstrates the toxicity in three corn varieties from *Monsanto*. In the report's "Abstract" it states: "We present for the first time a comparative analysis of blood and organ system data from trials with rats fed three main commercialized genetically modified (GM) maize—"corn"—"(NK 603, MON 810, MON 863), which are present in food and feed in the world. NK 603 has been modified to be tolerant to the broad spectrum herbicide Roundup and thus contains residues of this formulation.

MON 810 and MON 863 are engineered to synthesize two different Bt toxins used as insecticides. ... Our analysis clearly reveals for the 3 GMOs new side effects linked with GM maize consumption, which were sex- and often dose-dependent. Effects were mostly associated with the kidney and liver, the dietary detoxifying organs, although different between the 3 GMOs. Other effects were also noticed in the heart, adrenal glands, spleen and haematopoietic system. We conclude that these data highlight signs of hepatorenal toxicity, possibly due to the new pesticides specific to each GM corn. In addition, unintended direct or indirect metabolic consequences of the genetic modification cannot be excluded."

According to the information contained in a research summary on genetically modified crops, prepared by the *Non-GMO Project*, a non-profit organization, titled **"GM Crops - Just The Science: Research Documenting The Limitations, Risks and Alternatives,"** it asks the question: **"Are GM Foods Safe To Eat?"** The report states that **"Contrary to industry claims,"** **genetically modified foods "are not properly tested for human safety before they are released for sale";** and, **genetically modified foods "are not labeled in the United States and other nations where they are widely eaten, and consumers are not monitored for health effects."**

Let us answer this question definitively: No genetically modified food is good to eat by the definition given by our Saviour Allah, Who appeared in the Person of Master Fard Muhammad, and His Messiah, the Honorable Elijah Muhammad! Any live germ grafted from original is "devil," or "enemy," or "opposer"! And any genetically modified food is an opposer and an enemy to the natural product, and therefore, it deprives the natural product of the natural nutrients that God put in the natural product for us to eat!

"GM Crops—Just The Science" includes a section titled **"Animal Studies on Genetically Modified Foods Give Concern"**—and a cause for great concern! It states: **"Although studies on humans have not been done, scientists are reporting a growing number of studies that examine the effects of genetically modified foods on laboratory animals: Rats fed genetically modified tomatoes developed stomach ulcerations; Liver, pancreas and testes function was disturbed in mice fed [genetically modified] soy; Genetically modified peas caused allergic reactions in mice; Rats fed genetically modified oil-seed rape"**—(a.k.a. **"Canola oil,"** the

refined oil produced from several varieties of the rape plant)—**"developed enlarged livers, often a sign of toxicity; Genetically modified potatoes fed to rats caused excessive growth of the lining of the gut similar to a pre-cancerous condition; Rats fed insecticide-producing genetically modified maize, or corn, grew more slowly, suffered problems with liver and kidney function, and showed higher levels of certain fats in their blood; mice showed a marked disturbance in immune system cell populations; Mice fed with genetically modified insecticide-producing corn over four generations showed a buildup of abnormal structural changes in various organs (liver, spleen, pancreas), and reduced fertility";** and, **"Mice fed genetically modified soya over their entire lifetime—of 24 months—showed more acute signs of aging in their liver."**

We want to add to this study, because the study on humans is being done! And we are the humans that are showing all the side effects of what was seen in rats and mice that were fed genetically modified foods! The question we want to ask is: What types of cooking oils are used in the inner cities in the fast food industry to fry the foods?

Remember, all of this comes from a policy of government written in the **National Security Study Memorandum** of Henry Kissinger, and **The Global 2000 Depopulation Policy** under President Jimmy Carter, to produce in water and food, and other methodologies, that which would depopulate from 2-3 billion people from our planet.

'Protection' of corporate giants, and not the people, suffering the effects of GMO products

Who is Monsanto? Monsanto was created in 1901. The company's first product was the artificial sweetener *saccharin*; and in the 1920s, Monsanto expanded into basic industrial chemicals. It is the leader in genetically modified seeds and crops. **Monsanto is currently respon-**

sible for 90 percent of the genetically engineered seed on the United States market. Outside of genetically modified seeds, Monsanto is also the creator of the best-selling herbicide "Roundup."

Another American chemical company, **DuPont**, is the world's third largest producer of chemicals, agrochemicals, polymers, safety materials, electronics and genetically modified seeds. In 1999, DuPont became the largest seed company and producer of hybrid seeds used in production of genetically modified corn and soy. DuPont is among the top four biotech companies that produce 100 percent of the genetically modified seeds, and 60 percent of world pesticides.

However, according to a *Congressional Research Service* report dated September 2, 2010 entitled **"Agricultural Biotechnology: Background and Recent Issues,"** by Tadlock Cowan, there are ongoing concerns about the impact of Genetically Engineered crops on the environment and food safety; and whether U.S. regulations and oversight by the *U.S. Department of Agriculture*, the *Food and Drug Administration* and the *Environmental Protection Agency* are "adequate." This has caused many lawsuits against the *USDA* for its approval of *alfalfa* and *sugar beets*; where, in both cases, the District Courts found *USDA* approval of the genetically modified organism was *inadequate*, and ordered the *U.S. Department of Agriculture* to conduct an environmental impact statement—but it did not stop them from producing the genetically modified seeds!

In March of 2011, the *Public Patent Foundation* filed a federal lawsuit against Monsanto on behalf of the *Organic Seed Growers and Trade Association*, and other farmers and organizations, totaling 83 Plaintiffs. The essence of the lawsuit is stated in the **"First Amended Complaint"** filed in June 2011, which reads, in part:

"1. Society stands on the precipice of

forever being bound to transgenic agriculture and transgenic food. Coexistence between transgenic seed and organic seed is impossible because transgenic seed contaminates and eventually overcomes organic seed. ..."

In other words: **The "grafted thing" is disagreeable to live with in peace. There must be separation, for one will absolutely destroy the other.** The quote concludes with: *"History has already shown this as soon after transgenic seed for canola was introduced, organic canola became virtually extinct as a result of transgenic seed contamination. Organic corn, soybean, cotton, sugar beet and alfalfa now face the same fate, as transgenic seed has been released for each of those crops, too. And transgenic seed is being developed for many other crops, thus putting the future of all food, and indeed all agriculture, at stake."* The document defines **"transgenic,"** which means **"to introduce the genetic code of one species into another."** Also, it states that "transgenic plants" are sometimes referred to as "genetically modified" or "genetically engineered"; however, *"those terms are imprecise and, therefore, not used herein"*—in this case that is put before the court.

However, if there is no "coexistence" between *the natural seed* and *the transgenic (altered) seed*, and the altered seed will destroy the natural seed, **then the same is also true in our "race relations"!** Because "race relations" will continue to get worse, because the government cannot provide food, clothing, shelter and jobs for us anymore! As we sit around, waiting for somebody else to do this for us, we are making our former slave masters and their children angrier with us; and they are becoming completely disagreeable to live with in peace! And that is why we must be separated if we don't want to continue to suffer great loss!

"Treaty" Gives W.H.O. Ability to Declare "Emergency" and Take Rights Away

Changes to the United Nations' 2005 international health regulations (IHR) have been occurring "under the radar" because Americans would object to the unconstitutionality of the changes, according to **Jonathan Alexandre (in photo)**, a senior counsel for the international litigation nonprofit Liberty Counsel.

The Biden administration's proposed amendments to the IHR would further strengthen the **World Health Organization's** authority to declare public health emergencies and override U.S. governing bodies.

"They've done this undercover because they knew at any point, if you were to tell Americans you're ceding the[ir] authority to an international body that is unaccountable to the people, if the media were to echo that message, certainly Americans would have no regard for this," Alexandre said during a recent interview with "NTD News Today." "And we ought not to have any regard for this international body [the WHO] that is not accountable to us."

The Biden administration proposed 13 amendments to the IHR, that, if approved, would alter international public health rules—including expanding the powers given to the WHO director-general to declare a public health emergency, bypassing U.S. governmental bodies.

Leading Biologist Addresses Mississippi Lawmakers on Vaccine Dangers

My name is **Dr. Christina Parks**. I received my Ph.D. in Cellular and Molecular Biology from the University of Michigan and did my graduate work in the area of cytokine signaling. The degree that I hold is very much involved with how to manipulate genetic material as was done in the production of these new gene-transfer vaccines for COVID. Recently Pfizer has been in the news due to a Project Veritas video that brought into question whether Pfizer was doing "gain of function" research. People tend to understand that "gain-of-function" research might result in the creation of a more virulent form of the SARS CoV-2 virus. Thus, most people recognize this as a dangerous and unethical avenue of research. However, it seems that we've missed seeing the hazards and immorality in using "gene-transfer" technology for vaccines. The issue we should be focusing on is why our scientists and government decided to force millions, if not billions, of people to inject a product that forces the body to produce a toxic, foreign viral protein when they knew this would cause the body to attack the cells producing it, as the cells producing the spike protein would be seen by the body as "foreign invaders"? You don't need a Ph.D. to recognize that this is an astonishingly bad idea.

Not surprisingly, an avalanche of data is coming out that shows that tissues throughout the body are expressing the toxic, foreign spike protein for many, many months and that immune cells are infiltrating and causing inflammation and destruction in areas where the spike protein is being made. Pfizer's own data show that their nano-lipid particles are absorbed by fatty tissues. So, we have areas like the bone marrow, the adrenal glands, the ovaries and the heart making spike protein and then being infiltrated and attacked by the body's own immune cells.

We absolutely need to stop injecting people and especially children with this technology until all safety signals, such as myocarditis, menstrual issues, miscarriage, neurological disorders and cancers have been thoroughly studied. All medical procedures should be accompanied by informed consent and individualized care. However, there hasn't been any attempt to consider the specific needs of people of African descent during this vaccine roll-out. The work of **Dr. Gregory Poland** from the Mayo Clinic established that per-

sons of African descent respond more vigorously to vaccines containing RNA viruses and may need a lower dose. Persons of color also have high rates of gene mutations that are protective for malaria, but may compromise the body's ability to carry oxygen when the body is stressed, such as following receipt of a COVID vaccine. Were any of these susceptibilities screened for prior to vaccination? No. Does our government really care about Black people? I would say the answer is a resounding no. Many black Mississippians may have heard stories of their family members being experimented on in prison in the past. And Fauci has continued the legacy of using black people as guinea pigs by using healthy black orphans to test toxic HIV medications. The WHO recently ran a "Tetanus vaccine campaign" in Kenya, but the vaccine being used was found by independent labs to contain the hormone necessary to sustain pregnancy. Women who got it would have made antibodies to their pregnancy hormone, rendering them sterile.

In the wake of marginalization and exploitation of black people in America and around the world, it is now Mississippi's turn to decide how it will treat its black citizens. Regulatory filings show Pfizer knew of its shots' waning effectiveness in April 2021 but didn't publicly acknowledge it until late July 2021.

Preclinical studies for Pfizer's COVID-19 shots also warned of rhabdomyolysis, which is the breakdown of skeletal muscles, but the Pfizer trial reported it was "completed with no safety concerns."

Government emails from May 14, 2021, also discuss concerns about administering COVID-19 shots along with other vaccines during pregnancy.

Oxfam: Billionaires Grow Richer in “Pandemic”

The calculations by Oxfam America in a new report titled “TAX WEALTH, TACKLE INEQUALITY” show that:

- US billionaires are almost a third richer (over a trillion dollars, in real terms) than they were at the onset of the “pandemic” in 2020.
- US billionaires have increased their wealth by 86.3% since 2013, based on Forbes data. Nearly half of this increase (48.6%) has occurred in the last three years. The number of US billionaires is nearly 60% higher than it was a decade ago, clocking in at over 700 today.
- For every \$100 of wealth created in the last ten years in the United States (2012-2021), \$37 has gone to the richest 1%—while the bottom 50% have received just \$2.



At the same time, our country has a “permanent underclass” of working families who are denied their economic rights, trapped in poverty, and unable to accumulate wealth no matter how hard they work. Oxfam data shows that almost a third of the US labor force earns less than \$15 an hour; half of all working women of color earn less than \$15.

The racial wealth gap is actually growing wider since the 1980s, and today is close to what it was in 1950. The average Black American household currently has only about 12 cents in wealth for every dollar of the average white American household.

And while the gender pay gap has barely budged in two decades, the gender wealth gap is much wider. One study found a raw gender wealth gap of women owning 32 cents for every dollar of male wealth. For women of color, the gap is even more profound.

Groups Lobbying for COVID-19 Vaccine Mandates Were Funded by Pfizer

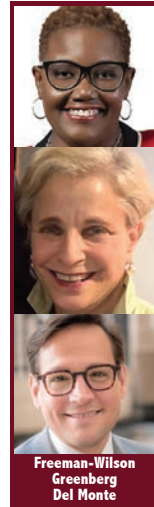
Epoch News reports that multiple organizations that pushed for COVID-19 vaccine mandates received funding from Pfizer, according to financial disclosures.

The **Chicago Urban League President Karen Freeman-Wilson** said in August 2021 that the benefit of vaccine mandates “far outweighs” concerns about them. She did not mention that her organization was on the receiving end of a \$100,000 grant from the “vaccine” manufacturer Pfizer.

That same month, the **National Consumers League** said it supported mandates imposed by governments and employers. “In recent weeks, it has become evident that employer mandates are effective at nudging reluctant people to get the COVID-19 vaccine,” the group said in a statement. Undisclosed by its **executive director Sally Greenberg** was this fact: the league received \$75,000 from Pfizer for “vaccine policy efforts.”

The **American Academy of Pediatrics**, led by CEO **Dr. Mark Del Monte**, drew more than \$250,000 from Pfizer in 2021, the bulk coming before the organization announced support for COVID-19 vaccine mandates for health care workers. The group claimed mandates would curb COVID-19 transmission and cases, and it now recommends COVID vaccines for all “kids 6 months and up.”

The **American Pharmacists Association, American College of Preventive Medicine, Academy of Managed Care Pharmacy, American Society for Clinical Pathology, and the American College of Emergency Physicians** also received grants from Pfizer before signing a letter that urged the Biden administration to impose COVID-19 vaccine mandates on private employers with 100 or more workers.

Why Three COVID Jabs Are Worse Than Two

Analysis by Dr. Joseph Mercola

COVID-19 is more than twice as prevalent among the boosted, compared to those who quit after the initial series. Those with a primary series plus one or two booster shots are catching the infection at a rate of 120 per 100,000, while those with the primary series only have an infection rate of 56 per 100,000.

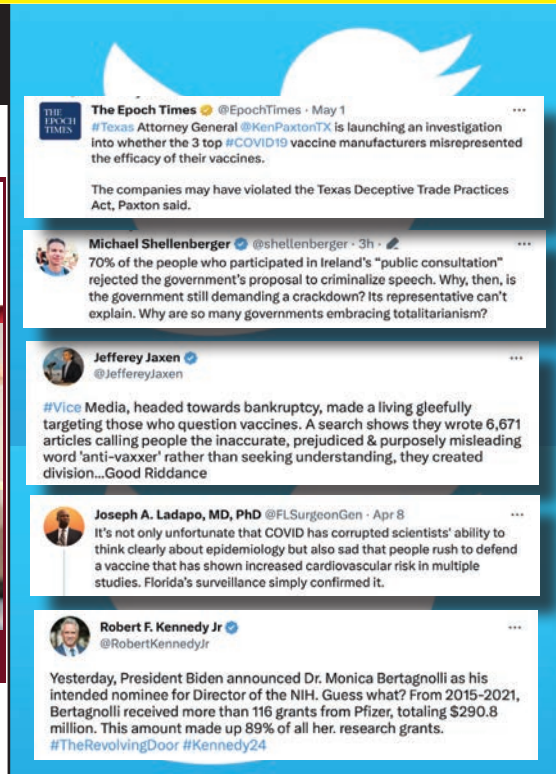
Pfizer’s pediatric trial reveals the shots raise, rather than lower, the risk of reinfection (meaning catching COVID more than once). In all, 12 of the children in Pfizer’s trial were diagnosed with COVID twice within the follow-up period (one to four months). Of those, 11 had received two or three jabs; only one unvaccinated child got COVID twice.

Data from Moderna’s trial also suggest the shot makes adults more prone to repeat COVID infections, thanks to an inhibited antibody response.

In Pfizer’s pediatric trial, six of the children, aged 2 to 4 years, in the vaccinated group were diagnosed with “severe COVID,” compared to just one in the placebo group. So, the shot may actually cause more severe infection in young children.

Believe it or not, we’re now at the point where even mainstream media are reporting that COVID-19 is more prevalent among the boosted, compared to those who quit after the initial series. That doesn’t mean that sanity is returning; it’s just interesting that they’re not able to ignore it completely, even though their efforts to rationalize it teeter on the verge of lunacy.
